COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT FOR A TERM OF  
TWO YEARS AS THE LEGISLATIVE BRANCH REPRESENTATIVE

**SECTION ONE. AUTHORITY**

- A. The Naabik'iyáti' Committee has legislative oversight authority over the Commission on Navajo Government Development and the Office of Navajo Government Development. 2 N.N.C. § 970.
- B. The Navajo Nation established the Naabik'iyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'iyáti' Committee to recommend all resolutions to the Navajo Nation Council on matters within the Committee's jurisdiction pursuant to 2 N.N.C. § 701(A)(3).
- C. One member shall be nominated by the Legislative Branch through the [Naabik'iyáti' Committee] to serve a term of two years from the date of confirmation by the Navajo Nation Council. 2 N.N.C. § 972(A)(3).

**SECTION TWO. FINDINGS**

- A. The Commission on Navajo Government Development is an "entity created by the Navajo Nation Council with quasi-independent authority to accomplish the Council's

1 project of instituting reforms necessary to ensure an accountable and responsible  
2 government.” 2 N.N.C. § 970.

3 B. The Commission shall be responsible directly to the Navajo Nation Council with  
4 respect to overall activities. 2 N.N.C. § 970.

5 C. The purpose of the Commission on Navajo Government Development shall be as  
6 follows:

7 1. To review and evaluate all aspects of the existing government structure of the  
8 Navajo Nation including laws, rules and regulations, practices, functions,  
9 goals and objectives of the Navajo Nation government, which includes the  
10 central government, Chapters, townships and local communities.

11 2. To develop recommendations and proposals for government reform and  
12 alternative forms of Navajo Nation government.

13 2 N.N.C. § 971(A) and (B).

14 D. The Commission shall consist of twelve (12) members confirmed by and serving at the  
15 pleasure of the Navajo Nation Council. 2 N.N.C. § 972(A).

16 E. Commission members shall be chosen from among individuals who have  
17 demonstrated scholarship, strong sense of public interest, knowledge of Navajo  
18 history and cultural heritage, spiritual leadership, leadership in the Navajo  
19 government and abilities likely to contribute to the fulfillment of the duties of the  
20 Commission. 2 N.N.C. § 972(D).

21 F. Larry Rodgers, the Executive Director of the Eastern Navajo Land Commission, has  
22 expressed an interest in serving on the Navajo Government Development  
23 Commission. His letter of interest and résumé are attached as **Exhibit A**.

24 G. Memoranda from the Executive Director of the Office of Navajo Government  
25 Development are attached as **Exhibit B**.

26 H. Two resolution approved by the Commission on Navajo Government Development,  
27 CNDG-1202-17 and CNDG-0201-19, are attached as **Exhibits C** and **D**, respectively.

1       **SECTION THREE. APPOINTMENT**

2       The Navajo Nation Council hereby confirms the appointment of Larry Rodgers as the  
3       Legislative Branch representative to the Commission on Navajo Government  
4       Development, for a term of two years from the date of confirmation by the Navajo Nation  
5       Council.

Yá'at'tééh! I hope this letter finds you in good spirit and health. On two separate occasions, the Commission on Navajo Government Development passed Resolution No's. CNGD-1202-17 and CNGD-0201-19, December 17, 2017 and February 16, 2019 (*attached*), respectively. Both of the aforementioned resolutions specifically addressed and strongly recommended a Legislative Branch representative to the Commission on Navajo Government Development be nominated without any additional delay.

The Legislative Branch representative to the "Commission" has now been vacant since June 19, 2013 under the then 22<sup>nd</sup> Navajo Nation Council, which is approximately 6 years and 3 months (exactly 75 monthly commission meetings in which a Legislative Branch representative to the Commission has been absent). This is simply unacceptable in the period of the need to seriously address government reform across the Navajo Nation civic landscape.

Recently, two requests for proposal were issued in a form of Public Notice in *Navajo Times* newspaper on June 27, 2019 and August 15, 2019, requesting for interested person to submit a letter of interest and resume. There were no inquiries or any application submitted after this public notice. Accordingly and you will notice, Mr. Larry Rogers letter of interest and resume predates both public notice date and essentially, this is the only applicant that is now being forwarded as a nominee.

In your collaboration with the Speaker of the Navajo Nation Council, the Office of Navajo Government Development faithfully requests that either you or the Speaker be the primary sponsor for this legislation. Additionally, the Commission politely request this be introduced right away in time for the upcoming Navajo Nation Council Fall Session.

SUBJECT: **Legislative Branch Representative to the Commission on Navajo Government Development**

The FY2019 First Quarter Report submitted to your office and the 24<sup>th</sup> Navajo Nation Council states the following under X. Major Issues and Recommendations (1) Vacancies on the Commission on Navajo Government Development: The VACANT representative from the Legislative Branch to the Commission on Navajo Government Development remains unfilled.

The Legislative Branch representative to the Commission under the 23rd Navajo Nation Council has never been filled despite numerous attempts by the office, commission, and concerned council delegates. In fact, the vacancy goes as far back as June 2013 under then Speaker Laurence T. Morgan of the 22<sup>nd</sup> Navajo Nation Council. For five and half (5 ½) years the Legislative Branch representative to the Commission on Navajo Government Development has been ignored and left unfilled.

Pursuant to 2 N.N.C. § 972 (A)(3) (1994 as amended), One member shall be nominated by the Legislative Branch through the Intergovernmental Relations Committee (now Naabik'íyáti' Committee) of the Navajo Nation Council to serve a term of two years from the date of confirmation by the Navajo Nation Council, the nominee shall have prior experience as an official or employee of a state government or any subdivision thereof.

Members of the 23<sup>rd</sup> Navajo Nation Council regularly queried about the effectiveness and productivity of the Office and Commission on Navajo Government Development, in light of then Speaker LoRenzo C. Bates legislative silence and responsibility to nominate a representative. The long-overdue vacancy and the lack of representation from Legislative Branch directly contributes to the assumed inaction that affect not only the Office but the Commission on Navajo Government Development and the Navajo Peoples aspiration for "government reform."

The Commission and this Office looks to your leadership to nominate a Legislative Branch representative to serve on the Commission of Navajo Government Development. Thank you.

RECOMMENDING THE SPEAKER OF THE NAVAJO NATION COUNCIL TO UPHOLD 2 N.N.C. § 972(3) TO NOMINATE A LEGISLATIVE BRANCH REPRESENTATIVE TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT, A LONG OVERDUE VACANCY SINCE JUNE 2013 THAT HAS BEEN DISREGARDED AND IT MUST BE FILLED ABSENT OF POLITICAL AMBIANCE

**WHEREAS:**

1. Pursuant to CD-68-89, the Navajo Nation Council established the Commission ("Commission") on Navajo Government Development including the Office of Navajo Government Development with quasi-independent authority to accomplish the Navajo Nation Council's project of instituting reforms necessary to ensure an accountable and responsible government; and,
2. Pursuant to 2 N.N.C. § 971 (1994 as amended), the purpose of the Commission on Navajo Government Development shall be as follow: (A) To review and evaluate all aspects of the existing government structure of the Navajo Nation including laws, rules and regulations, practices, functions, goals and objectives of the central government as it relates to Chapters, and local communities and the relationship of Chapters and local communities and the relationship of Chapters and local communities to the central government; and,
3. Pursuant to 2 N.N.C. § 972 (1994 as amended), A. The Commission shall consist of 12 Navajo members to be confirmed by and serve at the pleasure of the Navajo Nation Council as follow; and,
4. Pursuant to 2 N.N.C. § 972 (A)(3) (1994 as amended), One member shall be nominated by the Legislative Branch through the Intergovernmental Relations Committee (now *Naabik'iyáti' Committee*) of the Navajo Nation Council to serve a term of two years from the date of confirmation by the Navajo Nation Council, the nominee shall have prior experience as an official or employee of a state government or any subdivision thereof; and,
5. Pursuant to 2 N.N.C. § 972 (D) (1994 as amended), Commission members shall be chosen from among individuals who have demonstrated scholarship, a strong sense of public interest, knowledge of Navajo history and cultural heritage, spiritual leadership, leadership in Navajo government and abilities likely to contribute to the fulfillment of the duties of the Commission; and,
6. The Legislative Branch representative to the "Commission" has been vacant since June 19, 2013, under the then 22<sup>nd</sup> Navajo Nation Council Speakership; and,



7. For approximately four and a half (4 ½) years, the Legislative Branch representative to the Commission on Navajo Government Development has been disregarded and left unfilled; and,
8. Members of the Naabik'iyáti' Committee in the 23<sup>rd</sup> Navajo Nation Council have frequently queried the effectiveness and productivity of both the Office and Commission on Navajo Government Development, in light of its own legislative silence in leadership and responsibility to nominate a Legislative Branch representative; and,
9. The long-overdue vacancy and the lack of representation from Legislative Branch directly contributes to the questionable and postulated inaction, affecting not only the Office of Navajo Government Development but also the Commission on Navajo Government Development and more importantly, the Navajo Peoples aspiration for "government reform."

**NOW THEREFORE IT BE RESOLVED THAT:**

1. The Commission on Navajo Government Development hereby approves the recommendation for the Speaker of the Navajo Nation Council to uphold 2 N.N.C. § 972(3) to nominate a Legislative Branch representative, absent of political ambiance, through the Naabik'iyáti' Committee of the Navajo Nation Council to serve on the Commission on Navajo Government Development, for a term of two years from the date of confirmation.

**WHEREAS:**

1. 6. The Legislative Branch representative to the "Commission" has been vacant since June 19, 2013, under the then 22<sup>nd</sup> Navajo Nation Council Speaker; and
7. For approximately five and a half (5 ½) years, the Legislative Branch representative to the Commission on Navajo Government Development has been disregarded and left unfilled; and
8. Members of the Naabik'iyáti' Committee in the 23<sup>rd</sup> Navajo Nation Council have frequently queried the effectiveness and productivity of both the Office and Commission on Navajo Government Development, in light of its own legislative silence in leadership and responsibility to nominate a Legislative Branch representative; and
9. The long-overdue vacancy and the lack of representation from Legislative Branch directly contributes to the questionable and postulated inaction, affecting not only the Office of Navajo Government Development but also the Commission on Navajo Government Development and more importantly, the Navajo Peoples aspiration for "government reform."

**NOW THEREFORE IT BE RESOLVED THAT:**

1. The Commission on Navajo Government Development hereby approves an action to recommend to the Speaker of the 24<sup>th</sup> Navajo Nation Council to uphold 2 N.N.C. § 972(3) by nominating a Legislative Branch representative, absent of political dispute, through the Naabik'iyáti' Committee of the Navajo Nation Council to serve on the Commission on Navajo Government Development, for a term of two years from the date of confirmation.

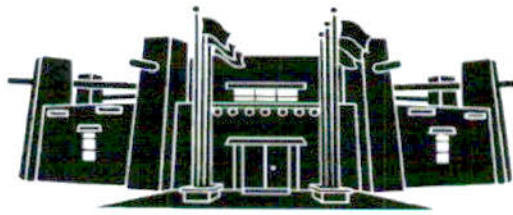
