

UNRESERVED, UNDESIGNATED FUND BALANCE TO THE NAVAJO
NATION DIVISION OF SOCIAL SERVICES FOR COVID-19-RELATED
BURIAL ASSISTANCE; WAIVING 12 N.N.C. §820(E), §820(F), AND §820(J)

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education, and Human Services Committee is a standing committee of the Navajo Nation Council with the authority to review and recommend legislation relating to the Navajo Nation Division of Social Services. 2 N.N.C. §454(B)(8).
- B. The Budget and Finance Committee is a standing committee of the Navajo Nation Council that is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. §301(B)(2).
- C. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council that is responsible for reviewing proposed resolutions that require final action by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
- D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).

1 E. The Navajo Nation Council has the authority to approve supplemental appropriations. "The
2 Navajo Nation Council may adopt and approve supplemental appropriations to the Annual
3 Comprehensive Budget during the fiscal year. Supplemental appropriations of General
4 Funds within the current fiscal year are permitted, if and when additional sources of
5 revenues above and beyond the initial or current revenue projections are projected and
6 which are also in excess of the reserve amount set forth at §820(J)." 12 N.N.C. §820(L).

7 F. The restrictions on supplemental appropriations include:

8 1. Supplemental appropriations from non-recurring revenues shall be approved only for
9 non-recurring expenses. 12 N.N.C. §820(F). The Controller designates which revenues
10 are recurring and which are non-recurring. 12 N.N.C. §820(L).

11 2. The Navajo Nation shall budget all recurring operating expenses, including capital
12 maintenance costs, from recurring revenues only. Long-term debt shall not be used to
13 finance recurring operating expenses. 12 N.N.C. §820(E).

14 3. The Navajo Nation Code further provides, ". . . non-recurring revenues will be budgeted
15 only after an examination by the Controller to determine whether or not the revenues are
16 subsidizing an imbalance between recurring revenues and expenditures, and
17 expenditures may be authorized only if a long-term (three-five year) forecast shows that
18 the operating deficit will not continue. Otherwise, non-recurring revenues will be added
19 to the Unreserved, Undesignated Fund Balance. This provision may be amended or
20 waived by a two-thirds vote of the full Navajo Nation Council." 12 N.N.C. §820(F).

21 4. All requests for supplemental funding shall be submitted to the Office of Management
22 and Budget ("OMB") for budget impact analysis. 12 N.N.C. §820(M).

23 24 **SECTION TWO. FINDINGS**

25 A. The coronavirus pandemic of 2019 has caused large scale infections and loss of life
26 throughout the world, the United States, and the Navajo Nation. As of November 1, 2021, the
27 Navajo Nation Health Command Operations Center has confirmed 36,867 COVID-19 cases
28 and 1,487 COVID-related deaths on the Navajo Nation. COVID-19 variants have recently
29 emerged that threaten to increase these numbers and continue the pandemic's assault on the
30 Navajo People.

1 B. Under its COVID-19 Burial Assistance Program, the Navajo Nation Division of Social
2 Services ("NNDSS") continues to receive requests for financial assistance to help families
3 with funeral costs for Navajo Nation members who have passed away from COVID-19
4 causes and who resided on and off the Navajo Reservation.

5 C. On March 26, 2021, by Resolution CMA-14-21, the Navajo Nation Council appropriated
6 supplemental funding from the Unreserved, Undesignated Fund Balance in the amount of
7 \$2,002,000 to the NNDSS for COVID-19-related burial assistance. However, these funds
8 lapsed on September 30, 2021, thereby leaving 30 assistance requests with NNDSS that are
9 unfunded and currently pending.

10 D. The NNDSS has prepared a Supplemental Funding Proposal Summary, dated November
11 17, 2021. NNDSS is seeking \$2,046,781 from the Unreserved, Undesignated Fund Balance
12 to cover COVID-19-related burial assistance for Navajo decedents who resided on and off
13 the Navajo Reservation, and to pay for NNDSS' operating and overtime expenses.

14 **EXHIBIT A.** NNDSS' Budget Forms 1, 2, and 4 are also included. **EXHIBIT B.**

15 E. The memorandum from the Office of the Controller will be provided when this legislation
16 is being considered, in compliance with 12 N.N.C. §820(L).

17 F. The memorandum from the Office of Management and Budget will be provided when the
18 legislation is being considered, in compliance with 12 N.N.C. §820(M).

19
20 **SECTION THREE. APPROVING \$2,046,781 IN UUFBS SUPPLEMENTAL FUNDING**
21 **FOR THE NNDSS FOR COVID-19-RELATED BURIAL ASSISTANCE**

22 A. The Navajo Nation hereby approves \$2,046,781 in supplemental funding from the
23 Unreserved, Undesignated Fund Balance to the Navajo Nation Division of Social Services
24 for COVID-19-related burial assistance for Navajo decedents who resided on and off the
25 Navajo Reservation, and to fund NNDSS' related operating and overtime expenses.

26 B. This supplemental appropriation of \$2,046,781 shall be from the amount of funds that
27 exceeds the minimum fund balance of the Unreserved, Undesignated Fund Balance as
28 determined by the Office of the Controller.

29 C. This supplemental appropriation of \$2,046,781 shall be available until fully expended and
30 shall not lapse on September 30, 2022.

1 **SECTION FOUR. WAIVING 12 N.N.C. §820(E), §820(F), AND §820(J)**

2 The Navajo Nation Council hereby waives 12 N.N.C. §820(E), §820(F) and §820(J) to allow
3 funds out of the Unreserved, Undesignated Fund Balance to be used for recurring
4 expenditures.

5
6 **SECTION FIVE. EFFECTIVE DATE**

7 This legislation shall become effective in accordance with 2 N.N.C. §221(B) and 2 N.N.C.
8 §164(A)(17).

9
10 **SECTION SIX. SAVING CLAUSE**

11 If any provision of this legislation is determined invalid by the Supreme Court of the Navajo
12 Nation, or by the Navajo Nation District Court without appeal to the Navajo Nation Supreme
13 Court, the remainder of this legislation shall remain valid as the law of the Navajo Nation.

PART II. REASON FOR REQUEST AND STATEMENT OF NEED:


The public health pandemic has caused a profound impact on the Navajo Nation, especially COVID19-related death toll of the Navajo people at an unprecedented scale; in some situations, families have loss more than one family member to this dreadful virus. The Navajo Division of Social Services' Office of the Executive Director fully depleted FY2022 General Funds budget of \$87,500 leaving a deficit of \$2,900. The Division continues receiving COVID19 burial assistance requests on a daily basis. Since the onset of COVID19 pandemic, the Nation spent \$4,168,503 for 1,460 COVID19-related deaths of Navajo people who resided on and off the Navajo reservation. Currently, there are 30 pending COVID19-related burial assistance requests, for which supplemental funding is direly needed to assist grieving Navajo families. The Division woefully requests for supplemental funding from the Unreserved, Undesignated Fund Budget in the amount of \$2,046,781 to fund operational and overtime costs, and 572 COVID19-related burial assistance of Navajo individuals who resided on and off the Navajo reservation, including the pending burial assistance requests that have not been paid. Additionally, the Division requests for an appropriation provision that the supplemental funding be available until fully depleted and not to lapse on September 30, 2022.

PART III. LIST ALTERNATIVE FUNDING SOURCES BEING PURSUED AND CONTINGENCY PLAN IF REQUEST IS NOT FUNDED:

All funding sources that were available and allowable for COVID19 related burial assistance have been completely depleted, including: Navajo Nation General Funds and federal funding from the Centers for Disease Control and Prevention through the Navajo Epidemiology Center, and through the Navajo Office of Vital Records. The Navajo Division of Social Services' contingency plan is to seek supplemental funding from the Navajo Nation Unreserved, Undesignated Fund Balance.

PART IV. AFFIRMATION IS PROVIDED THAT THE BUDGET AND PROPOSAL INFORMATION IS COMPLETE AND ACCURATE AND THE APPROPRIATE BRANCH CHIEF RECOMMENDS APPROVAL AS A PRIORITY.

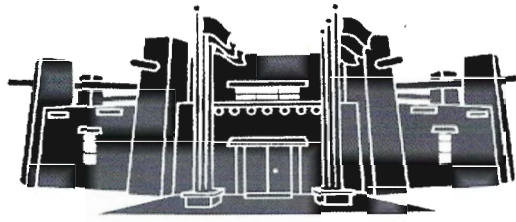
