**PURPOSE OF RESOLUTION:** This resolution, if approved, will rescind NABIAU-35-20, a resolution which recommended that *all schools, public and private, serving the Navajo Nation, including those operated by the State of New Mexico Public Education Department, the states of Arizona and Utah, and all schools operated by the Bureau of Indian Affairs and the Bureau of Indian Education, to delay plans and decisions to reopen schools for the 2020-2021 school year.* The proposed resolution introduced will rescind this previous action of the Navajo Nation.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

WHEREAS:

- A. The Health Education and Human Services Committee of the Navajo Nation Council has oversight over the Navajo Nation Department of Diné Education. 2 N.N.C. § 401 (C) (1).
- B. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council. It has the authority to "review and continually monitor the programs and activities of federal and state departments and to assist development of such programs designed to serve the Navajo People and the Navajo Nation through intergovernmental relationships between the Navajo Nation and such departments." 2 N.N.C. § 701(A)(7).

1 C. On August 13, 2020, the Naabik'iyáti' Committee passed resolution NABIAU-35-20,  
2 entitled "*An Action Relating To Health, Education And Human Services And*  
3 *Naabik'iyáti' Committees; Recommending That All Schools, Public And Private,*  
4 *Serving The Navajo Nation, Including Those Operated By The State Of New Mexico*  
5 *Public Education Department, The States Of Arizona And Utah, And All Schools*  
6 *Operated By The Bureau Of Indian Affairs And The Bureau Of Indian Education, To*  
7 *Delay Plans And Decisions To Reopen Schools For The 2020-2021 School Year.*"

AN ACTION RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES AND NAABIK'ÍYÁTI' COMMITTEES; RECOMMENDING THAT ALL SCHOOLS, PUBLIC AND PRIVATE, SERVING THE NAVAJO NATION, INCLUDING THOSE OPERATED BY THE STATE OF NEW MEXICO PUBLIC EDUCATION DEPARTMENT, THE STATES OF ARIZONA AND UTAH, AND ALL SCHOOLS OPERATED BY THE BUREAU OF INDIAN AFFAIRS AND THE BUREAU OF INDIAN EDUCATION, TO DELAY PLANS AND DECISIONS TO REOPEN SCHOOLS FOR THE 2020-2021 SCHOOL YEAR

**WHEREAS:**

- A. The Health, Education and Human Services Committee (HEHSC) is a standing committee of the Navajo Nation Council. It has the authority to review and recommend resolutions regarding certain matters, including health, education and social services. 2 N.N.C. §§ 164 (A)(9), 400 (A), 401 (B)(6)(a) (2012); see also CO-45-12.
- B. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council. It has the authority to "review and continually monitor the programs and activities of federal and state departments and to assist development of such programs designed to serve the Navajo People and the Navajo Nation through intergovernmental relationships between the Navajo Nation and such departments." 2 N.N.C. §701(A)(7).
- C. The Navajo Nation has children attending public schools in the state of New Mexico, including schools in McKinley and San Juan Counties.
- D. Due to coronavirus (COVID-19), Governor Michelle Lujan Grisham, through executive order, closed New Mexico public schools for the period March 16, 2020 - April 3, 2020. See, [newmexico.gov](http://newmexico.gov). On March 27, 2020, with 136 confirmed cases for COVID-19 in the state, the March/April school closure was extended for the remaining school year. Gov. Lujan Grisham stated, "We're working very hard to contain the virus, and we have to continue to take aggressive steps to mitigate spread



and protect New Mexicans of every age all across the state. It is more important than ever that we make sure all New Mexicans are heeding the imperative to stay home." She also stated, "Keeping schools closed is one of the most important tools we have to support the social distancing that can help us reduce and mitigate the spread of the virus." See, *newmexico.gov*. (March 27, 2020). Schools were directed to develop "continuous learning plans." *Id.*

- E. The Bureau of Indian Education (BIE) manages elementary and secondary schools and dormitories located on Indian reservations, including the Navajo Nation. Within the Navajo Nation, there are Navajo Nation controlled schools, and schools operated under contracts or grants with the BIE. The BIE also provides funds for residential programs.
- F. Arizona public schools are scheduled to reopen August 17, 2020. New Mexico public schools are scheduled to reopen August 3, 2020. Bureau-operated schools are scheduled to reopen September 16, 2020.
- G. On June 20, 2020, the New Mexico Public Education Department (NMPED), through its written *Reentry Guidance*, announced plans to reopen schools (K-12) beginning in August for school year 2020-2021. See, *newmexico.gov* and **Exhibit A** (an excerpt from June 20, 2020 NM PED *Reentry Guidance*)
- H. COVID-19 cases continue to increase across the country at an alarming rate. For New Mexico, as of July 1, 2020, over 12,000 cases of Coronavirus were reported. Nearly 500 deaths were reported as well. See, *cv.nmhealth.org* (NM Department of Health). And within the Navajo Nation, health officials have reported the highest per capita rate of infection for COVID-19 in the United States.
- I. There are a number of comments from the general public, including teachers and students, against reopening of schools. These comments are attached as **Exhibit B**.
- J. Statistics also provide that New Mexico "ranks second among states in percent of positive cases that are under 20 years of age. In New Mexico, 12% of positive cases have been children

and adolescents; the national average is 3%." See, [cv.nmhealth.org](http://cv.nmhealth.org) (FAQ).


- K. Navajo children must be protected. In midst of the continuous rising cases of COVID-19 throughout the country, it is too early to reopen schools in the manner proposed by the New Mexico Public Education Department.

**NOW THEREFORE BE IT RESOLVED THAT:**

- A. The Navajo Nation strongly recommends that all schools, public and private, serving the Navajo Nation, including those operated by the State of New Mexico Public Education Department, The States of Arizona and Utah, schools operated by the Bureau of Indian Affairs and the Bureau of Indian Education, delay plans and decisions to reopen schools for the 2020-2021 school year.

# Exhibit A

## Requirements for Reentry

NMPED's Reentry Guidance provides considerations, recommendations, and best practices to encourage a safe and successful school year. The following are important minimum requirements for all reentry.

The eight minimum requirements for reentry are:

- 1 To begin, all districts and schools across the state will be able to operate strictly according to hybrid guidelines. The Department of Health and Medical Advisory Team will regularly assess rates of the spread of COVID-19. Districts and schools will then follow the appropriate guidelines based on the designated safe reentry category.
- 2 Schools must participate in a surveillance and rapid response testing program for all staff.
- 3 Schools must adhere to the social distancing requirements of their designated category.
- 4 Schools should avoid large group gatherings.
- 5 Face coverings are required for all students and staff except while eating, drinking and exercising, with limited exceptions for students or staff who have medical reasons for not being able to wear a mask or face shield.
- 6 All staff must be screened on a daily basis, including a temperature check and review of potential symptoms. All sites must work with state and local health officials to have a plan for contact tracing. While not required, this is also recommended for students.
- 7 For transportation, all staff and students must wear face shields or masks. In addition:
  - a. A maximum of two students may sit together on a bus seat.
  - b. Schools in the yellow category should take all reasonable steps to limit bus seats to one student to the best of their ability.
- 8 Meals must be provided to students during in-person instruction and remote learning.

Dear Honorable Governor Michelle Lujan Grisham,

This letter is in support of Navajo Nation Legislation 0159-20. I support the Navajo Nation's request to delay the starting of the school year 2020/2021. As of current information the community of Crownpoint has 734 cases of COVID-19. The number of positive cases has been increasing on average of 8-10 cases a day. We are seeing a decline in positive cases due to the Navajo Nation's strict Shelter In Place orders and 57 hour Lock downs.

As an educator I am concerned for my safety, the safety of my colleagues, and most importantly the safety of our students. I feel that the COVID pandemic will continue to decrease with time. My colleagues and I are requesting that you, as the Governor of New Mexico, delay the start of the next school year. Cuba Independent School District (CISD) is a public school in the state of New Mexico, under the New Mexico Public Education Department (NMPED). Under the *Reentry Guidelines* of the NMPED, CISD is among other schools in New Mexico to reopen schools in August 2020. CISD learned about the resolution carried forth by Council Delegate Edmund Yazzie of the Navajo Nation Council, recommending that the NMPED delay their plans and decisions to reopen schools for the 2020-2021 school year.

Cuba Independent School District is located in Cuba, NM, in Sandoval County, on the edge of the Easternmost portion of the Navajo Nation. A majority of our students (70%) are Navajo and live on the Navajo reservation. The communities that CISD serves face the same issues that our relatives all across the Navajo Nation face, which are further exacerbated by the pandemic. As we all know, our Navajo people were hit harder by COVID-19 as compared to other communities and as cases of the virus continue to rise, our communities have shown apprehension about sending their children back to school.

Cuba Independent School District supports the resolution brought forth by Mr Yazzie to recommend that the NMPED delay their plans and decisions to reopen schools for the 2020-2021 school year. Given the statistics provided in the resolution and the danger and fears surrounding the pandemic, it would be comforting for our students, parents, and communities to know that the safety of our students are at the forefront of our planning during this time. We ask that NMPED consider the hardships that our Navajo communities face when making the decision about requiring students to return back to school this year. We feel it would be safest for our students to continue in remote learning at this time. We support Mr. Yazzie and the resolution set forth here, as a decision in this matter will affect our school, our children, and our community.

Dear District Administration,

Mesa Elementary School has prepared for the safe return of our students and thus far we have (38) students on our hybrid list. We have 32% of our staff who have completed both 1 and 2 doses of COVID vaccines as of Friday, February 19. Despite preparing for a safe return to hybrid learning environment, on Tuesday, February 17, we had a positive notification of a staff member and consequently (6) staff who were notified to quarantine and be screened for COVID-19. Thus, prompting higher stress levels of possible exposure to COVID-19 in the building, increase in mental and emotional stress levels, and the psychological well-being of our staff, families and the community. Our Staff Survey indicates that 65% of Mesa staff stress levels are *High to Extremely High* should we go to Hybrid Learning (see survey attachment). Pursuant to local control, our staff has collectively decided to continue **REMOTE ONLY** instruction for the remainder of the school year beginning Monday, February 22, until Friday, May 28, 2021. We are not willing to risk the lives of our colleagues, our students, and all of our families. We love our community therefore, this remains the only responsible course of action.

According to the New Mexico Department of Health COVID Dashboard, San Juan County currently has a 5.01% positivity rate. While this is better than the previous period of reporting where our positivity rate was 12.17%, we still have triple the number of cases for the standard of 8 people in 100,000 people testing positive. Further, San Juan County has the third highest number of COVID-19 cases and number of deaths. New Mexico reached 100,000 cases on December 2, 2020. In a little over two months' time, our state has recorded an additional 76,211. Our state's first four COVID cases were reported on March 11th, so it took almost nine months to reach our first 100K cases. Now we have recorded 75% of this case total in only two months. This is a concern!

The Navajo Nation Department of Health is reporting 43 new cases and 13 deaths on February 18, 2021. Compare this to the numbers reported two weeks ago of 110 new cases and 9 deaths on February 4, 2021, the number of people dying from COVID-19 in our area remains high and at a constant level. Any attempt to relax regulations would be premature and unethical. While the rise in cases last month is not as extreme as November, any rise shows that individuals are continuing to hold in-person and social gatherings. The Shiprock Service Unit has re-surpassed the Gallup Service Unit for the second highest number of positive COVID-19 cases on the Navajo Nation behind Chinle Service Unit. Community spread remains uncontrollable for Shiprock and Upper

Fruitland (February 16- Health Advisory Notice). Additionally, the Navajo Nation Reopening Status remains in "Red Code", which means high restrictions. The Navajo Nation is continuing Shelter-In-Place and Stay-At-Home Orders per amended Public Health Emergency Order No. 2021-003.

As NMPED is granting local control to school districts, we immediately request to keep our autonomy. CCSD has not implemented consistent policies across our district, instead has given Principals autonomy to decide what is best for their buildings, their staff, and their students. Mesa Elementary School will adhere to the resolution of the Navajo Nation Department of Dine Education (NNBEJA-691-2021) which requires schools on the Navajo Nation to remain remote for the remainder of the school year. We credit both our Diné and non-Diné staff for respecting tribal sovereignty, as well as our local government affiliations (see resolution attachments). Our District Administration has failed to acknowledge tribal sovereignty of the Navajo Nation.

In persevering through the Pandemic Learning Environment, Mesa Elementary has initiated, implemented and continues to modify/monitor for the needs of ALL students and their families under the core components of the Multi-layered System of Supports as follows:

- Consistent Bi-weekly Packet Days starting September 9<sup>th</sup>, 2020 with 100% Staff participation
- Parent Bi-weekly Packet Day participation percentages of 85% and above
- Increased opportunities for Parent Teacher Conferences
- Increased parent collaboration on weekly student academic progress
- Progress reporting on a weekly basis per "Mesa Parent Communication Logs" consistently submitted by Core Teachers
- Hosted (2) Parent Education Nights on December 14<sup>th</sup> (2 hours) and February 8<sup>th</sup> (2 hours) with two more sessions scheduled for March 22<sup>nd</sup> and May 17<sup>th</sup> ; Total of four parent sessions and an open house
- All teachers providing social emotional support for struggling families through weekly communication and providing community resources
- Quarterly Parent Surveys regarding Hybrid and Remote Preferences
- Quarterly Staff Surveys (See Attachment)
- High quality Instructional Packets and Material focused on ELA/Math/Science/ Social Studies and Specials (PE/ Technology/ Heritage/Music/ Art/ Counseling)

We oppose in-person learning. We support continuing Virtual Learning for the remainder of School Year 2020-2021, May 2021.

Recently, our Governor Ducey articulated that any State of Arizona Public School that does not return to "in person" teaching will not receive money from the State of Arizona. We as a Tribal Sovereign Nation can be exempt from this. We are Public School Educators for the Tuba City School District on the Navajo Reservation. We on the Navajo Reservation have been hit extremely hard by COVID. We are lacking in resources and constitute a high-risk population.

Our concerns are as follows. We recently have had a new, stronger strain of COVID on the Reservation. Our lack of sufficient health care has given us many problems, obstacles and barriers while dealing with the Virus. Many tribal members also lack everyday resources such as water, power and wood for heat. So far, simple things like social distancing and online learning have worked fairly well, to bring down the severity of outbreaks. For example, when Maricopa County opened up during the late Summer/early Fall it was disastrous. As a result, Phoenix became the worldwide hot spot.

Second, we feel our most important concern are for the elderly and family members with pre-existing health issues. A very large percentage of Navajo families reside with extended families, which include grandparents. Often, grandparents assist school age children while parents are working; many on the Reservation must travel long distances to work and can be away from home for weeks, due to the lack of employment opportunity locally. Hence, the elderly become caregivers for their grandchildren, which in turn leaves them vulnerable to COVID exposure. This is also a fear for Educators, Administrators and other school employees, since all have not yet been vaccinated. Dreadfully and unfortunately, we have suffered much heartache due to the loss of our own elderly relatives.

Third concern is the social behavior of kindergarten age students. At this young age, repercussions and consequences are not fully developed. They live in the moment. They can be impulsive, acting out before thinking logically. Can they comprehend the idea of 6 foot social distancing, and being required to wear a mask which can be removed easily? No. They will be required to wear a mask the entire school day, except during lunch time. Disposable masks may not fit well and ear loops can break easily. We are not prepared to provide numerous extra masks per day.

We believe it would be logical and even prudent to continue Distance Learning, at least for the remainder of SY 2020-2021. The idea of in-person learning can be revisited in the Fall. Johnathan Nez, Navajo Nation Tribal President, has been an advocate for continuing distance learning. So far, it has been as successful as possible, given the circumstances. In closing, we would like you to weigh the benefits vs. negatives. Nine more weeks of continuing a program that is working, both educationally, and health-wise, seems better than return to normal too soon. This could possibly set the health care system and our personal health back even further.

Many also believe it is too soon and it is not safe for our Navajo communities.

## RESOLUTION OF THE SHIPROCK CHAPTER Shiprock, Navajo Nation



SUPPORTING AND REAFFIRMING THE RELATED TO EDUCATION BY THE 24TH NAVAJO NATION COUNCIL AND THE NAVAJO NATION BOARD OF EDUCATION: APPROVING AND REQUIRING THAT ALL NAVAJO NATION SCHOOLS PROVIDE VIRTUAL OR ONLINE LEARNING OPTIONS ONLY, WITH NO FACE TO FACE INSTRUCTION FOR THE SECOND SEMESTER OF THE 2020-2021 SCHOOL YEAR.

### WHEREAS:

1. The **Shiprock** Chapter of the Navajo Nation acts on this resolution pursuant to the authority conferred on the Chapter through Navajo Nation Code Title 26, Chapter 1, B. Purpose which states "Through adoption of this Act, the Navajo Nation Council delegates to Chapters governmental authority with respect to local matters consistent with Navajo Law, including custom and tradition" and the inclusivity provided by the Dine' Fundamental laws", and
2. The **Shiprock** Chapter recognizes the Navajo Nation Board of Education (hereinafter the "Board") is the education agent in the Executive Branch for the purpose of overseeing the operation of all schools serving the Navajo Nation. 10 N.N.C. §106 (A). The Board carries out its duties and responsibilities through the Department of Diné Education (hereafter the "Department"). 10 N.N.C. §106 (G)(3).
3. The **Shiprock** Chapter recognizes the Department is the administrative agency within the Navajo Nation with responsibility and authority for implementing and enforcing the educational laws of the Navajo Nation. 2 N.N.C. §1801(B); 10 N.N.C. §107(A). The Department is under the immediate direction of the Navajo Nation Superintendent of Schools, subject to the overall direction of the Board. 10 N.N.C. §107(B).
4. The **Shiprock** Chapter understands that the Navajo Nation has substantial authority and broad jurisdiction to regulate all matters within its territorial boundaries pursuant to its inherent sovereignty and the Treaty of 1868. This authority and Law 100-297 grant, Public Law 93-638 contract, Bureau of Indian Education-operated schools, higher education institutions, and all FACE programs, early childhood education programs, and Navajo Head Start programs located on the Navajo Nation.
5. The **Shiprock** Chapter membership understand that the Coronavirus disease ("COVID-19") is a global infecting substantial number of people, which has spread exponentially and increased globally, as indicated by the Centers for Disease Control ("CDC"), the World Health Organization ("WHO"), and other public health organizations located within the United States and regionally.
6. The **Shiprock** Chapter recognizes that the Board maintains that the COVID-19 pandemic highlights the importance of our multiple school systems (Bureau of Indian Education-funded, public, chapter, private) and the need for a consistent, coherent, actionable and fully resources plan to support every school district reopening during the 2020-2021 academic year.
7. The **Shiprock** Chapter understand that the schools should be guided by the latest health information from the Navajo Department of Health, Navajo Health Command Operations Center, and the Center for Disease Control and supplemented to the extend the Best Practice Guidance document and the Re-opening Status Schedule go beyond what those plans provide.
8. The **Shiprock** Chapter recognizes that the Navajo Nation's school re-opening guidelines were developed in consultation with stakeholders from BIE-funded schools, school leaders, BIE officials, parents, and other stakeholders. The guidelines affirm the work and efforts to support local school superintendents, school leaders, and administrators, parents, students, and other stakeholders to ensure a smooth transition to reopen schools, for the 2020-21 school year in a manner informed by health data, applicable and actionable CDC, Navajo Nation, state and local health agency guidance, while prioritizing the health and safety of students and staff.

### NOW, THEREFORE, BE IT RESOLVED THAT:






