TITLE OF RESOLUTION: PROPOSED NAVAJO NATION COUNCIL RESOLUTION; AN ACTION RELATING TO RESOURCES AND DEVELOPMENT COMMITTEE, BUDGET AND FINANCE COMMITTEE, NAABIK'ÍYÁTI' COMMITTEE AND THE NAVAJO NATION COUNCIL; APPROVING SUPPLEMENTAL FUNDING FROM THE UNRESERVED, UNDESIGNATED FUND BALANCE IN THE AMOUNT OF \$947,613 TO COMPLETE THE CONVENIENCE STORE, FUEL STATION, AND LAUNDROMAT AT SHONTO CHAPTER; WAIVING 12 N.N.C. §§ 820(I) AND 860(C) RELATING TO THE CAPITAL IMPROVEMENT PROCESS

**PURPOSE:** This resolution, if approved, will approve supplemental funding from the unreserved, undesignated fund balance (UUFB) in the amount of \$947,613.00 to complete the convenience store, fuel station, and laundromat at Shonto Chapter, waiving 12 N.N.C. § 820(I) and § 860(C) relating to the Capital Improvement Process. The Shonto Chapter request for a convenience store, fuel station, and laundromat at Shonto Chapter is not included in the Title 12 Capital Improvement Plan as approved by Navajo Nation Council Resolution CAP-18-14.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

20	SECTION ONE. AUTHORITIES	
21	A. Pursuant to 12 N.N.C. § 820 (L), "[t]he Navajo Nation Council may adopt and	·
22	approve supplemental appropriations to the Annual Comprehensive Budget during	
23	the fiscal year. Supplemental appropriations of General Funds within the current	
24	fiscal year are permitted, if and when additional sources of revenues above and	
25	beyond the initial or current revenue projections are projected and which are also in	
26	excess of the reserve amount set forth at § 820(J)."	
27	B. Pursuant to 2 N.N.C. § 300 (C)(1)(3) and (4) the Budget and Finance Committee is	
28	authorized to recommend adoption of resolutions related to the expenditure of the	
29	Nation's financial resources.	

- C. Pursuant to 2 N.N.C. § 501 (C)(1), the Resources and Development Committee is the oversight committee for the Navajo Nation Chapters.
- D. Pursuant to 2 N.N.C. § 164 (A)(9), a proposed resolution that requires final action by the Navajo Nation Council shall be assigned to the Naabik'íyáti' Committee before it is heard by the Navajo Nation Council.

# SECTION TWO. TITLE 12 FINANCE ACT SUPPLEMENTAL APPROPRIATION PROCESS AND THE TITLE 12 CAPITAL IMPROVEMENT PROCESS

- A. The Title 12 Finance Act Supplemental Appropriation requirements include:
  - 1. Pursuant to 12 N.N.C. § 820(L), when the Controller identifies additional sources of revenues above and beyond the initial or current revenue projections, supplemental appropriations may be allocated by the Navajo Nation Council.
  - 2. Pursuant to 12 N.N.C. § 820 (L), "Supplemental appropriations made from non-recurring revenues shall only be made for non-recurring operations or purposes, as set forth at § 820 (F). The Controller of the Navajo Nation shall be responsible for designating recurring and non-recurring revenues and purposes."
  - 3. Pursuant to 12 N.N.C. § 820(M), all requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget ("OMB") for budget impact analysis.
- B. The Title 12 Capital Improvement Process includes:
  - 1. Pursuant to 12 N.N.C. § 810(F), "Capital Improvement" means a major project undertaken by the Navajo Nation that is generally not recurring on an annual basis and which fits within one or more of the following categories:
    - (1) All projects requiring debt obligation or borrowing;
    - (2) Any acquisition or lease of land;
    - (3) Purchase of major equipment or vehicles, with a life expectancy of five years or more, valued in excess of an amount to be established by the Controller;

- (4) Major building improvements that are not routine maintenance expenses and that substantially enhance the value or extend the useful life of a structure;
- (5) Construction of new buildings or facilities including engineering, design, and other pre-construction costs with an estimated cost in excess of an amount to be determined by the Controller; and/or
- (6) Major equipment or furnishing required to furnish new buildings or other projects, the cost of which is above a certain amount to be established by the Controller.
- 2. Pursuant to 12 N.N.C. § 820 (I), the "[d]evelopment of the Capital Budget shall be coordinated with development of the Operating Budget. All budget requests for capital improvements shall be in compliance with an adopted Capital Improvement Plan and shall not be approved unless in compliance with the Plan."
- 3. Pursuant to 12 N.N.C. § 820 (M), the Office of Management and Budget shall coordinate the overall preparation, adoption and implementation of both the annual operating and capital budgets of the Navajo Nation. All requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget for budget impact analysis and other appropriate action.
- 4. Pursuant to 2 N.N.C. § 501 (B)(4)(c), the Resources and Development Committee is to review and recommend to the Navajo Nation Council through the appropriate process supplemental appropriations to the capital improvement projects annual budget to fund necessary additional capital improvement projects.
- 5. Pursuant to 12 N.N.C. § 860 (C)(2) "[t]he appropriation portion of the Capital Improvement Plan is subject to approval of the Navajo Nation Council upon recommendation of the Budget and Finance Committee. Any modification or amendment affecting the approved Capital Improvement Plan is subject to

review and concurrence by the Resources and Development Committee prior to consideration by the Navajo Nation Council."

### **SECTION THREE. FINDINGS**

- A. Shonto Chapter is requesting \$947,613.00 from the Unreserved, Undesignated Fund Balance (UUFB) to complete the convenience store, fuel station, and laundromat at Shonto Chapter. The Shonto Chapter withdrew 10 acres at the southeast corner of US 160 and SR 98 for economic development activities which include the development of the convenience store, fuel station, and laundromat. Chapter has relied on its own limited liability company to secure grant money from the BIDF and the Navajo Nation Department of Transportation and has obtained a loan from a Community Development Financial Institution. The economic development project is under construction; however due to delays in regulatory approvals by state and tribal entities and several required redesigns, the winter weather conditions and increasing costs, Shonto Chapter is seeking the supplemental appropriation of \$947,613. The Shonto Community Governance memorandum dated March 28, 2016 describes the economic development project and is attached as Exhibit C. The budget documents regarding this request are attached as Exhibit D.
- B. The Shonto Chapter request for a convenience store, fuel station, and laundromat at Shonto Chapter is not included in the Title 12 Capital Improvement Plan as approved by Navajo Nation Council Resolution CAP-18-14.
- C. Pursuant to 12 N.N.C. § 820(L), the attached memorandum, Exhibit A, dated April, 2016 from the Office of the Controller has identified the additional revenues above and beyond the initial or current revenue projections.
- D. Pursuant to 12 N.N.C. § 820(M), the attached memorandum, Exhibit B, dated April, 2016 contains the Office of Management and Budget budget impact analysis.
- E. Pursuant to 12 N.N.C. § 820 (L), the attached memorandum, Exhibit A, dated April, 2016 from the Office of the Controller has determined whether this request

for supplemental appropriation is from recurring or non-recurring revenues and whether it is for recurring or non-recurring purposes.

- F. The Navajo Nation finds it in the best interest to waive 12 N.N.C. §§ 820(I) and 860 (C) regarding Shonto Chapter's request for funds to complete the convenience store, fuel station, and laundromat at Shonto Chapter.
- G. The Navajo Nation finds it in the best interest to approve Supplemental Appropriation of \$947,613.00 to complete the convenience store, fuel station, and laundromat at Shonto Chapter.

SECTION FOUR. WAIVING 12 N.N.C. §§ 820(I) AND 860 (C) REGARDING THE CAPITAL IMPROVEMENT PROCESS AND THE COMPLETION OF THE CONVENIENCE STORE, FUEL STATION, AND LAUNDROMAT AT SHONTO CHAPTER

The Navajo Nation Council hereby waives 12 N.N.C. §§ 820(I) and 860(C) with regard to the Capital Improvement process and the completion of the convenience store, fuel station, and laundromat at Shonto Chapter.

SECTION FIVE. APPROVING SUPPLEMENTAL FUNDING FROM THE UNRESERVED, UNDESIGNATED FUND BALANCE IN THE AMOUNT OF \$947,613.00 TO COMPLETE THE CONVENIENCE STORE, FUEL STATION, AND LAUNDROMAT AT SHONTO CHAPTER

A. The Navajo Nation Council, having received certification by the Office of the Controller of the availability of certain funds from the Unreserved, Undesignated Fund Balance (UUFB) for supplemental appropriation hereby approves the supplemental appropriation of \$947,613.00 to complete the convenience store, fuel station, and laundromat at Shonto Chapter, as further described in budget documents attached as **Exhibit D**.

B. This supplemental appropriation of \$947,613.00 shall be from that amount of funds that exceeds the minimum fund balance of the UUFB.

### Introduction:

The Shonto Chapter, a governance certified chapter of the Navajo Nation, has been focused for the last decade at developing an economy for Shonto and the neighboring communities. The Chapter dedicated and withdrew 10 acres at the southeast corner of US 160 and SR 98 for economic development activities. The first phase was the construction of a C-store/fuel station on the site. The first phase was expanded to include a laundromat and possible post office boxes. (The C-store/fuel station/Laundromat is identified herein as the "Project".) Key challenges have included (i) sufficient funding and (ii) identification of a developer/operator for the Project. There were a number of starts and eventually, Shonto relied on its own limited liability company to secure grant money from BIDF and Navajo Nation Department of Transportation and to obtain a loan from a Community Development Financial Institution.

The Project is under construction and current schedule is that some of the facilities may be able to open as early as late Spring, 2016. However, due to substantial delays in regulatory approvals by state and tribal entities and several required redesigns, the winter weather conditions and increasing costs of certain items, Shonto is seeking an additional \$950,000 of funding to complete the Project. See Budget attached.

### The Project:

Shonto Commercial has a Business Site Lease for 4.32 acres. The 4.32 acres is part of a 10 acre site that was withdrawn by the Shonto Chapter for economic development. Shonto Commercial is constructing a building that can house, a Convenience Store/Fuel Station, Laundromat, post office boxes, and a deli. At build out the 10-acre site will also include a hotel and artisan travel center and fast food restaurant.

Shonto Commercial obtained a grant from the Business and Industrial Development Fund ("BIDF") which was supplemented with a loan from a Community Development Financial Institution ("CDFI"). An architect was retained, construction documents were completed, and, in May 2015, Shonto Commercial bid the project through the required procedures of the Business Opportunity Act.

The SEDC Board of Directors as sole member of Shonto Commercial executed construction contracts with Woodruff Construction (General Contractor) and Cochise (Fuel System provider) in August 2015. Construction has commenced on the site. Delays ensued for months at a time as the architect/engineer team attempted to deal with the myriad of changes and delays and further changes and delays from NTUA. The cost of construction continued to escalate and still the ancillary approvals of ADOT and SRP have not been received. NTUA approved the offsite infrastructure last week.

Shonto Commercial has funding to finish the building structure. With the current funding there are insufficient funds to connect the convenience store/fuel station/Laundromat to the wastewater system across US Highway 160 and the SRP rail line at the NHA Housing Development. Without the connection to the sewer system, there cannot be Laundromat operations. No additional economic development activities can be planned on the 10-acre site without the connection to the sewer system. In addition there are not sufficient funds to locate postal boxes on site, provide the appropriate security and signage and purchase all of the FF&E.

### Request for Funding:

The Shonto Chapter in support of the SEDC Board is requesting your assistance in obtaining Navajo Nation financial support for the following:

Offsite Utility Infrastructure: In order to fully develop the 10 acre site, the Project needs to drill under Highway 160 and the SRP rail line and connect to the wastewater system at the NHA Housing development. The design has been reworked several times to deal with objections raised by NTUA. To finalize the design we are seeking the sum of \$38,440 and to construct the offsite infrastructure we are seeking \$264,216. SEDC was able to obtain a Right of Entry from NHA but ADOT and SRP have still not provided the Rights of Way for the Project. We anticipate that some design changes may be required.

<u>Laundromat Build-out</u>: The connection to the regional wastewater system will allow the Project to open the Laundromat. The cost to complete the Laundromat design is \$40,030 and the buildout is \$218,500. To operate the Laundromat will require the purchase of furniture, fixtures and equipment at a cost of \$240,298.

<u>Furniture</u>, <u>Fixtures</u> and <u>Equipment for the C-Store</u>: The FF&E for the C-Store includes Building signage (\$24,798); Building security (\$22,478); Shelving, beverage dispensers, display cases, shelving, tables and chairs (\$42,478); and Deli fixtures tables, sinks, cooler, slicers, oven, and storage racks (\$43897.

<u>USPS Post Boxes</u>: Mail boxes to replace the boxes at the old Trading Post (\$12,478).

Timing is critical. Shonto has been requesting additional funding for more than the last 6 months. It has been told that the Project was on the capital funding list, that various departments had funding, that funding was available from the settlement fund. Representatives of the Chapter and its wholly owned company spent time and resources tracking down the funding only to find over and over that there wasn't any funding.

### Benefits to the Navajo People:

The C-store/Fuel Station will have substantial benefits to Navajo people. As designed the C-store will be able to support product that would otherwise not be available without driving long distances to Tuba City or Kayenta. There are no modern laundromats in the vicinity of Shonto and this facility will serve the needs of the housing project as well as the broader residents of Shonto and the neighboring communities. The addition of the laundromat will generate sufficient funds to repay the loan that the company obtained to construct the Project. Taxes will be generated from the sale of fuel and C-store products. Jobs will be generated. Shonto will be in the vanguard of Chapters that are self-promoters. We are asking the Nation to help the Chapter see this Project to fruition, a Project that might have come in close to budget but for the regulatory red-tape and the cost of construction on the Navajo Nation.

You submitted a request for legislation regarding a supplemental appropriation request for \$947,613 for purposes of completing the convenience store, fuel station, and laundromat at Shonto Chapter. I have drafted the legislation; however, before the legislation is completely ready to be introduced into the legislative process, reviews by the Office of the Controller (OOC) and the Office of Management and Budget (OMB) are necessary; the OOC and OMB memorandums will become Exhibits A and B.

A request for supplemental appropriation requires a review of the budget documents by the OOC and the OMB. I prepared a review cover form for the OOC and OMB reviews. The review cover form (with the budget and Shonto resolution) were delivered to the OCC yesterday by a staff member from the Delegates' Office (I usually ask the Sponsor's LDA to submit these type of documents to the OOC and OMB; however, I learned that you do not currently have an LDA that is why I asked a Delegates Office staffer to take the documents to the OOC.). I have attached a copy of the review cover form which was submitted to OOC to this memorandum. As you will see, I put your phone number on the review cover form. This is so that when OOC has completed its review of the request for supplemental appropriation, OOC will call your phone number and tell you the review is completed. You then pick up the review documents and take them to OMB for that office's review. When OMB finishes its review, OMB will call you and tell you to come and pick up the documents.

The memorandums which will be completed by OOC and OMB, after they have reviewed the documents submitted to their offices, will be attached to your supplemental appropriation legislation as Exhibit A and Exhibit B. Your legislation will then be ready to be submitted to the Office of Legislative Services; your legislation will then have all its required Exhibits.

- 1. The balance of the UUFB was \$13,175,943 before the Navajo Nation Council Special Session held March 23, 2016. There were four (4) supplemental requests which passed during this Special Session. These are pending Navajo Nation President signature. If the President does sign these legislation the balance of the UUFB would be \$9,604,215.
- 2. These supplemental request is for the amount of \$947,613 which would include costs for Laundromat Design and buildout drawings, Laundromat Build-out, Laundromat Fixtures, Furniture and Equipment, Building Signage, Building security, C-Store Fixtures, Furniutre and Equipment, Deli Fixtures, Furniture and Equipment, USPS Postal Boxes, Off-site sewer design and drawings, and Off-Site Sewer Installation.
- 3. At the Budget and Finance meeting held April 5, 2016 there was an amount included in the Permanent Fund legislation for a Shonto C-Store. This was part of the report "Recommendations Re:FY 2016 Budget from the Office of the President/Vice President" this would be funded in the 1st year of the PTF-5 Year Plan.

The Office of Management and Budget has reviewed the above referenced document. Upon review of the proposed supplemental funding proposal, OMB notes the following:

- 1. The Navajo Nation Capital Improvement Plan 2013-2018 (CAP-18-14) does not include this as an approved project for a convenience store, fuel station, and laundromat at Shonto Chapter. The Appropriations Act, Section 820 (I), the Capital Budget states: "All budget requests for capital improvements shall be in compliance with an adopted Capital Improvement Plan and shall <u>not</u> be approved unless in compliance with the Plan." It is recommended that duly approved Capital Plan projects be funded before other capital projects are considered. Otherwise, why approve a plan if it is not used?
- 2. The BIDF (Business Industrial Development Fund) is mentioned as a possible fund source. Has this been explored further? Division of Economic Development should advise.
- 3. The Program Budget Summary and the Program Performance Criteria forms are lacking the appropriate signatures.
- 4. OMB has seen that a Shonto Convenience Store project in the amount of \$1,000,000 is proposed as an amendment for possible funding from the Permanent Trust Fund income. This legislation is sponsored by Delegate Seth Damon.
