SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council. *See* 2 N.N.C. §500 (A).
- B. The President of the Navajo Nation appoints and the Resources and Development Committee confirms the directors to the Navajo Agricultural Products Industry. *See* 2 N.N.C. §501(B)(9); *See also* 5 N.N.C. §1601(A).

SECTION TWO. FINDINGS

- A. In the event of a vacancy on the Board of Directors, pursuant to Navajo Nation Council Resolution CJA-05-10: "... the President of the Navajo Nation shall appoint a qualified candidate on or before thirty (30) working days. The Economic Development Committee of the Navajo Nation Council shall fill vacancies where the President has not made an appointment within thirty (30) working days by appointing and confirming a candidate that meets the qualifications stated above."

- 1 B. The Resources and Development Committee is the successor committee to the
2 Economic Development Committee of the Navajo Nation Council. CO-45-12.
- 3 C. The President of the Navajo Nation has submitted an appointee for confirmation to the
4 Resources and Development Committee within the thirty day requirement. *See* Exhibit
5 A (Appointment Letter to Honorable Otto Tso).
- 6 D. The President has appointed Mr. Elphonozo Nephew to serve on the Board of Directors
7 for the Navajo Agricultural Products Industry for a term of three years starting on June
8 3, 2014 and to expire on June 3, 2017. *See* Exhibit B (Letter from President to Mr.
9 Elphonozo Nephew).
- 10 E. Mr. Elphonozo Nephew has submitted his letter of interest as well as his resume. *See*
