- To fulfill the United States Government's trust responsibility to serve the higher education needs of the Navajo people and to clarify, unify, and modernize prior Diné College legislation.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Diné College Act of5 2021".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds as follows:

1	(1) The Treaty of 1868 between the United	
2	States of America and the Navajo Tribe of Indians	
3	provides for the education of the citizens of the Nav-	
4	ajo Nation.	
5	(2) The Navajo Nation created and chartered	
6	the Navajo Community College by Resolution CN-	
7	95–68 as a wholly owned educational entity of the	
8	Navajo Nation.	
9	(3) In 1971, Congress enacted the Navajo Com-	
10	munity College Act (Public Law 92–189; 25 U.S.C.	
11	640a et seq.).	
12	(4) The Navajo Nation officially changed the	
13	name of the Navajo Community College to Diné Col-	
14	lege by Resolution CAP-35-97.	
15	(5) The purpose of Diné College is to provide	
16	educational opportunities to the Navajo people and	
17	others in areas important to the economic and social	
18	development of the Navajo Nation.	
19	(6) The educational philosophy of Diné College	
20	is to apply principles of Sa'ah Naagháí Bik'eh	
21	Hózhóón (Diné Philosophy) to advance quality stu-	
22	dent learning through training of the mind and	
23	heart.	

(7) The United States has a trust and treaty
 responsibility to the Navajo Nation to provide for
 the educational opportunities for Navajo people.

4 (8) Significant portions of the Diné College's
5 infrastructure are dilapidated and pose a serious
6 health and safety risk to students, employees, and
7 the public.

8 (9) This Act is consistent with Executive Order 9 13592 (76 Fed. Reg. 76603, relating to improving 10 American Indian and Alaska Native educational op-11 portunities and strengthening tribal colleges and 12 universities) and fulfills the United States Govern-13 ment's trust responsibility to serve the educational 14 needs of the Navajo people.

15 SEC. 3. PURPOSE.

16 The purpose of this Act is to ensure that the Navajo17 Nation and Navajo people—

18 (1) exercise their right to self-determination,
19 particularly in matters relating to their internal and
20 local affairs;

(2) maintain and strengthen their distinct institutions of higher education through the teaching of
the Navajo language, culture, traditions, and history; and

1	(3) improve their economic and social condi-	
2	tions through higher education and postsecondary	
3	vocational training.	
4	SEC. 4. DEFINITIONS.	
5	In this Act:	
6	(1) Appropriate committees of con-	
7	GRESS.—The term "appropriate committees of Con-	
8	gress" means—	
9	(A) the Committee on Indian Affairs and	
10	the Committee on Appropriations of the Senate;	
11	and	
12	(B) the Committee on Natural Resources,	
13	the Committee on Education and the Work-	
14	force, and the Committee on Appropriations of	
15	the House of Representatives.	
16	(2) COLLEGE.—The term "College" means	
17	Diné College.	
18	(3) Operation and maintenance.—The term	
19	"operation and maintenance" means all costs and	
20	expenses associated with the customary daily oper-	
21	ation of the Diné College and necessary maintenance	
22	costs.	
23	(4) INFRASTRUCTURE.—The term "infrastruc-	
24	ture" means Diné College buildings, water and	
25	sewer facilities, roads, foundation, information tech-	

nology, and telecommunications, including class rooms and external matters such as walkways.

3 (5) RENOVATIONS AND REPAIRS.—The term
4 "renovations and repairs" means modernization and
5 improvements to the infrastructure.

6 (6) SECRETARY.—The term "Secretary" means
7 the Secretary of the Interior.

8 SEC. 5. AUTHORIZATION OF DINÉ COLLEGE.

9 Congress authorizes the Diné College to receive all 10 Federal funding and resources under this Act and other 11 laws for its operation, improvement, and growth, includ-12 ing—

13 (1) to provide programs of higher education for14 citizens of the Navajo Nation and others;

(2) to provide vocational and technical education for citizens of the Navajo Nation and others;
(3) to preserve and protect the Navajo language, philosophy, and culture for citizens of the
Navajo Nation and others;

20 (4) to provide Navajo communities and people
21 with employment and training opportunities;

(5) to provide economic development and community outreach for Navajo communities and people;
and

(6) to provide a safe learning, working, and liv ing environment for students, employees, and the
 public.

4 SEC. 6. FACILITIES AND CAPITAL PROJECTS.

From amounts made available under section 8(c), the
Diné College may undertake any renovations and repairs
to the infrastructure of the College that are identified in
the survey, study, and report carried out under section 9.

9 SEC. 7. STATUS OF FUNDS.

10 Funds provided under this Act to the Diné College 11 may be treated as non-Federal, private funds of the Col-12 lege for purposes of any provision of Federal law which 13 requires that non-Federal or private funds of the College 14 be used in a project for a specific purpose.

15 SEC. 8. AUTHORIZATION OF APPROPRIATIONS.

16 (a) IN GENERAL.—There are hereby authorized to be
17 appropriated to the Diné College, for each fiscal year, such
18 sums as may be necessary to pay for the operation and
19 maintenance of the College.

(b) BUDGET PLACEMENT.—The Secretary shall fund
the operation and maintenance of the Diné College separately from tribal colleges and universities recognized and
funded by the Tribally Controlled College or University
Assistance Act of 1978 (25 U.S.C. 1801 et seq.).

(c) FACILITIES AND CAPITAL PROJECTS.—In addi tion to amounts appropriated under subsection (a), there
 are authorized to be appropriated \$7,500,000, for each fis cal year, to carry out section 6.

5 SEC. 9. SURVEY, STUDY, AND REPORT.

(a) IN GENERAL.—The Secretary shall conduct a de-6 tailed survey and study of all capital projects and facility 7 needs of the Diné College, and shall report the results of 8 such survey and study to the appropriate committees of 9 Congress not later than October 31, 2022. Such report 10 shall include recommendations by the Secretary and any 11 recommendations or views submitted by the College and 12 the Navajo Nation regarding the capital projects and facil-13 14 ity needs of the College.

(b) INVENTORY.—Not later than January 31, 2022,
an inventory prepared by Diné College identifying repairs,
alterations, and renovations to facilities required to meet
health and safety standards and other factors shall be submitted to the Secretary. The Secretary shall use the inventory as baseline data to inform the survey, study, and report required under subsection (a).

(c) ADMINISTRATIVE EXPENSES.—Funds to carry
out this section may be drawn from general administrative
appropriations to the Secretary.

RESOLUTION OF THE BOARD OF REGENTS DINÉ COLLEGE

The Diné College Board of Regents respectfully request the support of the Navajo Nation Council in the reauthorization of the Diné College Act of 2021 as sponsored by Arizona Representative Tom O'Halleran.

WHEREAS:

- The Diné College Board of Regents is empowered to exercise authority and control over Diné College and is responsible for the accomplishment of the Diné College purposes, 10 NNC § 2003 (2005 ed.); and
- 2. The Diné College is a non-profit post-secondary educational institution chartered by the Navajo Nation Council in 1968 for the purposes of providing educational opportunities to the Navajo people and others in areas important to the economic and social development of the Navajo Nation and other purposes, 10 NNC § 2002; and
- 3. Diné College (the College), formerly known as Navajo Community College (NCC), became the first tribally controlled college in the Nation. Established in 1968, the founding principle of the College was to instill education with Navajo history, culture and language.
- 4. In 1971, Congress enacted the Navajo Community College Act (Public Law 92-189; hereinafter "NCC Act"). The NCC Act authorized funding for "operation, maintenance and construction."
- 5. In 1978, Congress enacted the Navajo Community College Assistance Act (P.L. Pub. L. 95-471; hereinafter "NCC Construction Funding Act") to correct this funding gap. The NCC Construction Funding Act authorizes \$2 million annually for construction funding for the college and to date, no funding was never allocated.
- 6. In 2018, the Inventory and Assessment Final Data Submittal (IAFD), contract no. A17PC00065 for the 1978 Congressional Mandated Facility Study for Diné College was completed.
- 7. Funding, as authorized in the Navajo Community College Assistance Act and the current Diné College Act, has never materialized and as such, the college has had to divert academic and student funding to maintain and operate its college facilities.

8. The purpose of the college is to provide educational opportunities to the Navajo people for the economic and social development of the Navajo Nation. To house and progress innovation, build and sustain economic opportunities, and cultivate and advance an valuable future workforce.

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Diné College Board of Regents hereby supports the reauthorization of the Diné College Act of 2021 as sponsored by Arizona Representative Tom O'Halleran.
- 2. The Diné College Board of Regents seeks the support of the Navajo Nation Council in the reauthorization of the Diné College Act as sponsored by Arizona Representative Tom O'Halleran.
- 3. The Diné College Board of Regents authorizes, directs, and empowers the Diné College President to perform all actions deemed necessary and proper to effectuate the purposes of this resolution.
