TITLE OF RESOLUTION: AN ACTION RELATING TO RESOURCES AND DEVELOPMENT AND NAABIK'ÍYÁTI' COMMITTEES; AUTHORIZING THE NAVAJO HOUSING AUTHORITY AS THE TRIBALLY DESIGNATED HOUSING ENTITY TO SUBMIT A RENEWAL GRANT APPLICATION TO HUD UNDER THE TRIBAL HUD-VASH DEMONSTRATION PROGRAM

PURPOSE: The purpose of the resolution is to authorize the Navajo Housing Authority as the Tribally Designated Housing Entity to submit a renewal grant application to Housing and Urban Development (HUD) under the Tribal HUD-VASH Demonstration Program.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).
- B. The Navajo Nation Council shall establish standing committees of the Council and delegate such authority to such committees as it deems necessary and proper for such committees to execute the purposes or powers delegated. 2 N.N.C. §102(G).
- C. The Resources and Development Committee exercises oversight authority over housing to establish policies and legislation appropriate to the housing needs of the Navajo Nation and its People. 2 N.N.C. § 500(C)(3).
- D. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'íyáti' Committee to coordinate all federal programs, i.e. U.S. Department of Housing and Urban Development (HUD), with the Navajo Nation government to provide efficient

- services to Navajo members. 2 N.N.C. §§ 700 (A), 701 (A)(4), 701 (A)(6), 701 (A)(4).
- E. On June 11, 2018, HUD issued a notice (Notice PIH-2018-10) regarding Procedural Guidance for Tribal HUD-VA Supportive Housing Renewal Grant Applications for existing recipients of the program which is a supportive housing and rental demonstration program called the Tribal HUD-VA Supportive Housing program (Tribal HUD-VASH). The program provides rental assistance and supportive services to Native American veterans who are homeless or at risk of homelessness living on or near a reservation or other Indian areas. Notice PIH-2018-10 is attached as **Exhibit B**.
- F. The NHA Board of Commissioners recommended to the Navajo Nation to authorize the NHA to submit a renewal grant application under the Tribal HUD-VASH program. Attached hereto as **Exhibit A** is a copy of NHA resolution number NHA 4833-2018 Recommending to the Navajo Nation to Approve and Authorize the Navajo Housing Authority to Submit a Renewal Grant Application to HUD for the Tribal HUD-VASH Program.

Therefore, Be It Resolved:

- A. The Navajo Nation hereby authorizes the Navajo Housing Authority as the Tribally Designated Housing Entity to submit a renewal grant application, to HUD under the Tribal HUD-VASH Demonstration Program.
- B. The Navajo Nation hereby authorizes the Navajo Housing Authority to take all necessary action to effectuate this resolution.

WHEREAS:

- 1. Public Law 104-330, the Native American Housing Assistance and Self Determination Act of 1996 ("NAHASDA"), was enacted to provide housing assistance that recognizes the rights of Indian Self-determination and Self-governance through a program known as Indian Housing Block Grant ("IHBG") program; and
- 2. The Navajo Housing Authority ("NHA") (a) was created and established as a public body of the Navajo Nation under the laws of the Navajo Nation at 6 N.N.C. § 601 and its Plan of Operation is codified thereunder; (b) pursuant to 24 CFR 1000.206 of the NAHASDA regulations, is the Tribally Designated Housing Entity ("TDHE") for the Navajo Nation and is an eligible recipient of IHBG pursuant to Navajo Nation Council ("NNC") Resolution CD-82-03; and (c) is otherwise regulated by HUD NAHASDA program requirements set forth in the Code of Federal Regulations, Title 24 Housing and Urban Development, Part 1000; and
- 3. Pursuant to 6 N.N.C., Sections 605 and 616(b)(3), the Board of Commissioners of the NHA is empowered with the authority to manage the affairs of the NHA with the power to do all things necessary or desirable to secure the financial aid or cooperation of the federal government in the undertaking of providing safe, decent and sanitary housing; and
- 4. On October 21, 2015, the U.S. Department of Housing and Urban Development ("HUD") issued a notice (Notice) in the Federal Register for the administration of a supportive housing and rental demonstration program called the Tribal HUD-VA Supportive Housing program ("Tribal HUD-VASH"). The program provides rental assistance and supportive services to Native American veterans who are Homeless or At Risk of Homelessness living on or near a reservation or other Indian areas; and
- 5. HUD made available \$4 million in grant funding to Indian tribes and tribally designated housing entities ("TDHEs") to fund this rental assistance and associated administrative fees; and
- 6. The HUD-VASH program combines Housing Choice Voucher program ("HCV") rental assistance for Homeless veterans with Case Management and clinical services provided by or through the VA through Veterans Administration Medical Centers ("VAMC"). Historically, this program has not reached Native American veterans in tribal communities due to legal impediments preventing tribes and TDHEs from participating in the HUD-VASH program; and

- 7. In the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235, approved December 16, 2014) ("2015 Appropriations Act"), Congress authorized funding for a demonstration program in order to expand the HUD-VASH program into Indian Country. The 2015 Appropriations Act directed HUD to coordinate with Indian tribes, TDHEs, and other appropriate tribal organizations on the design of this program, and to ensure the effective delivery of housing assistance and supportive services to Native American veterans who are Homeless or At Risk of Homelessness; and
- 8. Housing assistance under this program was made available by grants to tribes and TDHEs that are eligible to receive IHBG funding under NAHASDA. Tribes were able to request Tenant-Based and/or Project-Based Rental Assistance by the number of bedrooms in a rental unit. Grants were awarded based on the number of rental units (Tenant-Based and Project-Based Rental Assistance) approved by HUD; and
- 9. 26 Tribes/TDHEs were invited to participate in a pilot program and to apply for Tribal HUD-VASH demonstration program shortly after publication of the Notice. By letter dated October 29, 2015, HUD invited the NHA to participate in the demonstration program. To receive a grant, tribes/TDHES were required to submit a Tribal HUD-VASH application by December 2, 2015; and
- 10. As a part of the initial application process, HUD required a Tribal Resolution if an application is submitted by a TDHE on behalf of an Indian tribe. The Navajo Nation submitted the required tribal resolution authorizing the TDHE to submit the application under the Tribal HUD-VASH program. The NHA was awarded \$268,835 under the initial demonstration program; and
- 11. Since the start of the demonstration program, the NHA has housed 19 Navajo veterans using 19 of the 20 vouchers that were issued to the NHA. One more veteran has been issued a voucher and is in the process of locating housing. The NHA will have used all the 20 vouchers that it was issued.
- 12. Pursuant to the Consolidated Appropriations Act, 2017, P.L. 115-31 ("2017 Appropriations Act"), Congress appropriated \$5 million and authorized HUD to renew rental assistance and associated administrative fee to all eligible Tribal HUD-VASH grants initially funded with appropriated funds from Fiscal Year 2015 provided they meet applicable program requirements.
- 13. On June 11, 2018, HUD issued PIH Notice 2018-10 announcing renewal requirements and procedural guidance for existing recipients of the Tribal HUD-VASH program. The deadline for submitting a renewal application is August 15, 2018; and
- 14. One of the requirements for the renewal application is a new tribal authorization resolution; and

- 15. Based on the foregoing, the NHA Board of Commissioners recommends to the Navajo Nation to authorize NHA to submit a renewal application under the recently announced renewal of the Tribal HUD-VASH program; and
- 16. The NHA Board of Commissioners believes it is in the best interest of NHA and the Navajo Nation to approve this resolution.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Board of Commissioners of the Navajo Housing Authority hereby recommends to the Navajo Nation to approve a tribal resolution authorizing the Navajo Housing Authority as the Tribally Designated Housing Entity to submit a renewal application to HUD under the announced renewal of the Tribal HUD-VASH program.
- 2. The Board of Commissioners of the Navajo Housing Authority hereby recommends to the Navajo Nation to approve and authorize the renewal resolution for HUD-VASH so that it remains in effect indefinitely until amended by the Navajo Nation.
- 3. The Board of Commissioners of the Navajo Housing Authority hereby authorizes and directs the Interim Chief Executive Officer to take all other necessary action to effectuate this resolution.

SUBJECT: Procedural Guidance for Tribal HUD-VA Supportive Housing Renewal Grant Applications

I. PURPOSE

This Tribal HUD-VA Supportive Housing (Tribal HUD-VASH) notice announces renewal requirements and procedural guidance for existing recipients of the program. Pursuant to the authority provided by the Consolidated Appropriations Act, 2017, P.L. 115-31 (*2017 Appropriations Act"), the Department will renew rental assistance and associated administrative fees to all eligible Tribal HUD-VASH grants initially funded with appropriated funds from Fiscal Year 2015 provided they meet applicable program requirements. This notice specifies the criteria for renewal grants, including data on the utilization of assistance reported by grant recipients under the demonstration program.

II. ELIGIBILITY

Eligible recipients for Tribal HUD-VASH renewal funding are limited to tribes and tribally designated housing entities (TDHEs) that were awarded assistance under the rental assistance and supportive housing demonstration program for Native American veterans authorized under the Federal Register notice, "Tribal HUD-VA Supportive Housing Program Awards, Fiscal Year 2015" (FR-5889-FA-02). A list of grantees eligible for renewal are located in Table 1.

HUD will award renewal funds based on the requirements issued in this notice.

III. Award Information and Overview

HUD intends to award renewal funds in one round during calendar year 2018, covering the period of January 8, 2016 – June 30, 2018. HUD will process Tribal HUD-VASH renewal funding as amendments to existing grant awards, as listed in Table 1 of this notice.

In order to receive renewal funds, Tribal HUD-VASH grantees must submit a renewal package as outlined in this notice, including reporting information such as rent payment data, number of lease renewals, and veteran enrollment.

Renewal funding will be based on a grantee's rental assistant payment and leasing information, plus an inflation factor. In addition, grantees will receive an administrative fee

equivalent to the amount for all units awarded in the original HUD grant. This administrative fee renewal amount will be calculated at \$85/month per unit, plus an inflation factor, for the 30-month funding period.

IV. Renewal Package Submission

1) Receipt Deadline

Grantees must electronically submit the renewal information outlined in this notice to: tribalHUDVASH@hud.gov. The application window for renewal packages will be from July 1, 2018-August 15, 2018. Electronic packages must be received no later than 11:59:59 p.m. Eastern Standard Time on August 15, 2018.

If electronic submission is not possible, grantees must notify the Area ONAP office of its intent to mail an application and include a justification. Upon notification, grantees may mail one original and one copy of their renewal package to:

Mailed submissions must be postmarked no later than the date the information is due. Handcarried or faxed information will not be accepted.

2) Renewal Package Content

Grantees must submit the following information in their renewal package:

- a) Cover Letter: The tribe/TDHE must submit a one-page cover letter on the organization's letterhead with the components below:
 - i) Contact Information: Provide the current Tribal HUD-VASH point of contact information for the tribe/TDHE, including mailing address, phone number, and email address.
 - ii) Tribal Resolution (if applicable): Grantees must include a statement whether the original tribal resolution for participation in the Tribal HUD-VASH program is still applicable. If the original tribal resolution is no longer applicable, then the grantee should submit a new resolution.
 - iii) Authorized Representative signature: The cover letter should be signed by the person authorized to submit the renewal package on behalf of the grantce.
- b) Program Update and Overview: Grantees must report the demonstration program's progress as outlined in Section VI.1 of this notice. (2 pages maximum)
- c) Renewal Funding Information: A completed Renewal Funding Table as provided in Section VI.2 of this notice.

d) Federal Financial Report (SF-425): If not previously submitted, provide a copy of the latest SF-425 with the renewal package. If applicable, report any program income used towards meeting Tribal HUD-VASH program objectives.

V. Review and Award Process

HUD staff from headquarters and area offices will conduct a review to confirm that grantees have met the criteria for renewal under this notice. HUD will look at factors including:

- a) Renewal package content: Submission of a complete renewal package.
- b) Indian Housing Plan (IHP) and Annual Performance Report (APR): Verification that the tribe/TDHE's IHP and APR have been updated annually to include current Tribal HUD-VASH information.
- c) SAM registration: Confirmation that the tribe/TDHE's registration is current in the System for Award Management (SAM).

HUD will review the renewal package and will respond to grantees within 45 days of receipt. At HUD's sole discretion, HUD may contact the applicant to clarify items in the submission, and establish deadlines for response.

If HUD identifies any deficiency in the application, HUD will notify the applicant by email describing the deficiency and request a cure. HUD will send an email to the person designated in the contact information on the cover letter. The applicant must carefully review the request for cure and provide the response in accordance with the instructions contained in the deficiency notification. Deficiency clarifications or corrections must be received by HUD within the time limits specified in the notification. If a response to the deficiency is not received or in accordance with the instructions contained in the deficiency notification, the applicant will not be considered for renewal funding.

Upon HUD's approval of the renewal package, HUD will issue a grant amendment to be signed by the tribe/TDHE, and will disburse funds through the HUD LOCCS system.

VI. Utilization of Assistance Summary

Grantees must report its execution of the Tribal HUD-VASH program and renewal funding request based on the criteria in this section. The renewal funding data should cover the funding period of January 8, 2016 – June 30, 2018.

1) Program Update and Overview

The grantee must report how it has utilized its current funding to administer the demonstration program, including the grantee's progress towards meeting the program's goals, current and projected program enrollment, challenges faced, measures taken to address issues, conducting interim/annual reexaminations, and the grantee's community involvement strategies. (2 pages maximum).

2) Renewal Funding Information

HUD will send via email, a formatted excel file to Tribal HUD-VASH grantees eligible for renewal funding. Grantees applying for renewal funding must fill out this excel file and include a copy with their renewal application. The renewal funding data should reflect actual data based on the funding period of January 8, 2016 – June 30, 2018.

A sample of the excel file and the information required is provided below in Table 2. (Note: HUD does not need detailed participant information such as address, resident ID number, etc. for renewal funding.)

HUD will review the data reported by grantees and will base final renewal awards on the following factors:

- a) Lease Period: Identify the start and end dates for each veteran's lease
- b) Total Unit Months Leased: Specify the number of months covered under the funding period.
- c) Monthly Rental Assistance Payment: This should reflect the grantee's rental assistance payment under the Tribal HUD-VASH program (total rent for the unit minus any veteran contribution and any non-HUD funds used to pay rent).
- d) Total Administrative Fee: Grantees will receive an administrative fee equivalent to the amount for all units awarded in the original HUD grant. This administrative fee renewal amount will be calculated at \$85/month per unit, plus an inflation factor, for a 30-month period. For more information on eligible administrative and planning expenses, see Section M of FR-6091-N-01.

^{**} If a Veteran's rent increased with a new lease period, enter the new lease period and rent amount on a separate line.

The tribe/TDHE must ensure the accuracy of renewal data. HUD will validate the data and reserves the right to determine the final renewal amounts based on data validation and the availability of funds.

VII. Risk Evaluation

In accordance with 2 CFR §200.205, HUD will continue to consider risk and administrative capacity before making awards. HUD will examine a range of capacity indicators, including program performance, compliance with reporting requirements, outstanding financial audits, unresolved HUD monitoring findings, OIG findings or audit findings, unresolved outstanding civil rights violations, high unexpended grant balances, compliance with mitigation plans, and overall administrative capacity to administer the Tribal HUD-VASH program.

HUD may impose new/revised mitigation plan requirements or special terms and conditions in accordance with 2 CFR §200.207, if any substantial administrative or programmatic concerns are identified in the review process.

VIII. Eligible Activities

Renewal funding awarded under the terms of this notice will be limited to current Tribal HUD-VASH program activities outlined in FR-6091-N-01.

IX. Reporting

Recipients of renewal awards will be subject to the reporting requirements of FR-6091-N-01-Section O and the terms and conditions of the grant award.

Navajo Housing Authority Tribal HUD VASH Program Update and Overview

The Navajo Housing Authority (NHA) was approved to administer 20 Tribal HUD VASH vouchers designated for homeless or at-risk homeless Navajo veterans under the Tenant Based Rental Assistance Program in coordination with the Northern Arizona Veteran Administration Health Care System (NAVAHCS). NHA was assigned a VA Case Manager who is a licensed clinical social worker. She was centralized and stationed at the Indian Health Service Unit in Chinle, AZ to assist interested Navajo Veterans. The NHA, VA and HUD staff attended the Tribal HUD-VASH Program training on January 31 – February 2, 2017. NHA created and implemented the Tribal HUD VASH Administrative Plan that was approved by the NHA Board of Commissioners on February 17, 2017. The NHA and NAVAHCS staff reached out to Navajo Veterans throughout the Navajo Nation at local Chapter meetings, Chapter Veteran Organization meetings, Veteran community functions, area properties, and at each of the NHA's 15 Housing Management Offices.

NHA began issuing Tribal HUD VASH vouchers to eligible Veterans in March 2017. Three voucher recipients were housed and leased in May of 2017. The VA social worker resigned in August 2017 but with the assistance of NAVAHCS staff, NHA issued all 20 vouchers in September 2017. The Veterans were assisted by NAVAHCS staff in searching for units and encountered the following challenges: availability of units, various bedroom sizes, rentals exceeding fair market standards, background checks, rental history, and case management. Once a voucher is issued, the Veteran has 120 days to locate and occupy an eligible unit through a valid lease contract. The NHA issued six vouchers that eventually expired due to the previously mentioned challenges. The expired vouchers were reissued to the next eligible Veteran from the interest list.

The NHA Tribal HUD VASH Program currently has 19 Veterans who are leasing in the following border towns of the Navajo Nation: Gallup, NM - 1, Farmington, NM - 3, Winslow, AZ - 2, Flagstaff, AZ - 7, Prescott, AZ - 4, Tsaile, AZ - 1 and Page, AZ - 1. The following is a breakdown of the number of bedroom sizes leased under the Tribal HUD VASH Program 0BR - 4, 1BR - 3, 2BR - 8, and 3BR - 4. A total of \$126,617.89 was expended from May 2017 to June 30, 2018. Five Veterans have been recertified into the second year lease agreements and will continue occupancy with their current properties.

The NHA Tribal HUD VASH Program has provided stability by providing housing and case management services. There are several participants who have completed rehabilitation and continue to access community resources to improve their health and wellness. Four of the participants have enrolled in higher education at various community colleges. Several of the participants have secured employment. Each Veteran is required to participate in case management with the VA Case Manager. The NHA continues to receive inquires about the program and have 20 Veteran families on the interest list. Due to the demographics of the area that is covered, it is necessary to ensure adequate case management is delivered.

RESOLUTION OF THE NAABIK'ÍYÁTI' COMMITTEE OF THE NAVAJO NATION COUNCIL

23rd NAVAJO NATION COUNCIL - Second Year, 2016

AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT, BUDGET AND FINANCE, AND NAABIK'İYATI' COMMITTEES; AUTHORIZING THE NAVAJO HOUSING AUTHORITY AS THE TRIBALLY DESIGNATED HOUSING ENTITY TO SUBMIT AN APPLICATION TO HUD UNDER THE RECENTLY ANNOUNCED TRIBAL HUD-VASH DEMONSTRATION PROGRAM

Whereas:

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. \$102(A).
- B. The Navajo Nation Council shall establish standing committees of the Council and delegate such authority to such committees as it deems necessary and proper for such committees to execute the purposes or powers delegated. 2 N.N.C. \$102(G).
- C. The Resources and Development Committee exercises oversight authority over housing to establish policies and legislation appropriate to the housing needs of the Navajo Nation and its People. 2 N.N.C. § 500(C)(3).
- D. The Budget and Finance Committee has the power to approve and accept agreement, including grants, between the Navajo Nation and any federal authority upon the recommendation of the standing committee which has oversight of the division, department or program which has applied for the agreement. 2 N.N.C. § 301(B)(15).
- E. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'íyáti' Committee to coordinate all federal programs, i.e. U.S. Department of Housing and Urban Development (HUD), with the Navajo Nation government to provide efficient services to Navajo members. 2 N.N.C. §§ 700 (A), 701 (A)(4), 701 (A)(6), 701 (A)(4).

- F. On October 21, 2015, HUD issued a notice (Notice) in the Federal Register for the administration of a supportive housing and rental demonstration program called the Tribal HUD-VA Supportive Housing program (Tribal HUD-VASH). The program will provide rental assistance and supportive services to Native American veterans who are homeless or at risk of homelessness living on or near a reservation or other Indian areas.
- G. HUD made available \$4 million in grant funding to Indian tribes and Tribally Designated Housing Entities (TDHEs) to fund this rental assistance and associated administrative fees.
- H. The HUD-VASH program combines Housing Choice Voucher program (HCV) rental assistance for homeless veterans with case management and clinical services provided by or through the VA through Veterans Administration Medical Centers (VAMC). Historically, this program has not reached Native American veterans in tribal communities due to legal impediments preventing tribes and TDHEs from participating in the HUD-VASH program.
- I. In the Consolidated and Further Continuing Appropriations Act 2015 (Pub. L. 113-235, approved December 16, 2014) (2015 Appropriations Act), Congress authorized funding for a demonstration program in order to expand the HUD-VASH program into Indian Country. The Appropriations Act directed HUD to coordinate with Indian appropriate and other tribal Country, TDHEs, organizations on the design of this program, and to ensure the effective delivery of housing assistance and supportive services to Native American veterans who are homeless or at risk of homelessness.
- J. Housing assistance under this program will be made available by grants to tribes and TDHEs that are eligible to receive Indian Housing Block Grant Program (IHBG) funding under the Native American Housing Assistance and Self Determination Act (NAHASDA). Tribes will be able to request Tenant-Based and/or Project-Based Rental Assistance by the number of bedrooms in a rental unit. Grants will be awarded based on the number of rental units (Tenant-Based and Project-Based Rental Assistance) approved by HUD.

- K. A few selected tribes/TDHEs in each Office of Native American Programs (ONAP) region were invited to apply for Tribal HUD-VASH demonstration program shortly after publication of the Notice. By letter dated October 29, 2015, HUD invited the Navajo Housing Authority (NHA) to participate in the demonstration program. To receive a grant, tribes/TDHEs are required to submit a Tribal HUD-VASH application that is due on December 2, 2015.
- L. As a part of the application process, HUD requires a tribal resolution if an application is submitted by a TDHE on behalf of an Indian tribe. The tribal resolution must be submitted in support of the application and must authorize the TDHE to submit the application under the Tribal HUD-VASH program. Because of the short turnaround time for the application submission, the tribal resolution can be submitted to HUD after the HUD application due date.
- M. The NHA Board of Commissioners recommended to the Navajo Nation to authorize the NHA to submit an application under the recently announced Tribal HUD-VASH program. Attached hereto as Exhibit B is a copy of NHA resolution number NHA 4567-2015 Recommending to the Navajo Nation to Approve and Authorize the NHA to Submit an Application to HUD for the new Tribal HUD-VASH Program.
- N. Based on the foregoing, it is in the best interest of the Navajo Nation to authorize the NHA to submit an application, **Exhibit A**, to HUD for the new Tribal HUD-VASH Program.

Therefore, Be It Resolved:

- A. The Navajo Nation hereby authorizes the Navajo Housing Authority as the Tribally Designated Housing Entity to submit an application, Exhibit A, to HUD under the recently announced Tribal HUD-VASH Demonstration Program.
- B. The Navajo Nation hereby authorizes the Navajo Housing Authority, in consultation with Navajo Nation Department of Veteran's Affairs, to implement the Tribal HUD VASH Demonstration program on behalf of Navajo veterans.

C. The Navajo Nation hereby authorizes the Navajo Housing Authority to take all necessary action to effectuate this resolution.

The Navajo Housing Authority (NHA) (a) was created and established as a public body of the Navajo Nation under the laws of the Navajo Nation at 6 N.N.C. § 601 and its Plan of Operation is codified thereunder: (b) pursuant to 24 CFR 1000.206 of the NAHASDA regulations, is the Tribally Designated Housing Entity (TDHE) for the Navajo Nation and is an eligible recipient of IHBG pursuant to Navajo Nation Council (NNC) Resolution CD-82-03; and (c) is otherwise regulated by HUD NAHASDA program requirements set forth in the Code of Federal Regulations. Title 24 Housing and Urban Development, Parts 85 and 1000; and
- 3. Pursuant to 6 N.N.C., Sections 605 and 616(b)(3), the Board of Commissioners of the Navajo Housing Authority (NHA) is empowered with the authority to manage the affairs of the NHA with the power to do all things necessary or desirable to secure the financial aid or cooperation of the federal government in the undertaking of providing safe, decent and sanitary housing; and
- 4. On October 21, 2015, the U.S. Department of Housing and Urban Development (HUD) issued a notice (Notice) in the Federal Register for the administration of a supportive housing and rental demonstration program called the Tribal HUD-VA Supportive Housing program (Tribal HUD-VASH).
