BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 300(A).
- B. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).
- C. The Budget and Finance Committee has oversight of the Office of Management and Budget. 2 NNC § 301(B)(13).

SECTION TWO. FINDINGS

- A. The Budget and Finance Committee held a budget hearing and took budget testimony regarding the Office of Management and Budget Fiscal Year 2019 Budget. 12 N.N.C. § 840 (A).
