AN ACTION

RELATING TO NAABIK'ÍYÁTI' COMMITTEE; APPOINTING A DELEGATE MEMBER FROM THE NAABIK'ÍYÁTI' COMMITTEE TO THE NAVAJO TIMES PUBLISHING COMPANY AS A SHAREHOLDER REPRESENTATIVE

BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Naabik'iyáti' Committee is established as a standing committee of the Navajo Nation Council. 2 N.N.C. §700(A).

SECTION TWO. FINDINGS

- A. Standing committees are required to select a member to serve as a Shareholder Representatives or Member Representatives for certain Navajo Nation enterprises.
- B. The By-Laws of Navajo Times Publishing Company, Inc. state, "[a]s a sole shareholder, the Navajo Nation's shares in the Corporation shall be exercised by five (5) shareholder representatives' comprised of one member from each of the five (5) standing committees of the Navajo Nation Council or their successor committees . . . "
- C. The Naabik'iyati' Committee is permitted to designate one member representative to the Navajo Times Publishing Company, Inc., as a shareholder representative.

SECTION THREE. NAABIK'ÍYÁTI' COMMITTEE SHAREHOLDER REPRESENTATIVE DESIGNEE

A. The following member from the Naabik'iyati' Committee is designated to serve as its shareholder representative to the Navajo Times Publishing Company, Inc.: Honorable Delegate Otto Tso.
