On 13 June 2019, Legislation 0098-19 was tabled "for a Naabik'iyáti' Committee Work Session within a timeframe of 45 days". To date, Legislation 0098-19 has not had a Naabik'iyáti' Committee Work Session. As of August 15, 2019, 63 days have lapsed without a Naabik'iyáti' Committee Work Session, which exceeds the 45 days timeframe. Per Navajo Nation Standing Committee Rules of Order Rule 18. H., "Any legislation not taken up from the table in the manner provided herein or at the time directed by the Committee shall be deemed to have expired and shall be eliminated from the agenda of the Committee." Legislation 0098-19 will be closed out.

BE IT ENACTED:

SECTION ONE. AUTHORITY

A The Resources and Development Committee of the Navajo Nation Council is a standing committee of the Navajo Nation Council exercising oversight authority over water, land, grazing and environment. 2 N.N.C. § 500 (C).

B. The Naabik'íyáti' Committee of the Navajo Nation Council is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700.

SECTION TWO. FINDINGS

A. The twelve domains of Sustainability adhere to the tenets of Navajo Fundamental law,

1 focusing on organizational and operational sustainability and sustainable stewardship to
2 secure the rights of future generations. The principles in the twelve domains of sustainability
3 align with the teachings of Fundamental Law expressed in 1 N.N.C § 201, “Nahasdzaán dóó
4 yádl̨h̨il̨ nitsáhákees yil̨ hadeidiilaa, Tó dóó dził diyinii nahat’á yil̨ hadeidiila, Nılch’I dóó
5 nanse’ altaas’ éi iiná yil̨ hadediilaa, Kq’, adinííín dóó ntl’iz náadahaniihji’ sihasin yil̨
6 hadediilaa. Díí ts’ídá aláají nihi beehaz’áanii bitse siléi nihá’ ályaa.” The Fundamental
7 principles of thinking, planning, life, and wisdom are the same principles at the heart of
8 sustainability practices.

9 **B.** The Navajo Government Development Commission (Commission) adopted the
10 Navajo Nation sustainable governance principles and practices plan, to transition toward
11 a sustainability in governance processes and establish objective targets for the protection
12 of life-supporting elements of land, water, air and fire.

13 **C.** To that end, the Naabik’íyáti’ Committee of the Navajo Nation Council finds it to be in
14 the best interest of the Navajo People to adopt the following twelve (12) domains of
15 sustainable practices and to commit to establishing objective targets and applying such
16 principles to all programs and policies of the Navajo Nation Government. The following
17 are the twelve domains of sustainable practices:

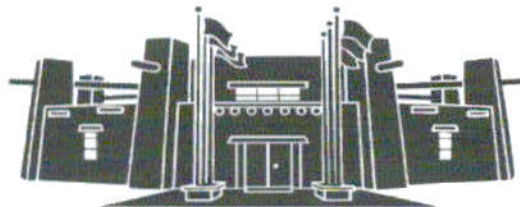
- 18 1. Awareness education and engagement;
- 19 2. Environmentally friendly buildings and facilities;
- 20 3. Transportation modes, infrastructures and operations;
- 21 4. Climate protection, adaption and mitigation;
- 22 5. Sustainable operations and management;
- 23 6. Waste reduction and recycling;
- 24 7. Environmentally preferable purchasing/procurement;
- 25 8. Sustainable food systems and production;
- 26 9. Sustainable energy transition;
- 27 10. Diné Language and Culture
- 28 11. Natural habitat and ecosystem; and
- 29 12. Social equity, wellness and justice.

1 **SECTION THREE. RESOLVED**

2 **A.** The Naabik'iyáti' Committee of the Navajo Nation Council, recognizing that the
3 principles in the twelve domains of sustainability align with the teachings of Fundamental
4 Law expressed in 1 N.N.C § 201, “Nahasdzáán dóó yádilhił nitsáhákees yił hadeidiilaa, Tó
5 dóó dził diyinii nahat'á yił hadeidiila, Níłch'I dóó nanse' altaas' éí iiná yił hadediilaa, Kq',
6 adinííín dóó ntl'iz náadahaniihji' sihasin yił hadediilaa. Díí ts'ídá aláají nihi beehaz'áanii
7 bitse siléí nihá' ályaa.” and that the Fundamental principles of thinking, planning, life, and
8 wisdom are the same principles at the heart of sustainability practices hereby adopts the
9 following twelve (12) domains of sustainable practices and commits to establishing objective
10 targets and applying such principles to all programs and policies of the Navajo Nation
11 Government. The following are the twelve domains of sustainable practices:

24 **B.** The Office of Navajo Government Development, using the resources available to it,
25 shall develop and present to the Naabik'iyáti' Committee of the Navajo Nation Council
26 for its consideration and adoption, objective targets for the preservation of the life-
27 supporting elements of land, water, air and fire to be applied to the twelve domains of
28 sustainable practices and applying such principles to all programs and policies of the
29 Navajo Nation Government.

Dear 24th Navajo Nation Council:

I submit this letter to express my support for Honorable Council Delegate Jamie Henio's Legislation 0098-19.

Although the legislation is a commendable effort to support and complement a transition toward a sustainable future for our people, I do have a few suggestions intended to strengthen it's impact. The suggested revisions revolve around replacing the word "sustainable" with "regenerative" because in most cases, we would not want to simply maintain the status quo, but we would want to renew, restore, revive replenish something into a better state. This would especially apply to our economy and to our food systems.

In the twelve domains of sustainability, I would suggest the following revisions:

- combine #2 and #6 to read: "Environmentally friendly buildings and facilities that promote and accommodate waste reduction and recycling"
- Draft a new domain in place of the previous #6 to read: "Regenerative economy"
- revise #8 to read: "**Regenerative** food systems and production"
- Revise #11 to read: "Natural habitat and **regenerative** ecosystem"

It is no longer enough to strive for "sustainability" alone, we need to reverse the damage we have done to our environment and our economy by creating and producing something better that will continue to reproduce excess benefits for our communities, our cultural landscapes, our environment, and our economy.



In Navajo, natural ecosystems should be promoted throughout all levels of community development. Approaches in the maintenance and encouragement of natural ecosystems creates a more sustainable relationship with the natural environment.

Rural and urban design enabling individual building projects to maximize renewable energy access, and the design and construction of commercial and residential facilities that are designed with passive solar design principles to utilize available solar access, is a feature of environmentally responsible community development. Easy access to public transport is also important, and this aspect can be extended to include provision of cycle ways and electric vehicles charging facilities.

Flexibility in transportation design can permit projects to fit a particular physical setting and preserves scenic, aesthetic, historic, and environmental resources, while maintaining safety and mobility.

Types of sustainable town planning include:

- * Development of a Renewable Energy Policy for all communities
- * Preparation of Local Environmental Plans
- * Preparation of Development Control and Management Plans
- * Preparation of Development Applications
- * Project management of flora and fauna studies,
- * Training programs for staff and professional training in biodiversity conservation and ecologically sustainable development.

Dear 24th Navajo Nation Council:

I submit this letter to express my support for Honorable Council Delegate Jamie Henio's Legislation 0098-19.

This legislation is a commendable effort and a start in creating a model transition toward a sustainable future for our Dine' people. The Navajo Government Development Commission is well suited to carry out this effort. Time and again we have witness isolated plans developed that have been devoid of the teachings of Fundamental Laws and ended with lost of precious Navajo Nation funds in the millions of dollars.

History has shown us that project programs developed without a standard set of guidelines and devoid of Fundamental Law's principles results in creating policies that utilize western worldview and they result in failure:

Navajo Nation lost \$3.2 million between 2005 and 2009, through the misuse of tribal discretionary funds, absconded by members of the Council (77 of the 88) and employees of the

tribe. The Navajo public has never received a report on whether or not any funds have been paid back.

The Navajo Nation gave \$30 million to the project Dine' Power Authority and no tangible outcome was realized. Again, program was created utilizing and through the lens of western worldview.

Applaud the Navajo Government Development Commission for taking on the task via Legislation 0098-19 to create the Principles and Practices of sustainable Navajo Governance.




