SECTION ONE. AUTHORITY

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Law and Order Committee has oversight over the administration of justice on the Navajo Nation. 2 N.N.C. §600 (C)(1)
- C. Any proposed resolution requiring final action by the Navajo Nation Council shall be assigned to the Naabik'iyáti Committee. 2 N.N.C. §501(C)(1).

SECTION TWO. FINDINGS

- A. The Navajo Nation President recommends a person as the Navajo Nation Deputy Attorney General. 2 N.N.C. §1962(B).
- B. The Navajo Nation President recommends Kimberly Dutcher as the Navajo Nation Deputy Attorney General. Ms. Dutcher's appointment letter and résumé are attached as Exhibit A.
- C. The Navajo Nation Council appoints the Navajo Nation Deputy Attorney General at the recommendation of the Navajo Nation President. 2 N.N.C. §1962(B).

1 D. The recommended Navajo Nation Deputy Attorney General serves at the pleasure of

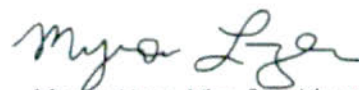
Dear Ms. Dutcher,

The Nez-Lizer Administration was elected on a mandate of change for the Navajo Nation. This change involves appointing qualified, motivated and experienced individuals who will move the Navajo Nation forward by "Working Together" to serve the Navajo people. This letter shall serve as a formal notification to your appointment as Deputy Attorney General of the Navajo Nation. This appointment will take effect on April 08, 2019 at 8:00AM. Please note that this position is subject to confirmation by the Navajo Nation Council.

Your duties as Deputy Attorney General are outlined at 2NNC §1961-1965. Along with the Attorney General, you shall be responsible for the administration and management of the Navajo Nation Department of Justice and supervision of all personnel. This includes ensuring compliance with all applicable Navajo Nation laws and policies.

You will be compensated at the negotiated salary of _____, including medical benefits and deferred compensation. Following your appointment, you will report to the Navajo Nation President, Vice President, Chief of Staff and Attorney General until confirmation by the 24th Navajo Nation Council. Again, we thank you for your commitment to serve the Navajo people. Ahéhee'.

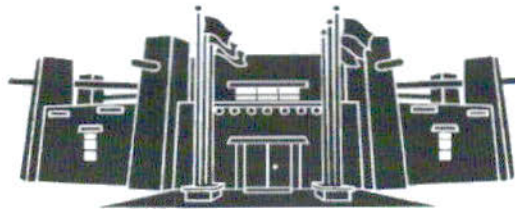
