AN ACTION

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE; SELECTING AND APPOINTING A HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE MEMBER AS SHAREHOLDER REPRESENTATIVE TO THE NAVAJO NATION OIL AND GAS COMPANY, INC.

BE IT ENACTED:

SECTION ONE. FINDINGS

- A. On October 5, 2015, the Navajo Nation Council ratified the Restated Federal Chapter of Incorporation for the Navajo Nation Oil and Gas Company with the Navajo Regional Director's condition. CO-40-15, 23rd Navajo Nation Council (Oct. 5, 2015).
- B. The Ratified Charter states, "[a]ll rights of the shareholder of the Corporation shall be exercised by the appointed shareholder representatives, composed of one member from each of the standing committees of the Navajo Nation Council or their successor committees, in accordance with this Charter and the applicable tribal law...Each standing committee shall select its own shareholder representative." Restated Federal Chapter of Incorporation for the Navajo Nation Oil and Gas Company art. V, sec. D.
- C. The Navajo Nation Council established the Health, Education and Human Services Committee as a Navajo Nation standing committee. 2 N.N.C. \$400 (A) (2012) see also CJA-03-13.
- D. As a Navajo Nation Council standing committee, the Health, Education and Human Services Committee shall select a member to serve as a Navajo Nation Oil and Gas shareholder representative.
- E. Selecting and appointing a Navajo Nation Oil and Gas shareholder representative is in the Navajo Nation's best interest.

SECTION 2. SELECTION AND APPOINTMENT

The Health, Education and Human Services Committee selects and appoints $\underline{\text{Amber Kanazbah Crotty}}$ as its Navajo Nation Oil and Gas shareholder representative.
