RELATING TO NAABIK'IYATI' COMMITTEE AND THE NAVAJO NATION COUNCIL; CONFIRMING THE APPOINTMENT OF RACHEL R. FELIX TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT FOR A TERM OF TWO YEARS, AS THE JUDICIAL BRANCH REPRESENTATIVE

SECTION ONE. AUTHORITY

- A. Pursuant to 2 N.N.C. § 970, the Naabik'íyáti' Committee shall have legislative oversight authority over the Commission on Navajo Government Development and the Office of Navajo Government Development.
- B. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'íyáti' Committee to recommend all resolutions to the Navajo Nation Council on matters within the Committee's jurisdiction pursuant to 2 N.N.C. § 701(A)(3).
- C. Pursuant to 2 N.N.C. § 972(A)(2), one member shall be nominated by the Judicial Branch through the Chief Justice of the Navajo Nation to serve a term of two years from the date of confirmation by the Navajo Nation Council.

SECTION TWO. FINDINGS

A. The Commission on Navajo Government Development is an "entity created by the Navajo Nation Council with quasi-independent authority to accomplish the Council's

- project of instituting reforms necessary to ensure an accountable and responsible government." 2 N.N.C. § 970.
- B. Pursuant to 2 N.N.C. § 970, the Commission shall be responsible directly to the Navajo Nation Council with respect to overall activities.
- C. Pursuant to 2 N.N.C. § 971(A)-(B), the purpose of the Commission on Navajo Government Development shall be as follows:
 - To review and evaluate all aspects of the existing government structure of the Navajo Nation including laws, rules and regulations, practices, functions, goals and objectives of the Navajo Nation government, which includes the central government, Chapters, townships and local communities.
 - 2. To develop recommendations and proposals for government reform and alternative forms of Navajo Nation government.
- D. Pursuant to 2 N.N.C. § 972(A), the Commission shall consist of twelve (12) members confirmed by and serving at the pleasure of the Navajo Nation Council.
- E. Pursuant to 2 N.N.C. § 972(A)(2), one member shall be nominated by the Judicial Branch through the Chief Justice of the Navajo Nation to serve a term of two years from the date of confirmation by the Navajo Nation Council: the nominee shall be a licensed attorney and a member of the Navajo Nation Bar Association.
- F. Pursuant to 2 N.N.C. § 972(D), Commission members shall be chosen from among individuals who have demonstrated scholarship, strong sense of public interest, knowledge of Navajo history and cultural heritage, spiritual leadership, leadership in the Navajo government and abilities likely to contribute to the fulfillment of the duties of the Commission.
- G. Pursuant to 2 N.N.C. § 972(A)(1), the Chief Justice of the Navajo Nation has appointed Rachel R. Felix to represent the Judicial Branch on the Commission on Navajo Government Development. Letter of appointment is attached as **Exhibit A**.
- H. Rachel R. Felix's letter of interest is attached as **Exhibit B** and resume is attached as **Exhibit C**.
- I. Rachel R. Felix is licensed attorney with the State Bar of New Mexico. Exhibit E.
- J. Rachel R. Felix is a member of the Navajo Nation Bar Association. Exhibit D.

SECTION THREE. APPOINTMENT

Pursuant to 2 N.N.C. § 972(A)(2), the Navajo Nation Council hereby confirms the appointment of Rachel R. Felix as the Judicial Branch representative to serve on the Commission on Navajo Government Development, for a term of two years from the date of confirmation by the Navajo Nation Council.

Dear Mr. Dee:

I am writing to express my interest in serving as the Judicial Branch representative to the Commission on Navajo Government Development (the "Commission"). As my enclosed resume indicates, the practical skills I gained through my education and work experiences combined with my long-standing interest in public service, solving legal issues and making a positive difference will make me well-suited to fulfill the work of the Commission. I have demonstrated strong qualities of scholarship, a sense of public interest, background knowledge of Navajo history and cultural heritage and the leadership skills required to be a member of the Commission.

I am an attorney licensed to practice in New Mexico and a member of the Navajo Nation Bar Association. In addition, I am an enrolled member of the Navajo Nation (Census No. 224,628). My clans are: Ta'neeszhaani (nishli), born for Nakai (báshíshchiin). I grew up in Shiprock, New Mexico, graduated high school from Gallup, New Mexico and attended college at the University of New Mexico, Albuquerque, where I received three degrees: a Bachelor in University Studies, Master in Public Administration, and Juris Doctorate with a certificate in Indian Law. During college, I was a recipient of the Chief Manuelito Scholarship and Navajo Law Fellowship awards. I have a strong educational background that reflects my interests in Native American government, politics and law. In addition, I have always demonstrated a firm commitment to give back to my tribe and to use my education in a way that serves the best interest of the Navajo Nation.

During law school, I served as editor-in-chief of the Tribal Law Journal. This opportunity provided me with leadership experience, including public speaking, time management and priority-setting as I led a team of editors and staff towards achieving common goals as we published and solicited articles, and invited scholars to speak on Indian Law topics. I consider leadership duties and the role of *Nataanii* to be a special privilege and a very important responsibility, not to be taken lightly. Personally, I find helping others to be very rewarding and fulfilling, and I enjoy interacting with people from all walks of life.

As a legal practitioner during my time as a law student and in my current practice as an attorney, I have had the opportunity to travel to various Indian reservations and Pueblos where I represented Native American clients, entered multiple appearances in tribal courts, researched applicable law, wrote and filed motions and pleadings, conducted witness interviews and presented oral argument before the courts. This practical experience has provided me with a wealth of exposure regarding the layers of complexity involved in the practice of Indian Law.

In addition, my work on the Navajo Nation requires that I possess and maintain a working knowledge of Navajo history and laws, exercise cultural competency and to be respectful in all interactions. Through my work as an associate attorney at Sacks Tierney P.A. in Scottsdale, Arizona, I often commute to the Navajo Nation. Therefore, distance will not be a barrier to me if I am selected to serve on the Commission. I am certain that serving on the Commission will expose me to a wide array of issues in Navajo government, and will also help me to participate and grow as a leader as I use my background experiences, knowledge and skills to serve Navajo communities and address challenges that impact the future of our People.

Thank you for your time, confidence in me and anticipated consideration for the position of judicial representative to the Commission on Navajo Government Development. You will find me to be positive, highly motivated, energetic, hard-working and good at interacting with people. I am grateful for the opportunity to be considered, and I look forward to working with you.






