26	SECTION TWO. FINDINGS	
27	A. The Navajo Engineering and Construction Authority is organized "[t]o engage in the	
. 28	general engineering and construction industry." 5 N.N.C. § 1972 (A)(1).

- B. The management board for the Navajo Engineering and Construction Authority shall be appointed by the President of the Navajo Nation and confirmed by the Resources and Development Committee. See 5 N.N.C. § 1973(C); 2 N.N.C. § 501(B)(9).
- C. Individuals with experience and/or education in the engineering, construction, architectural, legal, accounting, management, or other construction related field shall be given preference for appointment to the Board. 5 N.N.C. § 1973(D).

D. The members of the board shall serve four-year terms. 5 N.N.C. § 1973(C).

E. The Navajo Nation President appointed Kim Kanuho to serve as a member of the Navajo Engineering and Construction Authority Board of Directors. Appointment letter attached as Exhibit A; letter of interest attached as Exhibit B; résumé attached as Exhibit C and Certificate of Navajo Indian Blood attached as Exhibit D. 5 N.N.C. § 1973(D).

#### SECTION THREE. CONFIRMING APPOINTMENT

The Resources and Development Committee of the Navajo Nation Council confirms the appointment of Kim Kanuho to serve on the Navajo Engineering and Construction Authority Board of Directors, for a term of four (4) years beginning with the certification of this resolution.
