TITLE OF RESOLUTION: AN ACTION RELATING TO LAW AND ORDER, NAABIK'ÍYÁTI' COMMITTEES AND NAVAJO NATION COUNCIL; AMENDING TITLE 2 REGARDING THE NAVAJO NATION POLICE COMMISSION

**PURPOSE:** The resolution's purpose is to approve the Navajo Nation Police Commission.

17	A. The Law and Order Committee of the Navajo Nation Council reviews and makes	
18	recommendations to the Navajo Nation Council proposed amendments to the Navajo	
19	Nation Code and exercises oversight over the Department of Public Safety. 2 N.N.C. §	
20	601(B)(14) and (C)(1).	
21	B. The Naabik'íyáti' Committee of the Navajo Nation Council, pursuant to 2 N.N.C. §	
22	164(A)(9), reviews proposed legislation which requires final action by the Navajo Nation	
23	Council.	
24	C. Enactments of positive law must be reviewed and approved by resolution by the Navajo	
25	Nation Council. 2 N.N.C. § 164(A).	
26	D. The Law and Order Committee's purpose is "[t]o enhance the operations and	
27	coordination of all departments within the Navajo Division of Public Safety in order to	
28	increase the availability, quality, and effectiveness of public safety services on the Navajo	
29	Nation" and "[t]o enable the Navajo Nation to more effectively provide efficient public

3	E. Diné Traditional Law declares and teaches that "[t]he leaders of the Legislative Branch
4	shall enact policies and laws to address the immediate and future needs" 1 N.N.C. §
5	203(D).
6	F. Diné customary Law declares and teaches that "[i]t is the right and freedom of the people
7	that every child and every elder be respected, honored and protected with a healthy
8	physical and mental environment, free from all abuse" 1 N.N.C. § 204(E).
9	G. The Law and Order Committee believe creating the Navajo Nation Police Commission is
10	necessary in order to improve the immediate and future needs of the Navajo Nation. 1
11	N.N.C. § 203(D).
12	
13	Section Two. Amending Navajo Nation Code Title 2
14	The Navajo Nation amends the Navajo Nation Code, Title 2 as follows:
15	
16	Title 2. Navajo Nation Government
17	Chapter 3. Legislative Branch
18	Subchapter 11. Boards and Commissions
19	Article 8. Navajo Nation Police Commission
20	
21	§ 961. Establishment
22	The Navajo Nation Police Commission is established as an independent commission within
23	the Navajo Nation Legislative Branch; receiving administrative support and assistance from the
24	Navajo Nation Police Department.
25	
26	
27	§ 962. Purpose
28	The purpose of this chapter is to create an independent commission whose mission is to
29	provide regulatory oversight of the Navajo Nation law enforcement and to act as the liaison
30	

1	between the community, law enforcement, and the Navajo Nation's Executive and Legislative
2	branches.
3	
4	§ 963. Definitions
5	The following words, terms and phrases as used in this chapter, shall be defined as follows:
6	A. Commission shall mean the Navajo Nation Police Commission.
7	B. Commissioner and/or member shall mean an authorized member of the Navajo Nation
8	Police Commission.
9	C. Chairman shall mean the Chairperson of the Navajo Nation Police Commission.
0	D. Vice Chairman shall mean the Vice-Chairperson of the Navajo Nation Police
1	Commission.
2	E. Law Enforcement shall mean an agency responsible for enforcing the laws of the Navajo
3	Nation.
4	F. Law Enforcement Officer or Law Enforcement Official shall mean any authorized
5	personnel delegated authority to enforce the laws of the Navajo Nation.
6	
17	§ 964. Commission membership, qualifications, removal and personnel
8	A. Composition. The Navajo Nation Police Commission shall consist of six appointed
9	members.
20	1. The Navajo Nation President shall appoint three members with Law and
21	Order Committee review and confirmation by Naabik'íyáti' Committee.
22	2. The Law and Order Committee shall appoint three members with
23	confirmation by Naabik'íyáti' Committee.
24	3. The Navajo Nation Police Commission's members terms shall be four
25	years, staggered. Two member's terms shall end two years after
26	confirmation, another two shall end three years after confirmation, and the
27	final two shall end four years after confirmation.
28	B. Qualifications. The Navajo Nation President and the Law and Order Committee shall
29	appoint three members each. An appointee is qualified based on education, experience, or office
30

1	C. Removal. A Commissioner shall be removed only for cause by the Law and Order
2	Committee and upon ratification by the Naabik'íyáti' Committee of the Navajo Nation Council.
3	The Commissioner removed may appeal the removal to the Navajo Nation Supreme Court within
4	ten (10) calendar days of 2 N.N.C. § 221(C). For the purposes of this Subsection, "cause" means
5	1. Incapacity. Physical or mental incapacity, where such incapacity extends
6	or is expected to extend longer than six months.
7	2. Nonfeasance. Failure to perform the duties of office including, but not
8	limited to, repeated and unexcused failure to attend the meetings and other
9	official functions of the Commission.
10	3. Ex parte violation. Participation in ex parte consultations with any
11	representative who is an appellant in a dispute before or with the
12	Commission.
13	4. Certain other acts. Any act that is a felony in the jurisdiction where
14	committed, or any act involving moral turpitude that is a misdemeanor in
15	the jurisdiction where committed.
16	5. A vacancy in the Commission, whether caused by death, removal, term
17	expiration or resignation shall be filled by an interim appointment to
18	complete the vacated term made in accordance with 2 N.N.C. §964(A)(1)
19	and (2).
20	D. Personnel. The Navajo Nation Police Commission shall receive administrative
21	support and assistance from the Navajo Nation Police Department and shall hire personnel and
22	approve Commission expenditures as provided for in the Navajo Nation Police Commission Plan
23	of Operation and the Navajo Nation operating budget.

27	§965. Authority
28	A. Oversight of all Tribal Law Enforcement programs. The Chief of Police and other Tribal
29	Law Enforcement Managers shall manage the daily operations of their respective program and
30	

1	shall implement the Commission's policies and goals; the Chief of Police and other Tribal Law
2	Enforcement Managers shall report to the Commission.
3	B. Enact the overall policy, rules and regulations for the governance of Tribal Law
4	Enforcement and its personnel;
5	C. Prescribe penalties for violations of its rules and regulations;
6	D Form an Internal Review Board to conduct investigations and hearings on allegations of
7	law enforcement misconduct;
8	E. Hear final appeals from Law Enforcement Officers for discipline imposed by their
9	respective Law Enforcement Program Manager, Chief of Police or the Internal Review Board;
10	F. Review annual budgets prepared by Law Enforcement Program Managers and the Chief
11	of Police and make recommendations to the Navajo Nation President and Navajo Nation
12	Council;
13	G. Review the qualifications for each rank and grade in the law enforcement field and make
14	recommendations as necessary;
15	H. Review use of all property and equipment used by or in connection with the operation of
16	law enforcement departments/programs;
17	I. Advise the Chief of Police and other Tribal Law Enforcement Managers on law
18	enforcement community relations;
19	J. Submit an annual report to the Law and Order Committee;
20	K. All Commissioners shall have the authority to vote on issues coming before the
21	Commission;
22	L. To draft and administer by-laws of the Navajo Nation Police Commission;
23	M. To share relevant information/perspectives from other community groups, organizations
24	and/or constituencies with the Commission;
25	N. To represent the Commission at public events and other organizational meetings;
26	O. Serve on temporary committees or task groups that address specific work plan items;
27	P. Investigative subpoena power; and
28	Q. Serve as an outreach entity for citizens to submit law enforcement recommendations,
29	complaints and/or commendations.
30	

### § 966. Legislative oversight

The Navajo Nation Police Commission shall operate pursuant to a Plan of Operation and policies and procedures recommended by the Navajo Nation Police Commission and approved by the Navajo Nation Council's Law and Order Committee.

### Section Three. Codification

The provisions of the Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

### Section Four. Savings Clause

Should any provision of this Act be determined invalid by the Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.

### Section Five. Effective Date

The provisions of this Act shall become effective in accord with 2 N.N.C. § 221(B).
