RESOLUTION OF THE BUDGET AND FINANCE COMMITTEE OF THE NAVAJO NATION COUNCIL

24TH NAVAJO NATION COUNCIL - Fourth Year, 2022

AN ACTION

RELATING TO THE BUDGET AND FINANCE COMMITTEE; APPROVING A BUDGET REVISION REQUEST BY THE RISK MANAGEMENT PROGRAM TO IMPROVE ITS PROCESSING OF INSURANCE CLAIMS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 300(A). Among other authorities, the Committee oversees the Insurance Services Department and its subordinate programs, including the Safety & Loss Control Program and the Risk Management Program. 2 N.N.C. § 301(B)(13).
- B. The Navajo Nation's FY2022 Budget Instruction Manual ("BIM") explains that a "budget revision involves a change to an approved budget that deviates from the approved financial plan" and a "budget reallocation" is the "transfer or reallocation of budget funds between business units ..." BIM, Sect. IX(C), Sect. XI(C)2. The terms "budget reallocation" and "budget revision" are used interchangeably herein, and have the same meaning.
- C. The BIM requires that all Budget Revision requests shall be reviewed by the Office of Management and Budget ("OMB"), and the OMB Executive Director shall approve or disapprove the request. BIM, Sect. XI(E)(3) and XI(E)(4).
- D. The BIM further provides that oversight committee approval shall be required before a budget reallocation is processed. BIM, Sect. XI(C)(2).
- E. According to 2 N.N.C. § 185(A), a Navajo Nation program's or department's requested budget revision request must be

approved by a two-third's vote of the oversight committee members. 2 N.N.C. § 185(A).

SECTION TWO. FINDINGS

- A. The Risk Management Program ("RMP") is requesting approval of a Budget Revision. RMP explains that its proposed transfer is for moving \$48,200 for an existing vacant employee position (salary and fringe benefits) in the Safety & Loss Control Program to the Risk Management Program to create a new employee position. This transfer to RMP will allow RMP to hire a new Insurance Claims Examiner, which new employee will greatly assist RMP in expeditiously processing insurance claims for the Navajo Nation and will reduce RMP's current backlog of claims. RMP's request memorandum is attached hereto as **EXHIBIT A.**
- B. RMP has submitted a completed and signed Budget Revision Request Form, attached hereto as **EXHIBIT B**.
- C. RMP has also provided budget forms and a program organizational chart showing the proposed budget transfer for the new RMP employee position. EXHIBIT C.
- D. The OMB review and approval required by the BIM, Sect. XI(E)(3) and XI(E)(4), was obtained by RMP on September 13, 2022, as shown on the Section 164 Review Form attached hereto as **EXHIBIT D**. The OMB Director has indicated that the RMP's Budget Revision Request Form is correct.

SECTION THREE, APPROVAL

The Budget and Finance Committee hereby approves the Risk Management Program's Budget Revision Request as shown in attached **EXHIBIT A, EXHIBIT B,** and **EXHIBIT C.**

SECTION FOUR. EFFECTIVE DATE

This Action shall become effective in accordance with 2 N.N.C. \$ 221(C).

SECTION FIVE. SAVINGS CLAUSE

If any portion of this Action is determined invalid by the Supreme Court or by a Navajo Nation District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the remainder of this Action shall be the law of the Navajo Nation.

CERTIFICATION

I, hereby, certify that the foregoing resolution was duly considered by the Budget and Finance Committee of the Navajo Nation Council at a duly called meeting held by teleconference at which a quorum was present and that the same was passed by a vote of 4 in favor and 0 opposed, this 6th day of December 2022.

I am submitting this memorandum to request your assistance in sponsoring legislation before the Budget & Finance Committee "Reallocating" funds in the amount of \$48,200.00 and transfer of Insurance Claims Examiner (812023.1004) from Safety Loss Control Program (812023) to Risk Management Program (812005).

The Risk Management Program is proposing to reallocate funds from Business Unit 812023.1004 to Business Unit 812002.1014 in the amount of \$48,200.00. The reallocation of funds will only transfer the Position's Salary and Fringe from one Business Unit to another Business Unit under the Risk Management Program. The transfer of the position will allow the Risk Management Program to increase its staffing to handle insurance claims. Currently, due to the current staffing, there is only one claims examiner handling all Auto Physical Claims for the Navajo Nation and the Enterprises. This action would alleviate the backlog and provide an expeditious adjudication process.





1. The FY 2022 budget was set since October 1, 2021.

2. On June 24, 2022 OMB received a budget transfer from Risk Management.

- a. The transfer was from BU#812005 to 812023. Per the '22 BIM this is considered a reallocation.
- 3. On August 12, 2022 164 review doc. no. 019159 was submitted for a reallocation. The documents include the FY 2023 Budget Form 3.

FY 2023:

- 4. DPM provided the personnel listings to the Divisions in late June 2022.
- 5. If DGS/Risk's intent was to transfer the affect position from 812005 to 812023, then the changes should have been made via the personnel listing. The '23 BIM, instructions for BF3 should have been followed.

The dilemma:

- My view is, it's too late for a budget reallocation for FY 2022. There's 20 working days left in FY 2022.
- The FY 2023 budget was developed with the potential personnel transfer still in BU#812005. The changes were never made on the DPM personnel listing transferring the position to BU#812023. The '23 budget will be before NNC next week.

How do we resolve this? Suggestions/recommendations are welcome. I am also including OMB · Can do in FY 23 bidget after 10/1/22.
