RESOLUTION OF THE NAVAJO NATION COUNCIL $24^{\rm th}$ NAVAJO NATION COUNCIL - SECOND YEAR, 2020

AN ACTION

RELATING TO NAABIK'ÍYÁTI' COMMITTEE AND THE NAVAJO NATION COUNCIL; CONFIRMING THE APPOINTMENT OF MR. HARRISON TSOSIE TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT FOR A TERM OF TWO YEARS AS THE REPRESENTATIVE FOR THE JUDICIAL BRANCH

BE IT ENACTED:

SECTION ONE. FINDINGS

- A. The Naabik'íyáti' Committee has legislative oversight authority over the Commission on Navajo Government Development and the Office of Navajo Government Development. 2 N.N.C. § 970.
- B. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'íyáti' Committee to recommend all resolutions to the Navajo Nation Council on matters within the Committee's jurisdiction pursuant to 2 N.N.C. § 701(A)(3).
- C. The Navajo Nation Council confirms appointments to the Commission on Navajo Government Development. 2 N.N.C. § 972.

SECTION TWO. FINDINGS

- A. The Commission on Navajo Government Development is an "entity created by the Navajo Nation Council with quasi-independent authority to accomplish the Council's project of instituting reforms necessary to ensure an accountable and responsible government." 2 N.N.C. § 970.
- B. The Commission consists of twelve (12) members confirmed by and serving at the pleasure of the Navajo Nation Council. 2 N.N.C. § 972 (A).
- C. One member is nominated by the Judicial Branch through the Chief Justice to serve a term of two years from the date of confirmation by the Navajo Nation Council. 2 N.N.C. § 972 (A)(2). The qualifications for the nominee for this position include being a "licensed attorney and a member of the Navajo Nation Bar Association." 2 N.N.C. § 972 (A)(2).

- D. Commission members shall be chosen from among individuals who have demonstrated scholarship, strong sense of public interest, knowledge of Navajo history and cultural heritage, spiritual leadership, leadership in the Navajo government and abilities likely to contribute to the fulfillment of the duties of the Commission. 2 N.N.C. § 972(D).
- E. Mr. Harrison Tsosie has been nominated by the Hon. Chief Justice JoAnn Jayne to fill the position for the Judicial Branch on the Commission for Navajo Government Development. See Exhibit A. Mr. Tsosie meets all the qualifications for the position. His letter of interest and résumé are attached as Exhibit B.

SECTION THREE. APPOINTMENT

The Navajo Nation Council hereby confirms the appointment of Mr. Harrison Tsosie as the Judicial Branch representative to the Commission on Navajo Government Development, for a term of two years from the date of confirmation by the Navajo Nation Council.

- 2. Served as Navajo Nation Attorney General with the Shelly/Jim Administration to represent the legal interests of the Navajo Nation. Supervised and administered the day to day operation of the Navajo Nation Department of Justice, which included the Office of the Attorney General, Prosecutor's Office and Juvenile Justice Program. Managed all Offices to accomplish their vision, mission and goals by leading all staff including attorneys, legal advocates and support staff. During

my tenure as Attorney General, DOJ accomplished the following major projects including Navajo Nation Code - Title II Amendments to restructure the Navajo Nation Council, Little Colorado River Water Settlement, Lease Amendments to Four Corners Power Plant and Navajo Generating Station, developed the Navajo Energy Policy, purchased the BHP Navajo Mine, settled litigation against Peabody Energy Company and Navajo Generating Station owners for a lump sum, intervened in and obtained \$1.2 B for uranium cleanup in the Trunex Bankruptcy proceedings and obtained a settlement of \$554 M in a Historical Trust Asset Mismanagement Litigation against the federal government. In many instances, had to educate and obtain consent and approval by the Navajo Nation President and Council to accomplish the results.

- 3. Served as Navajo Nation Deputy Attorney General under the Shirley/Dayish Administration. Served as second in command with the Attorney General to supervise and administer the day to day operations of the Navajo Nation Department of Justice to accomplish its vision, mission and goals. Performed legal work for all branches of the Navajo Nation government including departments, divisions and programs. Worked primarily to develop gaming and the Desert Rock Energy Project and Navajo Transmission Line and provided support to settle the 1934 Navajo-Hopi Land Dispute.
- 4. Made numerous presentations to the Navajo Nation governmental bodies including the Office of the President and Vice-President, Navajo Nation Council and Standing Committees, Departments, Offices, Programs and Chapter regarding the legal interests of the Navajo Nation. The presentations were intertwined with tribal law, federal law, energy policies, environmental laws and business interests of the Navajo Nation and also all matters of legal interest to the Nation. Also interfaced and served on committees with governmental bodies including the federal government, state governments, Indian tribes and energy interest to advocate for polices and matters of common interest.
- 5. Interfaced with approximately 54 Indian tribes in the Southwest to inform and provide information regarding the Western Area Power Administrations hydro-electric power generated by various federal projects on the Colorado River System. Negotiated and contracted with Indian Tribes in the Salt Lake City Area Integrated Projects, generally including Wyoming, Colorado, New Mexico, Arizona, Utah and Nevada, for hydro-electric power generated by federal facilities. Participate as team member on all processes, from drafting contracts to contract administration of the Salt Lake City Area Integrated Project Post-2004 resource allocations. Helped to build coalitions among tribes, energy companies, state and local agencies and federal entities to accomplish the goals and objectives of delivering electric power to tribes.
- 6. Drafted and negotiated all contracts and other legal documents for Navajo Agricultural Products Industry (NAPI) during four years of employment. Key agreements relevant to this position included the P.L. 93-638 contracts held by NAPI with the Bureau of Indian Affairs. They include the Operation, Maintenance and Replace contract and the Scientific Lab contract. Also developed agreements with farming and cattle operators desiring to utilize the farm works as operators.
- 7. Served as one of two lead negotiators for NAPI to develop and participate in a \$150 M potato-processing project on the Navajo Indian Irrigation Project. Negotiated the four basic deal points including (1) risk of loss, (2) return, (3) control, and (4) duration. Also negotiated the critical issue of dispute resolution in Indian Country. Participated as team member to develop a French Fry Factory on the Navajo Indian Irrigation Project to draft the Factory Partnership Venture Agreement, Factory Lease Agreement, Growing Venture Agreement, Growing Lease Agreement, Potato Supply Agreement, Growing Sub-lease Agreement, and Utilities and Infrastructure Agreement.
