	16	(A) Pursuant to 2 N.N.C. §3352(B), the President of the Navajo Nation has the authority to	
	17	appoint members of the Navajo Tax Commission.	
	18	(B) The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council

	24	(A) The Navajo Tax Commission is established under the Executive Branch of the Navajo

	27	shall be enrolled Navajo Nation members. 2 N.N.C. §3352(A).

Pursuant to Navajo Nation 3 Council Resolution No. CO-45-12, the "Government Services Committee" now means 4 the Naabik'íyáti' Committee. 5 (D) Pursuant to 2 N.N.C. \$3352(C), the terms of office of commissioners shall be five (5) 6 years; provided however, that in order to stagger the expiration of terms of office, 7 March 31 of each year shall be the common anniversary date. 8 (E) Pursuant to 2 N.N.C. §3352(D), a commissioner shall be removed only for cause by 9 the President of the Navajo Nation and upon ratification by the Naabik'iyati' 10 Committee of the Navajo Nation Council; provided that the person so removed may 11 then appeal his/her removal to the Supreme Court of the Navajo Nation. For the purposes of this Subsection, "cause" means: 12 13 1. Incapacity. Physical or mental incapacity where such incapacity extends or is expected to extend longer than six months. 14 15 2. Nonfeasance. Failure to perform the duties of office, including, but not limited to, 16 repeated and unexcused failure to attend the meetings and other official functions of the Commission. 17 3. Ex parte violation. Participation in ex parte consultation with any representative of a 18 19 taxpayer who is an appellant in a dispute before or with the Commission. 4. Certain other acts. Any act that is a felony in the jurisdiction where committed, or 20 21 any act involving moral turpitude that is a misdemeanor in the jurisdiction where 22 committed. 5. A vacancy in the Commission, whether caused by death, removal, or resignation 23 shall be filled by an interim appointment to complete the vacated term made in 24 25 accordance with this Section. (F) By letter dated May 28, 2021, the President of the Navajo Nation appointed Shana 26 27 Barehand to serve on the Navajo Tax Commission. Letter attached as Exhibit A. 

#### Greetings President Nez:

I respectfully submit this letter of interest for my re appointment to the Navajo Tax Commission. I am Mono from California and I recently serve as the Tribal Liaison at the Washington State Department of Revenue. I have over twenty years of experience as an Indian Law attorney and even more experience working with tribes and tribal programs. Three of my children are Navajo citizens and my husband's family is from Chinle. I have a great respect for the Navajo Nation and I believe it has been a role model for all tribes. I would consider it a great honor to continue to serve the Navajo people.

For nine years I have worked in the area of tax policy and administration while with the Washington State Department of Revenue. Taxation, which is essentially law based on economic theory, when combined with Indian law, can become complicated. I am one of a handful of Native professionals with expert knowledge and real-world experience in the area of taxation. I am capable of seeing past the complexity, to provide consistent and fair answers and effective counsel for tax questions that are presented. I work for one of the most efficient state tax departments in the nation. It has won national awards for innovation and efficient tax administration. I would like to share my knowledge and experience from this Department with the Navajo Tax Commission and its Administration.

As part of my job, I kept apprised of current developments in tax policy and federal law. With this knowledge, I advised the Director and Governor on how to interpret Federal law or create policy that accurately reflects the law. These were often politically sensitive decisions, because nobody likes taxes.

Tax is a difficult area in which to work. One must constantly weigh the needs of the government and the burden on the taxpayer. One must consider its effect on the tribal economy, and look for ways to achieve the best compliance. My tax administrative experience will help guide the Navajo Tax Commission in achieving its goals. I think that my experience combined with the experience of the other Commissioners would assist the Commission in creating a fair and balanced tax system.
