RESOLUTION OF THE NAVAJO NATION COUNCIL 24th NAVAJO NATION COUNCIL -- First Year, 2019

AN ACTION

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE, NAABIK'ÍYÁTI' AND NAVAJO NATION COUNCIL; CONFIRMING THE NOMINATION OF CRYSTAL CREE, A GRADUATE STUDENT, TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT

BE IT ENACTED:

SECTION ONE. AUTHORITIES

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A). Pursuant to 2 N.N.C. § 972(A)(7), the committee has the authority to nominate a graduate student to the Navajo Government Development Commission.
- B. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council 2 N.N.C. § 700(A). Pursuant to 2 N.N.C. § 164 (A)(9), a proposed resolution that requires final action by the Navajo Nation Council must be assigned to the Naabik'íyáti' Committee before it is considered by the Navajo Nation Council.
- C. The Navajo Nation Council, pursuant to 2 N.N.C. §972(A), confirms appointments to the Commission on Navajo Government Development.

SECTION TWO. FINDINGS

A. The Commission on Navajo Government Development consists of 12 Navajo members. Regarding appointments to this commission, Navajo Nation law mandates - "Commission members shall be chosen from among individuals who have demonstrated scholarship, a strong sense of public interest, knowledge of Navajo history and cultural heritage, spiritual leadership,

leadership in the Navajo government and abilities likely to contribute to the fulfillment of the duties of the Commission." 2 N.N.C. § 972(D).

- B. Once appointed, members of the Commission on Navajo Government Development are confirmed by and serve at the pleasure of the Navajo Nation Council pursuant to 2 N.N.C. § 972(A).
- C. Concerning nomination and qualifications for the Commission on Navajo Government Development, Navajo Nation law provides "One member shall be nominated by the [Health, Education and Human Services] Committee of the Navajo Nation Council; the nominee shall be a graduate student from any accredited college or university, such member shall serve so long as said nominee is a full-time graduate student, but no longer than two years from the date of confirmation by the Navajo Nation Council." 2 N.N.C. § 972(A)(7).
- D. The Health, Education and Human Services Committee of the Navajo Nation Council nominates Crystal Cree to serve on and fill the graduate student position on the Commission on Navajo Government Development as provided at 2 N.N.C. § 972(A)(7). The nominee meets all the necessary qualifications to serve on the Commission. See attached Exhibit A, documents supporting appointment.

SECTION THREE. CONFIRMATION

Pursuant to 2 N.N.C. § 972(A)(7), graduate student requirements, the Navajo Nation Council hereby confirms the nomination of Crystal Cree to the Commission of Navajo Government Development. The term shall be served consistent with Navajo Nation law.

Over past few weeks, I've been approached by various stakeholders to resubmit my candidacy to the commission. After some serious consideration on my part, I've decided to seek re-nomination.

Last year, I graduated with a graduate certificate in Indigenous and Tribal Nation-Building, Leadership, Management, and Administration, and a Masters in Public Administration degree from Northern Arizona University. My education has trained me in all arenas of government and policy relations. Presently, I am a fultime doctorate student at West Chester University of Pennsylvania. I am seeking a Doctor of Public Administration with a concentration in Public Policy and Administration. The rigorous coursework honed my expertise in tribal policies, politics, and government administration. My study of indigenous environmental and human health sciences, policy, and management complements my knowledge of community economic development.

I currently work full-time as the Director of Legislative Affairs and Policy at Diné College. I oversee and direct legislative affairs and policy at the college. I also provide analysis and recommendation to the President and other leadership. I also oversee our development and alumni relations office. As an educated, experienced and trained member of the indigenous community. An essential component of this position is to have a comprehensive, overall working knowledge of the trust relationship, interaction, and policy goals of federal and tribal governments.
