# RESOLUTION OF THE BUDGET AND FINANCE COMMITTEE OF THE NAVAJO NATION COUNCIL

24<sup>TH</sup> NAVAJO NATION COUNCIL - Fourth Year, 2022

### AN ACTION

RELATING TO THE BUDGET AND FINANCE COMMITTEE; APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2023 BUDGET FOR THE GENERAL SERVICES DIVISION - INSURANCE SERVICES DEPARTMENT, RISK MANAGEMENT/SAFETY LOSS CONTROL, EMPLOYEE BENEFITS, WORKERS COMPENSATION, AND RELATED MATTERS, TO BE INCLUDED IN THE NAVAJO NATION'S FY2023 COMPREHENSIVE BUDGET

### BE IT ENACTED:

### SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee ("BFC") is a standing committee of the Navajo Nation Council with the oversight authority over the Insurance Services Department. 2 N.N.C. § 301(B)(13).
- B. Each Oversight Committee, including the BFC, shall review and make recommendations regarding the programs under its oversight responsibility, regarding the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year 12 N.N.C. § 840(A).

### SECTION TWO. FINDINGS

- A. The BFC held a meeting and took relevant testimony relating to the FY2023 Budget for the General Services Division-Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, and Workers Compensation.
- B. During these budget meetings, the BFC reviewed and considered the FY2023 Budget for the Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, and Workers Compensation as proposed by the Branch Chiefs and as commented upon by the public.

SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2023 BUDGET FOR THE GENERAL SERVICES DIVISION - INSURANCE SERVICES DEPARTMENT, RISK MANAGEMENT/SAFETY LOSS CONTROL, EMPLOYEE BENEFITS, WORKERS COMPENSATION, AND RELATED MATTERS

- A. The Budget and Finance Committee hereby approves the FY2023 Budget for the General Services Division Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, and Workers Compensation as detailed in the "Fund Type Budget Summary" attached hereto as Exhibit A.
- B. The BFC hereby approves certain revisions to the Branch Chiefs' proposed FY2023 Budget amount for the General Services Division Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, and Workers Compensation, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as Exhibit B.
- C. The BFC recommends certain changes to the General Fund Budget, as described in the attached **Exhibit C**.
- D. The BFC recommends certain Conditions of Appropriation and Legislative Concerns, as listed in **Exhibit D**.
- E. The BFC recommends that certain Unmet Needs for the General Services Division Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, and Workers Compensation be included in the Navajo Nation's FY2023 Comprehensive Budget, as explained in Exhibit E.
- F. The BFC hereby recommends that the Budget and Finance Committee approve the proposed FY2023 Budget for the General Services Division Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, and Workers Compensation, as well as all Committee recommendations, as set forth in the attached Exhibits A-E.
- G. As necessary and appropriate, the BFC hereby authorizes the BFC Chair and Vice-Chair to negotiate the BFC's recommendations herein with the Budget and Finance Committee, regarding the proposed FY2023 Budget for the General Services Division Insurance Services Department, Risk

Management/Safety Loss Control, Employee Benefits, and Workers Compensation.

### SECTION FOUR. EFFECTIVE DATE

This Act shall become effective as provided in 2 N.N.C. § 189(A).

### SECTION FIVE. SAVINGS CLAUSE

If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the remainder of this Act shall be the law of the Navajo Nation.

### CERTIFICATION
