**Section One. Authority**

- A. The Health, Education and Human Services Committee of the Navajo Nation Council has legislative authority and oversight over all matters related to education on the Navajo Nation. 2 N.N.C. § 401 (C) (1)
- B. The Naabik'iyati' Committee of the Navajo Nation Council has the legislative authority to authorize, review, approve and accept contracts implementing the Indian Self-Determination and Education Assistance Act, (P.L. 638, as amended; 25 U.S.C. 5301 *et seq.*) upon recommendation of the standing committee which has oversight of the division, department or program. 2 N.N.C. § 701(12)

**Section Two: Findings**

- 1 A. The United States Code (U.S.C.) Chapter 27: Tribally Controlled School Grants, §  
2 2502 (f) recognizes the authority of a tribal governing body to retrocede any  
3 program under Chapter 27 to the Bureau of Indian Education.
- 4 B. The Naabik'iyati' Committee of the Navajo Nation Council, upon recommendation of  
5 the education oversight of the Health, Education and Human Services Committee, is  
6 the tribal governing body in this matter.
- 7 C. The Navajo Nation Board of Education, in Board Resolution No. NNBEMY-438-2018,  
8 has recommended to the Health, Education and Human Services Committee and the  
9 Naabik'iyati' Committee that the Navajo Nation, in the best interest of the Navajo  
10 Nation, school, children and community, to retrocede the administrative control of the  
11 Alamo Navajo School System from the Alamo Navajo School Board, Inc. to the U.S.  
12 Bureau of Indian Education for continued operation as a Bureau operated school. See  
13 Exhibit A.
- 14 D. The Health, Education and Human Services Committee of the Navajo Nation Council  
15 finds it to be in the best interest of the Navajo Nation and the school, children and  
16 community for administrative control of the Alamo Navajo School System to be  
17 retroceded from the Alamo Navajo School Board, Inc. to the U.S. Bureau of Indian  
18 Education for continued operation as a Bureau operated school.
- 19 E. The Naabik'iyati' Committee of the Navajo Nation Council finds it to be in the best  
20 interest of the Navajo Nation and the school, children and community of Alamo Navajo  
21 for administrative control of the Alamo Navajo School System to be retroceded from the  
22 Alamo Navajo School Board, Inc. to the U.S. Bureau of Indian Education for continued  
23 operation as a Bureau operated school.

### 24 25 **Section Three. Approval**

- 26 A. The Health, Education and Human Services Committee of the Navajo Nation Council  
27 hereby approves the recommendation of the Navajo Nation School Board as found at  
28 Exhibit A, to retrocede, pursuant to 25 U.S.C. Ch. 27, §2502(f), administrative control of  
29 the Alamo Navajo School System from the Alamo Navajo School Board, Inc. to the U.S.  
30 Bureau of Indian Education for continued operation as a Bureau operated.

1 B. The Naabik'iyati' Committee of the Navajo Nation Council, as tribal governing body in  
2 this matter, hereby approves the recommendation of the Health, Education and Human  
3 Services Committee and the Navajo Nation School Board as found at Exhibit A, to  
4 retrocede, pursuant to 25 U.S.C. Ch. 27, §2502(f), administrative control of the Alamo  
5 Navajo School System from the Alamo Navajo School Board, Inc. to the U.S. Bureau of  
6 Indian Education for continued operation as a Bureau operated.

7 C. The Navajo Nation reserves the right, upon the future determination of the best interest of  
8 the Navajo Nation, to request the return of the Alamo Navajo School System to  
9 community control.

10 D. The Superintendent of the Navajo Nation Department of Diné Education is hereby  
11 authorized to notify the U.S. Bureau of Indian Education and all other necessary parties  
12 of this action of the tribal governing body.

**RESOLUTION OF THE  
NAVAJO NATION BOARD OF EDUCATION**

**Relating to Education; Recommending to the Health, Education, and Human Services Committee and Naabik'iyati' Committee to Retrocede the Alamo Navajo School Board, Inc. to the Federal Government Pursuant to Public Law 100-297 and Public 93-638 (as amended).**

**WHEREAS:**

1. The Navajo Nation Board of Education (hereinafter the “Board”) is the education agent in the Executive Branch for the purposes of overseeing the operation of all schools serving the Navajo Nation. 10 N.N.C. § 106 (A). The Board carries out its duties and responsibilities through the Department of Diné Education (hereinafter the “Department”). 10 N.N.C. §106 (G)(3).
2. Pursuant to 10 N.N.C. § 107 (B), the Department is under the immediate direction of the Navajo Nation Board of Education. Further, the Department is the administrative agency within the Navajo Nation with responsibility and authority for implementing and enforcing the educational laws of the Navajo Nation. 2 N.N.C. § 1801 (B); 10 N.N.C. § 107 (A).
3. “The Board [has the] general power to monitor the activities of all Bureau of Indian Affairs funded schools and local community school boards serving the Navajo Nation.” 10 N.N.C. § 106 (G)(1).
4. The Health, Education, and Human Services Committee is the oversight committee for the Department of Diné Education and Navajo Nation Board of Education. 2 N.N.C. § 401 (C)(1); 10 N.N.C. § 1(B). The Health, Education, and Human Services Committee of the Navajo Nation Council is empowered to “review, sanction and authorize applications, reapplications and amendments for Indian Self-Determination Act contracts and grants under the Tribally Controlled Schools Act for the operation of education programs... approval or denial of authorizations and reauthorizations shall constitute approval or denial by the Navajo Nation (as) the Tribal Governing Body.” 2 N.N.C. § 401 (B)(4)(b).
5. The Alamo Navajo School Board, Inc. is a tribally controlled Public Law 100-297 grant school (“tribal organization”) that is operating under the authorization, sanction, and jurisdiction of the Navajo Nation.
6. After discussion and deliberation, the Board has determined that continued operation of the Alamo Navajo School Board, Inc. in its present capacity will not result in any improvements to the operations of the school or achievement of its educational mission. Further, the Board has determined

that continued operation of the Alamo Navajo School Board, Inc. will result in significant harm the education of children who attend that school.


7. The Board also acknowledges that retrocession is an act of the Navajo Nation's inherent sovereignty and decision that the federal government must respect. Pursuant to 25 C.F.R. § 900(b)(4)-(5), "the Secretary (of Interior) recognizes that contracting under the Act is an exercise by Indian tribes of the government-to-government relationship between the United States and the Indian tribes... The Secretary recognizes that tribal decisions to contract or not to contract are equal expressions of self-determination."
8. The Board acknowledges recommendations provided by the Department of Diné Education regarding the Alamo Navajo School Board, Inc., including the recommendation to retrocede the school to the federal government as being in the best interests of the school, children and community. Pursuant to 25 U.S.C. §2502(f)(2), the Department and Board, through the Navajo Nation, recommends that the Navajo Nation to request that the retroceded school/program continue its operation as a Bureau-operated school.

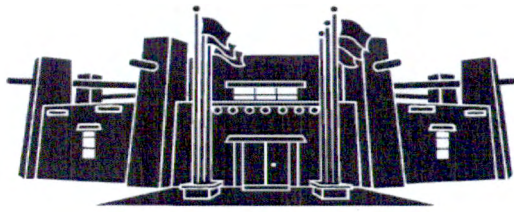
**NOW THEREFORE BE IT RESOLVED THAT:**

Pursuant to 25 U.S.C. §2502(f)(2), the Department and Board recommends that the Navajo Nation to request that the retroceded school/program continue its operation as a Bureau-operated school.
2. The Navajo Nation Board of Education hereby recommends and empowers the Superintendent of Schools to take any actions deemed as necessary and proper to carry out the purposes of this resolution.



Dear Speaker Hale,

This report is respectfully submitted to demonstrate actions taken by the Alamo Navajo School Board, Incorporated, to address concerns raised to the attention of the Naabikiyati. We trust that these substantial actions demonstrate good faith in satisfying those concerns, and we respectfully request that Naabikiyati delegates oppose Navajo Legislative Bill #0195-18 and allow the community of Alamo to maintain administrative control of the Alamo Navajo School System.

1. The Alamo Navajo School Board voted to withdraw the lawsuit against Navajo Nation Department of Dine Education No NNDC no. AL-CV-2016-002
  - a. Order of Dismissal granted by the District Court of the Navajo Nation, Judicial district of Alamo
  - b. Department of Dine Education is now welcomed to Alamo to monitor and conduct their reviews on the Alamo Navajo School Board Inc. operations under PL 100-297 programs
  - c. Darrick Franklin, Department of Dine Education and other DODE officials met with the CEO and Alamo School Principal to begin dialog
  - d. Darrick Franklin, Department of Dine Education attended the ANSB Regular monthly board meeting on July 26, 2018
2. Recall petitions for 3 Board members have been approved by the Navajo Nation Election Administration
  - a. Board members filed appeals on their recall, hearing scheduled for September 2018
3. Department of Interior Inspector General and Navajo Nation White Collar Crime Unit both conducted an onsite preliminary investigation of ANSBI Board matters
  - a. White Collar Crime Unit follow-up onsite visit is scheduled the week of August 20, 2018
  - b. Department of Interior Inspector General Personnel were onsite to interview School Board Members on June 19, 2018

4. Complied with all terms and conditions imposed by the BIE in their High Risk Sanction letter dated May 15, 2018
  - a. Monthly drawdown of all programs funds awarded through Indian Affairs Bureau of Indian Education beginning May 15, 2018 through June 30, 2019
  - b. Monthly Federal Financial Reports SF 425s due on the 30<sup>th</sup> of each month beginning with May 30<sup>th</sup> throughout the remainder of the School Year 2017-2018 and new School Year 2018-2019
  - c. Along with the monthly SF 425s the school is attaching copies of all expenditure and revenue reports for each month for all program funds


