- D. A standing committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight. 2 N.N.C. §185(A).
- E. A reallocation of funds must be approved "by two-thirds (2/3) vote of the full membership of the committee, board or commission." 2 N.N.C. §185(A).

SECTION TWO. FINDINGS

- A. The Office of the Speaker, Legislative Branch, is requesting a reallocation of funds in the amount of \$224,000 from the Business Unit Number 101015 to Business Unit Number New Project Account. The Budget Revision Request is attached as **Exhibit** A.
- B. The budget reallocation is requested to cover multiple renovation projects as set forth in **Exhibit A**.

SECTION THREE. APPROVAL OF REALLOCATION
