## RESOLUTION OF THE LAW AND ORDER COMMITTEE OF THE 25th NAVAJO NATION COUNCIL - FIRST YEAR, 2023

### AN ACTION

RELATING TO THE LAW AND ORDER COMMITTEE; APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE NAVAJO NATION OFFICE OF PUBLIC DEFENDER AND RELATED MATTERS, TO BE INCLUDED IN THE NAVAJO NATION'S FY2024 COMPREHENSIVE BUDGET

## BE IT ENACTED:

### SECTION ONE. AUTHORITY

- A. The Law and Order Committee ("LOC") is a standing committee of the Navajo Nation Council with oversight authority over the Navajo Nation Office of Public Defender ("Public Defender"). 2 N.N.C. §600(A); 2 N.N.C. §601(C)(1).
- B. Each Oversight Committee, including the Law and Order Committee, shall review and make recommendations regarding the programs under its oversight responsibility for the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

## SECTION TWO. FINDINGS

- A. Pursuant to 12 N.N.C. §840(A), each Oversight Committee, including the Law and Order Committee, "shall review and make recommendations to the Budget and Finance Committee concerning the budget[s]" for the Programs they oversee. 12 N.N.C. §840(A) further provides that Oversight Committee recommendations shall not exceed the base planning amounts established in the FY2024 Budget Instructions Manual. The base planning amounts were established by the Budget and Finance Committee in the FY2024 Budget Instructions Manual (see Resolution No. BFJY-15-23).
- B. In accordance with 12 N.N.C. §840(A), the Law and Order Committee held public meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed FY2024 Budget for the Navajo Nation Office of Public Defender.

- C. During these budget meetings, the Law and Order Committee reviewed and considered the proposed FY2024 Budget for the Navajo Nation Office of Public Defender, as compared to the base planning amounts established in the FY2024 Budget Instructions Manual and as recommended by the Office of Management and Budget.
- D. The Law and Order Committee finds that approval of the proposed FY2024 Budget for the Navajo Nation Office of Public Defender and inclusion of such Budget in the Navajo Nation's FY2024 Comprehensive Budget is in the best interest of the Navajo Nation.

## SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE NAVAJO NATION OFFICE OF PUBLIC DEFENDER AND RELATED MATTERS

- A. The Law and Order Committee hereby approves the FY2024 Budget for the Navajo Nation Office of Public Defender, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit**A.
- B. The Law and Order Committee hereby approves certain revisions to the Branch Chiefs' proposed FY2024 Budget amount for the Navajo Nation Office of Public Defender, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**.
- C. The Law and Order Committee recommends the changes to the General Fund Budget described in **Exhibit C**.
- D. The Law and Order Committee recommends certain Conditions of Appropriation and Legislative Concerns, as listed in **Exhibit** D.
- E. The Law and Order Committee recommends that certain Unmet Needs for the Navajo Nation Office of Public Defender be included in the FY2024 Comprehensive Budget, as explained in Exhibit E.
- F. The Law and Order Committee hereby recommends that the Budget and Finance Committee approve the Navajo Nation Office of Public Defender FY2024 Budget and all Committee recommendations, as set forth in **Exhibits A E**.
- G. As necessary and appropriate, the Law and Order Committee

hereby authorizes the Chair and Vice-Chair to negotiate the Law and Order Committee recommendations herein with the Budget and Finance Committee.

## SECTION FOUR. EFFECTIVE DATE

This Action shall become effective as provided in 2 N.N.C. §189(A).
