BE IT ENACTED:

**Section One. Authority**

- A. The Navajo Department of Workforce Development is a department within the Navajo Nation Division of Human Resources. The Health, Education, and Human Services Committee is the oversight committee for the Navajo Division of Human Resources. 2 N.N.C. § 400(C)(1).
- B. The Budget and Finance Committee is charged with receiving and approving audit reports from the Auditor General. 12 N.N.C. §6(A) and 12 N.N.C. §7(D). The Budget and Finance Committee also, “determines what action should be taken” after the follow-up review conducted by the Auditor General and based on any recommendations by the oversight committee. 12 N.N.C. § 7(I).

**Section Two. Findings**

1 A. The Budget and Finance Committee approved the Navajo Department of Workforce  
2 Development's ("NDWD") Corrective Action Plan pursuant to Budget and Finance  
3 Committee resolution BFCF-03-09, "Accepting the Special Review of the Navajo  
4 Department of Workforce Development Submitted by the Office of the Auditor  
5 General and Approving the Corrective Action Plan Submitted by the Navajo  
6 Department of Workforce Development," on February 17, 2009, which is attached as  
7 **Exhibit A.**

8 B. The Budget and Finance Committee imposed sanctions upon the NDWD Department  
9 Manager on April 1, 2014 through Resolution BFAP-11-14, "Accepting the Follow-  
10 Up Review of the Navajo Department of Workforce Development Corrective Action  
11 Plan Implementation and Imposing Sanctions Against the Department Manager."  
12 This resolution is attached as **Exhibit B.**

13 C. The Office of the Auditor General's Plan of Operation provides, "[o]nce proof of  
14 implementation of the corrective action plan is demonstrated, the Auditor General  
15 shall immediately report this compliance to the Controller and, where applicable, the  
16 chapter government, who shall then release the withheld salary to the director of the  
17 program, division, enterprise or entity or to the chapter official." 12 N.N.C. § 9(C).

18 D. To date, NDWD has been unable to successfully implement the corrective action  
19 plan. As a result, the Auditor General is not able to report its compliance to the  
20 Controller.

21 E. The Department Manager, who was sanctioned in 2009, is no longer employed with  
22 the Navajo Nation and is unable to oversee the implementation of NDWD's  
23 corrective action plan. As a result, all payments withheld pursuant to Resolution  
24 BFAP-11-14 shall be returned.

26 **Section Three. Rescinding BFAP-11-14, "Accepting a Follow-Up Review of the**  
27 **Navajo Department of Workforce Development Corrective Action Plan**  
28 **Implementation and Imposing Sanctions Against the Department Manager"**

29 The Navajo Nation hereby rescinds BFAP-11-14, which imposed sanctions on the  
30 Department Manager of NDWD.



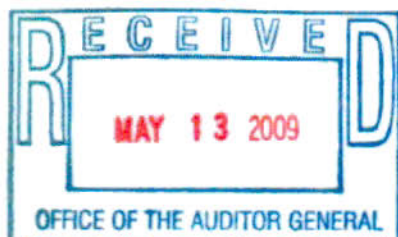
1       **Section Four. Directive to the Office of the Auditor General to Conduct a Follow-**  
2       **Up Review**

3       The Navajo Nation hereby directs the Office of the Auditor General to conduct a follow-  
4       up review upon NDWD the within one year from the date this resolution and to make  
5       recommendations to the oversight committee and to the Budget and Finance Committee.

7       **Section Five. Directive to the Office of the Controller to return payments held**  
8       **pursuant to BFAP-11-14**

9       The Office of the Controller is directed to release all salary payments withheld pursuant  
10      to BFAP-11-14 to all individuals impacted by BFAP-11-14 at the earliest possible pay  
11      cycle after the approval of this legislation.

**BE IT ENACTED:**

1. The Navajo Nation hereby accepts Audit Report No. 08-27, the Special Review of the Navajo Department of Workforce Development, and approves the Navajo Department of Workforce Development corrective action plan, hereto attached as Exhibits A and B, respectively.
2. The Navajo Nation hereby directs that copies of the Navajo Department of Workforce Development corrective action plan be provided to the Office of the President/Vice-President, and the Human Services Committee, as part of their oversight responsibilities for the Navajo Department of Workforce Development.
3. The Navajo Nation hereby directs the Navajo Department of Workforce Development to submit a written status report on their progress in implementation of the corrective action plan to the Office of the Auditor General six months after the approval of this resolution.
4. The Navajo Nation hereby directs the Office of the Auditor General to review the written status report to be submitted by the Navajo Department of Workforce Development and report to the Human Services Committee, as well as the Budget and Finance Committee.
5. The Navajo Nation hereby directs the Office of the Auditor General to conduct a follow-up review twelve months after the approval of this resolution to verify actions claimed to have been taken by the Navajo Department of Workforce Development, to issue a written follow-up report indicating the Navajo Department of Workforce Development progress in implementing the corrective action plan, and to make recommendations to the Human Services Committee, as well as the Budget and Finance Committee.

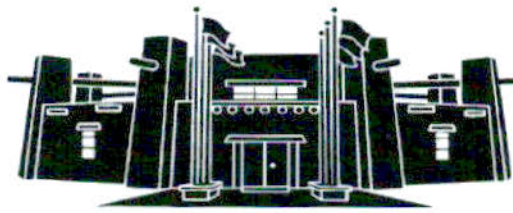
BE IT ENACTED:






