to allocate \$5,000,000 from the Síhasin Fund to the Division of Economic Development for the planning, design, and construction of the Chilchinbeto Chapter Convenience Store/Fuel Station Project.

AN ACT

RELATING TO THE RESOURCES AND DEVELOPMENT, BUDGET  
AND FINANCE, AND NAABIK'ÍYÁTI' COMMITTEES, AND TO  
THE NAVAJO NATION COUNCIL; ALLOCATING \$5,000,000 FROM  
THE SÍHASIN FUND FOR THE CHILCHINBETO CONVENIENCE  
STORE/FUEL STATION PROJECT; APPROVING THE RELATED  
EXPENDITURE PLAN PURSUANT TO 12 N.N.C. §2501 – §2508

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council with oversight authority over all 110 Navajo Nation Chapters. 2 N.N.C. §500(C); 26 N.N.C. §102.
- B. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with the responsibility to “review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds.” 2 N.N.C. §301(B)(2).
- C. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council that considers all proposed final actions by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
- D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).
- As such, the Council may approve appropriations from the Navajo Nation's Síhasin Fund.

1 E. 12 N.N.C. §2502, as amended by CJA-03-18, states the purpose of the Navajo Nation Síhasin  
2 Fund (“Síhasin Fund”) as follows:

3 §2502 Purpose

4 A. The purposes of this Fund are to provide financial support and/or financing for:

- 5 1. The planning and development of economic development and regional  
6 infrastructure supporting economic development and community  
7 development, including such infrastructure as, but not limited to,  
8 housing, commercial and government buildings, waterline, solid waste  
9 management development, powerline projects, and transportation and  
10 communication systems, within the Navajo Nation; . . .

11 B. For the Purpose in §2502(A)(1), Fund expenditures for infrastructure shall not  
12 be limited by 12 N.N.C. §1310(F) or TCDCJY-77-99.

13 C. Leveraging the Fund by way of guaranteeing loans, match funding, direct  
14 funding in part, and other weighted uses of the Fund, including loan financing  
15 from the Fund, for the purposes in §2502(A)(1), shall be favored over direct  
16 funding in whole.

17 F. The Síhasin Fund provides that “Fund Principal” shall consist of all deposits made to the  
18 Síhasin Fund and that “Fund Income” shall consist of all earnings (interest, dividends, etc.)  
19 generated and realized by the Fund Principal, and that Síhasin Fund Income shall be  
20 deposited in, and added to, the Fund Principal until such time as a Fund Expenditure Plan is  
21 duly approved. 12 N.N.C. §2504 and §2505(C).

22 G. The Síhasin Fund provides that “Fund Principal and Income shall not be expended except  
23 pursuant to a Fund Expenditure Plan consistent with the purposes set forth in §2502 of this  
24 Chapter and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation  
25 Council.” 12 N.N.C. §2505(A).

26  
27 **SECTION TWO. FINDINGS**

28 A. The Division of Economic Development (“DED”), on behalf of the Chłłchinbeto Chapter, is  
29 requesting \$5,000,000 from the Síhasin Fund for the planning, design, and construction of a  
30 proposed Convenience Store/Fuel Station Project (“Project”) in the Chapter. DED explains

1 its request for funds in its previous ARPA-FRF funding request, attached hereto as  
2 **EXHIBIT A.**

3 B. The Chilchinbeto Chapter fully supports the Project and its Council Delegate's efforts to  
4 secure funding for the Project. Resolution No. CCH-20-14-2021A, dated October 14th, 2021,  
5 attached as **EXHIBIT B.**

6 C. DED has prepared a "Program Budget Summary" and a line-item breakdown of all estimated  
7 Project costs. **EXHIBIT C.**

8 D. Red Mesa Fuel and Convenience Retailers, out of Farmington, New Mexico, has provided a  
9 Letter of Intent regarding its intention to assist with the Project by installing modern fuel  
10 dispensers and a canopy over fueling areas, constructing a self-service laundromat, and  
11 operating a U.S. Post Office inside the finished convenience store. **EXHIBIT D.**

12 E. Allocation of the \$5,000,000 as requested by DED meets the criteria for Síhasin expenditures  
13 because the proposed expenditure involves a "commercial building" project and "economic  
14 development" in Chilchinbeto, as described in 12 N.N.C. §2502(A)(1).

15 F. Given the lack of services in the Chilchinbeto area, the Navajo Nation finds that providing  
16 DED with the requested \$5,000,000 in Síhasin Funds is in the best interest of the Navajo  
17 Nation and the Navajo People.

18  
19 **SECTION THREE. ALLOCATING \$5,000,000 FROM THE SÍHASIN FUND FOR**  
20 **THE CHILCHINBETO CONVENIENCE STORE/FUEL**  
21 **STATION PROJECT; APPROVING THE RELATED**  
22 **EXPENDITURE PLAN FOR THE PROJECT**

23 A. In accordance with 12 N.N.C. §2505(A), the Navajo Nation hereby approves \$5,000,000 out  
24 of the Síhasin Fund for the Chilchinbeto Convenience Store/Fuel Station Project, as  
25 explained in the attached EXHIBIT A and EXHIBIT C.

26 B. The \$5,000,000 in Síhasin funds approved herein may be further leveraged by bond or loan  
27 financing pursuant to the Navajo Nation Bond Financing Act (12 N.N.C. §1300 *et seq.*, as  
28 amended), using Síhasin Fund earnings for repayment and financing costs, upon approval of  
29 the Budget and Finance Committee and upon further approval by a two-thirds (2/3) vote of  
30 the full membership of the Navajo Nation Council.

1 C. The Controller shall determine whether the source of the \$5,000,000 approved herein will be  
2 Síhasin Fund Principal or Síhasin Fund Income, or a combination of both.

3 D. The Navajo Nation hereby approves the Expenditure Plan for the Chł̄chinbeto Convenience  
4 Store/Fuel Station Project, as set forth in the attached EXHIBIT A and EXHIBIT C.

5 E. The \$5,000,000 approved herein shall be disbursed to DED within twenty (20) business days  
6 after the effective date of this Act. DED shall then arrange for use of the \$5,000,000 for the  
7 planning, design, and construction of the Chł̄chinbeto Convenience Store/Fuel Station  
8 Project.

9 F. The DED shall be responsible for ensuring compliance with the Project's Expenditure Plan,  
10 as well as all Navajo Nation laws and regulations pertaining to the Project.

11 G. Any and all savings or unused amounts of the Síhasin funds approved herein shall be  
12 immediately returned to the Síhasin Fund Principal once the Project is completed, or upon  
13 the reversion deadline in Section Three (H) below.

14 H. The \$5,000,000 shall not lapse on an annual basis, which would otherwise occur pursuant to  
15 12 N.N.C. §820(N). However, any Síhasin funds not spent or encumbered within twenty-  
16 four (24) months of the date DED receives the \$5,000,000 shall then immediately revert to  
17 the Síhasin Fund Principal, unless otherwise approved by both the Resources and  
18 Development Committee and the Naabik'íyáti' Committee of the Navajo Nation Council.

19 I. The Síhasin Fund shall be reimbursed the \$5,000,000 amount approved herein, from funds  
20 available to the Navajo Nation from any and all state and federal sources, including  
21 Congressional appropriations under the American Rescue Plan Act of 2021 or other COVID-  
22 19-related relief, so long as the Project expenditures described herein are deemed eligible  
23 under such COVID-19-related or other funding sources.

#### 24 25 **SECTION FOUR. EFFECTIVE DATE**

26 This Act and the approved Expenditure Plan for the Chł̄chinbeto Convenience Store/Fuel  
27 Station Project shall become effective pursuant to 12 N.N.C. §2505.

#### 28 29 **SECTION FIVE. SAVING CLAUSE**

30 If any portion of this Act is invalidated by the Supreme Court of the Navajo Nation, or by any

1 Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the  
2 remainder of this Act shall be the law of the Navajo Nation.

(a) Describe the Program(s) and/or Project(s) to be funded, including how the funds will be used, for what purposes, the location(s) to be served, and what COVID-related needs will be addressed:

Chilchinbeto Convenient Store will be constructed using the ARPA funds in the 5,000,000 million dollars. The store, gas station, and the laundry mat will be occupied by and operator who will pay lease to the Navajo Nation. The community of Chilchinbeto be served by the new development after completion. During the Covid-19 pandemic the Chilchinbeto community was an effected area by the virus. During these uncertian time the community was isolated and didn't have a store, gas station, and laundry mat for taking care of personal amenities needed by the community members. Shopping center were miles away 25 mile to northwest and 34 mile to the southeast was the nearest store with less infected resident residing there. Communities should have access to its own resources, like now during the Covid-19 pandemic, and for the safety of the community.

Chilchinbeto is a rural area with many miles of travel to the grocery stores, gas station, and laundry mats. The convenient store will help the community boost their economy, buy food, fuel for their vehicle, home, and cooking. Employment opportunity for people living in the area. The availability of Luandry mat where people can go to wash their clothes. For those that do not has washing machine ot running water or traveler who are visiting the area. Chilchinbeto has a 75% unemployment rate and about 70% improvish rural community of 600 people.

Phase 3: Architectural and site plan designs for building and Electrical extension and design.

Phase 4: Construction of 4,000 sq. feet convenient store building; electrical line extension, Underground storage tanks installation.

Chilchinbeto, DED, SBDD, and WRBDO were working on developing the area prior to the COVID-19 Pandemic. The community has about 500 members, with existing economic disparities, and plans are in place to expand the community by building a convenient store, gas station, and laundry mat. Qualifies under Navajo County, AZ and is designated as economically disadvantaged communities by HUD's "Qualified Census Tracts and Difficult Development Areas" data

This project development will increase local spending and reduce travel to border town/cities. The dollars will stay within the Navajo Nation and will provide jobs for the community of Chilchinbeto.

2. THE OWNER SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS.
3. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY UTILITIES INFORMATION.
4. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY EROSION CONTROL MEASURES.
5. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY TRAFFIC CONTROL MEASURES.
6. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY FLOOD DAMAGE PREVENTION MEASURES.
