PURPOSE: The purpose of this proposed resolution is reaffirm Navajo Nation Council Resolution CM-9-50; to direct the Resources and Development Committee to direct the divisions and departments under its oversight to comply with CM-9-50; and to direct the Navajo Nation Division of Transportation to report annually the compliance with CM-9-50.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

29	Section One. Findings	
30		

- A. In 1989 the Navajo Nation Council through Resolution CD-68-89 established a three branch government with the Navajo Nation Council as the legislative body of the Navajo Nation government. Prior to the enactment of CD-68-89 the Advisory Committee was one of the committees Navajo Nation Council. When the Navajo Nation Council passed Resolution CD-68-89, it stated that references to the Advisory Committee would refer to the Government Services Committee.
- B. By Initiative of the Navajo People, the Navajo Nation Council was reduced in number of delegates from 88 to 24. The reduction of the number of delegates initiated the change in the number of the Navajo Nation Council's standing committees from twelve to five and provided for the committee's authorities. See, CAP-10-11 and CO-45-12.
- C. The Government Services Committee, the Resources Committee and the Transportation and Community Development Committees ceased to exist and their functions were divided among the newly established five standing committees. One of the five standing committees is the Resources and Development Committee. 2 N.N.C. § 500.
- D. The Navajo Nation Council has delegated to the Resources and Development Committee oversight authority over land, rights-of-way and surface disturbances, roads, economic and community development, commerce, and housing. 2 N.N.C. § 500(C).
- E. In 1950 the Navajo Nation Council passed Resolution CM-9-50, attached as Exhibit "A." (Exhibit "A" contains the signed version of CM-9-50 and a "PERMANENT FILE-NAVAJO TRIBE ARCHIVE COPY" which is easier typed in larger print.) In the Whereas section of Resolution CM-9-50, it states that "the Navajo Tribe deems it advisable to control all business enterprises, structures, installations, and any other developments for a distance of seven hundred fifty (750) feet on both sides of the right-of-way of all constructed and maintained roads on tribal lands[.]"

- F. Navajo Nation Council Resolution CM-9-50 stated "that controlled zones of seven hundred fifty (750) feet on both sides of the rights-of-way of any constructed, maintained, or proposed new roads are hereby established. The Advisory Committee of the Navajo Tribal Council shall have full authority, acting for the Navajo Tribal Council, to make and regulate any installations and specify conditions which must be met to receive a permit or lease in said zones, subject to the approval of the General Superintendent of the Navajo Agency. This authority shall not be construed to regulate the control of engineering structures required in the construction of roads, water development, soil and moisture conservation structures, or any other land improvements to be made by the government for the benefit of the Navajo Tribe of Indians, nor shall this authority be construed to restrict the use of land within such zones for grazing and farming by individuals Navajo Indians who may have recognized use rights of tribal lands within such zones."
- G. The Resources and Development Committee has oversight authority over the Navajo Division of Natural Resources, the Navajo Division of Economic Development, the Navajo Division of Community Development and the Navajo Division of Transportation. 2 N.N.C. § 501(C).
- H. A proposed resolution that requires final action by the Navajo Nation Council shall be assigned to the Naabik'íyáti' Committee before it is heard by the Navajo Nation Council. 2 N.N.C. § 164 (A)(9).
- I. The Navajo Nation Council believes it is in the best interest of the Navajo Nation to reaffirm Navajo Nation Council Resolution CM-9-50 and to direct the Resources and Development Committee to direct the divisions and departments under its oversight to develop procedures to ensure compliance with CM-9-50.

Section Two. Reaffirming Navajo Nation Council Resolution CM-9-50

The Navajo Nation Council hereby reaffirms CM-9-50, attached hereto as Exhibit "A."

Section Three. Directing the Resources and Development Committee

- A. Directing the Resources and Development Committee to direct the Navajo Division of Natural Resources, the Navajo Division of Economic Development and the Navajo Division of Community Development to submit proposed amendments to the rules and regulations for homesite leases, business site leases, rights-of-way and other land use authorizations demonstrating compliance with Navajo Nation Council Resolution CM-9-50.
- B. Directing the Resources and Development Committee to direct the Navajo Division of Transportation to report annually, during the second week of May, to the Resources and Development Committee the Navajo Nation Division of Natural Resources', the Navajo Nation Division of Economic Development's and the Navajo Nation Division of Community Development's compliance or non-compliance with CM-9-50.

THEREAS, the government has constructed and plans to construct and maintain additional roads on the Revajo Reservation, and

THERMAS, the Havajo Tribe decas it advisable to control all business outerprises, structures, installations and any other developments for a distance of seven hundred fifty (750) feet on both sides of the right-way of all constructed and maintained roads on tribal lands;

HEREFORE, SE IT PESSITED, that controlled zones of eaven bundred fifty (750) foot on both sides of the right-of-way of any constructed, maintained, or proposed new roads are hereby established. The Advisory Committee of the Havajo Tribal Commoil shall have full authority, acting for the Havajo Tribal Commoil, to make and regulate any installations, to receive applications, grant permits or leases, establish rental rates, require submission of plans for proposed installations and specify conditions which rust be not to receive a parmit or lease in said somes, subject to the approval of the General Superintendent of the Bevajo Agency. This authority shall not be expetreed to regulate the control of engineering structures required in the construction of roots, water development, soil and soisture conservation structures, or any other land improvements to be sade by the government for the bonefit of the Newsjo Tribs of Indians, nor shall this authority be construed to restrict the use of land within such some for graving and farming by individuals Havajo Indians who may have recognised use rights of tribal lands within such somes.

This authority shall not be construed to regulate the control of engineering structures required in the construction of roads, water development, soil and mositure conservation structures, or any other land improvements to be made by the government for the benefit of the Navajo Tribe of Indians, nor shall this authority be construed to restrict the use of land within such zones for grazing and farming by individuals Navajo Indians who may have recognized use rights of tribal lands within such zones.


