TITLE OF RESOLUTION: AN ACTION RELATING TO AN EMERGENCY FOR THE NAVAJO NATION; WAIVING 11 N.N.C. §§ 3(B), (C) AND 6(A); POSTPONING THE 2020 NAVAJO NATION CHAPTER ELECTIONS FOR ONE YEAR AND EXTENDING THE CURRENT TERMS OF OFFICE FOR SUCH TIME; AND RESCINDING CJN-49-20 AND CJY-60-20

**PURPOSE:** This emergency resolution, if adopted, would waive 11 N.N.C. §§ 3(B), (C), 6(A), postpone the 2020 Navajo Nation Chapter Elections for one year and extend current terms of office for such time. The action would also rescind CJN-49-20 (a previous resolution cancelling the primary election in the 2020 Chapter Elections and setting only one election for November 2, 2020) and CJY-60-20 (overriding veto).

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

#### **SECTION ONE. AUTHORITY**

1. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).

2. Pursuant to 2 N.N.C. §164(A)(16):

"Matters constituting an emergency shall be limited to the cessation of law enforcement services, disaster relief services, fire protection services or other direct services required as an entitlement under the Navajo Nation or Federal law, or which directly threaten the sovereignty of the Navajo Nation. Such an emergency matter must arise due to the pressing public need for such resolution(s) and must be a matter requiring final action by the Council. "2 N.N.C. §164 (A) (16). 3. Ensuring the health and safety of all residents and employees within the Navajo Nation is an inherent attribute of sovereignty.

#### SECTION TWO. FINDINGS

 COVID-19 is a dangerous respiratory virus. There have been over 500 deaths within the Navajo Nation to date due to the virus. Although positive tests have declined within the Navajo Nation, there is no vaccine for Covid-19 and the danger is still very imminent.
There have been significant increases in Covid-19 cases on the Navajo Nation once more, and, consequently, the Office of the President and Vice-President has issued another Public Health Emergency Order on September 22, 2020, prompting the reimplementation of a 57-hour weekend lockdown to begin at 8:00 p.m. on Friday, September 25, 2020.

3. On-going Navajo Nation Public Health Emergency Orders, first issued in March, 2020, restricting in person gatherings, requiring the wearing of masks and requiring Navajo Nation residents to stay at home are still in full force and effect today.

4. Due to Covid-19 health concerns, the Navajo Nation Council, on July 01, 2020, by resolution CJY-54-20 cancelled all of the Tribal Fairs, Rodeos and Ropings held on the Navajo Nation, "due to the highly contagious nature of Covid-19, Dikos Nitsaaígíí Náhast'éíts'áadah, and the need to prevent spread of the virus and to protect our Navajo people from being infected by this virus, it is necessary to cancel all the fairs, rodeos and roping events that would ordinarily be held on the Navajo Nation during 2020".

5. The Navajo Nation Council also cancelled all physical public meetings: Navajo Nation Council Session, Oversight Committee meetings, Chapter Meetings and other physical public meetings to prevent the spread of the deadly virus. Instead, the Navajo Nation Council instituted meetings held via telephone.

6. All of these cancellations were to ensure that the Navajo People were not subject to the deadly infections of Covid-19.

7. Finally, due to Covid-19 health concerns, the Navajo Nation Council, on June 19, 2020, by resolution CJN-49-20 cancelled the 2020 Chapter Primary Elections. It was determined that one election would be conducted on November 3, 2020, with candidates

elected by plurality vote. Although the resolution was vetoed by the Navajo Nation President, the Council overrode the veto by resolution CJY-60-20. See Exhibit A.

8. As a result of Council's action, two lawsuits were filed. One concerns the cancelled primary election (*Brown v. Navajo Nation*, WR-CV-62-20), and the other concerns the apportionment plan adopted for school boards for the next term (*Chavez v. Navajo Nation et al.*, WR-CV-55-20).

9. In both legal actions, the plaintiffs filed Motions for Injunctive Relief to enjoin the Navajo Nation from holding the 2020 Navajo Nation Chapter Elections. If the plaintiffs prevail on their Motions for Injunctive Relief, the 2020 Navajo Nation Chapter Elections will be enjoined. This will undoubtedly create confusion and will subject the Navajo Nation voters to possible disenfranchisement and prompt further legal action.

10. A postponement of the 2020 Navajo Nation Chapter Elections until 2021 will ensure that the postponed Chapter Elections will not be interrupted by any Court Orders as the legal issues raised in the two lawsuits mentioned herein would have been resolved by the time the filing period begins and the Primary Elections are held in 2021; the pending lawsuits will have been heard by the Courts, a ruling issued or the parties may have settled the matter.

11. For as long as the Navajo people have been exercising their right to vote, the Navajo People are very use to voting in person at each of the polling site. That pattern has not changed to date. Thereby, the majority of the Navajo People voting on November 03, 2020 will vote in person.

12. The State and Federal elections will be held concurrently with the 2020 Navajo Nation Chapter Elections. However, the Arizona, New Mexico and Utah Secretary of State offices have instituted highly innovative and effective "vote by mail" or "absentee ballot" systems which will prevent a high rate of voters voting in person yet, the voters will still be able to exercise their right to vote.

13. However, the Navajo Nation Election Office has failed to institute such highly innovative and effective "vote by mail" or "absentee ballot" systems for the 2020 Navajo Nation Chapter Elections. Thus, the majority of the Navajo Nation voters will be voting "in-person".

14. By all known scientific facts and epidemiological conclusions, the Covid-19 virus will not disappear by November 03, 2020. The deadly virus is beginning its upswing prompting another 57-hour lockdown to be imposed. The Navajo Nation Council cannot allow for the Navajo voters to be physically gathered at polling sites subjecting the Navajo voters to an increased risk of Covid-19 infections.

15. By resolution TEE-JUN-17-2020, the Teesto Chapter is requesting and supports the postponement of the 2020 Navajo Nation Chapter Election to 2021. See **Exhibit B**.

16. To ensure the fair and safe participation of voters in the Chapter Official election process, it is in the best interest of the Navajo Nation to postpone the 2020 Chapter Elections until 2021.

#### SECTION THREE. POSTPONING THE 2020 CHAPTER ELECTIONS

The Navajo Nation hereby postpones the 2020 Navajo Nation Chapter Elections. Accordingly:

- 1. The 2020 Chapter Elections shall be postponed for one year. Resolution CJN-49-20 is rescinded, and filing fees paid shall be returned.
- 2. The terms of Office for the current Chapter Officials and other elected officials elected to four-year terms in the 2016 Chapter Elections, or otherwise currently serving, shall be extended for one year, until the newly-elected officials from the 2021 Navajo Nation Chapter General Election are certified and inaugurated, consistent with this emergency action of the Navajo Nation.
- 3. The Navajo Board of Election Supervisors (board) shall issue a new schedule for the 2021 Chapter Election cycle, pursuant to the Navajo Nation Election law under 11 N.N.C. §1, et. seq., designating such matters as filing periods, registration timelines, Primary and General election dates and all other necessary time periods. Filing fees shall be prorated by the Navajo Board of Election Supervisors based on a three-year term.
- 5. Except as otherwise provided herein, all requirements of the Navajo Election Code shall continue to apply to the Chapter Elections to be conducted in 2021. All terms of

office from the 2021 election shall end upon the certification and inauguration of newly elected officials from the 2024 Chapter Elections.

- The Navajo Election Administration and the Navajo Board of Election Supervisors shall ensure that adequate funds are available to conduct the primary and general Chapter Elections, now set for 2021.
- The Navajo Board of Election Supervisors shall be delegated the authority to adopt rules and regulations for purposes of implementing the intent and purposes of this action of the Navajo Nation.
- For purposes of this action, 11 N.N.C. §§ 3(B), C and 6(A) are waived. These sections, respectively, concern the Chapter General Election date, the primary election date for Navajo elections, and 4-year terms for elective positions.

9. Filing fees paid for the postponed 2020 Chapter Elections shall be refunded.

#### SECTION FOUR. SAVINGS CLAUSE

Should any part of this action be determined invalid by the Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, portions not determined invalid shall remain the law of the Navajo Nation.

#### SECTION FIVE. EFFECTIVE DATE

This action shall become effective in accord with 2 N.N.C. § 221(B).

#### RESOLUTION OF THE NAVAJO NATION COUNCIL 24th NAVAJO NATION COUNCIL - SECOND YEAR, 2020

#### AN ACTION

RELATING TO NAABIK'ÍYÁTI' AND NAVAJO NATION COUNCIL; OVERRIDING THE NAVAJO NATION PRESIDENT'S VETO OF NAVAJO NATION COUNCIL RESOLUTION CJN-49-20

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. All resolutions enacting new law or amending existing laws are subject to veto by the President of the Navajo Nation pursuant to 2 N.N.C. § 1005 (C) (10) and (11) and override by the Navajo Nation Council. 2 N.N.C. § 164 (A) (17).
- B. A vetoed resolution shall first be submitted to Naabik'iyáti' Committee before consideration by the Council. 2 N.N.C. § 164 (A) (17).
- C. Veto legislation passed by the Navajo Nation Council [is] subject to an override of the veto by two-thirds (2/3) vote of the membership of the Navajo Nation Council. 2 N.N.C. § 1005 (C) (11).

#### SECTION TWO. FINDINGS

- A. The Navajo Nation Council on April 20, 2020 approved resolution number CJN-49-20 entitled, "AN ACTION RELATING TO NAABIK'ÍYÁTI' AND THE NAVAJO NATION COUNCIL; CANCELLING THE PRIMARY ELECTION FOR THE 2020 CHAPTER ELECTION; SETTING ONE CHAPTER ELECTION DATE FOR NOVEMBER 3, 2020; WAIVING 11 N.N.C. §§ 3 (C) AND 41."
- B. The Navajo Nation President vetoed CJN-49-20 on July 2, 2020. Attached as Exhibit A is his memorandum supporting his decision to veto the resolution of the Council.

#### SECTION THREE. OVERRIDE

The Navajo Nation Council hereby overrides the Navajo Nation President's veto of Resolution CJN-49-20.


Dear Speaker Damon.

Pursuant to the authority vested in the Navajo Nation President, I am vetoing CJN-49-20.

"There is no right more basic in our democracy than the right to participate in electing our political leaders." This principle is the basis of the Navajo Nation's legal argument to the New Mexico court in the case of *State of New Mexico, ex rel., M. Keith Riddle, et al. v. Maggie Toulouse Oliver* filed earlier this year supporting the Navajo People's right to vote in State elections. The Navajo Nation has also fought for the People's right to vote in Arizona and Utah elections. CJN-49-20 has the potential to undo all the legal arguments made by the Navajo Nation Department of Justice and cripple the Nation's position in State election cases. Had the Navajo Election Commission and the Navajo Nation Council consulted the Navajo Nation Department of Justice there may have been a solution to our own election situation rather than an immediate rush to cancel our Primary Election.

The Navajo Nation has fought for decades to secure certain rights for our People and the right to vote is a fight we continue to this day. We owe much to our parents and grandparents who lead that fight for our rights, so we have an obligation as Navajo leaders to protect those rights for future generations. We are in a difficult time now where we need to be seriously concerned for our People's health, safety, and welfare but we must balance that concern without giving up our hard carned right to vote. There are still many options available to the Navajo Election Office for the Primary Election; some of those options are expressed in the New Mexico case brief mentioned above.

We agree the coronavirus presents a major challenge for all of us but over the past months we have learned to meet that challenge head on. We live in a COVID world now with face coverings, washing our hands, limiting our movement outside our homes, and keeping our physical distance from others. Our People are well aware of the seriousness of the virus and we are learning new social norms. Election day was a time we met with our relatives to eatch up on news, have a cup





of coffee and a hot meal. We cannot do these things now, but we can still exercise our right to choose our leaders.

The Navajo elections must be taken seriously. As a Nation we have made accommodations to have our own elections coincide with State elections to have our Navajo People participate in all elections. This is one of those years it is important to get out the vote. Our Navajo People have influence on State elections and the national election, but we will lose that influence with the cancellation of our Primary Election this year. The rational for cancelling the Navajo Primary this year will have repercussions not only for Chapter elections but the State and national elections as well.

A veto of CJN-49-20 protects the right to vote of all Navajo People and we recommend the Navajo Election Office and the Navajo Nation Board of Election Supervisors consider alternative methods to allow Navajo People their vote in the Chapter elections. We also recommend the Election Office and Board of Supervisors review the Navajo Nation's position on State elections with the Navajo Department of Justice so that we are in step with each other on this important issue.

#### RESOLUTION OF THE NAVAJO NATION COUNCIL 24<sup>th</sup> NAVAJO NATION COUNCIL - SECOND YEAR, 2020

AN ACTION RELATING TO NAABIK' İYATI' AND THE NAVAJO NATION COUNCIL; CANCELLING THE PRIMARY ELECTION FOR THE 2020 CHAPTER ELECTION; SETTING ONE CHAPTER ELECTION DATE FOR NOVEMBER 3, 2020; WAIVING 11 N.N.C. §§ 3 (C) AND 41

BE IT ENACTED:

#### SECTION ONE. AUTHORITY

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700. Pursuant to 2 N.N.C. § 164 (A) (9), "a proposed resolution that requires final action by the Navajo Nation Council [must] be assigned to standing committee(s) having authority over the subject matter at issue and the Naabik'iyáti' Committee."
- C. The Navajo Board of Election Supervisors was created by the Navajo Nation Council as "an independent entity." 2 N.N.C. § 871 (A), Consistent with this status, the Board is responsible only to the Navajo Nation Council, with the authority to enforce provisions of the Navajo Election Code and to make rules and regulations furthering the intent and purposes of the Election Code. 2 N.N.C. § 873 (B)(6) and 11 N.N.C. §§ 321 (A)(6) and 322.

#### SECTION TWO. FINDINGS

- A. Under the Navajo Nation Election Code, primary election for the 2020 Chapter Elections must be conducted August 4, 2020. 11 § N.N.C. 3 (C).
- B. Pursuant to directive of the Navajo Nation Council for recommendations, the Navajo Board of Election Supervisors, "the board," is requesting that the primary election scheduled for August 4, 2020 be cancelled. Exhibit A, resolution BOESMY-024-20. The board expresses health concerns over the recent outbreak of coronavirus (COVID-19). The Navajo Election Administration (NEA) states similar concerns. Exhibit B, NEA memorandum. Essentially, the concerns are over the safety of

the voting public, candidates, poll officials, and staff of the Election Administration. For purposes of mitigating the spread of COVID-19, the request is made for the cancellation of the primary election and that one election be held on November 3, 2020.

- C. COVID-19 is a virus causing serious respiratory illness. It is pandemic, with many cases involving death continuing to be reported across the United States. In addressing the concerns, the Navajo Nation has issued a number of public health orders for all residents of the Navajo Nation. These orders include mandatory curfews, restrictions on public gatherings, the mandatory wearing of masks in public places and social distancing. Access to government offices has also been restricted to the general public. See, Emergency Management Commission resolution CEM 20-03-11; Executive Orders Nos. 001-20, 002-20, 003-20, 004-20; Public Health Emergency Orders 2020-001, 2020-002, 2020-003, 2020-004, 2020-005, 2020-006, 2020-007, 2020-008 (incorporated herein by this reference).
- D. In spite of mitigation measures, COVID-19 has disproportionately affected the Navajo Nation. Today, the Navajo Nation has one of the highest per capita rates of positive tests for COVID-19 in the United States. See, https://thehill.com/policy/healthcare/497091-navajo-nationhas-more-coronavirus-cases-per-capita-than-any-us-state. The number of positive tests continues to increase at an alarming rate.
- E. Historically, elections within the Navajo Nation have been conducted in-person. Although mail-in balloting is permitted, most voters choose to cast their ballots at the polling sites that are established in each of the 110 chapters on election day. The emergency caused by COVID-19 has impacted preparations for the 2020 Chapter Elections.
- F. All voters, candidates and poll officials must be properly protected on election day. Preparations and precautionary measures must include the purchase and availability of Personnel Protective Equipment (PPE). The Navajo Election Administration calculates the costs for such protective equipment to range between \$57,884.68 and \$84,401.20. Exhibit B. In addition to these anticipated costs, the Election Administration is also reviewing the prospect of on-line voting, as well as purchasing computer software and additional equipment for election purposes. For the 2020 Chapter Elections, the Administration intends to continue working with

Navajo Nation Health Command in ensuring compliance with all guidelines for conducting a safe election.

- G. COVID-19 will likely affect voter turnout in the 2020 Chapter Elections, particularly for the primary. Voter turn-out is generally lower in primary elections than in general elections. In the last Chapter Election conducted in 2016, the primary election voter turn-out was 29.52 %. Aside this issue, the Navajo Board of Election Supervisors expresses concern regarding instances in which candidates will run unopposed in the primary election. Upon election, such candidates are automatically placed on the general election and certified upon such election.
- H. COVID-19 presents a major challenge in the conduct of the 2020 Chapter Elections. The pandemic facing the Navajo Nation makes it extremely difficult to proceed with elections as has been done in the past. As there is no vaccine, it is crucial that the spread of the virus be minimized.

SECTION THREE. CANCELLING PRIMARY ELECTION; AUTHORIZING CHAPTER ELECTION FOR NOVEMBER 3, 2020

- A. The Navajo Nation hereby cancels the primary election for the 2020 Chapter Elections. For purposes of this action, 11 N.N.C. \$\$ 3 (C) and 41 are waived.
- B. Chapter Elections shall be conducted on November 3, 2020. There shall be one election, with no primary election. All eligible candidates shall be placed on the election ballot and the winning results for each position shall be determined by plurality vote.
- C. The Navajo Board of Election Supervisors shall set the candidate filing period, and shall further adopt any necessary rules and regulations for purposes of implementing and furthering the intent and purposes of this resolution of the Navajo Nation Council.

#### SECTION FOUR. EFFECTIVE DATE

This action of the Navajo Nation Council herein shall be effective pursuant to 2 N.N.C. § 221(B). Further, the "President's authority to sign into law or veto legislation shall be deemed waived if not exercised within ten calendar days after certification of the legislation by the Speaker or Speaker Pro Tem and the legislation shall be deemed enacted and become effective pursuant to 2 N.N.C. \$ 221." 2 N.N.C. \$ 1005 (C)(12).

#### SECTION FIVE. SAVINGS CLAUSE

Should any provision of these amendments be determined invalid by the Navajo Nation Supreme Court, or the District Courts of the Navajo Nation without appeal to the Navajo Nation Supreme Court, those amendments that are not determined invalid shall remain the law of the Nation.

#### SECTION SIX. DIRECTIVE

The Office of the Controller and Business Regulatory Department shall provide administrative support to the Navajo Nation Election Office for financial procurement of goods and services to ensure the 2020 election is held in a safe and orderly manner.

#### Recommending the conduct of only the General Election for the 2020 Chapter Elections; recommending waiving 11 N.N.C. §§ 3(C) and 41 with a timeline attached at Exbibit A,

#### WHEREAS:

(

1. Pursuant to 2 N.N.C. § 871(A), the Navajo Board of Election Supervisors was created by the Navajo Nation Council as "an independent entity." Consistent with this status, the Board is responsible only to the Navajo Nation Council, with the authority to enforce provisions of the Navajo Election Code and to make rules and regulations furthering the intent and purposes of the Election Code. 2 N.N.C. § 873(B)(6) and 11 N.N.C. §§ 321(A)(6) and 322.

2. There are a number public health orders issued residents and members of the Navajo Nation for purposes of addressing COVID-19, orders including stay-at-home orders. It is uncertain when orders and restrictions will be lifted.

3. Under the current provisions of the Navajo Nation Election Code at 11 N.N.C § 3(C) primary elections are held on first Tuesday in August in any year in which a general election is held and at which candidates for public office are to be elected. The processes for a primary election are held in 11 N.N.C. § 41 as well. The new timeline is attached as Exbibit A.

4. It is not uncommon in a primary election to have only one interested candidate applying for a position. In these instances, the sole candidate, pursuant 11 N.N.C. § 25, is placed on the ballot as an "unopposed candidate" in both the primary and general elections. In the primary elections for 2016 Chapter Elections, there were 479 unopposed candidates.

5. Through a directive of the Navajo Nation Council issued on April 10, 2020, the Navajo Board of Election Supervisors must within 60 days thereof address through resolution, the Chapter Elections.

#### NOW THEREFORE BE IT RESOLVED THAT:

1. To minimize the contact amidst COVID-19 and for the purposes of compliance with the various Navajo Nation Health Orders issued to date, the Navajo Board of Elections Supervisors, in respect to the 2020 Chapter Elections, recommends that requirements of conducting a primary election this year to be waived and to have only a General Election in November 2020. See Exhibit A.

2. Pursuant to the Navajo Nation Election Code, the Navajo Board of Election Supervisors states that the General Election of the 2020 Chapter Election be conducted on November 3, 2020.


This memorandum is written to support and to provide information to the Navajo Nation Council on the Navajo Board of Election Supervisors resolution to recommend waving 11 N.N.C. §§ 3 (C) and 41, and to proceed directly to the General Election and not have a Primary Election for the 2020 Election. The Navajo Elections Administration (NEA) has assessed the current office standing as for available resources in operations to proceed with the planning and the implementation of the 2020 election without a primary election. And our office has identified the following as to support our aforementioned position for the 2020 Election:

1. The primary concern in proceeding with elections as codified within the election code is the safety of the NEA staff, volunteers and the general public. The COVID19 (CCP Virus) pandemic makes it difficult to proceed with the elections as it has been done in the past. We are tasked with procuring building material to build barriers, counter space to direct public traffic for open filing and the elections, establishing a controlled environment to mitigate direct and community spread of the virus, partitions to separate staff work stations and establishing a decontamination work stations for all 6 offices to process the submission of public documents to mitigate the indirect spread of the virus to the NEA offices and staff who will have to handle documents submitted by candidates. The NEA will have to seek additional supplemental funding immediately from council to prepare for this election year, as we will incur significant additional expenditures for this election cycle.

2. The NEA has also identified that we will have to acquire Personal Protective Equipment (PPE) --which includes masks, hand sanitizer stations, gloves and disinfectant supplies---for staff members to operate in the normal course of business serving the general public and candidates. The PPEs will also have to be procured and made available for poll workers, volunteers, registered voters and staff members who may enter into the polling sites on the designated election days. The anticipated registered voters for the 2020 elections is 108,968 and thus it is estimated to provide sufficient PPEs for a safe election it will cost at the least \$57,884,68 and \$84,401.20 on the high end.

3. The NEA, as result of the unique situation posed by the pandemic, time lines for printing the ballots has been directly affected and thus having to focus on a primary and a general election could hinder sufficient time to ensure the ballots would be ready for both the primary and general election. We have to also consider possible further delays which may come from candidates who may file within the Office of Hearings & Appeals and the Navajo Nation courts. This election cycle will result in possible instances of first impression and thus may further impinge upon the overall election process schedule.

4. It is recommended to have open filing for candidates to be set for July 23, 2020 to August 5, 2020 as opposed to June 4, 2020 as the NEA is currently working to establish online filing for candidates to limit person to person contact and to prevent contamination of our offices from documents which may have latent viruses upon them. We are acquiring a license to establish a viable online platform to allow for candidates to file for candidacy online. The initial cost of the annual licensure is \$700.00 and thus will have to include in operations expenditures.

5. The NEA administration has been seriously neglected and thus the interim Executive Director is working bring the office back up to sufficient operation standards. The computer system and the voter data base are both obsolete and operating on Window 2003, new computers have been ordered and some have arrived and have yet to be installed, computer software also need to be ordered for all the new computers, we also need additional equipment to include scanners, printers and hard drives. In addition to the office equipment the NEA is having to resubmit an application to acquire an Operational PCard to streamline purchasing office supplies and equipment.

6. The NEA requires additional time to work with the Navajo Nation Health Command to establish protocols and procedures for a safe election process for the November 3, 2020 General Election. This includes dispatching all protective measures at all the polling sites, train all staff and temporary support staff to properly deploy protective protocols for all sites, consider alternatives for casting ballots to include absentee ballots, mail in ballots and/or curb side voting. The NEA will also be looking to work with State entities to cost share on equipment and supplies for all polling sites. The NEA will be looking at alternative options to include limiting and consolidating polling sites for the General Election. We have also been tasked to attempt to implement online voting however such a platform would most likely not be available until the next years voting cycle.

7. The COVID19 (CCP Virus) has caused many Navajo Nation Offices to shut down or operate on limited staffing and hours which has affected processing of and approving purchase orders and request for direct payments, this has hindered NEA operations. Should the Navajo Nation reopen by June 2020, or thereafter we should be able to push all our purchasing forward within the process or via an operational PCard (which would the best option for the NEA).

8. Statistics from the 2016 Primary Elections is recorded as follow; 118,673 persons registered to vote and only 35,027 (29.52 %) voted in the primary election in 2016.

9. Lastly, we also are establishing an internal administrative work group to work with and advise the Automated Election Services (AES), who primarily prints all Navajo Nation ballots and houses our voting machines, to work out details for ballot printing and to amend our agreement to utilize voting machines that could accommodate alternative voting for curbside voting, mail in and absentee balloting and to accommodate ballots that will have back to back printing to accommodate candidate ballots and referendums. The use of the updated voting machines would make tallying ballots efficiently and will also

help in over reporting of statistics. This also will open possible discussion to initiate the implementation of a new voter and election data base.

This memorandum is not written to undermine nor infringe upon the general public's right to vote but is made to ensure that the safety of the Navajo Nation tribal members in this years' election, which also includes the NEA staff and volunteers. Should you require additional information I may be reached at my office and will also be available to appear before the Navajo Nation Council when this matter is addressed in a regular or special meeting.

#### Requesting and Recommending the Navajo Nation Council and the Office of the President and Vice President of the Navajo Nation the Postponement of the Navajo Nation Chapters 2020 General Election to 2021

#### WHEREAS:

1. The Teesto Chapter is a duly recognized and certified chapter of the Navajo Nation government pursuant to 26 N.N.C. Section 3 and 12 N.N.C. Section 10; and

2. Pursuant to Title 10 N.N.C. Section 1 (B) the Teesto Chapter is a Local Governance certified chapter vested with the authority to review all matters affecting the community; make appropriate corrections when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate action; and

3. The Coronavirus 19 has profoundly impacted the Navajo Nation government, Navajo Nation schools, Navajo Nation chapters and the general welfare and wellbeing of the Navajo people putting the everyday livelihood as we know it on hold including the counties, states, national and globally; and

4. The trend has been on the increase steadily throughout the last few months reaching over 6,000 positive cases and over 300 deaths even when the Navajo Nation instituted weekend and nightly curfews; and

5. The 2020 Navajo Nation general election is proposed to be held on November 3, 2020 while the primary election is to be canceled that raises many questions with respect to voting rights infringement that invites legal challenges and a possible injunction; and

6. A second wave of the Coronavirus that could even be more devastating in the fall and winter is being projected by the national Center for Disease Control and Prevention; and to be compounded by seasonal influenza impacting the general election in many ways that is potentially very risky and hazardous. An election after a vaccine is in place in 2021 will provide some stability and assurance a later election would be much safer and conducive to safety and protection of our citizens; and

7. The new Teesto Chapter replacement facility, after 7 years of emergency declaration to replace, has finally contracted a contractor to begin construction perhaps by the end of this month and that may take 10 months to complete; and

8. The Teesto Chapter officials are concern for the need for continuity to complete this \$4.0 million project as a turnover may jeopardize the project due to the election as it once did to a prior senior citizens center that stands vandalized today.



#### WHEREAS:

- 01. The New Mexico Navajo Central Agency School Board, formerly known as the Eastern Navajo Agency\_School Board, is authorized and empowered to function as the policy making body for the New Mexico Navajo Central Agency (NMNCA) consistent with the authority granted by CFR 25 Code Federal Regulations § 32.0 (4), Public Law 95-561 and Public Law 100-297; and
- 02. The New Mexico Central Agency School Board; henceforth, shall be referred to as the Agency School Board and shall exercise Indian Self-determination and Local Control in the planning, development, management, operation, budget, staffing, priority setting and evaluation of all aspects of the Agency education process as outlined under P.L. 95-561, P.L. 100-297; and 25 Code of Federal Regulations § 32.4 (3); and
- 03. The New Mexico Navajo Central Agency School Board is established and empowered by the Navajo Nation Council pursuant to Navajo Nation Council Resolution CAU-87-69 and the Navajo Sovereignty in Education Act of 2005 (CJY-37-05), §251 and 253; and
- 04. The New Mexico Navajo Agency Central School Board leaders and educators of Bureau Funded Schools have a common interest to preserve in unity the education services we provide our students through local community schools and that our united voices are expressed by using the same language in our resolutions and is therefore respectfully requested of our elected leaders not to disregard our voices just because our resolution languages are the same; and
- 05. The Covid-19 virus will not subside by November 03, 2020 and is beginning to spike an increase in cases currently and the Navajo Nation Council cannot allow for the Navajo voters to be physically gathered at polling sites subjecting the Navajo voters to an increased risk of COVID-19 infections.
- 06. The Navajo Nation Council Delegates must hear their Diné people's voices and take every measure to protect our Nation from any further devastation of losing precious, unreplaceable lives.
- 07. The Navajo Nation Election Office has failed to institute an extensive "mailin/absentee" system as the Secretary of State offices have implemented which allows all voters to exercise their right to vote; and
- 08. The Navajo Nation Council overrode the Navajo Nation President's veto of resolution CJN-49-20 for the primary election to proceed which resulted in two lawsuits being filed. One concerns the primary election and the other concerns the apportionment plan adopted for school boards for the next term; and

- 09. A postponement of the 2020 Navajo Nation Chapter Elections until 2021 will ensure that the postponed Chapter Elections will not be interrupted by any Court Orders as the legal issues raised in the two lawsuits mentioned herein would have been resolved by the time the filing period begins and the Primary Elections are held in 2021; the pending lawsuits will have been heard by the Courts, a ruling issued or the parties may have settled the matter; and

Reference: Why election should be held in November 2020

Dear Ms. Pino

Per our conversation earlier, here are a few of justifications as to why I think the election should be held in November.

Meetings are absent due to the quorum not being met. It has been a while since I have attended a Chapter meeting at Navajo Mountain where people from the community gathered, numbered more that 25 or more. Lately the number have dwindled to less than 10 - 15, or a quorum is never met despite waiting extra time in hopes of getting more to come to the meeting.

When the water and electrical lines came, it went to the chapter and school. Prior to it coming in, people were told to get their homes ready to receive the electricity and water. Some resident living in the Arizona counties were prepared but, were forgotten. They are still waiting to get these services. One has to have a relative who are chapter officials or live on the Utah side to get service.

Navajo mountain Chapter officials lack communication with the two Arizona county officials. I often wonder if the chapter is aware that our community is located with three counties; Coconino, Navajo and Utah. They need to let these two Arizona counties know we need services in the Navajo Mountain chapter service area.

Some of the committees that the chapter has are complaining of little or no help from the chapter. It is a shame that some community members are denied assistance or help from the chapter but, help is given to family members of chapter officials who do not attend meetings or live in the area. Two chapter officials also do not live in Navajo Mountain. Chapter house employees are told not to disseminate chapter official's phone numbers or residence location, therefore cannot be contacted. Chapter employees are unable to assist with the need at hand.

I feel that it is very crucial that these elected chapter officials serve this community far better than they are doing. This presents the Navajo Mountain community members to exercise their right to Vote. Postponing the election denies their right to vote.
- 3. <u>Devotion</u>: The opposing candidates have devoted his/her time and established expenses with their campaign. Community members, family and friends made their decision to support their candidates. Unnecessary time and expense has been sacrificed by the opposing candidates with postponement of the election. These opposing candidate may not be available in 2021 after one year.
- 4. <u>NO: 0234-20</u>: The incumbent Chapter officials have been uncooperative with the Chapter Veteran's Organization request for assistance although Supplemental Veteran's funds are available for this purpose. Veteran lives have been lost due to lack of assistance and Veterans are in dire need of assistance. A change in Chapter leadership is necessary.

As a concerned Navajo citizen and voter, I am emailing you to OPPOSE Legislation 0234-20 to delay the elections for one year for all chapter officials, land board, farm boards, grazing officials, and school boards. The elections should happen without delay. The Council should not use the COVID-19 pandemic as an excuse to delay the election. Other states have adapted to the pandemic to ensure voting goes on. I am ready to exercise my right to vote. Postponing this election is only going to cause more confusion and disenfranchise Navajo voters.

As far as COVID-19 concerns, Navajo people have been dealing with this pandemic for some time now and generally have responded well in terms of social distancing, wearing face masks, complying with health orders, and ensuring proper precautions are in place. Based on what I've seen, the Navajo Nation government, including the Navajo Election Administration should be ensuring that COVID-19 precautions are in place during the voting process. Taking precautions also should be common sense and practice by now. Food stands and campaigning should not be allowed.

I'm also very concerned that postponing this election is going to have a negative impact by diluting and reducing the vote of our Navajo people in the upcoming federal, state, and county elections. Generally, tribal, state, and federal elections coincided with each other. Delaying this election will ensure that Donald Trump's reelection. Trump has hurt our Navajo people and needs to be removed. Martha McSally also needs to be removed.

Legislation 0234-20 also calls for refunds to be issued to all candidates who filed for office. How that can be accomplished because the filing fees were set by referendum and are non-refundable. (11 N.N.C. §26, CAP-22-06, April 20, 2006). Elmer Begay and the Council cannot overrule the vote of the Navajo people. It also seems as if Elmer Begay is making promises (filing fee refunds) that he can't keep or as an attempt to mislead other delegates and people to support his legislation.



## SUPPORTING LEGISLATION 0234-20, AN ACT RELATING TO AN EMERGENCY FOR THE NAVAJO NATION; WAIVING 11 N.N.C. SUBSECTION 3(B), (C), AND 6 (A); POSTPONING THE 2020 NAVAJO NATION CHAPTER ELECTIONS FOR ONE YEAR AND EXTENDING THE CURRENT TERM OF OFFICE FOR SUCH TIME; AND RESCINDING CIN-49-20 AND CIY-06-20.

#### WHEREAS:

- 1. Pursuant to 26 N.N.C., Section 3 (A), the Tsidi To'ii Chapter is a duly recognized chapter of the Navajo Nation Government, as listed at 11 N.N.C., Part 1, Section 10, and
- The Tsidi To'ii Chapter is a certified chapter government of the Navajo Nation in accordance with the Navajo Nation Local Governance Act, 26 N.N.C., Section 1 (B); thereby, vested with the authority to protect and promote the general health, safety, and welfare of the Chapter membership; and
- 3. As a Certified Chapter, Title 26, Chapter 1. Subchapter 1. Section 1.B.2, was established for Purposes of chapters, such as Tsidi To'ii Chapter to make decisions over local matters. This authority, improves community decision making, allows communities to excel and flourish, and enables local leadership to implement the goals and objectives of the community; and
- 4. In March 2020, the OPVP closed all government offices due to the fast spreading virus, COVID-19. During the shutdown many Navajo lives were affected by the virus in many ways, some lost their jobs, some caught the virus and recovered, but are having other health problems due to the virus, and some died from the virus; and
- Due to the virus, the community of Birdsprings lost several community members and some recovered from it, but have been financially impacted, because they got sick, they were not able to work for those times and are now financially struggling; and
- 6. The Office of the President and Vice-President vetoed the first legislation the 24<sup>th</sup> NN Council passed to cancel the primary chapter elections citing the council violated the voting rights of the Navajo people, but not seeking guidance from communities across the Navajo Nation and hard won cases that guaranteed voting rights of the Navajo people across three (3) states and within the US Supreme Courts; and

- 7. The local leadership is concerned for families in Birdsprings that may be compromised immune deficient might be exposed to viruses during times candidates are campaigning for office and at the election office; and
- 8. The leadership toke an oath and in Title 26, the officials are charged with acting during a state of emergency, pandemic, and to maintain the health and well-being of their community members; and
- Postponing the Chapter elections for one year and extending the terms of current officials of the same are aligned with the goals, objectives, and directives of the Executive and Legislative Branches of the Navajo Nation Government.

#### NOW THEREFORE BE IT RESOLVED THAT

- The Tsidi To'ii Chapter Hereby Respectfully Supports Legislation 0234-20, an Act Relating to an Emergency for the Navajo Nation; Waiving 11 N.N.C. Subsection 3(B), (C), and 6 (A); Postponing the 2020 Navajo Nation Chapter Elections for One Year and Extending the Current Term of Office for Such Time; and Rescinding CIN-49-20 and CIY-06-20.

### RESOLUTION OF THE NAVAJO BOARD OF ELECTION SUPERVISORS

### <u>Strongly Opposing the Navajo Nation Council Legislation No. 0234-20 An Action</u> <u>Relating to an Emergency for the Navajo Nation; Waiving 11 N.N.C. §§ 3(B), (C) and 6(A);</u> <u>Postponing the 2020 Navajo Nation Chapter Elections for One Year and Extending the Current</u> <u>Terms of Office for Such Time; and Rescinding BOESMY-024-20, attached as Exhibit A.</u>

### WHEREAS:

1. Pursuant to 2 N.N.C. § 871(A), the Navajo Board of Election Supervisors was created by the Navajo Nation Council as "an independent entity." Consistent with this status, the Board is responsible only to the Navajo Nation Council, with the authority to enforce provisions of the Navajo Election Code and to make rules and regulations furthering the intent and purposes of the Election Code.

2. On July 2, 2020, the Navajo Nation President vetoed Navajo Nation Council resolution CJN-49-20, entitled "An Action Relating to Naabik' lyáti' and Navajo Nation Council; Cancelling the Primary Election for the 2020 Chapter Election; Setting One Chapter Election Date for November 3, 2020; Waiving 11 N.N.C. § 3(C) and 41."

3. On July 22, 2020, the Navajo Nation Council overrode the President veto by resolution CJY-60-20, entitled "An Action Relating to Naabik'iyáti' and Navajo Nation Council; Overriding the Navajo Nation President's Veto of the Navajo Nation Council Resolution CJN-49-20, thus allowing for a General Chapter Election to occur on November 3 2020.

4. On September 18, 2020, Legislation No. 0234-20 An Action Relating to an Emergency for the Navajo Nation; Waiving 11 N.N.C. §§ 3(B), (C) and 6(A); Postponing the 2020 Navajo Nation Chapter Elections for One Year and Extending the Current Terms of Office for Such Time; Rescinding CJN-49-20 and CJY-60-20, was filed.

5. Pursuant CJY-60-20, the Navajo Election Administration opened candidacy filing August July 28, 2020 with a closing date of August 10, 2020. Last day to file grievances for elections was September 10, 2020. Ballot design was due to the printing company on September 3, 2020.

6. The Navajo Board of Election Supervisors hereby opposes Legislation No. 0234-20, due to too much time has passed since the CJY-60-20 was approved. Early voting and Absentee voting began on October 5, 2020 incurring a substantial amount of expenses. Candidates have begun their campaign operations, and a considerable amount of resources and effort has been expended in preparation and arrangement of the 2020 Chapter Election with neighboring States of New Mexico, Arizona and Utah.

7. The Navajo Board of Election Supervisors recognizes and respects that Voting is a fundamental right of all Navajo Nation citizens. The entire process of voting will be conducted in accordance with COVID-19 Public Health Orders 009-20 and 021-20, issued by the Navajo Nation Department of Health. The Navajo Board of Election Supervisors understands that COVID-19 is

an extremely serious health concern. It is crucial at this time to protect the health of all residents, including election staff, chapter poll workers and candidates. *See* Exhibits B.

#### NOW THEREFORE BE IT RESOLVED:

1. The Navajo Board of Election Supervisors strongly opposes the Navajo Nation Council Legislation No. 0234-20 An Action Relating to an Emergency for the Navajo Nation; Waiving 11 N.N.C. §§ 3(B), (C) and 6(A); Postponing the 2020 Navajo Nation Chapter Elections for One Year and Extending the Current Terms of Office for Such Time, rescinding <u>BOESMY-024-20</u>. See Exhibit A.

2. Pursuant to the Navajo Election Code, and Navajo Nation Council Resolution CJY-60-20, the Navajo Board of Election Supervisors states that the General Election of the 2020 Chapter Election be conducted on November 3, 2020.
