Findings. A. The Navajo Nation Council established the Law and Order Committee as a Navajo 18 Nation standing committee and as such the Law and Order Committee shall use 19 20 Nitsáhákees, Nahat'á, Iiná and Siihásin in exercising oversight over law enforcement for the purpose of enhancing operations and coordination of all departments within the 21 Navajo Division of Public Safety in order to increase the availability, quality, and 22 effectiveness of public safety services to the Navajo Nation and to enable the Navajo 23 Nation to more effectively provide efficient public safety services to the Navajo Nation. 2 24 25 N.N.C. §§ 600 (A), 601 (C)(5)(6). B. The Navajo Nation President appointed John Billison as the Executive Director of the 26 Navajo Division of Public Safety on February 02, 2011 and the Navajo Nation Council 27 confirmed the appointment on April 21, 2011. 2 N.N.C. § 1353. 28 C. The Executive Director of the Navajo Division of Public Safety shall exercise full 29 30 authority and control over all division activities and shall be responsible for the selection

and supervision of all department directors and all personnel, including delegation of authorities; and, shall further exercise full authority to commission certified law enforcement personnel pursuant to standards approve by the Navajo Nation. 2 N.N.C. § 1353.

- D. The Executive Director of the Navajo Division of Public Safety has failed in his execution of the duties outlined above as observed and reported by the personnel of the Navajo Division of Public Safety.
- E. The Navajo Division of Public Safety has been in turmoil in the time of John Billison's appointment as the rank and file officers have reported to the Law and Order Committee their concerns.

Section Two. No Confidence and Recommendation

- A. The Law and Order Committee of the Navajo Nation Council has considered the concerns of the rank and file officers of the Navajo Division of Public Safety regarding the lack of leadership, direction and supervision of the Navajo Division of Public Safety Executive Director John Billison and hereby expresses no confidence in the Executive Director John Billison to continue in his post; and,
- B. The Navajo Nation Law and Order Committee hereby recommends to President Ben Shelly that no Navajo Division of Public Safety personnel be subject to retaliatory action in relation to testimony or statements regarding the Executive Director; and,
- C. The Navajo Nation Law and Order Committee hereby recommends to President Ben Shelly to immediately remove John Billison as Executive Director of the Navajo Division of Public Safety.

This email, is my support in the actions for Law & Order Committee Resolution (Legislation NO: 0111-15). Many employees have been targeted with unfair treatment and continued harassment. I, myself have been investigated 4 times, once each year Mr. Billison has been in office. As of today I'm still being targeted.

I do have an active Grievance Hearing (Step-4) and Labor Commission Complaint against the Division of Public Safety, both are awaiting a date for schedule hearing.

On October 24, 2011 several employees, including myself spoke before the Law & Order Committee. We informed the committee about some of the mismanagement of Mr. Billison. After the hearing, personnel were ordered not to speak outside the division, unless it was approved by Mr. Billison and he was too be informed on what topics that would be discuss by the employee (Directive Memo was issued-copy not available)

As an attachment I'm submitting copies of a completed Labor Commission case by 12 current & former employees (file name: Class Action complaint Vs NN President & Billison April 18, 2013). CASE NO: NNLC-2013-034. Although an agreement was reached (Stipulated Order), Mr. Billision is still abusing his authority. The document will shed some light on the abuse and mismanagement; plus his use of the Office of Internal Affairs.

Greetings Law and Order Committee Members,

I would like to express my opinion on the recent NNC Legislation #0111-15, "An Action Relating To Law and Order; Expressing No Confidence in Executive Director of Navajo Division of Public Safety and Recommending Removal of Executive Director".

I have read the proposed legislation and completely agree with its merits that the Executive Director John Billison, does in fact retaliate against personnel and further abuses the authority of the office. And despite being informed directly and indirectly, President Shelly continues to ignore the situation, to include an injunction order petition that was filed and settled upon in 2013 (NNLC2013-034) which cited these exact issues and several other individual grievance suits filed with the Navajo Nation Labor Commission.

I had at one time before this individual retaliated against me for performing my job as a lawfully commissioned police officer in investigating an alleged incident involving him I observed him to be very authoritative, abusive and critical toward the public, often with little or no compassion. He also was overbearing when given assignments often criticizing his superiors responding with profanity to include the oversight committee. His performance was substandard, because he just failed to complete his investigations which is probably contributed to his limited understanding of the law enforcement profession.

While associated with this individual I was informed by several private sources that he was labelled as an abuser, committing domestic violent acts. This was confirmed when I was referred to the Maricopa Family Court Records website in which it listed several petitions for "restraining orders" against him.

Although I was wrongfully terminated by John Billison I was constantly contacted and informed by police personnel of his abusive actions against them, him and his close associates Harry Sombrero, Gordon Toadlena and Ivan Tsosie.

This legislation is long overdue and I applaud the Law and Order Committee in pursuing and rectifying the turmoil that exist within the Navajo Division of Public Safety. As cited the NPD personnel have family and lives to support and because of this they are indeed afraid to compromise their financial security by reporting the consistent mistreatment by John Billison.

I sincerely pray that the Law and Order Committee effectively represents and protects those that protect our people and communities. Thank you.

I submit these comments for consideration by the Navajo Nation Council:

- 1. With all due respect to Council Delegate Edmond Yazzie, his legislation fails to articulate the problem(s) he bases his recommendation on; general conclusions should be rejected in their entirety.
- 2. The government is on dangerous ground when the legislative body "rubber stamps" employee grievances and makes drastic recommendations without offering meaningful remedies. Disgruntled employees should follow the established grievance policy. To entertain such grievances will set precedent for other executive branch programs.
- 3. President Shelly appointed John Billison to manage the Division of Public Safety and I believe Mr. Billison has done an admirable job given the state of affairs at DPS.
- 4. Without leadership, the public safety of the Navajo people (which should be of paramount concern for the oversight committee and the Navajo Nation Council) will be compromised. DPS has not been able to fill the Police Chief position--how easy will it be to find a replacement for Mr. Billison's position--that is, who is willing to take that job for a few weeks?
- 5. To politicize public safety by reacting to employee complaints will disrupt not only the management of Navajo law enforcement, but puts the government in a precarious position with the federal government. Because of direct involvement of the oversight committee (if, in fact, the concerns were raised to the oversight committee versus "behind closed doors" with Mr. Yazzie) this legislation will under mind and sabotage the administration of Navajo Nation's first responders.

This legislation should fail.

Dear Mr. Platero,

Let this letter serve as a response to the proposed legislation: "An Action Relating To Law and Order; Expressing No Confidence in Executive Director of Navajo Division of Public Safety (NDPS) and Recommending Removal of Executive Director."

- 1. When Mr. Billison assumed leadership of the Navajo Division of Public Safety (NDPS), this Division was severely underfunded, disorganized, and competitive. The Division is now better organized, has a unambiguous strategic future, and has become much more respected among public safety organizations. The professional employees of this Division consistently provide very effective public safety services to the Navajo Nation.
- 2. He has contracted experts to evaluate the historical functional, operational, and organizational condition of the NDPS rather than relying on rumors and hearsay. As a result, a strategic 5-year plan has been developed that will lead this Division into a state-of-the-art functional and financial position. This enables the NDPS to provide increasingly more effective and efficient public safety services to the Navajo Nation.
- 3. Multiple Tiger Team Police Department enhancement Projects have been initiated (several of which have been successfully completed) that have already significantly improved NDPS performance and enhanced the Division's ability to identify future external funding streams that will provide severally needed police equipment acquisition. The ongoing and critical upgrade to our 911 emergency call system is just one important example.
- 4. He has continually provided high-level training and support for all NDPS employees. NDPS employees have found this training challenging and rewarding. To date, employees have taken advantage of many significant opportunities to grow professionally and personally, thus ensuring that the NDPS continues it's exceptional record in providing safety services to the Navajo Nation.

5. Section Two. No Confidence and Recommendation

"The Law and Order Committee of the Navajo Nation Council has considered the concerns of rank and file officers of the Navajo Division of Public Safety regarding leadership, direction and supervision of the Navajo Division of Public Safety Executive Director John Billison...."

This paragraph's only emphasis is a few rank and file officers and does not consider or reflect the opinions of the other 600+ personnel from other NDPS departments.

- 6. Removing him as Director of NDPS would be very detrimental for the following reasons:
 - This action would end the successful completion of current and future critical Tiger Team Projects.
 - Employee growth and certification would be negatively impacted.
 - This action would downgrade the continued growth and increased effectiveness of the NDPS.
 - This action would significantly weaken the provision of effective and efficient public safety services to the Navajo Nation (now and in the future).

In closing, this proposed legislation should fail, thank you for your time.

Dear Mr. Platero:

I submit the following facts for consideration by the Navajo Nation Council:

- Mr. Yazzie's proposed legislation is invalid as codified in the Navajo Nation Code; Legislative Oversight shall not involve program administration (2 N.N.C. § 192). Mr. Yazzie is acting outside the scope of his authority – this proposed measure exceeds the boundaries for permissible action.
- 2. The Navajo Division of Public Safety (NDPS) Division Director has direct supervisory authority of the (1) Police Chief, (2) Director of Criminal Investigation, (3) Director of Corrections, (4) Fire Chief, (5) Director Emergency Medical Services, (6) Support Services Manger, and (7) Internal Affairs Supervisor.
 - a. The department heads have direct supervisory authority over their own department personnel consisting of 650 employees.
 - b. The department heads have control over their program budget and personnel management in accordance with the Navajo Nation Personnel Policies Manual (NNDPM), XIII. Discipline of Employees, A. Authority for Disciplinary Action, 2 Program Managers and Supervisors shall have the authority and responsibility to administer appropriate disciplinary action for violations of law, Nation policies, practices, rules and regulations.
 - c. Each and every employee must comply with the policies and procedures that affect or apply to their employment (NNDPM. I.A.3).
