WHEREAS:

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Navajo Nation Council established the Naabik'iyáti' Committee as a standing committee of the Navajo Nation Council and specifically empowered the Committee to:
 - i. To review and continually monitor the programs and activities of federal and state departments and to assist development of such programs designed to serve the Navajo People and the Navajo Nation through intergovernmental relationships between the Navajo Nation and such departments.
 - ii. To coordinate with all committees, Chapters, branches and entities concerned with all Navajo appearances and testimony before Congressional committees, departments of the United States government, state legislatures and departments and county and local governments.

1 iii. To recommend to United States departments and agencies, the states and
2 various regional agencies the appointment of individuals who, in the
3 judgment of the Committee, will fulfill the requirements of their office and
4 serve the interests of the Navajo Nation.

5 2 N.N.C. §§ 700 and 701 (A)(7)-(9).

6 C. The Navajo Nation has a government-to-government relationship with the United
7 States of America, Treaty of 1868, Aug. 12, 1868, 15 Stat. 667.

8 D. Congresswoman Deb Haaland is an enrolled member of the Pueblo of Laguna in New
9 Mexico.

10 E. In 2006, Congresswoman Haaland earned her Juris Doctor from the University of
11 New Mexico School of Law.

12 F. Congresswoman Haaland's political career includes serving as the Vote Director for
13 Native Americans in Barack Obama's 2012 presidential re-election campaign and in
14 2015, Congresswoman Haaland was elected to a two-year term as Chair of the
15 Democratic Party of New Mexico.

16 G. In 2018, Congresswoman Haaland was elected to the United States House of
17 Representatives for the First District of New Mexico and became one of first two
18 Native American women to serve in the House of Representatives.

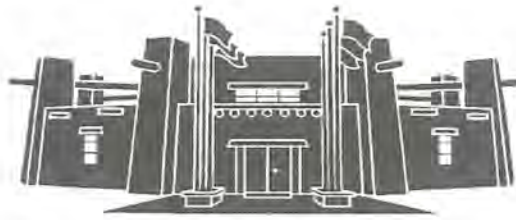
19 H. Congresswoman Haaland has close to twenty years of public service including
20 representing Native American governments, including but not limited to her Laguna
21 Pueblo and San Felipe Pueblo.

22 I. Congresswoman Haaland is and has always been a well-informed and tireless advocate
23 for United States Public Lands and Native American issues.

24 J. Congresswoman Haaland has the education, public service, and political experience
25 necessary to lead the U.S. Department of Interior in a direction that enhances and
26 protects, rather than diminishes, Native American governments and Native American
27 lands and on December 17, 2020, United States President nominated Congresswoman
28 Haaland to be appointed as first Native American Secretary of the Interior.


1 **NOW THEREFORE, BE IT RESOLVED:**



I am a Navajo Nation citizen, a mother, a graduate of Stanford University, and an environmental consultant who has worked with Federal, State, and tribal agencies for over 15 years on environmental impact analyses and land management plans. Based on my consulting work for the Department of the Interior, I recognize the importance and historic nature of the appointment of Deb Haaland to Interior Cabinet Secretary in the Biden-Harris Administration.

President Joe Biden and Vice President Kamala Harris were elected with the backing of Native American voters in record turnout based on their commitment to Indian Country to uphold trust responsibility to tribal nations, strengthen relationships between the United States and Indian tribes, and empower tribes to govern their own communities and make their own decisions. Deb Haaland's nomination is a first step toward advancing the Biden-Harris commitment to Indian Country.

As the Secretary of the Interior, Deb Haaland would oversee the caretaking of public lands and wildlife in over one-fifth of the United States and she would oversee the Bureaus of Indian Affairs and Education. Dear Navajo Nation Council,

I am writing to you today urging you to support Legislation 0014-21: "SUPPORTING NEW MEXICO CONGRESSWOMAN DEB HAALAND TO BE APPOINTED AS SECRETARY OF THE INTERIOR, U.S. DEPARTMENT OF INTERIOR, UNDER THE PRESIDENT JOE R. BIDEN ADMINISTRATION."

My name is Nekesia Tulley and I am a college student at University of New Mexico seeking a bachelor's degree in anthropology. My hope is to attain a degree so that I may influence the preservation of knowledge and wisdom of our people as an anthropologist on the Navajo Nation.

I know this area of study is sometimes controversial in our community because of the cultural and traditional beliefs regarding how we interact with our sacred ancestral sites. However, as a Navajo woman I strongly believe that my upbringing, teaching and worldview can influence this profession so that it is more respectful of our Navajo traditional values. If I do not do this work, then this work will be performed by outsiders who have limited knowledge of our ways and ethical standards and they may not take our views into account.

I share this with you because my plight is similar to the work of Congresswoman Deb Haaland—and that is why I want you to support her. Deb knows the controversy and struggle she faces in leading the Department of the Interior, an agency making the tough decisions of weighing environmental and economic impacts. These decisions do not just impact tribal communities, but all communities.

We know that for nearly a century on the Navajo Nation the natural resource extractive industries have brought economic resources to our people and families--in fact, our own Navajo government was created for the purpose of negotiating and executing contracts for mining and oil development. However, we also know that tribal communities are disproportionately impacted by environmental hazards through industry practices and public policies. This reality has created a dilemma. How do we move forward in ensuring the environmental safety of our people while addressing the economic impact to our Navajo families when we decrease our reliance on natural resource extraction and an increase our investment into renewable energy?

There are tough decisions to make, and our Nation is at a crossroads. However, I feel more confident putting my trust in a fellow Native American like Deb Haaland. She knows tribal communities and knows the impact that the Department Interior's decisions will have on our Native families. I trust that she will lead with an even-hand and that the United States will have an Interior Secretary who will make decisions with an Indigenous point of view. For too long individuals have occupied that position and they have little-to-no understanding of the needs of our tribal communities and Navajo families.

I urge our Navajo Nation Council leadership to fully support Deb Haaland's confirmation as the U.S. Secretary of the Interior. Like me, she is working to include a passionate and benevolent voice into a sphere where Indigenous views have often been lacking.

Thank you for considering my perspective.

My name is Ervin Chavez, a member of the Navajo Nation, Nageezi Chapter President, and a 40 year advocate for the Navajo Allottees in Northwest New Mexico. My comments on proposed Navajo Council Legislation 0014-21. I was heavily involved in two major litigations involving the Department of Interior. First under Shii Shi Keyah Navajo Allottee Association VS Donald Hodel Department of Interior from 1982 to 1996. Second litigation Elouise Cobell VS Department of Interior 1996-2010. Both of these cases involved Indian Allotment owners, We advocating for production and accounting of Indian Oil and Gas royalties. At present, Navajo Allotment lands, in Eastern Agency, are part oil and gas productions resulting in IIM royalties being realized by Navajo families. This income is so important to this region of the Navajo Nation because of the lack of economy developments and now being hit with pandemic. Navajo families depend on these revenues for their daily living needs.

New Mexico Congressional Delegations, namely Senators Udall, Senator Heinrich, Representative Lujan, and Representative Deb Haaland tried to push through HB 2181 and SB 1079 placing a 30 mile buffer Zone north of Chaco Canyon National park of no Oil and Gas Developments. These areas are within t Nageezi, Huerfano, and other Navajo Chapters. This was done without any consultations with the Navajo Allottee living and ownership of these allotment lands of Northwest New Mexico. Allottees repeatedly requested for public meetings with these Congressional Delegations to no avail. Both Representatives Lujan and Haaland testified, on the Congressional floor, that they consulted with their constituents on HB 2181, when in fact they did not. The Eastern Agency allottee thanks the Navajo Nation Resources and Development Committee and Navajo Nation Council for supporting resolution on limiting a buffer zone to 5 miles.

Therefore, it is the request that Navajo Nation Council do not support proposed Navajo Council Legislation 0014-21, for the Secretary of Interior and to leave the option open for Congressional hearing. On behalf of Allottees who has concerns with Deb Haaland, as a candidate for this position and her prior actions on land issues in Chaco Canyon area, we strongly feel that she WILL NOT be objective on land issues, including Navajo allotment lands, in her decisions if appointed to Secretary of Interior. We oppose her consideration for this appointment by President Biden/Harris Administration.



First, I want to thank the Honorable Delegate Charles-Newman for introducing Legislation 0014-21 supporting New Mexico Congresswoman Deb Haaland to be appointed as Secretary of the Interior, Department of Interior, under President Joe Biden Administration. Legislation by Delegate Charles-Newman is the right thing to do with the Biden Administration, it strength the relationship between the Navajo Nation and Biden Administration and Congresswoman Haaland during her tenure as the Secretary of the Interior.

Second; I don't know the Congresswoman, never met her but reading the written articles about her, her upbringing in her early years on the Laguna reservation in New Mexico is very much like ours. No running water, inadequate housing, BIA schools, lack of economic development and jobs. She fully understands the hardships her people and other Native Americans went through. The failure of the federal government to carry out their trust responsibilities.

The Secretary of the Interior position is a very powerful position and is responsible for the entire natural resources, federal lands including Indian reservations. The Secretary carries out Presidential Executive Orders, can make policies and change policies, execute extractive leases and other leases, can place moratorium on lands and have power over all waters and so many other important things.

Third; in Dził Yíjiiin region and elsewhere on the reservation we have felt the powers of the Secretary in most cases in a negative ways. Federal government do make mistakes, but they rarely admits them. For example; the creation of the 1882 Executive Order Reservation for two tribes was a major mistake, after 140 years we continue to live under the aftermath. Due to unresolved question as to who real owns the land, federal government place a moratorium on everything on the entire reservation exclusive of the original Hopi reservation. Today, we still lack many economic and infrastructure development, the cancelled grazing permits has not been restored today. While there was moratorium on leases, only Peabody and Kayenta Mine leases on Black Mesa were approved by the Secretary to extract coal and the N-aquifer, our sole source water.

The 50 year lease to mine coal must be weak on reclamations and clean up, Peabody is in the process of walking away leaving the mined area unrestored to its original condition, no underground water recharge system in place, Peabody has no plan to share and laid off all its worker. Instead Peabody has requested the federal government to grant it five years delay for the reclamation. Perhaps given them time to file another bankruptcy which will allow them to walk away untouched. All this is in the hands of the Secretary of the Interior.

In New Mexico, the current policy in executing oil and gas leases by individuals with the government is presenting a serious issues. The extraction of oil and gas uses and pollute lot of underground water. These water are not individually owned but by the entire community. These damaged water effects everyone. The current policy is also in the hands of the Secretary.

Finally, the Navajo Nation in November, 2020 election a huge number supported Biden/Harris ticket, it's beginning to pay off, Biden Administration is appointing Navajos to certain important positions within the Administration, with your unanimous support to legislation 0014-21 it will create an even stronger relationship with the Administration. The new Secretary of the Interior may not be able to correct all of federal failures but will lead the way to softening adverse policies and make them more livable. Consultations and federal trust responsibility with Navajo and other tribes will greatly improve. With the passage of this legislation, other tribes throughout the country will join in.

Honorable Members of the Navajo Nation Council,

Please accept this correspondence concerning Legislation #0014-21, as my personal thoughts in opposition of the Sponsor Ms. Eugenia Charles-Newton's proposal to have the Navajo Nation Council support appointment of New Mexico Congresswoman, Deb Haaland as US Secretary of Interior under President Joe R. Biden Administration. Although I've always voted the Democratic ticket during County, State and General Elections, I chose not to vote for Congresswoman Deb Haaland in the last General Election. Had I voted for her during the 2020 Election Year, it would've meant I agreed with her initiative to proceed with the House and Senate Bills to increase the Buffer Zone on allotted lands surrounding Chaco Canyon National Park located within Eastern Navajo Agency, where many of my relatives own and currently reside on allotted lands that have been passed to them through generations of time. She and other Democratic Congressional leadership never made efforts to consultation with us as actual Allottees. Similarly our own Navajo Nation President failed to consult with us to sit at a listening session to discuss Allottee rights to lease land for gas and oil drilling, although this activity has provided many, many of my relatives self sufficiency with food, shelter, clothing, transportation and education.

I have grave concerns as to what other decisions will commence to be made in behalf of our people from all Navajo Agencies and other Native Tribes across this United States of America, with no consultation on Native issues/concerns. If Congresswoman Haaland was capable of taking the actions she has with Gas & Oil without giving us ANY TIME to consult, what other initiatives will she do to benefit her own Agenda without consultation with all Native Tribes? At the few times I've heard her talk, she's never referenced ANY NATIVE TRIBE at all. She talks about her Tribe and her Tribe alone.

Remember Honorable Delegates, the Naabikyati Resolution, NABIIA-20: OPPOSING THE CHACO HERITAGE AREA PROTECTION ACT of 2019, was approved and passed by you. Congresswoman Deb Haaland was a part of that initiative. Of much graver concern to me is, when she brings out that Chaco Canyon rightfully belongs to the Pueblo people, does that mean she may be beginning another era like that of the former Navajo/Hopi Land Dispute? Chaco Canyon is in the heart of Eastern Navajo. Our people have lived there for generations. Our people cannot go through another era of land dispute because our Navajo Government supported an Interior Secretary who already fails to CONSULTATION with grass rooted Dine' who currently occupy allotted land surrounding Chaco Canyon.
