20 SECTION ONE. AUTHORITY	
A. The Resources and Development Committee is a standing committee of the Navajo Nation	
Council with oversight authority regarding environmental protection, land, community	
development, the use of Navajo Nation lands, and related matters. 2 N.N.C. §500(C) and	
24 §501(B)(1).	
B. The Resources and Development Committee also has authority over the Division of	
Economic Development ("DED"), including DED's subordinate Departments and Offices	
such as the Chinle Regional Business Development Office ("Chinle RBDO"). 2 N.N.C.	
28 §501(C)(1).	
C. The Budget and Finance Committee is a standing committee of the Navajo Nation Council	
with the responsibility to "review and recommend to the Navajo Nation Council the	
·	

- budgeting, appropriation, investment and management of all funds." 2 N.N.C. §301(B)(2).
- D. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council that considers all proposed final actions by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
- E. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A). As such, the Council may approve appropriations from the Navajo Nation's Síhasin Fund.
- F. 12 N.N.C. §2502, as amended by CJA-03-18, states the purpose of the Navajo Nation Síhasin Fund ("Síhasin Fund") as follows:

§2502 Purpose

- A. The purposes of this Fund are to provide financial support and/or financing for:
 - 1. The planning and development of economic development and regional infrastructure supporting economic development and community development, including such infrastructure as, but not limited to, housing, commercial and government buildings, waterline, solid waste management development, powerline Projects, and transportation and communication systems, within the Navajo Nation; . . .
- B. For the Purpose in §2502(A)(1), Fund expenditures for infrastructure shall not be limited by 12 N.N.C. §1310(F) or TCDCJY-77-99.
- C. Leveraging the Fund by way of guaranteeing loans, match funding, direct funding in part, and other weighted uses of the Fund, including loan financing from the Fund, for the purposes in §2502(A)(1), shall be favored over direct funding in whole.
- G. The Síhasin Fund provides that "Fund Principal" shall consist of all deposits made to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.) generated and realized by the Fund Principal, and that Síhasin Fund Income shall be deposited in, and added to, the Fund Principal until such time as a Fund Expenditure Plan is duly approved. 12 N.N.C. §2504 and §2505(C).
- H. The Síhasin Fund provides that "Fund Principal and Income shall not be expended except pursuant to a Fund Expenditure Plan consistent with the purposes set forth in §2502 of this Chapter and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation Council." 12 N.N.C. §2505(A).

SECTION TWO. FINDINGS

- A. In a letter dated November 2, 2022, the Chinle RBDO requests \$65,000 from the Síhasin Fund for site demolition and cleanup ("Cleanup Project") of the abandoned Smith's Cafe business site located in the Chinle community. **EXHIBIT A**. The Chinle RBDO explains that, once the Cleanup Project is completed, the site will be ready for new business opportunities; furthermore, this Cleanup Project is part of the Chinle RBDO's 5-year Plan. **EXHIBIT B**.
- B. A Summary and Scope of Work for the Cleanup Project is attached hereto as **EXHIBIT C**.
- C. A detailed Cost Estimate for the Cleanup Project, and a map showing the location of the site, are attached hereto as **EXHIBIT D**.
- D. Allocation of the Síhasin funds as requested by the Chinle RBDO meets the criteria for Síhasin expenditures, because the Cleanup Project will involve economic and community development, and commercial buildings, as described in 12 N.N.C. §2502(A)(1).
- E. Allocation of the requested Síhasin funds also meets the criteria for the leveraging of funds, as described in 12 N.N.C. §2502(C), because the Cleanup Project will clean up and clear the abandoned site and prepare it for new business opportunities, which will then generate new tax revenue for the Navajo Nation.

SECTION THREE. APPROVING \$65,000 FROM THE SÍHASIN FUND FOR THE DEMOLITION AND CLEANUP OF THE FORMER SMITH'S CAFE BUSINESS SITE UNDER THE CHINLE RBDO; APPROVING THE RELATED EXPENDITURE PLAN

- A. Pursuant to 12 N.N.C. §2505(A), the Navajo Nation hereby approves \$65,000 from the Síhasin Fund for the Chinle RBDO's proposed demolition and cleanup of the abandoned Smith's Cafe business site located in the Chinle community.
- B. The Navajo Nation hereby approves the related Expenditure Plan for the Chinle RBDO's proposed Cleanup Project, as set forth in **EXHIBIT D** attached hereto.
- C. The Controller shall determine whether the source of the Síhasin funds approved herein will be Síhasin Fund Principal or Síhasin Fund Income, or a combination of both.
- D. The total amount of approved Síhasin funds may be further leveraged by bond or loan

financing pursuant to the Navajo Nation Bond Financing Act (12 N.N.C. §1300 *et seq.*, as amended), using Síhasin Fund earnings for repayment and financing costs, upon approval of the Budget and Finance Committee and upon a 2/3 approval vote of the full membership of the Navajo Nation Council.

- E. No later than 30 business days after the effective date of this Action, the approved Sihasin funds shall be disbursed to the Division of Economic Development for the Chinle RBDO's use in implementing and completing its Cleanup Project, as described herein.
- F. The approved Sihasin funds shall not be comingled with any other funds, and shall be used by Chinle RBDO strictly for the Cleanup Project. DED and Chinle RBDO shall be responsible for ensuring that all expenditures comply with the approved Expenditure Plan (EXHIBIT D).
- G. The approved Síhasin funds for the Cleanup Project shall not lapse at the end of any fiscal year, as might otherwise occur under 12 N.N.C. §820(N), so long as: (1) all Síhasin funds in the Cleanup Project account are accounted for as of September 30 of each fiscal year; and (2) any/all remaining Síhasin funds are budgeted in the next upcoming fiscal year for use on the Cleanup Project.
- H. Notwithstanding Section Three (G) above, any remaining amount of Síhasin funds not expended or encumbered within 24 months of DED's receipt of such funds shall revert to the Síhasin Fund, unless otherwise approved prior to such reversion by both the Resources and Development Committee and the Naabik'íyáti' Committee.
- I. The Sihasin Fund may be reimbursed the amount of funds approved herein, from funds available to the Navajo Nation from any and all state, federal, or other sources.

SECTION FOUR. EFFECTIVE DATE

This Action shall become effective pursuant to 12 N.N.C. §2505(A) and 2 N.N.C. §221(B).

SECTION FIVE. SAVING CLAUSE

If any portion of this Action is invalidated by the Supreme Court of the Navajo Nation, or by any Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the remainder of this Action shall be the law of the Navajo Nation.

PROJECT SUMMARY

Demolition/Site Cleanup Project FORMER BENNIE SMITH BUSINESS SITE Chinle, Arizona

This site, formerly known as the Bennie Smith Business Site, is located along US Route 191 on the west side just across the Chinle High School in Chinle, AZ. The site of 1.44 acre has been abandoned due to the decease of both lessees. The remains of a business structure that has burnt consist of mainly debris, a concrete staircase that is approximately 10 ft x 15 ft., a flag pole, signage and asphalt.

SCOPE OF WORK

- 1. Completely demolish all remaining structures, including floors and foundations, and dispose of the building materials and all debris on the 1.44-acre business site.
- 2. Grade the site to a smooth finish, free of any debris such as pieces of concrete and/or burnt trees. All small pieces of debris shall be raked up.

ESTIMATED CONTRACTUAL COST:

\$65,000.00

Demolition/Site Cleanup Project FORMER SMITH'S CAFÉ BUSINESS SITE Chinle, Arizona

The project consists of demolition and site cleanup of the former Smith's café business site located in Chinle, AZ. The entire site is 1.44 acres in size. The double wide mobile building structure burned several years ago and currently the burnt debris and remains of the building remain on the site. The remaining debris includes the old foundation, brick walls, metals and other debris scattered on the site. The entire site is in need of demolition and cleanup and the site should be cleared and leveled.

SCOPE OF WORK

- 1. Completely demolish all remaining structures, including concrete foundations, steps, walls and debris and dispose of the contents to an approved waste disposal location.
- 2. Remove and dispose of all asphalt/concrete parking lot up to the main road entrance to Highway 191 and concrete sidewalks and brick walls around the lot.
- 3. Dispose of all metal trailer frames and remnants of the burnt building structure including mangled metal frames, galvanized posts, etc.
- 4. Remove/uproot two fire damaged dead trees, steel posts, tires, debris, junk, concrete piles and trash from the entire site.
- 5. Remove or retire and cap all former water lines, sewer lines, and gas lines in accordance with NTUA requirements.
- 6. Disconnect and remove all site utilities (electric, water, sewer and telecommunications) in accordance with NTUA requirements including three (3) street light poles and any buried utilities.
- 7. Remove two metal signage and flag pole on the site and dispose of to an approved disposal location.
- 8. Preserve or remove any buried utility indicated by a yellow utility marker on the site.
- 9. Grade the site to a smooth finish, free of any debris such as pieces of concrete. All small pieces of debris shall be raked up.


