TITLE OF RESOLUTION: A PROPOSED NAVAJO NATION COUNCIL RESOLUTION; AN ACTION RELATING TO BUDGET AND FINANCE AND NAABIK'ÍYÁTI' COMMITTEES, AND THE NAVAJO NATION COUNCIL; RESCINDING CD-85-18 WHICH AMENDED THE NAVAJO NATION PERMANENT FUND INCOME FIVE YEAR EXPENDITURE PLAN, CAP-19-16, REGARDING FOURTH YEAR FUNDING FOR FORT DEFIANCE AGENCY PROJECTS

PURPOSE: The purpose of this resolution, if passed, is to rescind CD-85-18, regarding the expenditure of the permanent fund income pursuant to the Permanent Income Five Year Expenditure Plan for Fort Defiance Agency from three economic development projects to one economic development project, the Indian Wells Economic Development Project. By rescinding CD-85-18, to fully restore the \$3,700,000 funding, allocated through CAP-19-16, to the Indian Wells Economic Development, the Fort Defiance Agency's Fourth Year Project.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

Section One. Authority

- B. The Naabik'íyáti' Committee of the Navajo Nation Council, pursuant to 2 N.N.C. §164(A)(9), reviews proposed legislation which requires final action by the Navajo Nation Council.
- C. The Budget and Finance Committee is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. §300(B)(2).

Section Two. Findings

- 1 A. The Navajo Nation Council passed and the Navajo Nation President signed into law
2 CAP-19-16, the Navajo Nation Permanent Fund Income Five Year Expenditure Plan.
3 *See* CAP-19-16.
- 4 B. In CAP-19-16 the Navajo Nation approved use of the Permanent Fund Income for
5 major waterline projects throughout the Navajo Nation and economic development
6 projects in regional centers across the Navajo Nation; including the Fourth Year
7 economic development project for Indian Wells Economic Development Project
8 totaling \$3,700,000. CAP-19-16, Exhibit A attached as **Exhibit 2**.
- 9 C. The Navajo Nation Council amended CAP-19-16 by enacting CD-85-18 which is
10 attached as **Exhibit 1**. Resolution CD-85-18 amended the Fort Defiance Agency
11 economic development project from one project—the Indian Wells Economic
12 Development funded at \$3,700,000—to three economic development projects—the
13 Indian Wells Economic Development project at \$1,500,000, Greasewood Springs
14 Economic Development Convenience Store at \$1,500,000, and Little Colorado River
15 Corporation Economic Development at \$700,000; a total of \$3,700,000.
- 16 D. The Indian Wells Chapter through its resolution IWC-19-150, attached as **Exhibit 3**,
17 “supports and approves a request for the 24th Navajo Nation Council to Rescind the
18 23rd Navajo Nation Council Resolution CD-85-18 restoring an original funding
19 amount of \$3,700,000 to the Indian Wells 10 Acre Commercial Site Project.”

21 **Section Three. Rescinding CD-85-18**

- 22 A. The Navajo Nation hereby rescinds CD-85-18, **Exhibit 1**, regarding the expenditure
23 of the permanent fund income pursuant to the Permanent Income Five Year
24 Expenditure Plan for Fort Defiance Agency from three economic development
25 projects to one economic development project, the Indian Wells Economic
26 Development Project.
- 27 B. The Navajo Nation hereby rescinds CD-85-18 to fully restore the \$3,700,000 funding,
28 allocated through CAP-19-16, to the Indian Wells Economic Development, the Fort
29 Defiance Agency’s Fourth Year Project.

AN ACTION

RELATING TO BUDGET AND FINANCE AND NAABIK'ÍYÁTI' COMMITTEES, AND
THE NAVAJO NATION COUNCIL; AMENDING THE NAVAJO NATION PERMANENT
FUND INCOME FIVE YEAR EXPENDITURE PLAN, CAP-19-16, REGARDING
FOURTH YEAR FUNDING FOR FORT DEFIANCE AGENCY PROJECTS

BE IT ENACTED.

SECTION ONE. AUTHORITY

- A. The Navajo Nation Council is the governing body of the Navajo Nation, pursuant to 2 N.N.C. § 102 (A).
- B. The Naabik'iyáti' Committee of the Navajo Nation Council, pursuant to 2 N.N.C. § 164(A)(9), reviews proposed legislation which requires final action by the Navajo Nation Council.
- C. The Budget and Finance Committee is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. § 300(B)(2).
- D. Pursuant to 2 N.N.C. § 300(C)(3), the Budget and Finance Committee of the Navajo Nation Council shall exercise oversight authority including, but not limited to, budget, finance, investment, bonds, contracting, insurance, audits, accounting, taxes, loans, chapter budget and finance for the purpose of recommending to the Navajo Nation Council the adoption of resolution designed to strengthen the fiscal and financial position of the Navajo Nation and to promote the efficient use of the fiscal and financial resources of the Navajo Nation.

SECTION TWO. FINDINGS

- A. The Navajo Nation Council passed, and the Navajo Nation President signed, into law CAP-19-16, the Navajo Nation Permanent Fund Income Five Year Expenditure Plan. See CAP-19-16.
- B. As stated in CAP-19-16, the Navajo Nation Permanent Fund sets out the procedures for expenditure of fund income by stating "[no Fund income shall be expended, except as set forth in §§

908 and 909 of this Chapter, for a period of 20 years from date of the first Navajo Nation contribution to the Fund. Thereafter, ninety-five percent (95%) of the Fund income may be expended in accordance with a plan for its use covering at least a five-year period adopted by resolution of the Navajo Nation Council provided that the expenditure of income in any fiscal year shall not exceed the income earned during that year. The remaining five percent (5%) of the Fund income shall be reinvested in the Permanent Fund." 12 N.N.C. §905.

- C. In CAP-19-16 the Navajo Nation contemplated the use of the Permanent Fund Income for major waterline projects throughout the Navajo Nation and economic development projects in regional centers across the Navajo Nation; including the Fourth Year economic development projects for Indian Wells totaling \$3,700,000. See CAP-19-16, **Exhibit A**.
- D. The Fort Defiance Agency proposes amending CAP-19-16, **Exhibit A**, of a single project plan to three economic development projects which include the Indian Wells Economic Development at \$1,000,000, Greasewood Springs Economic Development Convenience Store at \$1,500,000, and Little Colorado River Corporation Economic Development at \$1,200,000; a total of \$3,700,000. See preliminary project descriptions attached as **Exhibits B, C and D**, respectively.

SECTION THREE. APPROVING AN AMENDMENT TO CAP-19-16

- A. The Navajo Nation hereby amends CAP-19-16, **Exhibit A**, regarding the expenditure of the permanent fund income pursuant to the Permanent Income Five Year Expenditure Plan for Fort Defiance Agency; from a single economic development project to three economic development projects.
- B. The Navajo Nation hereby amends CAP-19-16 to include, for Fort Defiance Agency's Fourth Year Projects as:
 - 1. Indian Wells Economic Development at \$1,000,000; **Exhibit B**,
 - 2. Greasewood Springs Economic Development Convenience Store at \$1,500,000, **Exhibit C**, and,
 - 3. Little Colorado River Corporation Economic Development at \$1,200,000. **Exhibit D**.

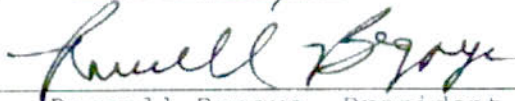

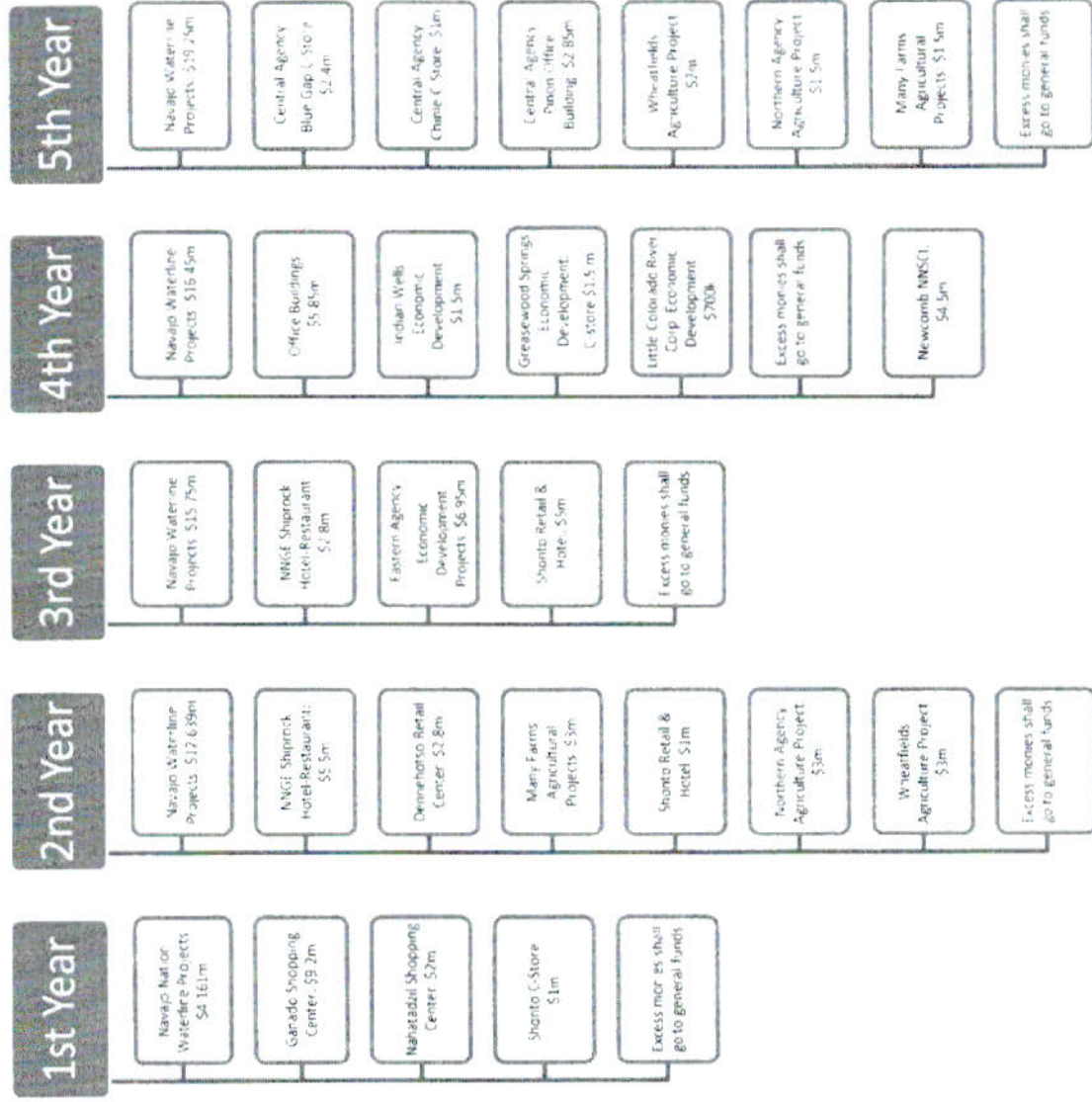

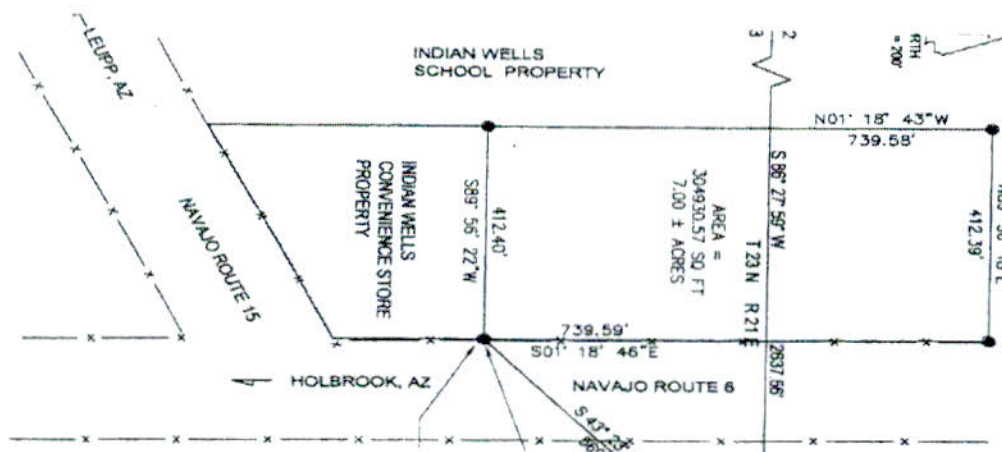

The Chinle Regional Business Development Office, Division of Economic Development, the Navajo Nation is seeking retail tenants for the proposed 10 acres commercial tract, at Indian Wells, Navajo Nation (Arizona). The development will be located at the northwest intersection of Navajo Route 6 and Navajo Route 15.

An anchor Convenient Store with gasoline pumps is recommended on the southern end of the tract consisting of 2 – 3 acre plot. The remaining tract of land will consist of retail shops/spaces.

Indian Wells Commercial Site Development

In 2005, the Indian Wells Community withdrew 25 acres of land for commercial development. Of the 25 acres, the Division of Economic Development, Small Business Development Department, is currently working on developing infrastructure for 10 of the 25 acres.

The 10 acres infrastructure project consists of the following:

1. Clearing, grubbing and grading of the site, which is currently raw land.
2. Construction of two access roads to the project site, earthwork only.
3. Drainage works.
4. Installation of a watermain to the project site.
5. Installation of an on-site sewer disposal system. The sewer system includes 8 inch gravity sewer mains; manholes; distribution boxes; and a drainfield.

The Infrastructure Engineering Design/Construction Documents for the 10 acres was completed by the project consultant, iina' ba', inc. The costs of the engineering work totaled \$89,867.50, which was funded by DED.

The infrastructure work was publicly advertised in order to procure a contractor to construct the project. The amount of funds that were available limited the scope of work to clearing, grubbing, grading, access roads and drainage works. Arviso Construction Company, Inc. was awarded the construction contract in the amount of \$601,013. The funding for the contract included DED sales tax funds and Tourism funds.

In order to complete the infrastructure project within the 10 acres, additional funds are necessary. Funds are also needed to develop the additional 15 acres. In order to fully develop the whole 25 acres in a consistent and efficient manner, a Commercial Development Feasibility Study to evaluate the market, technical, financial and organizational aspect of the development is indispensable. Along with the Feasibility Study, a Masterplan for the entire 25 acres is essential.

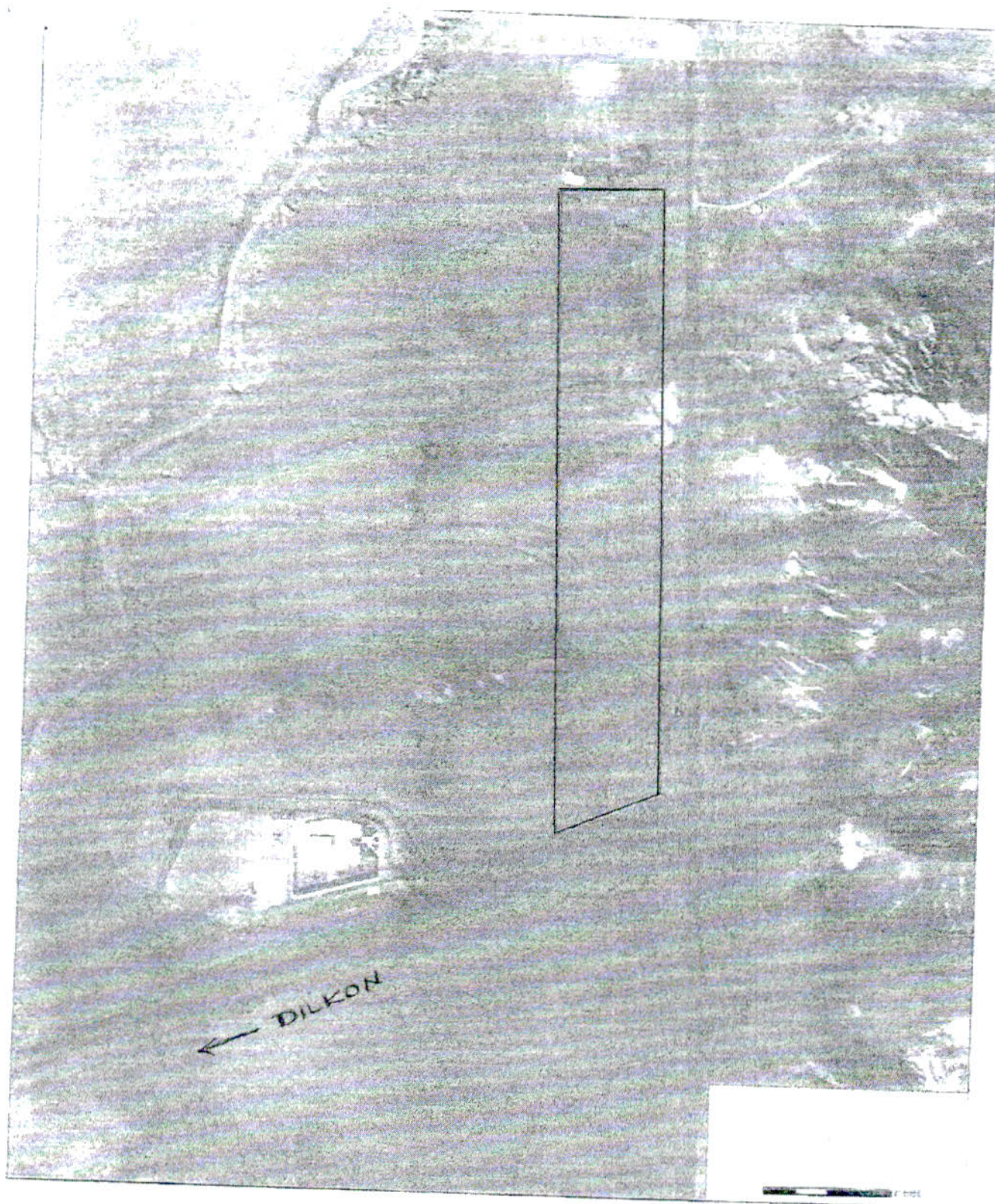
Indian Wells Commercial Site
Infrastructure Project Summary

Location: Intersection of Navajo Route 6 and Navajo Route 15.

Awarded a construction contract, in the amount of \$601,012.96, to Arviso Construction, Inc. for site preparation work. The work is being funded by DED Tourism funds and the Sales Tax funds. The Project is scheduled to be completed in 60 days, with December 15 projected as the completion date.

1. The Site Preparation Scope of Work includes:

- A. Grade and Drain work on 10 acres. Grade the current raw land and prepare it for development.
 - B. Construct 2 access road turnouts to site. One from Route 6 and one from Route 15. Grade an drain only.
2. Upon funds availability, the rest of the infrastructure can be completed, including extension of a 6 inch waterline to the site and installation of the wastewater disposal system.
3. Upon completion of the infrastructure, development of commercial projects within the 10 acre site can proceed.
4. Concurrently, a Feasibility Study and Master Plan for the entire 25 acres Commercial Site is recommended.



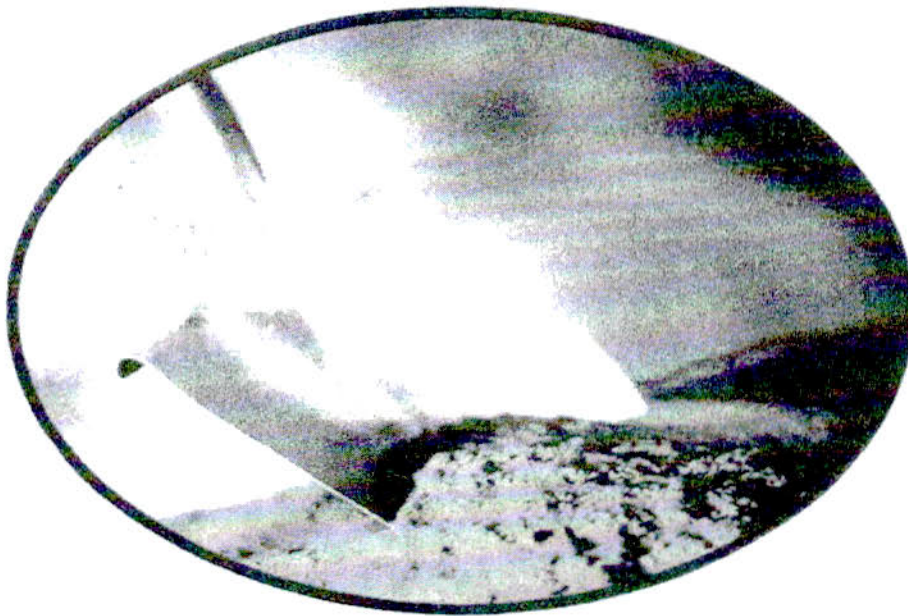
Indian Wells Future Development Site - Aerial

\$1162(B) FOR A LIMITED TIME PERIOD

BE IT ENACTED.

Section One. Authority

- A. The Navajo Nation Council is the governing body of the Navajo Nation, pursuant to 2 N.N.C. § 102 (A).
- B. The Naabik'íyáti' Committee of the Navajo Nation Council, pursuant to 2 N.N.C. §164(A)(9), reviews proposed legislation which requires final action by the Navajo Nation Council.
- C. The Budget and Finance Committee is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. §300(B)(2).
- D. Pursuant to 2 N.N.C. §300(C)(3), the Budget and Finance Committee of the Navajo Nation Council shall exercise oversight authority, including but not limited to, budget, finance, investment, bonds, contracting, insurance, audits, accounting, taxes, loans, chapter budget and finance for the purpose of recommending to the Navajo Nation Council the adoption of resolution designed to strengthen the fiscal and financial position of the Navajo Nation and to promote the efficient use of the fiscal and financial resources of the Navajo Nation.

Section Two. Findings

- A. The Navajo Nation Permanent fund, established in 1985, made available certain funds after a 20 year period and such funds have been available for use since 2005;

however, the fund income of the Navajo Nation Permanent fund continues to be reinvested in the Permanent Fund.

- B. The Navajo Nation Permanent Fund was established for the purpose of creating reserves for future generations after finding that the Navajo Nation's General Reserve Fund had been declining. See CJY-53-85, Whereas Clause Two and Six.
- C. The Navajo Nation Permanent Fund defines fund income as consisting of all earnings generated by the principal of the Fund. 12 N.N.C. §903(B).
- D. The Navajo Nation Permanent Fund sets out the procedures for expenditure of fund income by stating "[n]o Fund income shall be expended, except as set forth in §§903 and 909 of this Chapter, for a period of 20 years from date of the first Navajo Nation contribution to the Fund. Thereafter, ninety-five percent (95%) of the Fund income may be expended in accordance with a plan for its use covering at least a five-year period adopted by resolution of the Navajo Nation Council provided that the expenditure of income in any fiscal year shall not exceed the income earned during that year. The remaining five percent (5%) of the Fund income shall be reinvested in the Permanent Fund." 12 N.N.C. §905.
- E. As stated above, the permanent fund income has been available for use since 2005 and a prospective plan for the use of the permanent fund income covering a 5-year period, attached as Exhibit A, includes major waterline projects throughout the Navajo Nation and economic development projects in regional centers across the Navajo Nation and is generally described as:
 - 1. Navajo Nation Waterline Projects, Total: \$68,250,000, detailed in Exhibit B;
 - 2. Regional Economic Development Projects, Total: \$81,750,000, detailed in Exhibit C;
- F. The Navajo Nation Local Governance Trust Fund is established with an appropriation that "Beginning in Fiscal Year 2007, the Fund shall annually receive fifty-percent (50%) of the income available from the Navajo Nation

Permanent Fund pursuant to 12 N.N.C. §905; However to accomplish the essential Navajo Nation waterline and regional economic development projects it is necessary to lessen the appropriation to the Local Governance Trust Fund for the five year period of the expenditure plan. See 12 N.N.C. §1162 regarding annual appropriation and Exhibit A for Fund appropriation over the five year period.

- G. The Navajo Nation finds it in the best interest of the Nation to approve the Permanent Fund Income Five Year Expenditure Plan.

Section Three. Waiving 12 N.N.C. §1162(B)

The Navajo Nation hereby waives 12 N.N.C. §1162(B) for the period of the Permanent Income Five Year Expenditure Plan and approves the reduced annual appropriation to the Navajo Nation Local Governance Trust Fund to Confirm with the Permanent Income Five Year Expenditure Plan.

Section Four. Recommending and Approving

The Navajo Nation hereby recommends and approves the expenditure of the permanent fund income pursuant to the Permanent Income Five Year Expenditure Plan described as:

A. Navajo Nation Waterline Projects, Total: \$68,250,000;

B. Regional Economic Development Projects, Total:
\$81,750,000

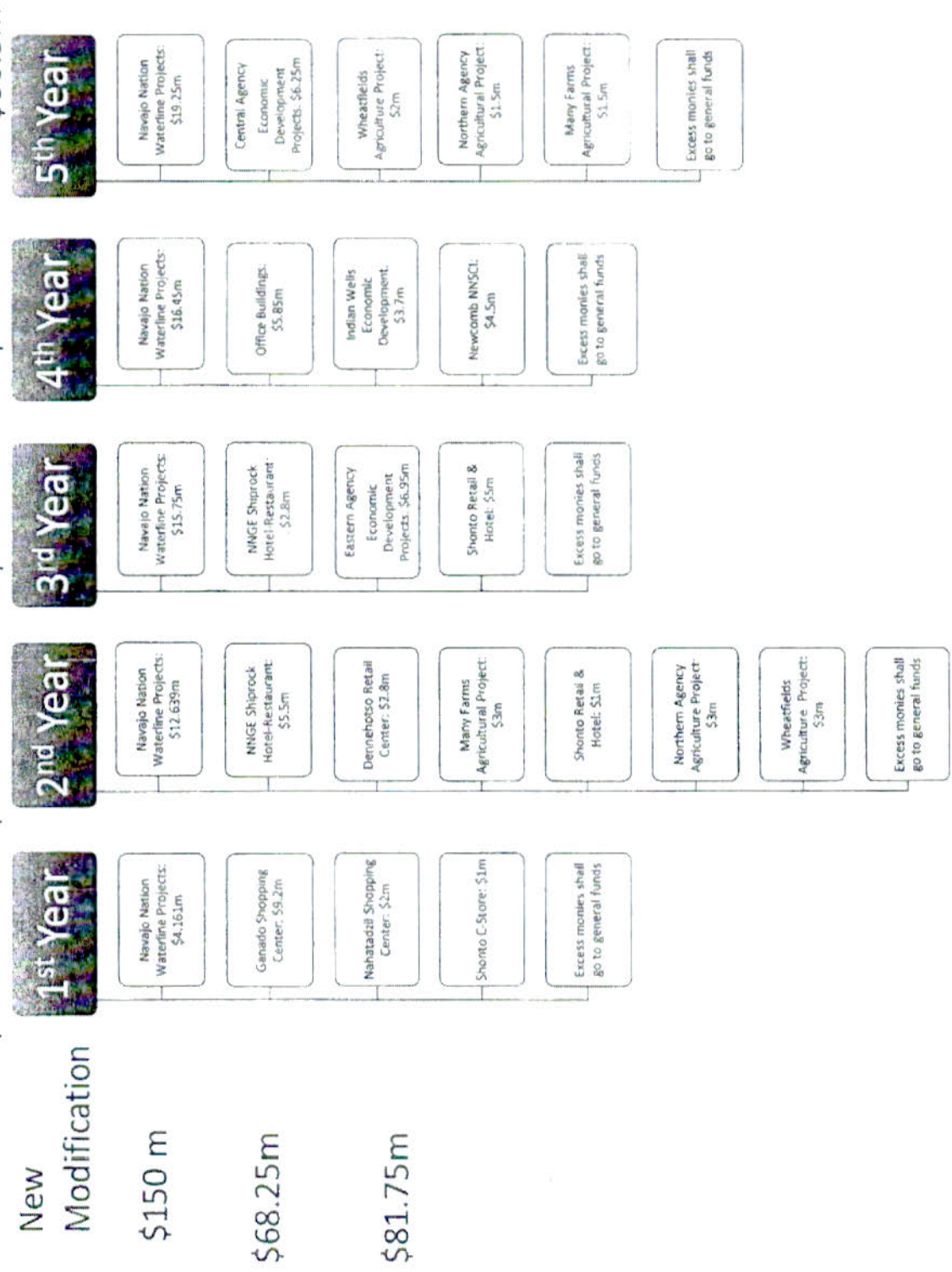

WHEREAS:

1. The Indian Wells Chapter is a recognized Chapter of the Navajo Nation government, vested with certain authority and responsibilities to consider and take action on matters of local concern that are in the best interest of the health, safety and welfare of the Chapter membership and residence, and;
2. Pursuant to 26 N.N.C., Navajo Nation Local Governance Act, the Navajo Nation Council delegates to Chapters governmental authority with respect to local matters, consistent with Navajo law, including customs and traditions, to make decisions over local matters, and to govern with responsibility and accountability to the local citizens, and;
3. Pursuant to Navajo Nation Council resolution CAP-19-16, the Navajo Nation Council allocated \$3.7 million to the Indian Wells Economic Development for the 4th year of the five-year plan from the Navajo Nation Permanent Fund Income Five Year Expenditure Plan, and;
4. The Navajo Nation Council Resolution number CD-85-18 reduced the Indian Wells Economic Development project funds from \$3.7 million to \$1 million, reallocating \$2.7 to other projects, and;
5. The Indian Wells Chapter advocates for the continued economic development preparation as initially planned by the Community.

NOW THEREFORE BE IT RESOLVED THAT:

1. The Indian Wells Chapter and its community membership supports and approves a request for the 24th Navajo Nation Council to Rescind the 23rd Navajo Nation Council Resolution CD-85-18 restoring an original funding amount of \$3,700,000 to the Indian Wells 10 Acre Commercial Site Project.

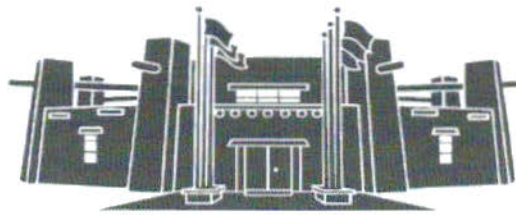

The Greasewood Springs Chapter with Resolution GSC-08-16-0653 & GSC-07-14-0461 withdrew community lands with proper consent for Economic Development and through Contract AIA B104-2007 retained JW2 Architects to complete a Master Plan that includes a gas station, food market, laundromat, transit bus stop, picnic area, and available spaces for vendors; herein attached as Exhibit 1.
4. The Greasewood Springs Chapter with Resolution GSC-08-18-0869 reaffirmed an Economic Development Zone of 32.8972 acres: surveyed by Northland Exploration Surveys on 02/10/2017; biologically surveyed & cleared by NN Fish & Wildlife on 08/09/2018 (NNDFW Review No. 18GSC-01); formally withdrawn & approved by the NN Land Department on 08/23/2018; geotechnically evaluated & cleared on 04/16/2017 by GeoTech Environ Inspections Material; and archeologically cleared & approved by the Bureau of Indian Affairs on 01/24/18, herein attached at Exhibit 2.

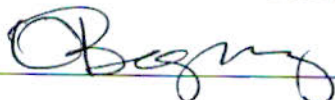

The Navajo Nation has 9 parcels of Land here within the city ready to be developed; each zoned differently. Parcel 5 is commercially zoned and is our number one project and is now shovel ready. Again, the Winslow Dineh have from the get-go envisioned opportunities to develop these lands for economic development. Winslow city's location is prime for these developments to benefit the border town relocated people and the Navajo Nation. The LCCDC vision states Self-Reliance and Self-Sufficiency to achieve these goals in light of challenges facing us.

Winslow city also have the Relocateses whom were forcibly removed off their lands. The negative consequences of this relocation is endless, currently effecting through the 3rd generation.

Currently, we are in the process of seeking MATCHING FUNDS at the AZ State Level to leverage the 1.2 million in the CD-85-18.

We have enclosed our proposal which will explain more in depth, Winslow Dineh and LCCDC goals and objectives.

We encourage the Navajo Nation Standing Committee; Budget and Finance and The Naabik'yaati Committee and The 24th Navajo Nation Council **TO OPPOSE** passage of TRACKING NO. 0270-19 Legislation. Your efforts and support are very much appreciated in advance.

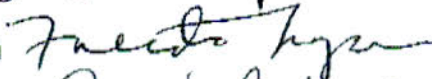

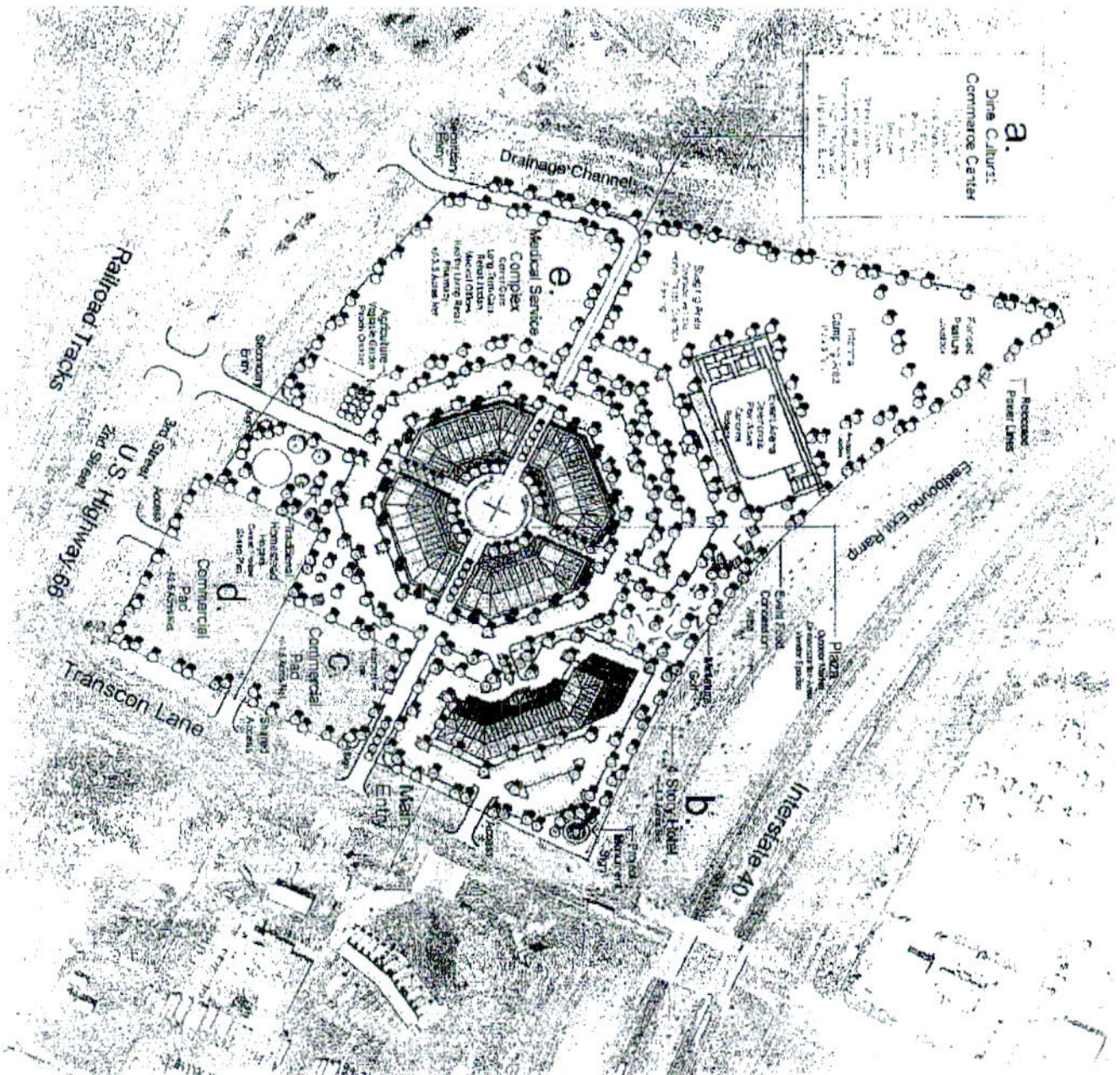

Introduction

The Little Colorado Community Development Corporation (LCCDC) was created to represent the interests of the Winslow Dine Residents (WDR) and to seek resources that would further the mission of both organizations. WDR is a grassroots organization of Dine residents living in Winslow, Arizona. Many were either directly impacted or are second and third generation victims of the Navajo Hopi Settlement Act of 1974 having been forcefully removed from their home communities and moved into urban centers across the Southwest. Several hundred were relocated to Winslow, forty years later, they are now experiencing the negative impacts of a failed human designed government policy. The Settlement Act also known as the Relocation Act left more than 10,000 Dine alienated from their culture and stripped of their right to the Dine way of life. Today, relocated families and the generations that have followed are experiencing economic difficulties, a lack of adequate housing, and as a result have high instances of social and health challenges. These families and others affected by conditions in a border town community formed Winslow Dine Residents to proactively improve the social and economic outcomes as a result of being part of the Winslow community.

Little Colorado CDC was formed to support Dine residents of Winslow, Arizona. Located within 15 miles of the Southernmost boundaries of the Navajo Nation, Winslow's population is 30% Native American. In 2010, a grassroots group of relocates and other Navajo residents of Winslow began to meet to provide support and discuss solutions to the problems they experience. The group Winslow Dine Residents met regularly for three years before they nominated the first Board of Directors to form Little Colorado Community Development Corporation. LCCDC is the people driven force created to act on behalf of the priorities set forth by WDR. A primary activity of LCCDC would be to utilize property owned by the Navajo Nation in and around the City of Winslow. In 2015, a Land Inventory Report was compiled and identified nine Navajo Nation owned parcels with various zoning designations.

LCCDC's goal is to utilize land resources owned by the Navajo Nation for the Dine residents of Winslow. The priorities set forth by WDR identified a need to develop lands that would provide economic benefits to the organization that would generate revenue to provide sustainable human centered services to the people. Leveraging the various land parcels, LCCDC could provide employment opportunities, small business development, artisan studio and gallery space, arts and crafts vending space, education services, quality housing, life skills training, and educational services for our Dine who are currently living in Winslow.

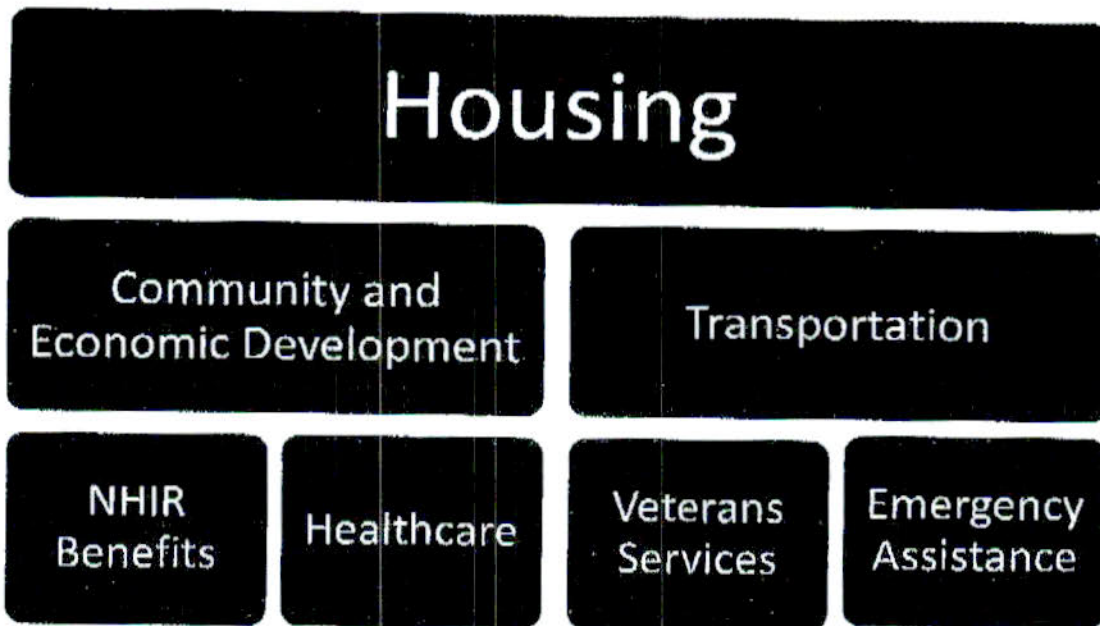

Priorities

Priorities identified by WDR and LCCDC.



Strategy for Project Development

LCCDC is working toward developing an organization to tackle these priorities and respond to the people's identified needs. Leveraging resources owned by the Navajo Nation will allow the organization to meet needs through coordinated efforts to build financial resources and provide economic opportunities while also building human centered programs. An evaluation of the nine parcels owned by the Navajo Nation within or adjacent to the City of Winslow boundaries indicated one parcel that was zoned commercial property and had the most opportunity to begin building the organization. A USDA grant was secured to develop a Master Plan for the site which will house a variety of community and economic development opportunities for the Dine residents in and around Winslow and for the citizens of Winslow. This project was designed to catapult all other efforts by the organization to continue to pursue other opportunities and build quality programs and services for Dine people.

Other parcels of land have been identified and will be used to provide housing and educational programs in addition to the possibility of agricultural uses.

Winslow Dine Cultural and Commerce Center Development

In 2016, the USDA awarded LCCDC a Rural Business Development Grant to provide master planning for the development of commercial property and to provide small business technical assistance, and other services. The grant was used to develop a Master Plan for Parcel Five, 33 acres of commercially zoned property identified in the Land Inventory Report. The plan was developed through a series of public meetings with WDR and the general public which provided the basis for the various elements within the commercial site. In 2017, LCCDC completed the plan including a zoning overlay from the City of Winslow and an official Land Withdrawal from the Navajo Nation allowing further site investigation to prepare for construction. The complete Master Plan includes an official land survey, environmental, and archeological assessment of Parcel Five. The commercial development will feature a cultural center that will provide visitors and local residents a place to experience the Dine culture and learn about the history of the Dine and surrounding Native people in Winslow. The site will be a central location to inform guests about travel and tourist information while also centralizing significant services that will provide economic and community development opportunities for local residents. The cultural center will feature artists galleries including an artist residency, cowork space for professionals traveling through Winslow on Interstate 40, meeting space, space for arts and crafts vendors, and a high quality but casual restaurant. Additionally, a professionally curated museum telling the story of Native people in the region will be built as a focal point of the cultural center. Finally, a viewing tour will allow for visitors to climb high enough to experience spectacular 360 degree views of the Little Colorado Plateau.

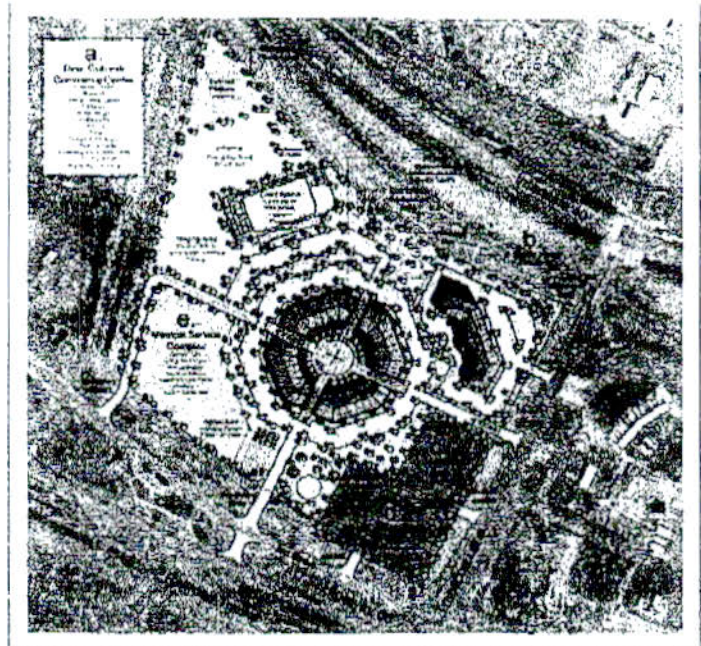

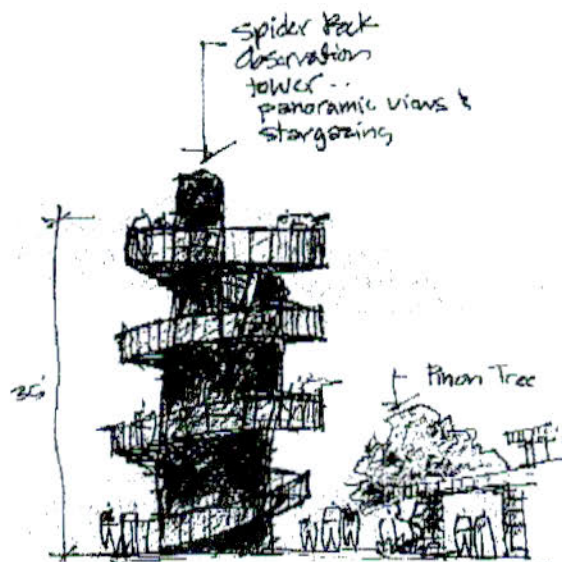

2018 LCCDC GOALS

Goal #1: Secure funds to open an LCCDC office to support operations

Lease office space in Winslow to manage operations and program administration. The Board of Directors seeks to hire full time staff to move the various projects forward. The commercial development needs to be managed by a Chief Executive Officer in addition to furthering other priorities and opportunities to leverage the land parcels. Up to this point, LCCDC and WDR have been operated by volunteers and many opportunities and interests of the board and residents are competing for time and resources. A staff would focus on implementing the vision that has been created for the organization. LCCDC's vision is to build a successful enterprise that would support the priorities of the Dine people in Winslow. One of the major priorities is adequate housing and education services.

Goal #2: Seek Financial Investment to develop Parcel 5, 7, & 8

LCCDC completed a Master Plan for the commercial district in Parcel 5 and will continue to seek financial investment and partnerships. The site has several components that are currently phased for development. LCCDC's priority for development is to acquire funds to pay for site infrastructure and excavation that will deem the site "shovel ready" and primed for investment. The Cultural Center will be managed by LCCDC and will house the organization once the construction is completed.

To support the needs of the commercial development, LCCDC is proposing a solar energy generation facility on 84.75 acres in Parcel 7 & 8. Boundary surveys have been completed, however environmental and archeological surveys are needed. This project will require a development partner that is experienced and well versed in solar generation.

Goal #3 Affordable Housing

Affordable housing is desperately needed by Dine residents and those who work in Winslow and the surrounding areas. LCCDC has identified Parcel 1 in the Land Inventory Report for the primary purpose of building a living community. We envision a living community that provides residents with affordable housing and the ability to engage in cultural activities that sustain and uplift families. Housing is essential for a community to sustain itself and the Board at LCCDC considers it to be essential to the success of the commercial development project. The next step is to pair the revenue producing activity, the commercial development project, with housing developments to increase the impact and the sustainability of both enterprises. Therefore, the next focus is a housing development on Parcel 1 which is 231 acres mostly zoned for agricultural residential with a small portion zoned commercial.



Goal # 4 Provide Educational Programming for Dine Families

The relocation policy promoted the loss of Navajo indigenous cultural knowledge, especially affected is the second generations of relocated families. As such social dysfunction is increasingly threatening relocated families and losing sight of cultural knowledge only complicates their ability and skills to manage their life condition.

Some of the conditions observed, reported, and discussed in WDR meetings are:

- Limited family support
- Parents limited education
- Native families are one parent head of household
- Families struggle to pay monthly bills; rez vs bordertown
- Limited employment opportunities
- 1st, 2nd, going on 3rd generation relocates living in one household
- Parents struggle with helping child w/homework and other related youth activities; city sports

The solution is to engage our youth in activities that demonstrate increasing youth leadership and capacity to lead them through integrated educational or mentoring programs therefore, WDR requests assistance in funding fun, academically beneficial activities, such as clubs, sports, tutoring, a scholarship program and establishing other youth organizations like The Native UNITY program.

Statistics have shown that Native Youth have the highest rate of substance abuse than the general population. Schools, out of school programs, health providers, tribal leadership and early childhood programs need to be involved and engaged with our youth. Our native community in Winslow need to empower our youth to resist drugs, alcohol, suicide and gang activity. The goal would be to motivate our youth at an early age to overcome these barriers they may face.

Currently:

- Native American comprise approximately 57% of the student population in Winslow Schools.
- More than half of Native American students at the Junior High and High School are placed in the SAFE rooms/detention than any other nationality. The SAFE rooms are for disciplinary actions.
- There is only one native club (Tribe of Many Feathers) within the Winslow School District as opposed to others that are not native. Organizing elementary and Junior High Native clubs will enhance leadership development and create an enabling environment by giving them the tools necessary for their growth and independence.
- The cost for city youth activities: youth football, basketball, baseball are \$60 for each sport and swim leagues cost from \$30 a mo. Funding these after school activities would give more students an opportunity to participate and prevent/eliminate the behavioral issues that arise.
- The Winslow School District proposed eliminating The INTERCESSION PROGRAM (a type of tutoring) which assisted students with staying intact with homework, improving their grades and staying on track for graduation. Funding a Tutoring Program will help foster learning, educational opportunity that our native youths deserve.

Solutions: Self Reliance, Growth, and Development Programs

- Establish a Youth Center
- Produce/gather accurate data
- Assist the youth to pay much needed sports fees to participate in sports
- Hire tutors to help with homework
- Youth Employment: Place them in occupations, academic related fields, STEM, and coding
- Training for families: Navajo (Language, history, government) as well as GED and other academics, parenting classes
- Leadership training for youth: Bring in positive role models & speakers

Outcomes:

- Develop skills for handling conflict/reconciling difficult situations
- Resolving emotional abuse: coping skills
- Communication skills
- Youth understanding rules & consequences
- Recognizing authority
- Job skills training
- Leadership skills training
- Knowing your rights in school, job, contacts, handbook, etc.
- In-school strategy & home work
- Youths will experience positive attitudes
- Winslow Natives will increase yearly academic learning; more on quarterly honor roll
- Increase high school graduation rate thus produce more professionals
- Stable households
- Reduce run ins with the law, reduce racial profiling
- Reduce incarcerations

Additionally, and in summary, funding will develop youth programs, empower our youth by instilling self-confidence, build resiliency, find/recover their identity, pursue their dreams by living healthy lifestyles and contribute to the well-being of their communities.

LCCDC is working with Navajo County to obtain a modular building that can house these programs. The building can be placed on Parcel 3, a 5.2 acre tract located near schools and parks. Additionally, other educational and training programs in agriculture could be developed on other parcels located in Winslow.

INDIAN WELLS ECONOMIC DEVELOPMENT PROJECT

Since the mid-seventies, the Indian Wells community begun the process of pursuing an economic and commercial development initiative with the goal of creating economic development and employment opportunities by withdrawing and setting aside 40 acres of land at the junction of Navajo Route 6 and Navajo Route 15. The site was chosen because of its proximity to north- and southbound vehicular traffic on the adjoining Navajo Route 6 and westerly and easterly vehicular traffic on the adjoining Navajo Route 15. The Indian Wells Elementary School, which is a part of the Holbrook Unified School District, is located west of the proposed business site. It is planned that development on the business site will consist of a convenience store, gas station, laundromat, and post office; perhaps a fast food/restaurant establishment.

From the onset of the vision for an economic development initiative, the Indian Wells community has consulted and worked collaboratively with the Navajo Nation Division of Economic Development – Rural Business Development Office for technical assistance and project planning activities to keep the project active. Several individuals and entities have been engaged, over the years, to provide assessments and studies to support the need for the project as well as how the project will benefit the community. However, because of a lack of adequate and sufficient funding, the project never got to the level of the development of engineering and construction designs and documents.

To date, site development, consisting of site clearing and grading and installation of cattle guards at the entry and exit points to the business site, have been initiated and completed. Further

site development consisting of site infrastructure and utility development have been halted due to the lack of adequate funds to plan, implement and complete construction. Plans to initiate the procurement process to engage the services of a design and engineering firm to begin the development of the architectural and engineering designs and construction documents have also been put on hold until the funding issues are resolved.

Sometime during the Fall of 2018, the Indian Wells community was informed of an allocation of funds through the Permanent Trust Fund Five-Year Expenditure Plan in the amount of \$3,700,000 and the Sihasin Funds in the amount of \$200,000. Upon learning of the allocation of funds, the Indian Wells community held a groundbreaking ceremony on October 19, 2018, where invited dignitaries and guests recognized and gave appreciation for the funds made available to finally bring the project to fruition. Shortly after the ground was broken and while clearing and grading of the project site was in progress, the Indian Wells community learned that part of the Permanent Trust Fund allocation of the \$3.7 million were reallocated to two other projects; this action being done without prior notification or consultation with the Indian Wells community. Furthermore, the Navajo Nation Office of Management and Budget had created a Business Unit Number for the project and later, when the funds were reallocated, were not aware that the project was underway and funds had been reprogrammed for other projects.

As a result, the Indian Wells community felt betrayed by the previous leadership and administration and looks to this leadership and administration to make whole the initial allocation of the Permanent Trust Funds of \$3.7 million in order for the other aspects of project planning, site development and construction of a convenience store for the Indian Wells community continue and a community initiative started years past realized.
