RESOLUTION OF THE RESOURCES AND DEVELOPMENT COMMITTEE 23rd Navajo Nation Council --- Fourth Year, 2018

AN ACTION

RELATING TO THE RESOURCES AND DEVELOPMENT COMMITTEE; APPROVING A BUDGET REALLOCATION OF FUNDS FOR PREVIOUSLY APPROVED FUEL EXCISE TAX (FET) PROJECTS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee (RDC) is a standing committee of the Navajo Nation Council. 2 N.N.C. §500 (A). RDC has oversight authority over matters involving roads and transportation for the purpose of planning and coordinating all roads and transportation activities of the Navajo Nation. 2 N.N.C. §500 (C) (6).
- B. A standing committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight. 2 N.N.C. §185(A).
- C. A budget reallocation is the reallocation of funds between business units which requires oversight approval. Navajo Nation Budget Instruction Manual Fiscal Year 2017, Section XIII, C, 1, b.
- D. A reallocation of funds must be approved "by two-thirds (2/3) vote of the full membership of the committee, board or commission." 2 N.N.C. §185(A).

SECTION TWO. FINDINGS

- A. The Resources and Development Committee approved an equal distribution of Fuel Excise Tax funds among the five Agencies based on a Navajo Division of Transportation priority list and Eastern Agency received a total of \$2,600,000 for various projects. See RDCS-61-14. Exhibit B.
- B. Two projects within Eastern Agency approved in RDCS-61-14 included Route N485 in Casamero Lake and Low Water Crossing for Eastern Navajo Chapters.

- C. Casamero Lake faced difficulties in gathering landowner consent for the right-of-way of N485 and other obstacles which may result in losing funds for the projects.
- D. Casamero Lake and Little Water Chapters support the reallocation for the purpose of construction costs for McKinley County Road 19, a road that serves more than one Chapter. Exhibit C; Exhibit D and Exhibit E.
- E. The Navajo Nation Division of Transportation supports a budget reallocation in accordance with the amounts and business unit numbers listed with the Navajo Nation Division of Transportation. See **Exhibit A**.
- F. This reallocation of funds will allow the Chapters to pursue matching funds from the State of New Mexico through a request during the 2018 State Legislative Session.

SECTION THREE. APPROVAL OF REALLOCATION

The Navajo Nation hereby approves budget reallocation from the Navajo Route N485 project and from the Low Water Crossing project to the McKinley County Road 19 project.

Dear President Yazzie:

The Navajo Division of Transportation is in the process of making a formal request to the Navajo Nation Council Resource and Development Committee (RDC) to have currently available Fuel Excise Tax (FET) funds transferred from a project on BIA Route N485 near Casamero Lake Chapter, which is \$1,050,500.00, and to be used for maintenance/improvements on McKinley County Road 19 (CR19). Additionally, on a second similar project, \$803,424.38, was identified for a residential road low water crossing project immediately off of McKinley County Road 19. The summation of both of these funding sources is \$1,853,924.38.

However, \$6,000 (for 401/404 Permits), and \$50,000 (for the low water crossing design & engineering); for a total sum of \$56,000, will remain with the secondary residential low water crossing project. The \$56,000 is the expected amount needed to continue with this phase of work on the low water crossing project for the residential route coming off of CR19. Therefore, \$1,853,924.38 - \$56,000 = \$1,797,924 will be transferred over to the forth coming McKinley County Road 19 maintenance/improvement project.

The request and action to reprogram the funds for both of these projects, has approval and acknowledgement by the FET funding recipient, Casamero Lake Chapter. The request will be presented to the RDC by NDOT and further supported by Casamero Lake Chapter. The amount of FET money to be transferred to the McKinley County Route CR19 project is \$1,797,924.

Over the recent past, NDOT has been working in partnership with the McKinley County Road Department on the CR19 project and recognizes the project's need for more funding to complete improvements planned. NDOT and the County will continue project management responsibilities including their handling of all matters regarding the transfer and the integration of FET funds into the CR19 scope of work.

This letter further acknowledges and concurs on the intentions of the community of Casamero Lake Chapter, which is specifically, McKinley County Road 19 improvements.

AN ACTION

Approving The Equal Distribution Of The Fuel Excise Tax Fund Balance of \$13,000,000 Among The Five Agencies And The Priority List Of Transportation Road Improvement Projects

BE IT ENACTED:

Section One. Findings

- 1. The Navajo Nation Road Fund Management Plan, 12 N.N.C. §§ 1003 et seq., authorizes the Resources and Development Committee to appropriate all Navajo Nation Fuel Excise Taxes Funds for administrative cost, preliminary studies, road maintenance, and road improvement activities.
- 2. The Navajo Nation's transportation needs, demands and requirements are unique in nature and scope due to its large population, land mass in excess of 25,000 square miles, and 110 rurally disperse Chapter governments served by roads which are predominantly dirt and unimproved.
- 3. The Navajo Davison of Transportation was directed by the Naabik'iyati' Committee of the Navajo Nation Council to propose legislation to include a Priority List for equal distribution of \$13,000,000 of the Fuel Excise Tax funds among the five agencies within the Navajo Nation. NABIMA-16-13(Exhibit B).

Section Two. Approvals

- The Navajo Nation hereby approves the Navajo Division of Transportation Road Priority List herein attached as Exhibit "A."
- 2. The Navajo Nation hereby approves the equal distribution of \$13,000,000 of Fuel Excise Tax funds, as referenced in NABIMA-16-13, among the five agencies within the Navajo Nation for the road projects on the Priority List.

3. The Navajo Nation Office of the Controller and the Office of Management and Budgets are directed to establish business units for the use of the funds consistent with this resolution.

RESOLUTION OF THE NAABIK'ÍYÁTI' COMMITTEE

22ND NAVAJO NATION COUNCIL - THIRD YEAR, 2013

AN ACTION RELATING TO RESOURCES AND DEVELOPMENT AND NAABIK'ÍYÁTI'; APPROVING THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE NAVAJO NATION AND NAVAJO COUNTY TO REPAIR, MAINTAIN AND IMPROVE ROADS FOR THE SAFETY AND GENERAL BENEFIT OF ARIZONA AND NAVAJO NATION RESIDENTS AND TRAVELERS; WITH THREE (3) DIRECTIVES

BE IT ENACTED:

1. The Navajo Nation hereby approves the Intergovernmental Agreement between the Navajo Nation and Navajo County to repair, maintain and improve roads for safety and general benefit of Arizona and Navajo Nation residents within the Navajo Nation (Navajo County, Arizona) as set forth in the documents attached as Exhibit A; and

2. The Navajo Nation hereby authorizes the President of the Navajo Nation to sign the Intergovernmental Agreement; and

3. The Navajo Nation hereby directs the Navajo Department of Transportation to prepare additional Intergovernmental Agreements for the remaining counties within the Navajo Nation and to divide the remaining balance of \$1,200,000 carry-over supplemental funding for road projects among the five (5) agencies; and

4. The Navajo Nation hereby directs the Navajo Department of Transportation to prepare a Priority List of the transportation projects within the Navajo Nation; and

5. Furthermore, the Navajo Nation hereby directs the Navajo Department of Transportation to use the Priority List and to propose legislation for the equal distribution of \$13,000,000 of the Federal Excise Tax funds among the five (5) agencies within the Navajo Nation.

RESOLUTION TO NAVAJO DEPARTMENT OF TRANSPORTATION AND RESOURCE & DEVELOPMENT COMMITTEE OF 23RD NAVAJO NATION COUNCIL RESPECTFULLY REQUESTING TRANSFERRING 2015 NAVAJO NATION FUEL EXCISE TAX (FET) FUND FOR NAVAJO ROUTE 485 IN THE AMOUNT OF \$1,050,500.00 AND LOW-LEVEL WATER CROSSING IN THE AMOUNT OF \$747,424.38 TO MCKINLEY COUNTY ROAD 19 FOR CONSTRUCTION COSTS.

Whereas:

- 01. Pursuant to N.T.C Section, the Casamero Lake Chapter is a certified local government of the Navajo Nation, vested with the authority to review and coordinate the function of its community government, and
- 02. Per Resolution CAP-34-98, the Navajo Nation Council adopted the Navajo Nation LOCAL GOVERANCE Act ("LGA"), Titled 26 of the Navajo Nation Code and through the adoption of this Act delegated to the Navajo Nation Chapters, governmental authority with respect to all local issues/matters consistent with the Navajo Law, custom and tradition; and
- 03. The Casamero Lake Chapters is respectfully request the transfer of funds from 2015 Navajo DOT Fuel Excise Tax for Navajo Route 485 in the amount of \$1,050,500.00 and Low-Level Water Crossing in the amount of \$747,424.38 to McKinley County Road 19 project for construction costs; and
- 04. The Casamero Lake Chapter is facing many obstacles gathering consents for Right of Way for both projects (N485 and Low Water Crossings) such as refusal from allottees; allottees residing out of state; whereabouts unknown; deceased unknown; family disputes playing a role in consents; monetary compensation to all heirs; Lack of communication; CFR amendments; probate; etc.; and, there is the possibility of losing these funds; and
- 05. County Road 19 is a priority project that will serve more than one (1) Chapter and many & Non-Navajo residents for socio-economic, government services & health purposes: and

- 06. State of New Mexico and McKinley County are willing to assist with funding for County Road 19 project and the contribution from Navajo Nation and Chapters will provide an incentive for New Mexico funding of County Road 19; and
- 07. Time is of urgency because New Mexico Legislature will convene in January 2018 and a decision needs to be made soon to leverage Navajo Nation funds with New Mexico funds: and
- 08. Both Casamero Lake and Littlewater Chapters supports the transfer of funds; to County Road 19; and
- 09. Easement or Right –Of-Way for Indian Allotments & Navajo Tribal Trust Lands have been procured & clearance studies have been essentially completed.

NOW, THEREFORE BE IT RESOLVED THAT:

The Casamero Lake Chapter is facing many obstacles gathering consents for Right of Way for both projects (N485 and Low-Level Water Crossings) such as refusal from allottees; allottees residing out of state; whereabouts unknown; deceased unknown; family disputes playing a role in consents; monetary compensation to all heirs; lack of communication; CFR amendments; probate; etc. and there is a possibility of losing funds; and
- 5. County Road 19 is a priority that will serve more than one (1) Chapter and;
- County Road 19 improvement will promote well being in areas of socio-economic, government services & health purposes; and
- 7. State of New Mexico and McKinley County are willing to assist with funding for County Road 19 project and the with said amount of contribution from Navajo Nation and Chapters will improve the rating for Navajo Nation's leveraging; and
- 8. Time is of urgency because 2018 State of New Mexico Legislators will convene January 16, 2018 and a decision needs to be made soon to leverage Navajo Nation Funds with State of New Mexico Funds; and
- 9. Both Casamero Lake Chapter and Littlewater Chapter fully supports the transfer of funds to County Road 19; and
- 10. Easements for Indian Allotments and Navajo Tribal Trust Lands have procured and all clearance studies have been completed.

III. Project Outline

a. **Project Summary:**

Casamero Lake Chapter and Littlewater Chapter is cognizant that County Road 19 road is in dire need of improvement, specifically for the School Bus Routes: Bureau Funded Schools (Baca/Dlo Yazhi Community School; Crownpoint Community School; Fort Wingate Elementary/Middle/High School; Dibe Yazhi Habitiin Olta, Inc.); Gallup McKinley County Schools (Crownpoint High School; Crownpoint Middle School; Crownpoint Elementary School; Thoreau High School; Thoreau Middle School; Thoreau Elementary School); St. Bonaventure Mission School; La Vida Mission School; Rehoboth Christian School; Dine College; University of New Mexico – Gallup Branch; New Mexico State University – Grants Branch; and Navajo Technical University share commitment for our children to obtain quality education services and that we also share responsibility to increase student achievement across all curriculum. Improved roads are an important element to ensure our children receive all instructional services on a daily basis and safe transportation means is necessary.

Casamero Lake Chapter and Littlewater Chapter unimproved (dirt) roads become a quagmire of mud after rain and melting of snow which create deep ruts and is extremely unsafe. In addition to affecting chapter services, it affects daily delivery of services and safety issues for Senior Citizens Van, Community Health Representative (CHR), Indian Health Services (IHS); Public Health Nurse; Community Water Hauling Project via St. Bonaventure Mission, Emergency and Non-Emergency Service Providers.

b. Introduction:

McKinley County Road 19 originated nearly 100 years ago as a wagon trail for Borrego Pass Trading Post and local community use. This portion of McKinley County Road 19 is 60 miles long, the road starts from the community of Baca/Prewitt through Casamero Lake, Littlewater, and Whitehorse Lake and up to Torreon/Star Lake Chapter. McKinley County Road 19 become part of McKinley County Inventory in later part of the 1960s. The first four (4) miles of the McKinley County Road 19 north bound from Interstate 40 was paved to Escalante Power Plant turnoff in the mid-1990s. The pavement was extended for another four (4) miles in 2013 approximately 1 (one) mile south of Casamero Lake Chapter. Approximately 90% of McKinley County Road 19 is unpaved. McKinley County has completed the clearances such as Archaeology Studies, Environmental Studies, Biological Studies, etc., have been approved by Bureau of Indian Affairs (BIA). Right of Way Grant of Easement has been issued to McKinley County. McKinley County is the owner and will construct, operate and maintain the road. The Navajo Nation is the Fiscal Agent. McKinley County and the Navajo Nation have an existing Intergovernmental Agreement (IGA) and this instrument will be used to finance the project. The project is ready for pavement construction and this proposal is seeking funding of \$3,900,000 to construct twenty (20) more miles of McKinley County Road 19.

c. Needs Statement:

The proposed project is needed because County Road 19 is in deteriorating condition, and the road serves the communities of Casamero Lake and Littlewater and numerous rural residences in the region. The purpose of the project is to enhance safety on County Road 19 by expanding the roadway to add shoulders, improving drainage crossings, and implementing other road improvement measures. Drainage improvements will allow for safer vehicle passage over drainage crossings and will reduce the need for repeated roadway maintenance. The people living in the area are mostly elderly, high risk medical clients, and school aged children. The Chapter has been faced with population growth in the past five years within our chapter boundaries, our Chapter Officials and Staff has developed a wish list of need improvements for our community. We prioritized the list based on most critical community needs and other factors such as the age, condition, and adequacy of the current county road. We then consulted with various Navajo Nation, County and Federal entities which are associated with this project to refine our prioritized needs list and put in the dollar amounts needed, then we planned for projects over the next five years in our 2019 ICIP.

<u>Education</u>: McKinley County Road 19 serves nine (9) different school systems with a student population over 2,000 students ranging from Head Start to Higher Education. Attendance plays an important role in student achievements. Students cannot afford to be absent and a good road/bus transportation system minimizes absenteeism or truancy. Improving McKinley County Road 19 will greatly assist in helping students to attend school without weather or road-related absenteeism. An improved McKinley County Road 19 will provide for security for students and families without having to worry about being stranded due to inclement weather or otherwise.

<u>Safety:</u> County Road 19 serves as a vital Emergency Response route for EMS, Fire and Police calls. The health and safety factor is vital to both communities. The route also serves for non-emergency medical transportation for elderly and high risk patients. Community Health Representatives and other medical providers utilize the route to check on patients ensuring lives are not at risk. The route is also utilized for basic necessities like propane, food supply and water (as many people still haul water for domestic and livestock usage). The critical need for improvement of County Road 19 will impact the lives of residents in both Casamero Lake and Littlewater communities.

<u>Daily Use:</u> County Road 19 serves as an artery for everyday commuters to travel on and off the reservation. The road also provides for interfamily visits, elderly care, nonemergency medical transport and medical field visits by Navajo Nation Community Health Representatives (CHR) and Indian Health Services - Public Health Nurses (PHN). The route also serves as a main bus-route for Head Start Program, Elementary, Mid, High School and College students. County Road 19 also allows residents a route to commute to job sites on a daily basis. This route serves as a delivery of durable medical equipment, utility companies, traditional/religious use and transporting livestock.

Economic Development: McKinley County Road 19 currently services two of the county's largest private sector employers including Escalante Generating Station and McKinley Paper, and will provide improved access to the El Segundo Coal Mine. The project would have a positive, short term direct effect on employment and income as a result of construction jobs created by this project. It has also been utilized for transportation for goods and service for Education, Senior Center, and Community needs for basic necessities. Once McKinley County Road 19 is improved, majority of our community members will benefit for Economic Development to increase tourist attraction as such gate way to Chaco Canyon National Monument. It will also open up for potential opportunities like a C-Store for community usage. It will also increase gross receipts tax base collected from local border towns like Gallup and Grants. The route is listed in the chapters' 10 year Community Land Use Plan as well as priority 1 on Casamero Lake ICIP, priority 1 on Littlewater Chapter ICIP and priority 1 on McKinley County ICIP. McKinley County Road 19 is being utilized by most domestic carriers such as FedEx/UPS and the U.S. Postal Service. In addition, McKinley County Road 19 serves as a food distribution route to Borrego Pass School and Trading Post. The road will attract other community events like Rodeos, Health Fairs and other events. An improved County Road 19 will open doors to better Economic Development Opportunities.

d. Scope of Work:

The project is to improve twenty (20) miles of existing McKinley County Road 19 from Casamero Lake south boundary to State Highway 509. This project includes shaping, grading, base course and chip seal with a 24 foot road surface. This project also includes any necessary drainage improvements, culverts replacements, signage and striping.

McKinley County has completed the clearances such as Archaeology Studies, Environmental Studies, Biological Studies, etc. have been approved by Bureau of Indian Affairs (BIA). Right of Way Grant of Easement has been issued to McKinley County. McKinley County is the owner and will construct, operate and maintain the road. The Navajo Nation is the Fiscal Agent. McKinley County and the Navajo Nation have an existing Intergovernmental Agreement (IGA) and this instrument will be used to finance the project.

McKinley County; Casamero Lake Chapter; Littlewater Chapter; Navajo Department of Transportation (DOT); and Navajo Nation Capital Project Management Department (CPMD) will work together to manage and to provide technical assistance to implementing, monitoring and evaluation of all aspects of the project construction. To accomplish this, the Navajo Nation will coordinate with involved entities to finalize project activity schedule, material listing and purchase, inventory design and engineering, and personnel throughout the project to monitor activities and schedules.

The BIA's deliberation as to whether a Finding of No Significant Impact (FONSI) is appropriate, or, whether an Environmental Impact Statement (EIS) should be prepared, took into consideration, the following issues, which are addressed in the environmental assessment (EA).

- Beneficial and adverse environmental impacts: The EA demonstrates that there will be no significant adverse or beneficial impacts on the quality of the human environment, including, topography, soils, geology, mineral and paleontological resources, water resources, vegetation, ecosystems and biological communities, agriculture, socioeconomic resources, resource use, wilderness, visual, climate change, Indian trust assets and hazardous materials.
- Public health and safety: CR 19 is an unpaved road servicing the Casamero Lake and Borrego Pass communities. Some of the numerous drainages crossing the road may be unsafe and/or impassable during storm events.
- 3. Unique characteristics of the geographic area: The project area is not unique within its geographical setting and is similar to other areas in the region. There are no prime farmlands, wild and scenic rivers, wilderness areas, refuges, park lands, unique ecological areas, or other unique or rare characteristics of the land and aquatic environs that will be significantly affected.
- 4. Degree to which the effects on the quality of the human environment are likely to be highly controversial: There are no known scientific controversies over the effects of the proposed project on the human environment.
- 5. Degree to which the effects are highly uncertain or involve unique or unknown risks: There are no known effects on the human environment that are highly uncertain or involve unique or unknown risks. The proposed activity will be in adherence to common road construction standards.

- Degree to which this action will establish a precedent for future actions with significant effects: This project will not set a precedent for similar projects that may be implemented by the BIA or other agencies.
- 7. Relationship to other actions with cumulatively significant impacts: There are no known incremental effects of the action that become significant when added to other past, present, or reasonably foreseeable future actions that have affected, or will affect, the project area.
- Degree to which the action may affect districts, sites, objects, or structures listed on, or eligible for, the National Register of Historic Places, or may cause loss of significant cultural resources: The Navajo Nation Historic Preservation Department (NNHPD) issued Cultural Resources Compliance Form, NNHPD No. HPD-16-661, dated November 22, 2016. All of the cited conditions will be met.

In the event of a discovery of a previously unidentified or incorrectly identified cultural resource(s), all operations in the immediate vicinity of the discovery must cease, and the NNHPD must be notified.

- 9. Degree to which the action may affect threatened, endangered, or sensitive species or their habitat: The Navajo Nation Department of Fish and Wildlife (NNDFW) issued Biological Resources Compliance Form, NNDFW Review No. 15dbs&a101, citing avoidance/mitigation measures pursuant to the Migratory Bird Treaty Act (U.S. Code Title 16, Chapter 7, 703-712), Migratory Birds not listed under the NESL, or ESA are prohibited from take by federal law. McKinley County will follow the guidelines in the Biological Evaluation listed under Section 2.7.
- 10. Whether the action violates Federal or local laws or requirements imposed for the protection of the environment: The proposed project will not violate any Federal or tribal environmental laws or requirements.
- 11. Indian Trust Assets: Under the Proposed Action, ROW agreements would be sought and prepared from negotiations between the Navajo Nation and McKinley County per CFR 169.
- 12. Climate Change: There would be a direct effect to greenhouse gas emissions from equipment operations. However, the increase in emissions would be negligible and temporary.



New Mexico 87313</u> for, and on behalf of: <u>Landowners of the Allotted Lands described below</u>, <u>American Indians of the Navajo Tribe</u> hereinafter referred to as GRANTOR, under authority contained in 209 DM 8 dated November 17, 1981, 230 DM 1 and 3 IAM 4 dated July 19, 2000 and pursuant to the provisions of the Act of February 5, 1948 (62 Stat. 17; 25 USC 323-328); and Part 169, Title 25, *Code of Federal Regulations*, which by reference are made a part hereof, in consideration of <u>S Waived</u>, the receipt of which is hereby acknowledged, does hereby grant to: <u>McKinley County, P.O. Box 70, Gallup, New Mexico, 87305</u>, its successors and assigns, hereinafter referred to as GRANTEE, an easement for right-of-way for the following purposes, specifically: <u>Construction, Operation and Maintenance of County Road 19 to serve residents in Littlewater, Casamero Lake and Borrego Pass</u>, McKinley County, New Mexico, over the land embraced within a right-of-way situated on the following described lands:

Said right-of way is limited to and more particularly described to be <u>64.8126</u> acres more or less in area, as shown on *Exhibit* A, attached hereto, and made a part hereof.

To have and to hold the said easement and right-of-way unto the GRANTEE and unto its successors and assigns subject to the following provisions:

- GRANTEE agrees to indemnify the landowners and authorized users and occupants against any liability for loss of life, personal injury and property damage arising from the construction, maintenance, occupancy or use of the lands by the applicant, his employees, contractors and their employees, or subcontractors and their employees.
- 2. GRANTEE agrees to restore the land to its original condition, as far as is reasonably possible, upon termination or revocation of this easement for any reason. Failing to comply with this stipulation, GRANTEE agrees to bear all expenses and costs incurred by the owner and/or the United States in accomplishing said restoration.
- 3. GRANTEE agrees to pay all damages and compensation, in addition to the deposit made pursuant to 169.4, determined by the Secretary to be due the landowners and authorized users and occupants of the land due to the survey, granting, construction and maintenance of the right-of-way.
- 4. GRANTEE agrees to that during the term of this Grant of Easement, if any previously unidentified cultural resources are discovered within the easement area, work should be halted immediately and the BIA and/or Tribal Contractor should be contacted immediately.

- 5. GRANTEE agrees to construct and maintain the right-of-way in a workmanlike manner.
- 6. GRANTEE agrees to clear and keep clear the lands within the right-of-way to the extent compatible with the purpose of the rightof-way; and dispose of all vegetative and other material cut, uprooted or otherwise accumulated during construction and maintenance of the project.
- 7. GRANTEE agrees to take soil and resources conservation protection measures, including weed control, on the land covered by the right-of-way.
- 8. GRANTEE agrees to do everything reasonable within its power to prevent and suppress fires on or near the lands to be occupied under the right-of-way.
- GRANTEE agrees to build and repair such roads, fences and trails as may be destroyed or injured by construction work and to 9. build and maintain necessary and suitable crossings for all roads and trails that intersect the works constructed, maintained, or operated under the right-of-way.
- 10. GRANTEE agrees to that upon revocation or termination of the right-of-way, the applicant shall, so far as is reasonably possible. restore the land to its original condition. The determination of "reasonably possible" is subject to Secretary's approval.
- 11. GRANTEE agrees at all times to keep the Secretary informed of its address, and in case of corporations, of the address of its principal place of business and the names and addresses of its principal officers.
- 12. GRANTEE agrees not to interfere with the use of the lands by or under the authority of the landowners for any purpose not inconsistent with the primary purpose for which the right-of-way is granted.
