- A. The Navajo Nation Council approved Council Resolution CN-88-20, the Navajo Nation Fiscal Year 2021 Comprehensive Budget, on November 30, 2020 and the Navajo Nation President signed CN-88-20 on December 10, 2020.
- B. As a result of the Navajo Nation President's exercise of the line item veto authority in Council Resolution CN-88-20, several legislative branch offices and programs have been impacted to the point of not being able to continue its work through Fiscal Year 2021.
- C. The Office of the Speaker and the Office of the President and Vice President, along with the Budget and Finance Committee of the Navajo Nation Council, have had discussions on the importance of restoring funding to the Legislative Branch to ensure continuity in its operations.
- D. If additional budgets are presented for the Executive, Legislative, and Judicial Branches, future amendments to Council Resolution CN-88-20 may be required.
- E. The Navajo Nation Council amends the Fiscal Year 2021 Comprehensive Budget as indicated in the Section Three, below.

SECTION THREE. AMENDING COUNCIL RESOLUTION CN-88-20, THE NAVAJO NATION FISCAL YEAR 2021 BUDGET

- A. The Navajo Nation Council approves the appropriations for Fiscal Year 2021 as listed here for the Legislative Branch for the following Business Units, totaling \$1,514,536, from General Funds which were the subject of a line item veto. Each affected Office or Program has submitted budget forms 1, 2, and 4. These forms are included in **Exhibit A.**
- B. The Navajo Nation Council approves amending Council Resolution CN-88-20, to restore funding for the Legislative Branch as follows:
 - a) Navajo Nation Council, BU # 101001, in the amount of \$521,153,
 - b) Budget and Finance Committee, BU # 101003, in the amount of \$42,345,
 - c) Office of the Speaker, BU # 101015, in the amount of \$551,038,
 - d) Office of Legislative Counsel, BU # 101017, in the amount of \$220,000, and
 - e) Elections Administration Office BU # 101021, in the amount of \$180,000.

SECTION FOUR. DIRECTIVE TO THE OFFICE OF MANAGEMENT AND BUDGET

The Navajo Nation directs the Office of Management and Budget to immediately recalculate the final monetary totals such that the figures conform to the amendments passed by the Navajo Nation Council.

SECTION FIVE. EFFECTIVE DATE

This Resolution shall be effective pursuant to 2 N.N.C. §§ 164(A)(17) and 221(B).
