Section One. Findings

A. Pursuant to 16 N.N.C., Section 1151(C), the Resources and Development Committee of the Navajo Nation Council has authority to give final approval on behalf of the Navajo Nation for permits for mission sites; and

B. The Congregational Methodist Navajo Mission has applied for Revocable Use Permit for mission site within Newcomb Chapter, as further described in Exhibit "A," attached hereto and incorporated herein by this reference; and

C. The mission site is located on 1.5. acres of trust lands in the Southeast Quarter (SE4) of Section 35, Township 24 North, Range 18 West, in the vicinity of Newcomb Chapter, Navajo Nation (San Juan County, New Mexico). The land description appears on the survey plat attached hereto and incorporated herein as Exhibit "B"; and

D. The District Grazing Official identified one land user, Thomas Joe Yazzie and his consent is attached hereto as "Exhibit "C." The Newcomb Chapter resolution and the signed petition by the local residents are also attached as Exhibit "D"; and

E. The Biological, Historical, Cultural and Archeological surveys and clearances for this permit were completed including an Environmental Assessment report, and are all attached and labeled as Exhibit "E"; and

F. On June 16, 2015, the Resources and Development Committee of the Navajo Nation Council (RDCJN-33-15) delegated the Director of Navajo Land Department (NLD), Division of Natural Resources, the power and authority to give final approval of all land withdrawal designations on the Navajo Nation. The Land Withdrawal Designation has been approved for five (5) years for the Congregational Methodist Navajo Mission attached as Exhibit "F"; and

G. It is in the best interest of Newcomb Chapter and the Navajo Nation that a Revocable Use Permit for Mission Site be approved for the Congregational Methodist Navajo Mission.


Section Two. Approval

All corporations must furnish evidence of authority of the person(s) signing this application to execute papers on their behalf. Evidence should ordinarily be in the form of a general resolution of the Board of Directors certified by the Secretary over the seal of the corporation.

For the purpose of conducting business within the Navajo Reservation, all corporations must file their Articles of Incorporation with the Economic Development Commerce Department of the Navajo Nation. The Commerce Department will issue a corporate number to the church organization.

In all cases of applications on behalf of Unincorporated bodies where documents do not explicit give one individual authority to execute necessary papers, a power of attorney executed before a notary public by all associated parties for this purpose should be attached. If this is not supplied, all such persons must personally sign this application and all other documents submitted to the Navajo Agency.

Unincorporated applicants should submit articles depicting their organization, unless none exists, in which case an explanation of the nature of the organization should be listed on a separate sheet.

Applicant agrees to give preference to qualified local residents of the Navajo Nation for employment in the construction of any improvement on the church site if the permit is granted.

Description of Undertaking: The Congregational Methodist Church proposes to construct a missionary site and associated facilities within a 1.50-acre tract of land. The area of potential effect measures 233.71 feet (71.25 m) by 218.70 feet (66.67 m) by 194.19 (59.20 m) by 173.99 feet (53.05 m) by 165.73 feet (50.52 m), or 1.50 acres (0.61 ha). Ground disturbance, both surface and subsurface, will be extensive. In addition, a water line right-of-way was requested to service the church site. The Navajo Tribal Utility Authority is assisting in the inspection of the water line. The proposed water line is 565 feet (172 m) with a 30-foot-wide (9.1-m) right-of-way or 0.39 acre (0.16 ha). The water line will start from an existing water line (located to the west) to the proposed mission site area. Heavy equipment will involve blading, trenching, excavation and installation of pipeline. b. Existing Data Review: A check of Navajo Nation Historic Preservation Department (NNHPD) and NNAD Shiprock Office archival records indicated that no projects have been conducted with no sites recorded within a 500-foot (152-m) radius of the project area. The records check conducted at the NNHPD Traditional Cultural Program files also indicated that there is two traditional cultural properties (TCP); #55 (Badlands Pinnacles), located more than 1 mile away and #125 (Grey Mesa) located more than a mile away from the project area. The TCP records search verification form is attached to this report. c. Area Environmental & Cultural Setting: The project is located in Newcomb Chapter. The nearest major water source is a tributary to Captain Tom Wash located approximately 1,241 feet (378 m) to the north. The elevation of the project area is 5642 feet (1720 m). Vegetation consists of Russian thistle, prickly pear cactus, rabbitbrush, and oak trees. Soils in the project area consist of sand. The cultural setting is rural and the development includes nearby homes, two-track roads, and power lines. d. Field Methods: An archaeological inventory was conducted Lindsey L. Benally of the NNAD and a TCP interview with the client, Wilford Yazzie, was also conducted. A Class III pedestrian survey was conducted by walking concentric circular transects spaced 32.8 feet (10 m) apart extending out to a 200-foot (60.97-m) radius area centered over the proposed church site, for a total inventory of 2.88 acres (1.16 ha). It should be noted that 412 feet (125.61 m) of the water line right-of-way segment was inventoried with a 35-foot buffer zone on each side of the right-of-way for a total of 100-feet wide survey corridor. Therefore, a total of 0.94 acre (0.38 ha) was inventoried for the water line. The total area inventoried equals approximately 3.82 acres (1.55 ha) for the proposed church site and water line.

15. CULTURAL RESOURCE FINDINGS:

- a. Location/Identification of Each Resource: One in-use area (IUA) was identified during the inventory. The IUA belonged to Thomas Yazzie, the client's uncle, and now belongs to the client and his family. The IUA consists of a mid-1970s to present homestead (burned), a nearby mission structure (burned), and an old church foundation. The project area has been heavily disturbed, but Wilford Yazzie plans to re-establish a Congregational Methodist Church mission site within the IUA. According to, Mr. Yazzie, there are no TCPs or burials located within the area of the proposed homesite. In addition, two TCPs were noted to be located more than 1 mile of the project area and they do not affect the church site.
- b. Evaluation of Significance of Each Resource (above): The IUA possesses integrity of location and setting. The IUA is not eligible for nomination to the National Register under criteria a through d. The IUA does not meet the 50-year eligibility guideline. The IUA is not of archaeological interest and it does not meet the 100-year age requirement necessary for classification as an archaeological resource under ARPA. Thus, it does not merit protection under ARPA. Finally, the IUA does not retain qualities or characteristics that would make it eligible for protection under AIRFA.

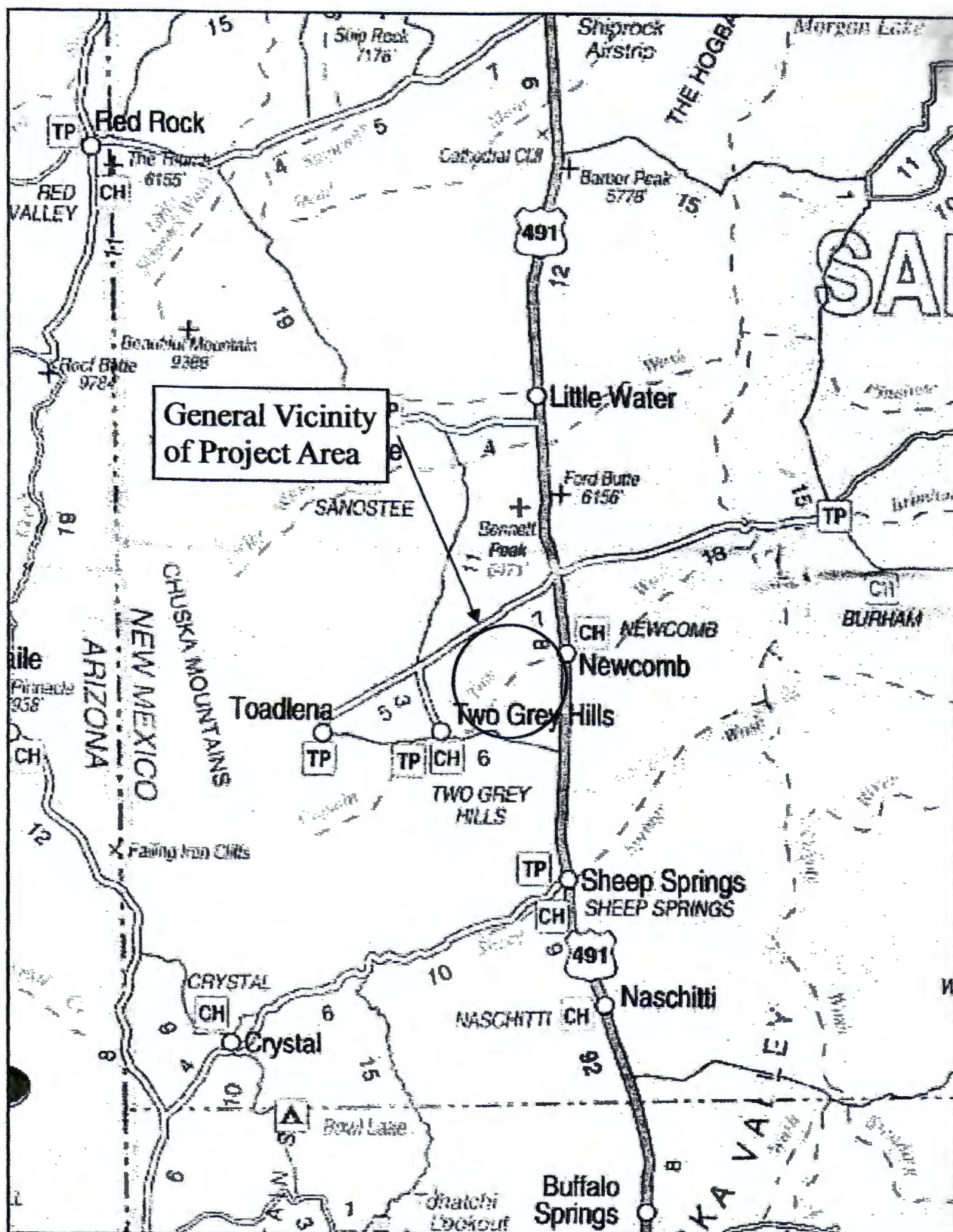


Figure 1. Vicinity map showing general project area. Indian Country Regional Map, n.d. (NNAD 14-097).

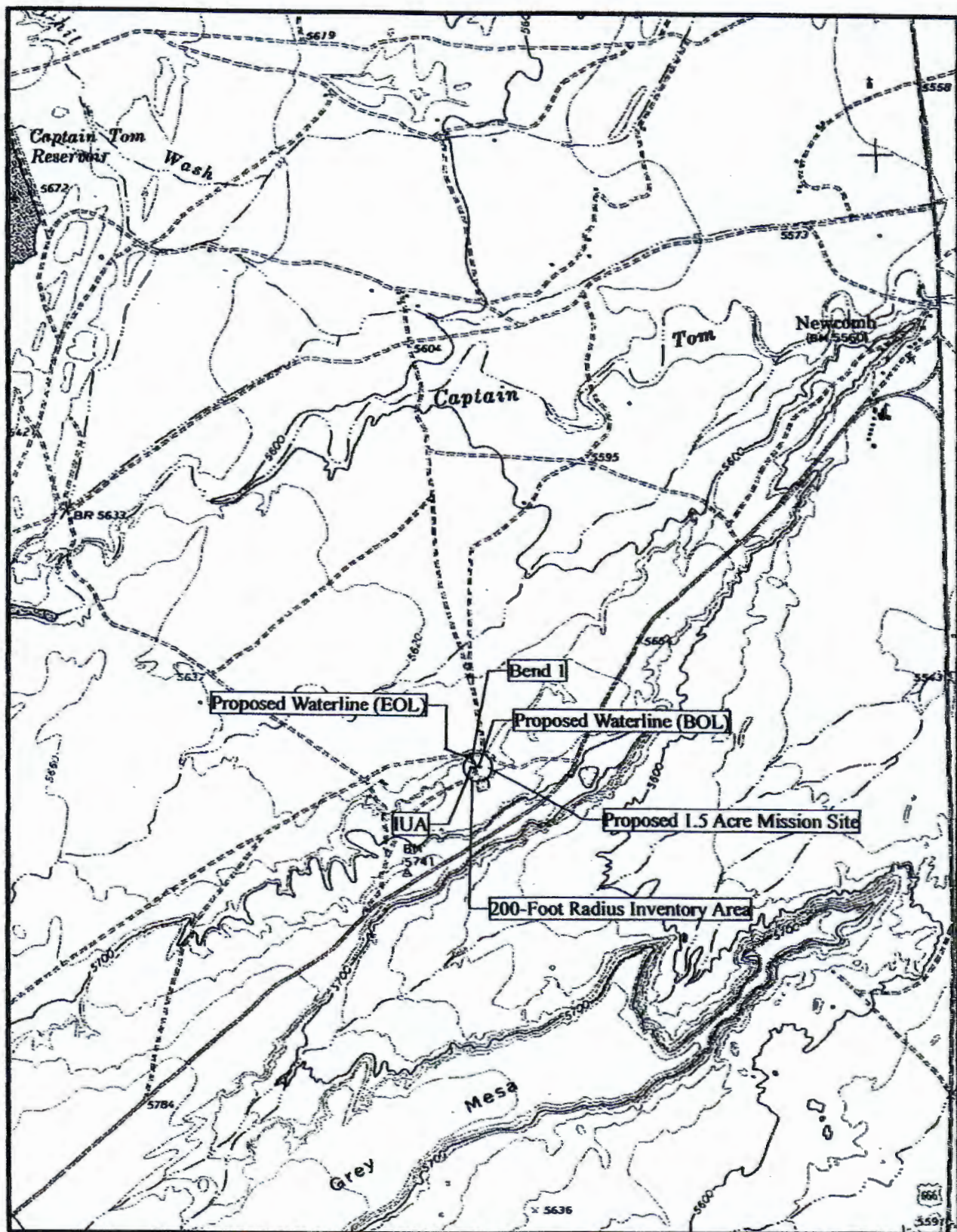


Figure 2. Location map showing project area and identified cultural resources. Newcomb, New Mex., 1966, 7.5' series USGS map; T24N,R18W, NMPM (NNAD 14-097).

The Navajo Nation Environmental Protection Agency (NNEPA) reviewed¹ and recommends *Conditional Approval* for the proposed mission lease for the existing Congregational Methodist Church lease in Newcomb, New Mexico.

1. The proposed mission lease will not significantly impact the Navajo Nation's environmental resources.
2. The proposed waterline must meet the following:
 - a. 401- A Section 401 certification is required if any drainage with discernable ordinary high water mark will be crossed/disturbed as determined by Patrick Antonio, Principal Hydrologist, NNEPA Water Quality Program on previous proposed projects.
 - b. 402 –Land surface disturbance in excess of 1.0 acre will require compliance with the federal General Construction Permit requirements for storm water discharges. The project will disturb 1.50 acres of land.
 - c. 404 – Boring under the drainage will require a Section 404 as determined by Patrick Antonio, Principal Hydrologist, NNEPA Water Quality Program. Contact the US Army Corps of Engineers.
 - d. The NNEPA - Public Water Systems Supervision Program (PWSSP) recommends *all proposed drinking water projects to be permitted by the PWSSP and all proposed drinking water projects (extensions, upgrades, new wells, new public water systems, etc.) must also comply with the design review and construction permit pursuant the §§1501 and 1601 of the Navajo Nation Primary Drinking Water Regulations.*

- e. *All proposed wastewater projects will be permitted by the Domestic Wastewater Program. Extensions, upgrades, new sewer infrastructure, septic tanks and other wastewater infrastructure must comply with the design review and construction permit requirements pursuant to §201 of the Domestic Wastewater Program.*
 - f. Contact Yolanda Barney, Environmental Program Manager, NNEPA, Surface & Groundwater Protection Department, PWSSP at 928/871-7755 for questions.
 - g. Apply water to control dust to lessen air impacts to community members and public located in or near the proposed action.
 - h. Congregational Methodist Church is subject to monitor and prevent invasive and noxious weeds either by manual or chemical control.
 - i. Before applying any chemicals, contact the NNEPA Pesticide Program at 928/871-7815/7810/7892 to ensure the product is in compliance and appropriately applied by a certified and licensed applicator.
 - j. Pesticide staff will also may need to be onsite to monitor during pesticide/herbicide application.
 - k. Solid waste generated from the construction and operation activities will be collected and transported by contractor to a designated trash bins to minimize significant impacts to human and wildlife resources.
 - l. If a sub-contractor will be hired to transport waste, ensure the contractors are certified and licensed with the Navajo Nation Business Regulatory Office.
 - m. The contractor must submit a copy of the landfill receipt/ticket to guarantee the construction waste has been properly disposed.
 - n. Do not allow public to take construction and operation waste. Cumulatively NNEPA receives complaints and reports on illegal trash dumpings on rural areas and in the waters of the US and Navajo Nation.
 - o. All illegal waste currently on the proposed site is the responsibility of the land user.
 - p. No underground or aboveground greater than 100 gallons is expected to be at the proposed site.
3. Any utility extensions right-of-way(s) outside the mission site lease will require a complete environmental assessment(s).
4. This environmental clearance is only for the 1.50 acre mission site lease.





The proposed action is approval, by the Bureau of Indian Affairs, of a Mission Lease on Navajo Nation Tribal Trust Land. The approved church lease will allow Congregational Methodist Navajo Mission to lease the tracts of land to construct a new church sanctuary, fellowship hall and water pipeline. The proposed project has an "as built" church building previously constructed and operated by the applicant's family. The project will affect 1.5 acres of Navajo Nation Tribal Trust Lands land located approximately 1.5 miles southwest of Newcomb, San Juan County, New Mexico. The project is sponsored by Congregational Methodist Navajo Mission, Post Office Box 7465, Newcomb, New Mexico 87455.

The project environmental assessment (EA) was reviewed by the Division of Environmental, Cultural and Safety Management, Navajo Regional Office. Based on the environmental assessment and the mitigation measures specified in the document, it is determined that the proposed action will not have a significant impact on the natural and human environment. Therefore, in accordance with the National Environmental Policy Act, Section 102 (2) (C), an environmental impact statement will not be required.

The following references, incorporated in the environmental assessment, serve as the bases for this decision:

1. Agency and public involvement was solicited. Environmental issues relative to mineral lease approval for the proposed project were identified. Alternative courses of action and mitigation measures were developed in response to environmental concerns and issues.
2. The EA disclosed the environmental consequences of the proposed and "no action" alternatives.
3. In compliance with the Endangered Species Act, informal consultation was held with the Navajo Nation Department of Fish and Wildlife (NNDFW), Natural Heritage Program (NHP). Although the NNDFW has no record of species of concern occurring on or near the project site at this time, it provided a list of species of concern having the potential to occur on the *Newcomb, NM*, USGS 7.5-Minute Quadrangles containing the project boundaries (Letter, dated September 19, 2014). The NNDFW issued Biological Resources Compliance Form (BRCF), NNDF & WL Review No. 14MNM-01 indicating Conditional Approval for the proposed project (EA, Appendix-BRCF). The operator shall comply with the Avoidance/Mitigation Measures and Conditions of Compliance cited in the BRCF (EA, Appendix A-BRCF).

4. Potential impacts to flood plains and wetlands by the proposed project have been evaluated in accordance with Executive Orders 11988 and 11990 respectively. The lease tracts are not located on a floodplain; nor located in a flood prone area. Federal Emergency Management Agency floodplain maps were reviewed for flood risk. The project area is excluded from any floodplain designation by the agency (FEMA, 2009) (EA, Part 3.1.10).

5. Water Resources- surface water drains north and into the Captain Tom Wash, which flows east to the Chaco River and north to the San Juan River. The proposed undertaking will have minimal effect on surface water quality in the area. The operator shall implement and maintain "Best Management Practices" to ensure protection of surface water quality during storm events and no other activity associated with the proposed action will require mitigation to conserve water quality and watershed management (EA, Part 3.3).

6. In compliance with the National Historic Preservation Act of 1966, as amended, Section 106 and 36 CFR 800.9 (b), a cultural resources inventory was conducted on the project area by Navajo Nation Archeology Department (NNAD). The Navajo Nation Historic Preservation Department (NNHPD) issued Cultural Resources Compliance Form (CRCF), NNHPD No. HPD-14-690, indicating, "No historic properties affected" (Appendix C-CRCF).

In the event of a discovery [discovery means any previously unidentified or incorrectly identified cultural resources including, but not limited to, archaeological deposits, human remains, or locations reportedly associated with Native American religious/traditional beliefs or practices] all operations in the immediate vicinity of the discovery must cease, and the Navajo Nation Historic Preservation Department must be notified.

7. RCRA, Subtitles C and D, Hazardous and Non-Hazardous Solid Waste- there will be no hazardous waste at the lease area that will be a factor, as the proposed action will not have any surface disturbance.

8. Air Resources- the proposed undertaking will have minimal effect on air quality in the area. However, no other activity associated with the proposed lease action will require mitigation to conserve air quality (EA, Part 4.3.4).

9. Noise levels- ambient noise would be increased by engine noise created by the motors of cars and pickup trucks for a very short duration. Due to the remoteness of the project area, and low volume of traffic on the route, noise shall not effect on the proposed action (EA, Part 3.1.9).

10. Noxious Weeds- If noxious weeds become established in the project area, the operator shall contact the Navajo Nation Department of Agriculture regarding management and control of noxious weeds. The NNEPA, Pesticide Enforcement and Development Program may be contacted regarding pesticide/herbicide applicators.

11. Cumulative and secondary effects on soil, water, air, noise, vegetation, cultural resources, and wildlife resources (species and habitat) were considered, and the proposed mitigation measures were found to be acceptable.

12. In accordance with Executive Order 12898 on Environmental Justice, impacts to minority and low-income populations and communities have been considered by the Regional NEPA Coordinator, as have impacts to Indian Trust Resources.

The proposed action would allow the church lease which would provide religious services on Sunday and Christian educational instruction to provide hope and faith for a better quality of life in the community.

CONGREGATIONAL METHODIST NAVAJO MISSION ENVIRONMENTAL ASSESSMENT

1.0 THE PROPOSED PROJECT

The Congregational Methodist Navajo Mission of Newcomb, New Mexico is preparing an application for a church lease. The proposed tract would be used to construct a new church sanctuary, fellowship hall and water pipeline. Reverend Wilford Yazzie intends to make application with the Navajo Land Department in Shiprock, New Mexico, and the Navajo Regional Office, Bureau of Indian Affairs, Gallup, New Mexico. Appendix A depicts the proposed church lease boundary and water pipeline land survey. The application and approval action will present a long-termed lease for the mission site.

Located approximately 1.5 miles southwest of Newcomb Chapter, the proposed mission project area and pipeline are shown at Figure 1. The Newcomb Chapter has passed a resolution approving the church proposed action, as shown at Appendix B. In the future, the Resource and Development Committee of the Navajo Nation Council would address a committee resolution for the proposed project. Final approval would be implemented by the Navajo Regional Office, Bureau of Indian Affairs.

1.1 Description of the Proposed Action.

Onsite, the proposed project area acreage at 1.5 acres would be totally developed. The proposed project site has an "as built" church building, previously constructed and operated by the applicant's family. The proposed lease tract would include a new church building and front porch (partially built), vehicle parking, and infrastructure. The new church building would encompass approximately 60'X60' (3600 square feet). The proposed building would include a sanctuary, fellowship hall, classrooms, kitchen, dining area and office. Restrooms would be located in the lobby area.

Open areas, adjacent to the buildings, would be used for ramada canopy meetings, wedding receptions, picnics, and athletic activities. Playground equipment would be temporary installed for the ministry children. A septic tank and leach field would be constructed on the northeast corner of the tract.

Infrastructure would include a proposed water pipeline, electrical power (as built), waste water septic tank and leach field. Utilities in the Newcomb Chapter area are provided by the Navajo Tribal Utility Authority. NTUA would provide electrical power and a water source. A 2,538 feet water line, encompassing 0.583± acre, would be constructed on the northwest side to service the church. The water line would tap into the existing community water system. An existing single phase 14.4 kv service line serves the church tract onsite. Propane gas is planned for heating and cooking.

A vehicle parking area would be included in the lease area. Construction of a new access road to the proposed parcel will not be required, as the church site is located adjacent to the existing main road. A turnout off the main road will provide access to the church site.

1.2 Purpose and Need

The purpose of the land use permit application is to organize and all-lawful religious business

Newcomb, New Mexico**

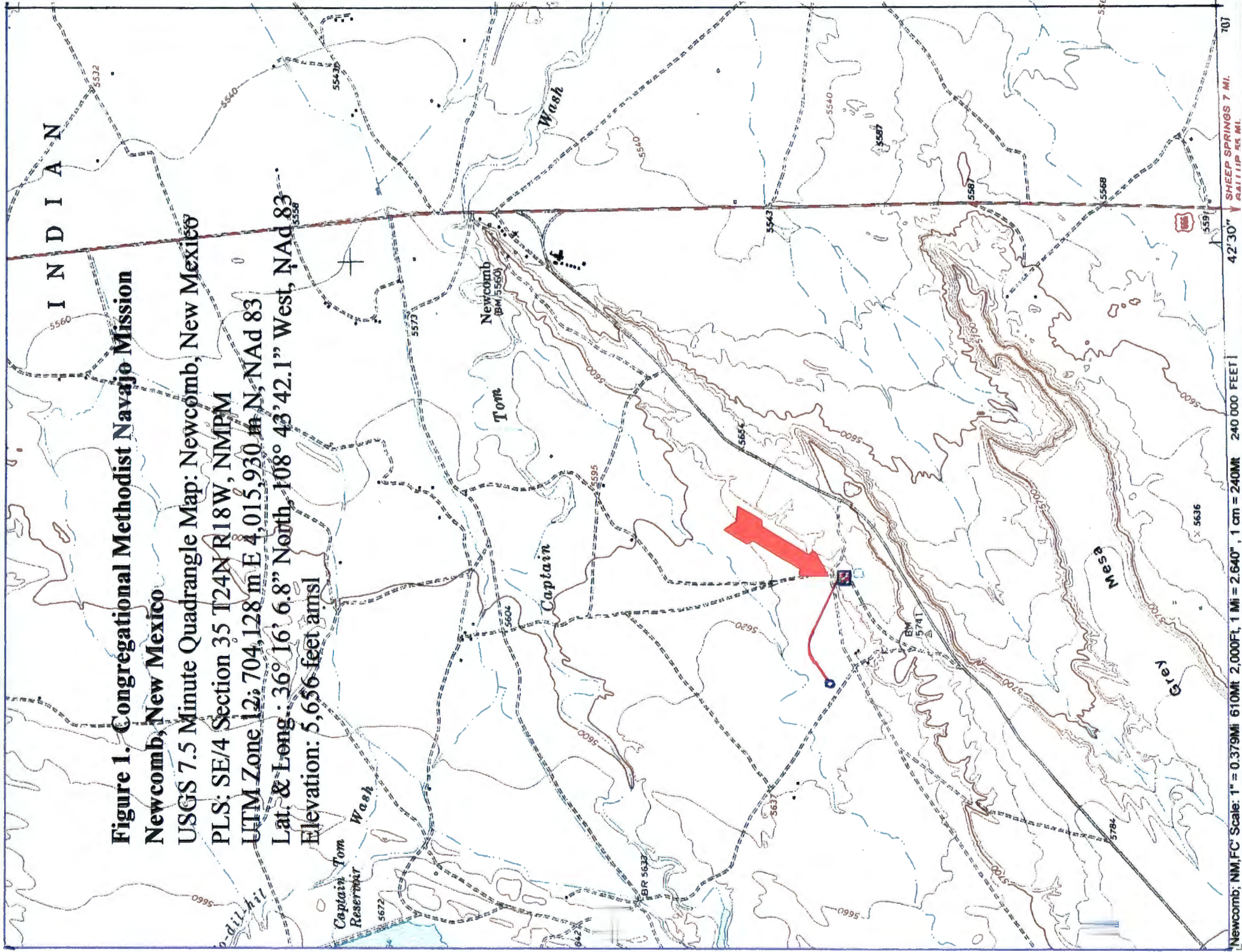

for the Congregational Methodist Navajo Mission, a nonprofit corporation. Operations of the church would include Sunday religious services and Christian educational instruction for the community congregation. In the future, various incremental improvements would be constructed on the buildings and property. The proposed long-term church lease would support the operations and maintenance of the church. The need of the ministry is to provide teaching and spreading of the Gospel of the Lord Jesus Christ in accordance with the doctrines and teachings of the New Testament, and for religious educational, benevolent and charitable purposes, and public worship. The church would provide families religious services on Sunday and Christian educational instruction. The church would provide hope and faith to the congregation and a better quality of life.

1.3 Location

The land boundary survey of the proposed project tract, at 1.5 acres, is shown in Appendix A. Figure 1 depicts the tract location on the USGS 7.5 Minute Quadrangle Map entitled *Newcomb, New Mexico*. Table 1 below describes the location coordinates for the proposed project.

The propose project area, located on Navajo Tribal trust lands, is 1.5 miles southwest of Newcomb Chapter, Shiprock Agency, San Juan County, New Mexico. The proposed project is at an elevation of 5,656 ± feet amsl.

1.4 Project Authorization

The purposed mission site is authorized by the Navajo Nation Trust Land Leasing Act of 2000, Public Law 106-568 and 25 USC Code § 415(e). Navajo Nation Code at Title 16 Land, Chapter 11 § 1101, Land for Public, Charitable and Religious Purposes, authorizes the Navajo Land Department to participate and manage land use leases on the Navajo Indian Reservation projects in rural Utah, Arizona, and New Mexico.

The Bureau of Indian Affairs is the lead Federal agency, as authorized by the Synder Act of November 20, 1921, 25 USC Chapter 1 § 13, which establishes appropriation for BIA leasing activity.

1.5 Purpose of Environmental Assessment

The environmental assessment is an instrument required by federal law and regulations to determine if potential impacts of a federal action are of such significant as to require the preparation of an environmental impact statement. The proposed federal action is approval of a land lease permit. The approval of the mission lease will allow the operator to withdraw a tract of land, on which to further construct, operate and maintain a church facility. This document

addresses potential impacts and mitigation for the approval of the permit. The approval of the proposed land use is a trust responsibility of the Bureau of Indian Affairs, which has jurisdiction over trust resources of the Diné People, and as managed by the Navajo Nation.

2.0 ALTERNATIVES

2.1 Alternate Site Locations

An alternate site, of sufficient size and at a location as convenient as the proposed location, is not available. Grazing permit holders generally try to retain their grazing permitted areas intact, and not to become fragmented. As permitted, holistic grazing areas are needed to sustain livestock herds. Other land use permits, i.e. church site of adequate size, become impossible to acquire. Open areas in the vicinity are used for family residents, livestock grazing and small dry farming.

Alternate locations were reviewed. Alternate site locations would be subject to the same assessments, approvals and clearance process as the preferred alternative. An alternative site would require a restart of approvals, starting with the grazing permit holder on trust lands, archaeology clearance, and biological resource assessment. When approved, existing grazing permit holders may reverse their decisions and reject the alternate location. The approved chapter and proposed Resource and Development Committee resolutions would become mute.

2.2 No Action Alternative

If the no action is taken, the proposed long-term church lease would not be approved. The existing church site would be without a church lease. Improvements to the church may not be constructed. Religious services and benefits to the local people would be curtailed and not be normally provided. Addition church construction would not go as planned. The existing tract would not be used, and would not be elevated to a higher productive state. The project would not be in compliance with the National Environmental Policy Act, and would continue to be noncompliant to Navajo Nation Environmental Codes. There would be no environmental assessment document, nor associated cultural and biological resource studies.

2.3 Approval of the Preferred Alternative

The preferred alternative involves approval of a Federal permit or lease which would allow for the construction, operation and maintenance of a church site for the people of Newcomb Chapter. Details of the preferred alternative and scope are described in Section 1.0, Description of the Proposed Action. The proposed land use permit would be approved by resolution of the Resources and Development Committee of the Navajo Nation Council. The BIA would provide final approval. The Newcomb Chapter support resolution is attached as Appendix B.

3.0 AFFECTED RESOURCES AND ENVIRONMENTAL EFFECTS

3.1 Resources Not Considered in Detail (Non-Critical)

Initial evaluation of the alternatives indicated that there would likely be little to no direct, indirect, or cumulative effects on several resources. These resources are discussed in Sections 3.1.1 through 3.1.12 to add to the overall understanding of the environmental setting of the project area.

3.1.1 Climate

Located in San Juan County, New Mexico, Newcomb Chapter has a semi-arid climate, at an elevation of 5,656 feet above mean sea level. The chapter experiences four distinct climatic seasons and has an annual average maximum temperature of 69.2°F and average minimum temperature of 14.0°F. Summer highs reach the mid 90's with lows in the upper 50's to lower 60's. Winter highs in January are at 42.6's with average lows at 14.0. Average annual precipitation is 6.0 inches and average annual snowfall is 0.5 inches with an average snow depth of less than one inch (WRCC 2014). Due to the size and nature of the work, the proposed project would have no effect on climate. Since there would be no effects on climate, no mitigation would be required.

3.1.2 Geology and Seismicity

The mission site is located on the west flank of the San Juan Basin Syncline. The regional geologic structure is stable. Eroded surface sandstone soils are of the Upper Cretaceous Member of the Menefee Formation. Surface soils are alternating beds of tan and brown sandstone and gray and brown claystone and siltstone. There are no regional faults or fissures in the area. The geologic formation dips gently approximately three degrees to the east (Cooley, M.E, J.W. Harshbarger, J.P. Akers, and W.F. Hardt, 1969). Based on the history of the area, geology will not be a factor in this development. There are no surface mineral resources located on the proposed tract. No mitigation is required for any geologic adversity.

3.1.3 Fisheries

There are no fisheries or fishery habitat occurrences in the Newcomb Chapter. Chapter residents would have to travel west to the Chuska Mountains for an afternoon of picnicking and fishing at Berland Lake or Whiskey Lake. Morgan Lake southeast of Shiprock offers a warm water fishery.

3.1.4 Socioeconomics and Environmental Justice

The proposed project would have no effects on the socioeconomics of the area because it would not limit either present-day or future opportunities for agriculture, raising livestock, business, employment, or housing.

Newcomb Chapter is a sparsely populated rural chapter. There are currently 324 homes in the Newcomb community. According to the 2004 census, approximately 738 people reside in the Chapter, which would indicate a population density of 8.3 persons per square mile. Native Americans make up 94.8% of the population (NN DED/LSRI, 2004).

Newcomb Chapter's economy is primarily based on employment with the Navajo Nation (educational, health, social services and public administration). Currently most residents in the Chapter area are wage earners, working a various government and commercial jobs in nearby towns and cities. Major employers in the area vicinity include the BIA Toadlena Boarding School, Newcomb School District, Newcomb Chapter and the Mustang Store.

Federal, state and tribal government services, law and order, schools and major retail outlets are available at Shiprock and Gallup, New Mexico. An Indian Health Service Hospital is located in Shiprock, New Mexico. San Juan Regional Hospital is located in Farmington, New Mexico.

In the past, the economy was primarily based on livestock production, but this is no longer the predominate source of income, and now livestock production makes up a small percentage of the Chapter's economy. While unemployment is high throughout the project area, raising livestock has been a sustainable economy in the past. The retired elderly in the area still carry on the

livestock rising life style. Traditional rug weaving provides some families with a source of income. Land use areas are relatively small and not large enough to sustain a viable operating ranch for the entire family. However, the younger family members wish to be with their elders and have moved back into the old homesteads; build their new houses on the ranch land. The area provides a better quality of life, in contrast to apartment living in nearby towns.

Environmental Justice

In accordance with the Environmental Justice, the project would have no disproportionate effects on minorities or low-income populations. Consistent with the project purpose, the project would benefit the community by providing religious services and education. Executive Order 12898, Environmental Justice, requires federal agencies to assess projects to ensure there would be no disproportionately high or adverse environmental, health, or safety effects on minority and low income populations. Minorities comprise a large proportion of the population residing in the action area. The church will be for the beneficial use of the Navajo Indian People and residents of the community. The local chapter has approved a supporting resolution, see Appendix B. A similar resolution would be approved by the Resource and Development Committee of the Navajo Nation Council. The Bureau of Indian Affairs, as federal trustee, would also approve the project.

The project would allow religious services and education to the people, lead better lives in the community, and would further provide a better quality of life for the congregation and community. Environmental Justice-the proposed action will benefit all sectors of society.

3.1.5 Land Use and Zoning

The existing and proposed property would be located on Indian trust land in Newcomb Chapter, Shiprock Agency. The surrounding land use is set aside for livestock rangeland use. The site is currently grazed year-around by domestic livestock, as marginal vegetation exist onsite. A dam and livestock watering hole is located behind the church, on the south side. The livestock watering point is currently dry. For many years the project site was used by the grazing permit holder. Soils in the immediate vicinity of the proposed tract are totally disturbed and nearly devoid of any natural vegetation from existing land uses. Ruins of a stone house and rock hogan remain onsite.

According to the Navajo Fish and Wildlife Department, the proposed church site would be located in an Area 3 Low Sensitive Wildlife Resource area, due to habitat requirements wildlife species are not present. The proposed site is located in a Desert Grassland Ecosystem. Vegetation cover is marginal. Site vicinity soils are largely atypical, previously disturbed.

Vicinity properties in all directions contain the following: on the south side, adjacent to the proposed project site, is a dam for livestock watering. The east side is an undisturbed rocky mesa out slope as part of the surrounding mesa. An existing single phase electrical line with transformer is located on the NE side. The hogan ruin and major access road is located on the north side of the proposed lease. The former rock house abuts the mesa out slope on the west site. Atypical disturbed areas adjacent to the proposed church site have been used for various purposes in the past.

A cluster of houses, livestock corrals and vehicles are located ½ mile to the west of the church site. An old community landfill is located approximately 3/8 mile northeast of the proposed church

site. The landfill is buried and no longer in use. Navajo Route N5001 is located one-mile south on the mesa. The ephemeral Captain Tom Wash is located to the north.

Navajo Route N5001, a major dirt road, would provide access from Newcomb to U.S. 491 highway. A dirt spur road off of N5001 provides access to the proposed church lease and residents west of the church site. A short access road off of the spur road would provide access to the church site.

Indian Trust Resources

The mission site would occupy a 1.5 acre parcel and the pipeline right of way at 0.583 acre, 2.083 total acres. This acreage would be withdrawn for the church site use and the pipeline right of way. There are no other bankable assets, such as timber, fossil fuels, fossils, or valuable minerals on the tract, surface or subsurface. Other than surface use, the proposed church lease will not impact any other Indian trust assets of the Diné People.

3.1.6 Prime Farmland

There are no Prime Farmland occurrences in the proposed project area. Due to the arid climate, dry farm land is very limited in the Newcomb area. Individual irrigated fields are located along Captain Tom Wash, however not in the vicinity of the proposed mission.

3.1.7 Recreation

Bowl Canyon Assayi Lake, Wheatfields Lake and Berland Lake in Chuska Mountains would be the nearest fishing lakes from Newcomb. The lakes would offer a cold-water fishery such as rainbow and cutthroat trout. Other outdoor recreation sports such as hiking, picnicking, camping, small and big game hunting is available.

Located northeast of Newcomb, Navajo Lake State Park and Cutter Dam would be a favorite fishing lake for cold water fish. The lakes offers picnicking, hiking and fishing.

Aztec Ruins National Monument, northeast of Farmington, offers well preserved ruins date back to about 1100 AD. Chaco Culture National Historical, 45 miles east of the project area, offers extensive ruins dating from about 1,000 years ago are related to other Anasazi cultures of other well-known sites in the Four Corners region, such as Mesa Verde. The National Park Service administers the two parks. Bisti & De-Na-Zin Wilderness located east of the project area is characterized by colorful land forms and unique geological features; fossils and petrified logs. Both wilderness areas are administered by BLM.

Gathering - approximately every three to five years, vicinity pinon trees in the project area will yield a bumper crop of pinon nuts. Native people would gather this crop for individual consumption. The pinon nuts would also be sold to local traders for cash.

Locally, horseback riding is another source of outdoor recreation, as horses and horse stables were observed. "Chicken Pulls" or rodeos are also a traditional sport and form of outdoor recreation in the region. In addition to the hunting, fishing, and gathering as described above, it is evident that ATV is another source of recreation. ATV vehicles were observed during site reconnaissance.

3.1.8 Traffic

The existing church is located in a rural setting along an unnumbered family access road. The family access road serves a family homes and a small ranch to the west of the proposed lease. The existing church and proposed lease area will not impacted the existing transportation use network; any activity and new construction at the proposed lease area would not be impact the use of any local routes.

3.1.9 Noise

The project area is located in a rural environment, which family homes and small ranches are located. No published noise ordinance for construction activities exists in the Navajo Indian Reservation, including the proposed lease area. Ambient noise would be increased by engine noise created by the motors of cars and pickup trucks for a very short duration. Due to the remoteness of the project area, and low volume of traffic on the route, noise would not have an effect on the proposed action. A backhoe tractor may be used during the day light hours. Noise would not be a factor in the proposed action.

3.1.10 Floodplain

The tract is not located on a floodplain; nor located in a flood prone area. Captain Tom Wash, a broad drainage basin, generally flows east at a moderate slope, which is ample drainage. Floodplain maps were reviewed. The project area is excluded from any floodplain designation by the floodplain study (Morrison Maierle Inc., 1977).

3.1.11 Wetlands and Riparian Habitat

The Toadlena National Wetlands Inventory Map (USF&WS, 1984) indicates structures north of the proposed project area along Captain Tom Wash. The wash is ephemeral; water regime is dry, non-tidal and may be temporary flooded during the monsoon season. A livestock impoundment is located just south of the proposed church site. The purported wetland site (impoundment) do not exhibit hydric soils, nor hydrophilic vegetation, nor does it support a wetland hydrology (U.S. ACOE,1987). There are no wetland or riparian habitat occurrences.

3.1.12 Hazardous, Toxic, and Radiological Waste

Other than surrounding scattered housing, and livestock grazing, there are no previous industrial uses of the area. The propose project site currently does not contain any damaged or discarded automotive or industrial equipment. No fill dirt has been brought onto the property that originated from a contaminated site. There is no evidence of leaks and spills of hazardous substance, radiological waste, or spills of petroleum products on the existing tract.

No Resource Conservation and Recovery Act (RCRA) Subtitle C hazardous waste sites, nor RCRA Subtitle D, non-hazardous solid waste sites occur on or near the church site. No Comprehensive Environmental Response Conservation and Liabilities Act (CERCLA) hazardous substance (including radiological waste) occur near the project area. No Toxic Substance Control Act (TSCA) waste sites occur on or near the existing church site. Hence, there will be no residual hazardous effects on the proposed church lease.

CRITICAL ELEMENTS

3.2 Topography and Soils

3.2.1 Existing Conditions

The Persayo-Rockland soil association occurs on gently sloping to undulating and rolling hills, tilted ridges and ledges, with sandstone and interbedded shale outcrops and cobble stone (NMSU-AES, 1973). The proposed site is located in a Desert Grassland Ecosystem. Undisturbed mesa out-slope top soils are covered with cobble stone 1" to 8" in diameter. Soils under the cobble stone are clay-shales and fine sandstone. Due to overgrazing and livestock trampling, natural vegetation cover is marginal. Site vicinity soils are largely atypical, previously disturbed. The tract drains north to the Captain Tom Wash. Onsite topography, eroded mesa tops dip approximately three percent toward the east, that allow for ample drainage to the Chaco River. The Chaco River drains north, eventually into the San Juan River, approximately 45 miles north. Project elevation is 5,656 ± feet amsl.

3.2.2 Effects

The topography and soils, as they exists now, will not impact the proposed undertaking.

3.2.3 Mitigation

No mitigation is required for the project topography and soils.

3.3 Water Resources and Water Quality

3.3.1 Existing Conditions

Surface water drains north and into the Captain Tom Wash, which flows east to the Chaco River and north to the San Juan River. The primary discharges of these drainages occur during the spring months, during the spring snow thaw and during occasional intense summer thunder showers in late summer. As a result, the stream flow is erratic and fluctuates widely both seasonally and annually. Torrential thunderstorms can produce flood-stage flows within minutes (Cooley, M. E., J. W. Harshbarger, J. P. Akers, & W. F. Hardt, 1969).

NTUA would provide Safe Drinking water to the church and from the Newcomb Community Water System. Newcomb Community wells are located in the upper Captain Tom Wash watershed.

3.3.2 Effects

Present and future project construction work or other related activities will not have impact on any springs, wells or aquifer recharge areas. The church site plans to construct a septic tank and leach field to collect its sewage. No impacts to the natural ground water in the church vicinity may be expected by the approval of the lease application. The church facility would become part of the Newcomb Community Water System.

3.3.3 Mitigation

The propose undertaking is a church lease application. The proposed project lease area and church is an "as built" facility. The old church has been destroyed and the proposed church has been partially constructed. Future church improvements would be constructed in an incremental manner, as church funds become available. Clean Water Act Section 402 (p) will not be applied for. Previous surface disturbance has stabilized.

3.4 Vegetation and Wildlife- Biotic Resources

3.4.1 Existing Conditions

The Newcomb church site and chapter are located in the Great Basin Grassland Ecosystem of northwest New Mexico. At an elevation of 5,656 amsl, the biome is a sagebrush-grassland

vegetation type, with intermittent juniper, yucca, and prickly pear occurring in the low areas and on the north slopes.

The Great Basin Grasslands mean annual precipitation would range from seven to twelve inches, and the annual growing season would range from 125 – 200 days (April to September). “These transitional grassland areas also receive a larger percentage of their precipitation during the winter and spring months; May through August rainfall averages less than 127 mm (5 inches)”. At lower elevations the contact is most frequently with Great Basin desertscrub (Turner, R.M. & Brown, 1994).

Perennial grasses of this biome are represented by the following species: Ring muhly *Muhlenbergia torreyi*, Blue grama *Bouteloua gracilis*, Galleta *Hilaria jamesii*, Indian ricegrass *Oryzopsis hymenoides*, Bottlebrush squirrel tail *Sitanion hystrix*, Needle and thread *Stipa comata*, Red-three awn *Aristida longiseta*, and Sand dropseed *Sporobolus cryptandrus*. Alkali sacaton *Sporobolus airoides* can be found in the swales and in the low areas along arroyos and washes (Turner, R.M. & Brown, 1994).

Forbs, although widely scattered in this sagebrush grassland community, are represented as Aster *Aster*, Coneflower *Ratibida*, Indian paint brush *Castilleja applegatei*, Thistles *circuimmus* and Groundsel *Senecio*. These forbs will present showy flowers during the wet season.

Shurbs such as Four-wing saltbush *Atriplex canescens*, Sagebrush *Atremisa*, winterfat *Ceratoides lanata*, Cholla *Opuntia*, Soapweed yucca *Yucca glauca*, rabbit brush *Chrysothamus*, and Snake weed *Gutierrezia* would be scattered throughout the biome. Grazing and human activity may alter the distribution of snakeweed, rabbit brush, and sagebrush.

Annual plants (noxious weeds) such as cheatgrass *Bromus tectorum*, Russian thistle *Salsolia kali*, tansy mustard *Descurainia obtusa*, sunflower *Helianthus annuus*, and kochia weed *Bassia hyssopifolia* occur on the parcel (De Witt I., Robert, 2006).

Distinct fauna of the Great Basin Grassland include the whitetail prairie dog *Cynomys gunnisoni*, pocket mouse *Perognathus parvus*, Ord’s kangaroo rat *Dipodomys ordii*, and the montane vole *microtus montanus*. Other mammals include the coyote *Canis latrans* and black-tailed jackrabbit *Lepus californicus*. Although rare in the Chapter, Pronghorn antelope are occasionally spotted on the grassland areas 50 miles to the southeast.

Birds, indigenous to the ecosystem, are the Mountain plover *Charadrius montanaca*, lark blunting *Calamospiza milanocorys*, sparrow *Ammodramus*, sage thrasher *Oreoscoptes montanus*, sage sparrow *Amphispiza belli*, and horned lark *Eremophila alpestris*. Other grassland bird species include the Western meadow lark *Sturnella neglecta*, Prairie falcon *Falco mexicanus*, and Burrowing owl *Athene cuicularia* (Turner, R.M. & Brown, 1994). Due to the abundance of forage (ground borrowing rodents), Golden eagles *Aquila chrysaetos*, Cooper’s hawk *Accipiter cooperii*, and Redtail hawks *Buteo jamaicensis* are occasionally sighted on the grasslands.

Due to its long cold winters in the Great Basin, reptiles are not well represented. Common species include the sagebrush lizard *Sceloporus graciosus*, and the Great Basin spadefoot toad *Scaphiopus intermontanus*, and collared lizard *Crotaphytus collais*. The Northern desert horned lizard *Phrynosoma platyrhinos*, Northern whiptails *Cnemidophorus tigris tigris*, Great Basin gopher snake *Pituophis melanoleucus deserticola* and Great Basin rattlesnake *Crotalus viridis* are a few of the other common reptile species (Turner, R.M. & Brown, 1994).

3.4.2 Effects

The area presently provides suitable foraging and nesting habitat for small mammals and birds. The proposed lease area will have no effect on the biota, as the species are not present. Initial field surveys indicate that species are not present on the proposed lease area, therefore the proposed project would not cause an incremental loss of potential nesting, cover and forage habitat of terrestrial flora and fauna species.

3.4.3 Mitigation

Indirect mitigation is recommended for all fauna and flora on the proposed area. Natural vegetative cover can be restored over time. The proposed undertaking will have minimal effect on vegetation and potential habitat in the area.

3.5 Threatened and Endangered Species

3.5.1 Existing Conditions

Navajo Fish and Wildlife Department indicates the proposed church site would be located in an Area 3 location, an area of Low Sensitive Wildlife Resources, i.e., due to habitat requirements, wildlife species are not present. See the Navajo Nation ESA & NESL consultation at Appendix D. The proposed site is located in a Desert Grassland Ecosystem. Vegetation cover is marginal. Site vicinity soils are largely atypical previously disturbed.

However, reconstruction of the existing church includes the new construction of the proposed waterline. The NDF&W Biological Resources Compliance Form stipulates conditions of compliance requires a field survey for the proposed water line and septic system be conducted during the appropriate field season for the Mesa Verde cactus, which would be usually be conducted during the flowering season in April of the year. Field surveys were conducted in August and September of 2014. The MVC was not found along the pipeline or pipeline right of way during the time.

The NDF&W data request consultation letter was received by the ministry September 22, 2014. The biological land clearance procedure, as stated in the NHP letter, qualifies the church site as an Area 3, an area of Low Sensitivity. The NDF&W data request/response letter also states there is no Federal listed species, or NESL, in the church development tract, nor is there a designation of critical habitat in the region.

3.5.2 Effects

Impacts posed by the existing church and water line can be expected to be minimal. The existing church and proposed water line is in a rural setting, and will not have an effect on the habitat or other elements necessary for the continued survival of T&E species, as these species are generally not found on the project area. The Navajo Department of Fish and Wildlife concurs with the finding: no federal ESA or Navajo NESL species would be impacted. See Appendix D for the Biological Resource Compliance Form and biological resource consultations.

3.5.3 Mitigation

The NDF&W recommends prior to construction the proposed activity would require a preconstruction survey of potential Mesa Verde cactus along the waterline right of way and buffer zone during the flowering season. Any MVC plants found during the survey, within the proposed project area, will be reported to the NDF&W biologist for appropriate mitigation prior to construction activities.

3.6 Navajo Endangered Species List (NESL) Special Management Species

3.6.1 Existing Conditions

The Navajo Department of Fish and Wildlife's *Biological Resource Land Clearance Policy and Procedures* (BRLCP&P) was consulted. The land clearance procedure qualified the church tract and surrounding area as an Area 3, an area of low sensitivity.

3.6.2 Effects

The proposed lease area will have no effect on the NESL, as the species are not present. Initial field surveys indicate that species are not present on the proposed lease area, therefore the proposed project would not cause an incremental loss of potential nesting, cover and forage habitat of terrestrial flora and fauna species. The Navajo Department of Fish and Wildlife concurs with the finding. See Appendix D for the Biological Resource Compliance Form and biological resource consultations.

3.6.3 Mitigation

No mitigation would be required for the Navajo NESL species. See the Biological Resource Compliance Form at Appendix D and biological resource consultations.

3.7 Migratory Birds

3.7.1 Existing Conditions

Migratory birds and their habitats are protected under the Migratory Bird Treaty Act (MBTA) (16 USC §703-712) and EO 13186. All federal agencies are required to consider management impacts to protect migratory non-game birds. Executive Order 13186 calls for increased efforts to more fully implement the MBTA. The U.S. Fish and Wildlife Service (USFWS) list of Birds of Conservation Concern (BCC) was reviewed, specifically as they pertain to the Colorado Plateau physiographic area. The list indicates there are 27 avian species occurring on the southern Rocky Mountains and Colorado Plateau. See Table 4.

Most priority bird species occur on the USFWS, Division of Migratory Bird Management "Birds of Conservation Concern 2008", (BCC 2008 list). The Service designates the Southern Rockies / Colorado Plateau region as Bird Conservation Region (BCR) 16, in which the Navajo Indian Reservation and the Shiprock Agency are located. Although migratory birds could potentially occur in the area, none were observed during the site visits.

3.7.2 Effects

Basis of Significance. An alternative would be considered to have a significant effect on vegetation and wildlife if it would: 1) result in the substantial loss or degradation of any plant community providing high quality wildlife habitat; or 2) permanently displace substantial numbers of resident wildlife species or migratory bird species.

No Action. This alternative would have no effect on existing vegetation and wildlife, including migratory birds, in the project area. The grassland habitats and associated wildlife species would be expected to remain the same.

Proposed Action. This alternative would result in a short-term and small scale loss of vegetation due to future construction. The remaining project activities are expected to occur in the existing church areas. No permanent loss of native vegetation is anticipated; native seed from the disturbed vegetation would also help to propagate the natural plant species. No long-term loss of vegetation or wildlife habitat is expected. As a result, the proposed action would have no significant effects on migratory bird species.

3.7.3 Mitigation

NN DF&W policy mandates that prior to construction the proposed activity would require a preconstruction survey of potential nesting birds on the tract, should large-scale construction occur during the breeding season. Any bird nests found during the survey, within the proposed project area, will be reported to the NN DF&W biologist for appropriate mitigation prior to construction activities.

3.8 Air Quality

3.8.1 Existing Conditions

Ambient air quality in the project area may be regarded as good. Primary pollutants in the project area is wind-blown dust from loose topsoil common during times of high wind during the spring and dust from vehicular traffic along unimproved roads in the vicinity. Total suspended particulate matter – TPM (measured as PM₂) – has been replaced by the measure of finer particulate matter (PM₁₀) as the federal mandated measure of air borne particulate matter; since

the finer particles of dust at PM 10 has been more closely correlated to negative health effects than TSP, i.e., the finer particles inhaled by humans.

3.8.2 Effects

Air quality will be affected locally by dust and a negligible amount of hydrocarbons generated by other construction equipment. However, these pollutants will not be generated in sufficient concentrations to produce measurable adverse effects to structural metals, paint and fabrics, or damage to vegetation. Construction activities, facilities, and infrastructure, will not have a significant long-term effect on the ambient air quality in the project area.

3.8.3 Mitigation

Disturbed soils during site preparation would be dampened by watering for dust suppression and soil compaction.

3.9 Esthetics and Visual Resources

3.9.1 Existing Conditions

No visibility studies have been conducted in the project area. However, regional visibility in the project area can be considered to be good to marginal, depending on the season.

3.9.2 Effects

Locally, the primary pollutant in the project area is occasional wind-blown dust from loose topsoil common during times of gusting winds during the spring, and dust from vehicular traffic along unimproved roads in the area.

3.9.3 Mitigation

Disturbed soils during site preparation would be dampened by watering for dust suppression and soil compaction.

3.10 Cultural Resources

3.10.1 Existing Conditions

Navajo Nation Archaeology Department of Shiprock, New Mexico conducted the archeological field survey of the proposed lease area. The archaeologist crafted a field report entitled: *A Cultural Resource Inventory of Re-establishing a Proposed 1.5 Acre Congregational Methodist Church Mission Site Near Newcomb, San Juan County, New Mexico*. The cultural resource field inventory report recommends "No historic properties affected". In addition, 2,538 feet long waterline rights of way (0.583 acre) was field inventoried to serve the mission. The total area of effect is therefore 2.083 acres total. Ground disturbance would be intensive and extensive with heavy equipment (NNAD, 2014).

3.10.2 Effects

Navajo Historic Preservation Department-Compliance Section has coordinated review of the cultural resource report with the Navajo Regional Office, Division of Environment, Cultural Resources and Safety Management, Bureau of Indian Affairs. A Cultural Resource Compliance Form HPD-14-690 has been created for this undertaking, as shown in Appendix C. A finding of "No Historic Properties Affected" to the cultural resources is determined for the proposed church lease (NNHPD, 2014).

3.10.3 Mitigation

The church management acknowledges the following statement with respect to cultural resources during construction: *In the event of the discovery [“discovery” means any previously unidentified or incorrectly identified cultural resources; including but not limited to archaeological deposits, human remains, or locations reportedly associated with Native American religious/traditional*

beliefs or practices] all operations in the immediate vicinity will cease and the Navajo Nation Historic Preservation Department will be notified at (928) 871-7132.

3.11 Native American Religious Concerns

3.11.1 Existing Conditions

As part of the archeological inventory, interviews regarding traditional cultural properties (TCPs) were conducted. No sacred sites or traditional cultural resources were identified within the proposed site.

There are several pieces of legislation or executive orders that are considered in an evaluation of Native American Religious Concerns (i.e., American Indian Religious Freedom Act [AIRFA] of 1978, Executive Order 13007, The Native American Graves Protection and Repatriation Act [NAGPRA] of 1990, and the Archaeological Resources Protection Act [ARPA] of 1979).

Traditional Cultural Properties (TCPs) are a separate class of cultural resources which may occur in the project study area, which may or may not coincide with archaeological sites and artifact loci, and may fall under the purview of one or more of the cited legislation. The National Park Service has defined TCPs as follows:

A traditional cultural property can be defined generally as one (a property) that is eligible for the National Register because of its association with cultural practices of beliefs of a living community that (a) are rooted in that community's history, and (b) are important in maintaining the continuing cultural identity of the community (National Register Bulletin 38). The field survey did not identify any known TCPs on the existing church tract. Additionally, no TCP have been identified by the local Native American tribes as a result of coordination efforts. Identification efforts for Native American Religious Concerns include interviews with chapter coordinators, home site owners, and local residents were conducted. Results of the interviews indicate there are no known TCPs within the proposed project area. There are no blessed structures, tipi grounds, or other ceremonial features associated with any in-use area.

3.11.2 Effects

Basis of Significance. An alternative would be to have a significant effect on Native American religious concerns if TCPs would have been identified and affected during the cultural resource field survey.

No Action. This alternative would have no effect on existing traditional cultural properties or American Indian Religion in the project area. This alternative would not prevent access to other sacred sites, nor would it interfere or otherwise hinder the performance of traditional ceremonies and rituals.

Proposed Action. This alternative would have no effect on existing traditional cultural properties or American Indian Religion in the project area. This alternative would not prevent access to other sacred sites nor would it interfere or otherwise hinder the performance of traditional ceremonies and rituals.

3.11.3 Mitigation Measures

No site specific Native American Religious Concerns have been recorded. In the event of any discoveries during project implementation, the NNHPD would be notified immediately.

4.0 CUMULATIVE IMPACTS AND CONSIDERATIONS FOR SELECTION OF THE PREFERRED ALTERNATIVE

Cumulative effects are effects of the project in consideration with other past, present, or reasonably foreseeable projects in the local area.

There are no past projects that resulted in identifiable long-term effects having a cumulative relationship with the effects of the proposed project. In the past 1970s, the previous church building was built by the grazing permit holder, Mr. Thomas Joe Yazzie. The church operated for approximately 45 years, until recently, when the old structure was vandalized and burned down.

Currently, there are no other ongoing or reasonably foreseeable church projects in or near the project area. The proposed action will not have significant impact on the human environment. The approval of the requested use area would have minimal effect on the resource use patterns in the project area. The grazing permit holder has relinquished 2.083 acres of trust land to the development. It is the practice of the Navajo Nation to compensate the traditional land user for the grazing resource loss.

In the future, the Navajo Nation would continue to develop projects to provide religious services and education to the congregation. There are no other church construction plans in the proposed project area. As a result, when the effects of the proposed projects are considered with other past, present, and reasonably foreseeable projects in the area, no significant cumulative effects are anticipated at this time. Impacts to the socioeconomic will be positive, as a church facility of this nature is expected to improve the quality of life.

With respect to cumulative impacts on regional air quality and climate change, the lack of scientific tools designed to predict climate change on regional or local scales limits the ability to quantify potential future impacts of the proposed project. However, potential impacts to natural resources and plant and animal species due to climate change are likely to be varied, including those in the southwestern United States. For example, if global climate change results in a warmer and drier climate, increased particulate matter impacts could occur due to increased windblown dust from drier and less stable soils. Cool season plant species' spatial ranges are predicted to move north and to higher elevations, and extinction of endemic threatened/endangered plants may be accelerated.

5.0 COMPLIANCE WITH ENVIRONMENTAL LAWS AND REGULATIONS

Clean Air Act, as amended and recodified (42 U.S.C. 7401 et seq.) Compliance. The project is not expected to violate any Federal air quality standards and would not degrade the attainment of air quality objectives of the air shed.

Clean Water Act § 402 Compliance. The Environmental Protection Agency administers Section 402 of the Clean Water Act (formerly the Federal Water Pollution Control Act). Operators are required to obtain all necessary permits and approvals for projects requiring CWA permits prior to any disturbance activities. The existing church was constructed in increments of less than one acre. Surface disturbance is at a minimum.

Endangered Species Act of 1973 (16 U.S.C. 1531 et seq.) Compliance. No Federally listed species or special management species (NESL) or their habitats have been identified in or near the project area. ESA requires all federal departments and agencies to conserve threatened and endangered species and the habitats on which they depend, and to consult with the U. S. Fish and Wildlife

Service (USFWS), on all actions authorized, funded or carried out by the agency to ensure that the action will not likely jeopardize the continued existence of any threatened and endangered species or adversely modify critical habitat.

Executive Order 11988, Floodplain Management Compliance. This order directs all Federal agencies to avoid to the extent possible the adverse effects associated with the modification of floodplains, and to avoid support of floodplain development wherever there is a practicable alternative. The proposed project would have no effect on floodplains, because they are not located in the project area.

Executive Order 12898 Environmental Justice Compliance. The order direct all Federal agencies to identify and address disproportionate adverse effects of their programs, policies, and activities on minority and low-income populations. No minority or low income populations would be directly affected in the vicinity of the proposed action. Indirect effects could include positive effects due to overall benefit related to the new water system in the area. The proposed action will benefit all sectors of society. The minority and low-income populations in the community are the focus of this project. The project would lead better lives in the community, and would further provide a better quality of life for the residents.

Farmland Protection Policy Act (7 U.S.C. 4201 et seq.) Compliance. There are no effects on prime farmland or farmland of statewide importance because no such farmland exist in the project area.

Migratory Bird Treaty Act, as amended (16 U.S.C. 703 et seq.)/ EO 13186 Compliance. Migratory birds and their habitats are protected under the Migratory Bird Treaty Act (MBTA) (16 USC §703-712) and EO 13186. All federal agencies are required to consider management impacts to protect migratory non-game birds. Executive Order 13186 calls for increased efforts to more fully implement the MBTA. The proposed action would have no significant effect on the bird species or their habitat.

National Environmental Policy Act (NEPA) (42 U.S.C. 4321 et seq.) Compliance. The final EA and signed FONSI are in full compliance with NEPA.

National Historic Preservation Act of 1966, as amended (16 U.S.C. 470 et seq.) Compliance. The Navajo Nation Historic Preservation Department would also require NHPA compliance and consultation with all development projects on the Navajo Nation. NNHPD has determined that NHPA § 106 responsibilities are adhered to, as no historic properties would be affected. See Appendix C.

Recourse Conservation and Recovery Act (RCRA), Comprehensive Environmental Response Conservation and Liabilities Act (CERCLA), or Toxic Substance Control Act (TSCA) Compliance. There are no Recourse Conservation and Recovery Act (RCRA), Comprehensive Environmental Response Conservation and Liabilities Act (CERCLA), or Toxic Substance Control Act (TSCA) sites

on the proposed site. The church will conduct their haulage and disposal of solid waste on a weekly basis. Existing restrooms with toilets would be employed during operations.

6.0 PUBLIC INVOLVEMENT

The Newcomb Chapter has passed a resolution approving the site. See Appendix B. In the future, a resolution is proposed for the Resource and Development Committee of the Navajo Nation Council, as well as BIA approval of the permit.

7.0 COORDINATION AND REVIEW OF THE EA

NNAD of Shiprock, New Mexico conducted the archeological survey of the site and crafted a field report entitled: *A Cultural Resource Inventory of Re-establishing a Proposed 1.5 Acre Congregational Methodist Navajo Mission Site Near Newcomb, San Juan County, New Mexico.*

Congregational Methodist Church conducted consultation with the Navajo Department of Fish and Wildlife, Navajo Nation. This consultation would assure mandated protection of ESA threatened and endangered species and Tribal species of concern. A concurrence letter and a *Biological Resource Compliance Form* is created for the project.

8.0 CONCLUSIONS

The preferred alternative is reasonable. The proposed action should not have significant adverse impacts on the human environment. No significant adverse impacts to the human environment have been identified during the onsite field reconnaissance and in the development of this environment assessment.

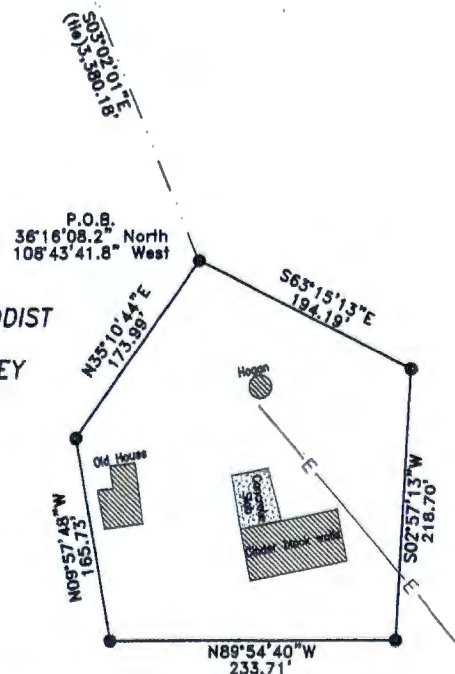

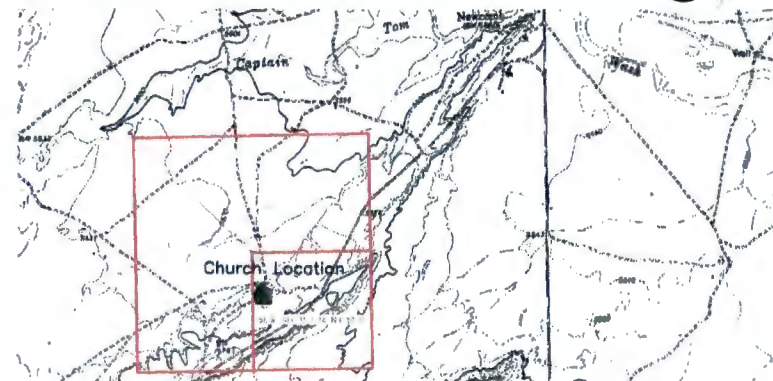

TERMS AND CONDITIONS FOR MISSION SITE PERMIT
Congregational Methodist Navajo Mission (PERMITTEE)

1. This Mission Site Permit is issued to Congregational Methodist Navajo Mission, Post Office Box 7465, Newcomb, New Mexico 87455 to use and occupy Navajo Nation Trust Lands for religious purposes, and shall be subject to the terms and conditions set forth herein. The term of the Mission Site Permit is effective beginning on the date the permit is approved by the Resources & Development Committee of the Navajo Nation Council or authorized representative. This Permit is authorized by Resources and Development Committee No. _____.
2. This permit is revocable at the discretion of the Resources and Development Committee of the Navajo Nation Council. The permit shall immediately be revoked for the failure to use the land herein described for religious purposes. It is understood and agreed that this instrument is 'NOT A LEASE' and is not to be taken or construed as granting any leasehold interest or right in or to the land herein described, but is merely a temporary permit, terminable and revocable.
3. The Permittee shall be given at least thirty (30) days written notice before this Mission Site Permit is terminated and revoked. Upon termination of the Mission Site Permit, the Permittee shall have ninety (90) days in which to remove from the site to dispose of any and all buildings, structures, materials and equipment and other personal property owned by the religious organization. After the expiration of the ninety (90) days, the Permittee shall peacefully and without legal process deliver the possession of the premises to the Navajo Nation. All improvements not removed after ninety (90) days will become the property of the Navajo Nation, unless the Navajo Nation demands in writing that the improvements be removed.
4. This Permit is not transferable, except with the consent of the Resources and Development Committee of the Navajo Nation Council.
5. This Permit shall be reviewed every five (5) years to reevaluate the rent and compliance with the terms and conditions.
6. The legal land description of the premises is described as follows:

7. The annual rental is set at \$_____ per year and is due on or before the first day of January of each year the Permit remains in effect. Pursuant to 16 N.N.C. § 1157, if the Permittee fails to pay the rent when due, this permit shall automatically terminate. The Permittee is responsible to make direct payments to the Navajo Nation Accounts Receivable Section, Post Office Box 3150, Window Rock, Arizona 86515.
8. The Permittee may develop, use and occupy the area under the permit for the purpose(s) of Mission Site. The Permittee may not develop, use or occupy the area under the permit for any other purpose without the prior written approval of the Navajo Nation. The approval of the Navajo Nation may be granted, granted upon conditions or withheld in the sole discretion of the Navajo Nation. The Permittee may not develop, use or occupy the area under the permit for any unlawful purpose.
9. In all activities conducted by the Permittee within the Navajo Nation, the Permittee shall abide by all laws and regulations of the Navajo Nation and of the United States, now in force and effect or as hereafter may come into force and effect, including but not limited to the following:
 - a. Title 25, Code of Federal Regulations, Part 162;
 - b. All applicable federal and Navajo Nation antiquities laws and regulations, with the following additional condition: In the event of a discovery all operations in the immediate vicinity of the discovery must cease and the Navajo Nation Historic Preservation Department must be notified immediately. As used herein, "discovery" means any previously unidentified or incorrectly identified cultural resources, including but not limited to archeological deposits, human remains, or location reportedly associated with Native American religious/traditional beliefs or practices;
 - c. The Navajo Preference in Employment Act, 15 N.N.C. §§ 601 et seq., and the Navajo Nation Business Opportunity Law, 5 N.N.C. §§ 201 et seq.; and
 - d. The Navajo Nation Water Code, 22 N.N.C. § 1101 et seq. Permittee shall apply for and submit all applicable permits and information to the Navajo Nation Water Resources Department, or its successor.
10. The Permittee shall ensure that the air quality of the Navajo Nation is not jeopardized due to violation of applicable laws and regulations by its operations pursuant to the permit.
11. The Permittee shall clear and keep clear the lands within the permit area to the extent compatible with the purpose of the permit, and shall dispose of all vegetation and other materials cut, uprooted, or otherwise accumulated during any surface disturbance activities.
12. The Permittee shall at all times during the term of the permit and at the Permittee's sole cost and

expense, maintain the land subject to the permit and all improvements located thereon and make all necessary and reasonable repairs.

13. The Permittee shall indemnify and hold harmless the Navajo Nation and their respective authorized agents, employees, land users and occupants, against any liability for loss of life, personal injury and property damages arising from the development, use or occupancy or use of the permit area by the Permittee.
14. The Permittee shall not assign, convey or transfer, in any manner whatsoever, the permit or any interest therein, or in or to any of the improvements on the land subject to the permit, without the prior written consent of the Navajo Nation. Any such attempted assignment, conveyance or transfer of the permit without such prior written consent shall be void and of no effect. The consent of the Navajo Nation may be granted, granted upon conditions or withheld in the sole discretion of the Navajo Nation.
15. The Navajo Nation may terminate the permit for violation of any of the terms and conditions stated herein. In addition, the permit shall be terminable in whole or part by the Navajo Nation or authorized representative for any of the following causes:
 - a. Failure to comply with any terms and conditions of the permit or of applicable laws or regulations;
 - b. Non-use of the permit; and
 - c. The use of the land subject to the permit for any purpose inconsistent with the purpose for which the permit is granted.
16. At the termination of the permit, the Permittee shall peaceably and without legal process deliver up the possession of the premises, in good condition, usual wear and tear excepted. Upon the written request of the Navajo Nation, the Permittee shall provide the Navajo Nation, at the Permittee's sole cost and expense, with an environmental audit assessment of the premises at least sixty (60) days prior to delivery of said premises.
17. The Permittee shall give written notice to the Navajo Nation Land Department regarding any change to the Permittee's contact information, address, leadership, organizational name, or any other substantial change to the organization. The notice shall be given within thirty (30) days and delivered to the Navajo Land Department at Post Office Box 2249, Window Rock, and Arizona 86515.
18. Holding over by the Permittee after the termination of the permit shall not constitute a renewal or extension thereof or give the Permittee any rights hereunder or in or to the land subject to the permit or to any improvements located thereon.
19. The Navajo Nation shall have the right, at any reasonable time during the term of the permit, to enter upon the premises, or any part thereof, to inspect the same and any improvements located thereon.
20. By acceptance of the grant of permit, the Permittee consents to the full territorial legislative, executive and judicial jurisdiction of the Navajo Nation, including but not limited to the jurisdiction to levy fines and to enter judgments for compensatory and punitive damages and injunctive relief, in connection with all activities conducted by the Permittee within the Navajo Nation or which have

a proximate (legal) effect on persons or property within the Navajo Nation.

21. By acceptance of the grant of the permit, the Permittee covenants and agrees never to contest or challenge the legislative, executive or judicial jurisdiction of the Navajo Nation on the basis that such jurisdiction is inconsistent with the status of the Navajo Nation as an Indian nation, or that the Navajo Nation government is not a government of general jurisdiction, or that the Navajo Nation government does not possess full police power (i.e., the power to legislate and regulate for the general health and welfare) over all lands, persons and activities within its territorial boundaries, or on any other basis not generally applicable to a similar challenge to the jurisdiction of a state government. Nothing contained in this provision shall be construed to negate or impair federal responsibilities with respect to the land subject to the permit or to the Navajo Nation.
22. Any action or proceeding brought by the Permittee against the Navajo Nation in connection with or arising out of the terms and conditions of the permit shall be resolved administratively under the laws of the Navajo Nation, and no action or proceeding shall be brought by the Permittee against the Navajo Nation, in any court of any state.
23. Nothing contained herein shall be interpreted as constituting a waiver, express or implied, of the sovereign immunity of the Navajo Nation.
24. Except as prohibited by applicable federal law, the law of the Navajo Nation shall govern the construction, performance and enforcement of the terms and conditions contained herein.
25. The terms and conditions contained herein shall extend to and be binding upon the successors, heirs, assigns, executors, administrators, employees and agents, including all contractors and subcontractors, of the Permittee, and the term "Permittee," whenever used herein, shall be deemed to include all such successors, heirs, assigns, executors, administrators, employees and agents.
26. There is expressly reserved to the Navajo Nation full territorial legislative, executive and judicial jurisdiction over the area under the permit and all lands burdened by the permit, including without limitation over all persons, including the public, and all activities conducted or otherwise occurring within the area under the permit; and the area under the permit and all lands burdened by the permit shall be and forever remain Navajo Indian Country for purposes of Navajo Nation jurisdiction.

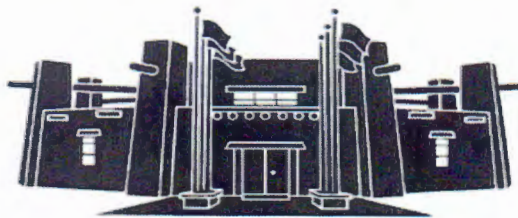


