PURPOSE: The purpose of this resolution is to approve a revised signatory document on file with the United States Department of Interior Office of the Special Trustee.


This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

Section Three. Approval


