BE IT ENACTED:

Section 1. Authority

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A).
- B. The Law and Order Committee is empowered to review and make recommendations to the Navajo Nation Council on proposed amendments and enactments to the Navajo Nation Code. 2 N.N.C. § 601(B)(14).
- C. The Naabik'íyáti' Committee considers proposed resolutions that require final action by the Navajo Nation Council. 2 N.N.C. § 164(A)(9).
- D. The Navajo Nation Council approves enactments and amendments of positive law. 2 N.N.C. § 164(A).

1 **Section 2. Findings**

2 A. The Health, Education and Human Services Committee currently meets on Mondays
3 pursuant to 2 N.N.C. § 403.

4 B. The members of the Health, Education and Human Services Committee wish to change
5 the committee's regular meeting day from Mondays to Wednesdays for reasons of
6 convenience and efficiency.

8 **Section 3. Amendments to Title 2 of the Navajo Nation Code**

9 The Navajo Nation hereby approves amendments to the Navajo Nation Code, Title 2,

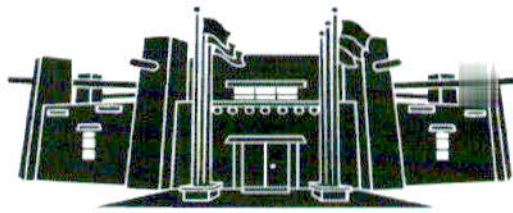
27 The amendments enacted herein shall be effective pursuant to 2 N.N.C. §221.

29 **Section 4. Codification**

1 The provisions of the Act which amend or adopt new sections of the Navajo Nation Code
2 shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel
3 shall incorporate such amended provisions in the next codification of the Navajo Nation
4 Code.

5
6 **Section 5. Saving Clause**

7 Should any portion of the amendment enacted herein be determined invalid by the Navajo
8 Nation Supreme Court, or the District Court of the Navajo Nation, without appeal to the
9 Navajo Nation Supreme Court, those portions not determined invalid shall remain the law of
10 the Navajo Nation.

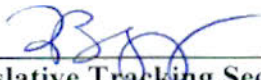

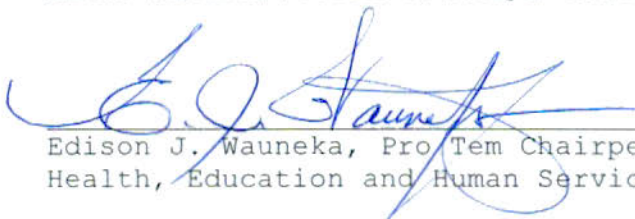
