RESOLUTION OF THE BUDGET AND FINANCE COMMITTEE OF THE NAVAJO NATION COUNCIL

24TH NAVAJO NATION COUNCIL - Second Year, 2020

AN ACTION

RELATING TO BUDGET AND FINANCE COMMITTEE; AMENDING THE SIGNATORY AUTHORITY FOR THE NAVAJO NATION OFFICE OF THE CONTROLLER TO CONDUCT BUSINESS WITH THE UNITED STATES DEPARTMENT OF INTERIOR OFFICE OF THE SPECIAL TRUSTEE FOR AMERICAN INDIANS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is established as a standing committee of the Navajo Nation Council. 12 N.N.C. § 300(A).
- B. The Budget and Finance Committee is empowered to exercise oversight authority including but not limited to budget, finance, investment, contracting, and audits in order to coordinate, oversee, and regulate the fiscal, financial, investment, contracting, and audit policies of the Navajo Nation. 12 N.N.C. § 300(C)(1).

SECTION TWO. FINDINGS

- A. The Navajo Nation acknowledges the United States Department of Interior Office of the Special Trustee for American Indians (the "Office of the Special Trustee") requires the designation of tribal officials to conduct financial business with the Office of the Special Trustee.
- B. The Navajo Nation Office of the Controller has submitted a revised designation form in the document, "Tribal Officials Authorized to Initiate Disbursements and Receive Information on Tribal Accounts," attached as Exhibit A. The Department of Justice has reviewed the revised designation form and determined it to be legally

sufficient. The Department of Justice review is attached as **Exhibit B**.

C. The prior designation of tribal officials authorized to conduct business in BFMY-08-16 shall be replaced with the updated authorization form in **Exhibit A**.

SECTION THREE. APPROVAL

The Navajo Nation hereby authorizes the designation by the Navajo Nation Office of the Controller, as set forth in the attached **Exhibit A**, to conduct business with the Office of the Special Trustee, including but not limited to requests for tribal disbursements and fund drawdowns.




