TITLE OF RESOLUTION: AN ACT RELATING TO HEALTH EDUCATION AND HUMAN SERVICES, LAW AND ORDER, AND NAABIK'ÍYÁTI' COMMITTEES AND THE NAVAJO NATION COUNCIL; AMENDING CERTAIN SECTIONS OF THE NAVAJO NATION CODE TO TRANSFER LEGISLATIVE OVERSIGHT OVER VETERAN SERVICES TO THE NAABIK'ÍYÁTI' COMMITTEE

PURPOSE: This resolution, if approved, will amend certain sections of the Navajo Nation Code to transfer legislative oversight over veteran services to the Naabikiyati Committee.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

In addition, the Naabikiyati Committee serves as the oversight for the Office of Legislative Services and other offices, programs, commissions, boards or task forces under the Legislative Branch of the Navajo Nation Government, unless otherwise designated by Navajo Nation law, and to approve and amend plans of operation thereto. 2 N.N.C. § 701 (A)(5)

D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).

A. In 2011, the Navajo Nation Council adopted Resolution CAP-10-11 which amended certain sections of the Navajo Nation Code, Title 2 §§ 101 through 835, to conform to the newly established 24-member Navajo Nation Council and made necessary revisions to the legislative process and current standing committee structure.

- B. Resolution CAP-10-11 established the Health, Education and Human Services Committee with legislative oversight over veteran services. 2 N.N.C. § 400(C)(3).
- C. The purpose of this legislation is to transfer legislative oversight over veteran services from the Health, Education and Human Services Committee to the Naabikiyati Committee.
- D. The Navajo Nation Council finds it in the best interest for the Navajo Nation Veterans Administration and Navajo Nation Veterans Advisory Council to be under the legislative oversight of the Naabikiyati Committee because Diné veterans are highly honored in Diné society and culture and all veteran matters and concerns should be addressed by the full Council at the Naabikiyati Committee level.

SECTION THREE. AMENDING TITLE 2 OF THE NAVAJO NATION CODE TO TRANSFER LEGISLATIVE OVERSIGHT FOR THE NAVAJO NATION VETERANS ADMINISTRATION AND NAVAJO NATION VETERANS ADVISORY COUNCIL TO THE NAABKIYATI COMMITTE

The Navajo Nation hereby amends the Navajo Nation Code, Title 2, as follows:

TITLE 2. NAVAJO NATION GOVERNMENT CHAPTER 5. EXECUTIVE BRANCH SUBCHAPTER 1. Generally

Article 3. Navajo Nation Veterans Administration

§ 1033. Navajo Housing Program

A. There is hereby established a Navajo Veterans Housing Program within the Navajo Veterans Administration.

- B. The Navajo Veterans Housing Program shall be administered by the Navajo Veterans Administration.
- C. Duties and Responsibilities of the Navajo Veterans Housing Program shall include administering the Navajo Nation Veterans Administrations Housing Program Policies and Procedures. The Veterans Administration Housing Program Policies and Procedures shall be approved by the Health, Education and Human Services Committee <u>Naabik'íyáti' Committee</u>, upon the recommendation of the Navajo Nation Veterans Advisory Council.

§ 1035. Oversight

The Navajo Nation authorizes the establishment of the Navajo Nation Veterans Administration, the Navajo Veterans Housing Program, and the Navajo Nation Veterans Advisory Council. Legislative oversight shall be provided by the Health, Education, and Human Services Committee Naabik'íyáti' Committee of the Navajo Nation Council, which will have final approval of the respective plans of operation.

SECTION FOUR. AMENDING 2 N.N.C §§ 400 *et. seq.* AND 2 N.N.C. § 701 TO TRANSFER LEGISLATIVE OVERSIGHT FOR VETERAN SERVICES FROM THE HEALTH EDUCATION AND HUMAN SERVICES COMMITTEE TO THE NAABKIYATI COMMITTEE

The Navajo Nation hereby amends the Navajo Nation Code, Title 2, as follows:

SECTION SIX. CODIFICIATION

The provisions of this legislation which amend the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

SECTION SEVEN. SAVINGS CLAUSE

Should any provisions of this legislation be determined invalid by the Navajo Nation Supreme Court, or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, those portions of this legislation which are not determined invalid shall remain the law of the Navajo Nation. *Office of Legislative Counsel Telephone: (928) 871-7166 Fax # (928) 871-7576*

<u>NNC LEGISLATION NO. 0023-22</u> is redundant legislation to Navajo Nation Council Standing Committees to attempt transfer oversight over veterans' services.

REDUNDANCY COMMITTEE'S RESPONSIBILITY

AMENDING CERTAIN SECTIONS OF THE NAVAJO NATION CODE TO TRANSFER LEGISLATIVE OVERSIGHT OVER VETERAN SERVICES TO THE NAABIK'IY ATI' COMMITTEE.

A. The <u>Health, Education and Human Services Committee</u> is a standing committee of the Navajo Nation Council and <u>has the power to review and recommend</u> resolutions relating to veterans and veteran services.

B. The <u>Law and Order Committee is a standing committee</u> of the Navajo Nation Council and <u>has the power</u> to review and make recommendations to the Navajo Nation Council on proposed amendments to and enactments in the Navajo Nation Code.

C. The <u>Naabik' iyati' Committee</u> is a standing committee of the Navajo Nation Council and <u>has the power</u> to review proposed legislation which requires final action by the <u>Navajo Nation Council</u>.

REMEDIATION

Instead of passing the buck (transfer oversight), Navajo Nation Council to create <u>Interim Navajo Nation</u> <u>Council Committee</u> to address "<u>Military and Veterans Affairs</u>". The applicable Navajo Nation Council Standing Committee appoint its member to the Interim Council Committee.

The Navajo Nation Veterans' Services is the least understood Navajo Nation Program Services. On February 3, 2016 the Navajo Nation enacted Navajo Veterans Act that codified the Navajo Veterans legal entity of the Na vajo Nation government. In 1971 Navajo Nation established the Office of Navajo Veterans Affair, did not codify.

RECOGNITION OF NATIVE AMERICAN VETERANS

March 21, 2016 than NN President, Russell Begaye, wrote a question letter to U.S. Veterans Administration, re: "VA not recognized organized Native American Veterans under U.S. Code of Federal Regulations. Title 38 Part 14.628: that authorizes preparation, presentation and prosecution of Federal Veterans' Benefit claims." March 21, 2017 VA amended its regulation to recognition of tribal organization.

NAVAJO VETERANS ACT

Upmost important purpose of the Navajo Veterans Act is to get Navajo Nation designated U.S. Veterans Administration (VA) Region. This allow federal veterans' benefits and services be make available on Navajo Nation and neighboring Native land. Navajo Nation is in three (3) VA Regions (AZ, NM & Ut), but there are no VA operated services on Navajo Nation, and /or any of other Native land in U.S.

PROBLEMATICAL NAVAJO VETERANS ADMINISTRATION

The problem of Navajo Veterans Administration (NVA) is misunderstanding the intended purpose of the veterans' program services is challenging.

- 1. The absence of Navajo Veterans Administration program <u>strategic plans</u> and <u>no collaboration work</u> <u>relationship</u> with federal and state veterans' program services for veterans' benefits and services.
- 2. Secrecy of Navajo Veterans Administration. In the past two (2) years there have been obscured changes made to veterans' benefit and services policies and management procedures. In fact, the VTF Financial Assistance <u>policies</u> and <u>procedures</u> were deleted without justification. The changes are made irrational, without justification (no documented legal opinions nor financial service recommendations) and absence of consultation with clienteles (Navajo Veterans, veteran's beneficiaries and communities). This show lack of understanding and disrespect the sensitivity of the Navajo culture (Naayéé' neizhàní) and tradition (Tóbàjíshchíní) way of life of the Navajo people, and lack of an empathy for vulnerable veterans and veteran's beneficiaries' needs to maintain quality of life.

SOLUTION

To be blunt the Navajo veterans Administration is in disarray conditions with excruciating management problems and there is no resolution insight. It reminded me of an instant I encounter in my early years.

On summer my brother and I came upon a man at the bottom of deep arroyo with a wagon loaded with three (3) 55-gallon barrels of water that was stuck. The man was whipping the team of mule to get them pull the wagon forward, but the mules refused to move, they just kicked and backing out. <u>Problem</u>: Two mules (team) were physically tired from pulling heavy load over 5 miles distance in hot weather on rough road. The man failed to take care the mules – feed, water and rest.

Solution: My brother unhitched the mules, gave them water and let them eat some vegetation. He walked them around and rubbed their backs and talk to them.

<u>Result</u>: The mules respond, pull the wagon out of the arroyo and completed the journey.

<u>Cause</u>: The man was a hired hand who have no experiences in caring (managing) for the animals.

NVA is like tired mules, cannot pull the load anymore. Whipping the NVA program with new management policies, procedures, consolidating or redirecting resources, releasing personnel, etc. is not going to strengthen the old system. Potentially causes greater disharmony within the program operation and distant relation with clienteles.

- To salvage the damage made to Navajo Veterans Administration, President and Council of the Navajo Nation to assume the leadership in the total Navajo Veterans Affairs to revitalize the program services to acceptable level of the Navajo veterans and surviving beneficiaries. Secondly, to implement comprehensive analysis of Navajo Nation Veterans' legislations, regulations, rules, policies and staffing. Lastly, develop a comprehensive strategic Plan (unbiased) for the Navajo Nation Veterans Program and services.
- 3. Program Review and Evaluation: NVA needs to undergo complete review and evaluation by independent study group, consisted of relevant professional and technical knowledgeable personnel and grassroot clienteles. Grassroot clientele's involvement is important to identify obstacles to service and needed services and developing new or add program services applicable to clientele needs and identify resources for program service improvement and development.

- 4. Strategic Planning is essential management tools for the programing and staff development, financial management and collaboration service delivery system. NVA is administered with multi-sorts of NN policies and procedures that impeded NVA staffing, financial management, programing veterans' service delivery system. The origin of NN Veterans Program Services is embedded within Navajo culture and traditional practices and subsequently integrated to US Veterans Administration.
- 5. Human Resource Development. Sad situation at the Navajo Veterans Offices that lacks qualified (certified VSO and Record Manager) staff to assistance veterans with their VA benefit claims and applicable services. It is important to have qualified staff (trained and certified)-Director, VSO, AMS, program manager and chapter veterans' organization members-to assist the veteran, surviving spouse and dependent with veteran's benefit claims. A single certified VSO per Agency is totally insufficient. VA claims are process through difficult path of VA system. Self-proclaimed know it all will do more harm to the claimants.

BIG QUESTION?

Is Navajo Nation going take the major responsibilities for the care of Navajo Veterans which include financial (disability, home loan), health care, social services (nursing services, handicap equipment) and cemetery. The Navajo veterans are eligible for federal veterans' benefits and services under the U.S. Veterans Administration.

TITLE OF RESOLUTION: AN ACT RELATING TO HEALTH EDUCATION AND HUMAN SERVICES, LAW AND ORDER, AND NAABIK'IY ATI' COMMITTEES AND THE NAVAJO NATION COUNCIL; AMENDING 2 N.N.C. § 1033 TO ESTABLISH A PROGRAM MANAGER TO ADMINISTER THE VETERANS HOUSING PROGRAM

A. Establish a Program Manager to administer the Veterans Housing Program is greatly questionable and mystery. It is difficult to assess the proposed Program Manager position without position description and the detail description of the Navajo Veterans Housing Program. The lack of detail budget and sort of fund for the position is mystery.

CONCERNS

- The Executive Director of Navajo Veterans Administration (NVA) have consolidated the veterans housing program funds for contracting prefabricated home (Hogan) construction. In that NVA Executive Director have no plan for restarting on-site home construction as original intended in pursuant of Health, Education and Human Service Resolution CJY-55-18.
- 2. There has been no veteran's house constructed in the past three (3) years and no plan to restart the construction veterans' home. In 2008, NNC appropriated 4%, NN Undesignated Fund, set aside VTF. In 2018, NNC, CJA-02-18 amended 4% set aside VTF which 2% of 4% set aside is designated for Veterans House Program and 2% direct appropriated into annual financial assistance. Amending 4% annual set-a-side had stopped the VTF principle growth. The Navajo Veterans Advisory Council recommended amending 4% Annual Set-A-Side to Navajo Nation Veterans Trust Fund without impact study and consultation with CVOs. Attachments-NNC res. CJA-2-02-18 (p.1-4) and VTF Income (p.1-2)
- 3. In 2019 Executive Director of Navajo Administration confiscated the completed Veterans' Housing Application files from Agency Veterans Offices and relocated the files at Central NVA. In early December 2021, Executive Director instructed the Agency Offices staff to update the Veterans' Housing Applications. Veteran Service Officer (VSO) from Northern Agency NVA Office disputed Executive Director's directive which the Central NVA have loss document(s) from the completed veteran's housing application. Executive Director intimidated VSO by either comply or be fire. VSO resigned on December 31, 2021. This is second VSO, Northern Agency, resigned under coerce action of the Executive Director within passed three (3) years. In 2021, the entire Northern Agency NVA staff (VSO, AMS, OMS) left their position due to dishearten treatment by Executive Director.

ANALYSIS

On September 24,2021 Veterans protested in Window Rock, Navajo Nation Council Chamber. The protest was against Executive Director, James Zwierlein, Navajo Veterans Administration (NVA), proposing to implement new financial assistance application for the Veterans Trust Fund (VTF) without consultation with the beneficiaries (veterans, surviving spouses and Gold Star Mothers).

- As a veteran, I value the people's right to freely express concern of intolerable treatment that is detrimental to their livelihood. With that, NVA must be administer openly for the beneficiaries to participate in the changes in a timely manner.
- The Director, Mr. James Zwierlein, autocratically changing application for VFT programs and services have certainly instigated dissatisfaction amongst beneficiaries' long-standing procedures and processes. In 2019 Mr. Zwierlein had HEHS Committee removed VTF policy and procedures, thus, there is not legislatively approved VTF policy existed.
- The Executive Director, Mr. James Zweirlein, forcing to use unofficial fund management method, using veteran population counts (use of veteran's discharge document, Form DD 214) to disburse VTF interest earned funds and consolidating the chapters veterans organizations' VTF allocation in total sum in lieu of official 50/50 formula specified by NN Trust Funds policy.

RECOMMENDATION

- I. Establish NVA Study Commission
 - It is an opportunity to create closer relations (respect, honesty, understanding and ke') to commission Navajo Veterans Administration Study Group.  - It is opportunity time to use ARPA funds to set up a separate NVA Study Commission Office with technical support staff (Planner, Statistician, Technical Writer, etc.), equipment and support services. The Navajo Veterans Administration Study to be complete within a year or less. Navajo Nation Council final approval all amendments to Navajo Veterans Administration policies, rules and regulations and intergovernmental relations with federal veteran's administration on Navajo Veterans' services.

RESOLUTION OF THE NAVAJO NATION COUNCIL

23RD NAVAJO NATION COUNCIL -- Fourth Year, 2018

AN ACT

RELATING TO THE LAW AND ORDER, HEALTH, EDUCATION AND HUMAN SERVICES, BUDGET AND FINANCE, AND NAABIK'ÍYÁTI' COMMITTEES, AND THE NAVAJO NATION COUNCIL; APPROVING AMENDMENTS TO 12 N.N.C. \$ 1176 OF THE NAVAJO NATION VETERANS TRUST FUND

BE IT ENACTED:

Section One. Authority

- A. The Law and Order Committee is a standing committee of the Navajo Nation Council and as such is empowered to review and make recommendations to the Navajo Nation Council on proposed amendments and enactments to the Navajo Nation Code. 2 N.N.C. § 600 (A) and § 601(B)(14).
- B. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council and as such serves as the oversight authority for veterans services. 2 N.N.C. § 400 (A) and § 400(B)(6)(a).
- C. The Budget and Finance Committee is a standing committee of the Navajo Nation Council and exercises oversight authority over budget and finance for the purposes of recommending to the Navajo Nation Council the adoption of resolutions designed to strengthen the fiscal and financial position of the Navajo Nation and to promote the efficient use of the fiscal and financial resources of the Navajo Nation. 2 N.N.C. §§ 300 (A) and 300 (C)(3).
- D. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council. A proposed resolution that requires final action by the Navajo Nation Council shall be assigned to the standing committee having authority over the subject matter at issue and the Naabik'íyáti' Committee. 2 N.N.C. §§ 164(A)(9) and 700(A).
- E. The Navajo Nation Council must review and approve enactments or amendments of positive law. 2 N.N.C. §§ 164(A).
- F. Amendments to 12 N.N.C § 1176 may be made upon recommendation of the Health, Education and Human Services Committee and the Budget and Finance Committee by a

majority vote of the full membership of the Navajo Nation Council. 12 N.N.C. § 1178.

Section Two. Findings

- A. The needs of Navajo veterans have increased since the Navajo Nation Veterans Trust Fund was created through Navajo Nation Council Resolution CJY-46-98.
- B. Resolutions in support of this amendment have been approved by the five Navajo Agency Veterans Organizations. These supporting resolutions are attached as Exhibits A through E.
- C. Supporting resolutions have also been approved by Casamero Lake Chapter, Tsayatoh Chapter, and Coyote Canyon Chapter Veterans Organization. These supporting resolutions are attached as **Exhibits F through H**.

Section Three. Amendments to Title 12

The Navajo Nation amends the Navajo Nation Code 12 N.N.C. § 1176, as follows:

NAVAJO NATION CODE ANNOTATED TITLE 12. FISCAL MATTERS CHAPTER 10. NAVAJO NATION TRUST FUNDS SUBCHAPTER 8. NAVAJO NATION VETERANS TRUST FUND

§ 1176. Expenditure of Trust Fund

The Fund income shall not be expended, except as in § 1177, from Fiscal Year 1998 to Fiscal Year 2003. From Fiscal Year 2004, the Fund income shall be expended as follows:

A. Four 75 percent (4 75%) of the average market value total income earned, plus the current projected set aside of the Fund covering the past three fiscal years will be used as supplemental funding for programs and services to benefit veterans, as noted under § 1172 on an annual basis, excluding two percent (2%), which shall be for the exclusive use of the Veterans Housing Program in accordance with 2 N.N.C § 1171 (A) and Navajo Nation Council Resolution CS-56-17. The market value of the Fund's income earned at the end of the previous audited fiscal year plus the current fiscal year projected set aside 12 quarters will be used to determine the average market value of the Fund for allowable expenditure (i.e. budget purposes). The excess of the Fund income over expenditures shall be

reinvested in the Fund to cover the rate of inflation and to provide for reasonable Fund growth.

- B. Tribal grants to non-tribal government programs and projects shall be awarded in accordance with rules and regulations developed by the Department of Navajo Veterans Affairs, in consultation with the <u>Health</u>, <u>Education and</u> Human Services Committee of the Navajo Nation Council and, if required, the Navajo Nation Council.
- C. Of the four 75 percent (4 75%) of the Fund (Market Value), total amount as set forth in paragraph A, ninety-five percent (95%) of the proceeds will be used for subsections (A) and (B) of this Section and five percent (5%) will be used for administrative purposes, and this be reviewed further by the Office of Management and Budget and the Program.

Except as provided at § 1177, all Trust Fund income distribution shall be determined pursuant to all eligible Navajo veterans and distributed among those applicable Navajo Nation chapters to be expended in accordance with § 1172 of this Plan.

Section Four. Codification

The provisions of the Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

Section Five. Saving Clause

Should any provision of this Act be determined invalid by the Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.

Section Six. Effective Date

The provisions of this Act shall become effective in accordance with 2 N.N.C. § 221(B).


