AN ACTION

RELATING TO NAABIK'ÍYÁTI' COMMITTEE; APPROVING AND ADOPTING THE LEGISLATIVE PRIORITIES OF THE NAVAJO NATION AS DETERMINED BY THE 24^{TH} NAVAJO NATION COUNCIL FOR 2020 RELATING TO THE STATE OF UTAH

WHEREAS:

- A. Statements of policy, enactment of positive law, intergovernmental agreements, budget resolutions, and reallocations, must be reviewed and approved by resolution by the appropriate standing committee(s) and the Navajo Nation Council except as otherwise provided herein. 2 N.N.C. § 164 (A).
- B. Statements of policy are written statements submitted to federal, state or local governments by a Navajo Nation official stating the official position of the Navajo Nation on proposed legislation or other action by that government. 2 N.N.C. § 110 (W).
- C. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'íyáti' Committee to assist and coordinate all requests for information, appearances and testimony relating to proposed county, state and federal legislation impacting the Navajo Nation. 2 N.N.C. §§ 700 (A) and 701 (A) (6).
- D. The 2020 Utah Legislative Priorities provides a list of topics addressed during the Naabik'íyáti' Committee's State Task Force Subcommittee meetings.
- E. The Navajo Nation's Naabik'íyáti' Committee's State Task Force Subcommittee legislative priorities for 2020 pertaining to the State of Utah are as follows:
 - 1. Water Rights
 - 2. Education
 - 3. MMDR/IW
 - 4. Healthcare

- 5. Transportation
- 6. Sacred Site Protection
- 7. Environmental Protection
- 8. Voting Rights
- 9. US 2020 Census
- 10. Broadband Expansion & Internet Capacity
- 11. Economic Development & Job Creation
- F. The Navajo Nation Naabik'íyáti' Committee's State Task Force Subcommittee recommends the Naabik'íyáti' Committee approve the priorities as indicated herein.

NOW THEREFORE, BE IT RESOLVED:

The Navajo Nation hereby approves the Navajo Nation's legislative priorities regarding the State of Utah for 2020 as determined by the 24th Navajo Nation Council and authorizes the Navajo Nation President, the Speaker of the Navajo Nation Council, and their designees, and the Naabik'íyáti' Committee to advocate the position of the Navajo Nation with the State of Utah Legislature, Utah State Agencies, and the State of Utah Governor's Office for the preservation of funding and policies in the Navajo Nation's priority areas.
