**PURPOSE:** If approved by the Navajo Nation Council, this legislation would confirm the appointment of Rudy Shebala as Executive Director of the Navajo Nation Division of Natural Resources.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

#### **WORK EXPERIENCE:**

<u>CHAPTER MANAGER / EMERGENCY SERVICES COORDINATOR:</u> Nazlini Chapter Government, Navajo Nation, Nazlini, Arizona; August 13, 2018 – Present. The Nazlini, Arizona, Chapter Government, a community branch of the Navajo Nation Government encompasses

approximately 400 square miles. There are 1260 resident voters of the Nazlini natural community. Most of these residents reside in scattered family homes throughout the rural Chapter lands. Nazlini, the larger southwest United States, is experiencing a continued drought that affects human, livestock, irrigable farmlands, rangelands, and wildlife. As Emergency Services Coordinator my initial responsibility is to assess water availability to Nazlini citizens, then livestock and farmlands.

Some Nazlini residents have running water and some residents transport potable water from the Nazlini Chapter House. Other residents in more remote areas rely on windmills and hand pumped water wells. I inventory, assess conditions of, and rehabilitate existing wells and roads leading to water sources and recondition breached and silted earthen livestock ponds for future precipitation. Access to water is by graded earth road. Many of these roads are damaged from prior flooding. My staff are installing corrugated culverts in flash flood areas and repairing flood damaged roads. These roads serve to transport water and are routes maintained for emergency use during natural or man caused disaster.

As Chapter Manager, I oversee the daily administrative functions and duties of staff to fulfill Chapter objectives. I work closely with the elected chapter officials to implement services for the citizens of Nazlini. The land and resources of Nazlini is also my responsibility and to date I am dredging the dormant Nazlini, Flat Rock, and Sitting Frogs reservoirs and input canals for water storage. Another immediate job is addressing the exotic stands of Russian Olive and Salt Cedar in the riparian areas. I am now pursuing the development of farmlands by readdressing the Nazlini aquifer in the Flat Rock area. That project was initiated earlier with two deep wells drilled for irrigation. I will attend to the completion of that project. I am responsible for identification, acquisition, and administration of the fiscal budget, records management, preparation of reports, advocate on behalf of Chapter citizens, and serve as the liaison to tribal and non-tribal organizations.
