26	and Finance Committee concerning the budget in accordance with the annual	
27	budget instructions. 12 N.N.C. § 840 (A).	
28	C. The Budget and Finance Committee has oversight of the Fixed Cost budgets for	
29	certain programs. 2 NNC § 301(B)(2).

SECTION TWO. FINDINGS

- A. The Budget and Finance Committee held a budget hearing and took budget testimony regarding the Fixed Cost Fiscal Year 2019 Budget for the Office of Management and Budget's Indirect Cost Plan, the Office of the Controller's annual audit, building maintenance, FMIS debt service, Investment fees, FMIS maintenance service, the Division of General Services' insurance premiums, utilities, telecommunications, radio communications, facilities maintenance, air transportation, the Executive Offices' Hopi Partition Land Rental, Division of Human Services' retirement plan account, Department of Justice's litigation and the Judicial Branch's Justice Information Sharing System. 12 N.N.C. § 840 (A).
- B. The Budget and Finance Committee recommends a fiscal year budget for the Fixed Costs. 12 N.N.C. § 840 (A).

SECTION THREE. APPROVING AND RECOMMENDING THE PROPOSED FISCAL YEAR 2019 BUDGET FOR THE FIXED COSTS

The Budget and Finance Committee requests the changes to the Budget, as set forth in the General Fund Comparative Summary Exhibit B, Recommended Changes to the General Fund Budget, Exhibit C, Recommended Conditions of Appropriation and Legislative Concerns, Exhibit D, and Recommended Unmet Needs, Exhibit E, be incorporated into the Navajo Nation Comprehensive Budget.
