BE IT ENACTED:

## Section One. Authority

A. The Resources and Development Committee exercises authority over chapters of the Navajo Nation. 2 N.N.C. § 501(C)(1).
B. The Budget and Finance Committee of the Navajo Nation Council exercises authority over budgeting, appropriation, investment and management of all funds. 2 N.N.C. § 301 (B)(2).
C. Council Resolution CAP-35-18 provides, "[a] chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter's Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as construction-
ready by CPMD or NTUA and the total Sihasin Funding for the District does not exceed $\$ 4,166,666.67 . "$ See, CAP-35-18, Section Four, Paragraph C.

## Section Two. Findings

A. The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-6814, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. $\S \S 810$ (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and Capital Improvement Process" on April 17, 2018. See, CAP-35-18.
B. A Capital Projects Management Department, Sihasin Project Amendment Certification, CAP-35-18, document is attached as Exhibit 1.
C. The Capital Projects Management Department, Sihasin Project Amendment Certification, CAP-35-18, document, Exhibit 1, indicates three Steamboat Chapter projects described as D-132, Old Chapter Renovation, D-133, Chapter Building Renovation, and D-134, Chapter Warehouse totaling $\$ 833,333.33$ are to be deleted. A new Steamboat Chapter project description called "Chapter Building(s)-Plan, Design, Construction, Equip" is to be added and funded at $\$ 833,333.33$ for Year 2.
D. For reference, the three Steamboat Chapter projects described as D-132, Old Chapter Renovation, D-133, Chapter Building Renovation, and D-134, Chapter Warehouse are included in Exhibit 2, Exhibit D, Projects 132, 133, and 134.

## Section Three. Approval

The Navajo Nation hereby approves a change to the Steamboat Chapter projects by deleting three Steamboat Chapter projects described as D-132, Old Chapter Renovation, D-133, Chapter Building Renovation, and D-134, Chapter Warehouse totaling $\$ 833,333.33$. A new Steamboat Chapter project description called "Chapter Building(s)-Plan, Design, Construction, Equip" is to be added and funded at $\$ 833,333.33$ for Year 2 in accordance with Exhibit 1.
