20	SECTION ONE. AUTHORITY	
21	A. The Resources and Development Committee is the oversight committee for the	
22	Navajo Nation Division of Transportation. 2 N.N.C. §501 (C)(1).	
23	B. The Budget and Finance Committee is empowered to "appropriate, allocate, cancel,	
24	re-appropriate and review the use of Navajo Nation funds received including but not	
25	limited to all grants, contracts, gifts and other funds from all sources. 2 N.N.C. §	
26	301(B)(3).	
27	C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council	
28	with the responsibility to hear proposed resolution(s) that require final action by the	
29	Navajo Nation Council. 2 N.N.C. § 164(A)(9).

- D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C.
 § 102(A).
- E. The Navajo Nation Code provides the purpose of the Navajo Nation Síhasin Fund ("Síhasin Fund") is as follows:

§ 2502 Purpose

- A. The purposes of this Fund are to provide financial support and/or financing for:
 - The planning and development of economic development and regional infrastructure supporting economic development and community development, including such infrastructure as, but not limited to, housing, commercial and government buildings, waterline, solid waste management development, powerline projects, and transportation and communication systems, within the Navajo Nation; and
 - 2. Education opportunities for members of the Navajo Nation.
- B. For the Purpose in § 2502(A)(1), Fund expenditures for infrastructure shall not be limited by 12 NNC § 1310(F) or TCDCJY-77-99.
- C. Leveraging the Fund by way of guaranteeing loans, match funding, direct funding in part, and other weighted uses of the Fund, including loan financing from the Fund, for the purposes in § 2502(A)(1), shall be favored over direct funding in whole.
- 12 N.N.C. § 2502, as amended by CJA-03-18.
- F. The Síhasin Fund provides that "Fund Principal" shall consist of all deposits made to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.) generated and realized by the Fund Principal, and that Fund Income shall be deposited in and added to Fund Principal until such time as a Fund Expenditure Plan is duly adopted. 12 N.N.C. §§ 2504 and 2505 (C).
- G. The Síhasin Fund provides that "Fund Principal and Income shall not be expended except pursuant to a Fund Expenditure Plan consistent with the purposes set forth in § 2502 of this Chapter and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation Council." 12 N.N.C. § 2505(A).

SECTION TWO. FINDINGS

- A. The N8031/N4 Road Project is a \$41,800,000 project, as detailed in the "N4/N8031– Hardrock Pinon Project Summary and Recommendations" attached as **Exhibit A**.
- B. The Resources and Development Committee approved the N8031/N4 project within the Navajo Nation's Tribal Transportation Improvement Program and the project was awarded \$22,300,000 in federal funds. See Resolution No. RDCMY-46-18. Because the project is estimated to cost a total of \$41,800,000 the amount of \$19,500,000 is needed for the project. **Exhibit B**.
- C. The Navajo Division of Transportation ("NDOT") will complete design plans, environmental clearances, permitting, and construction procurement. NDOT will provide construction management for the project, and is working with the Bureau of Indian Affairs/Navajo Region Division of Transportation for BIA/NRDOT to obtain the necessary right-of-way for the project on both Navajo Nation and Hopi tribal lands. BIA/NRDOT will hold the right-of-way and will be responsible for operation, maintenance, and repair of the road and bridge improvements once the project is completed. **Exhibit C**.
- D. The Hardrock Chapter has adopted a resolution supporting this Project. Exhibit D.
- E. The allocation of the \$19,500,000 for this Project meets the criteria for Sihasin expenditures because this Project involves "infrastructure" such as "transportation" as mentioned in 12 N.N.C. § 2502(A)(1).
- F. The allocation of the \$19,500,000 for this Project meets the preference for leveraging Sihasin funds, as mentioned in 12 N.N.C. § 2502(C), because \$22,300,00 in federal funding has already been awarded for this Project.

SECTION THREE. APPROVAL AND ADOPTION OF EXPENDITURE PLAN

- A. The Navajo Nation hereby approves and adopts the N8031/N4 Road Project Expenditure Plan, attached as **Exhibit A**.
- B. The Navajo Nation hereby approves and adopts funding for the N8031/N4 Road Project Expenditure Plan in the amount of \$19,500,000 from the Navajo Nation Sihasin Fund, in accordance with 12 N.N.C. § 2505(A).

C. The Síhasin Funds allocated for the N8031/N4 Road Project may be further leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 *et seq.*, as amended, using Síhasin Fund earnings for repayment and financing costs upon the recommendation of the Budget and Finance Committee and approval by a two-thirds (2/3) vote of all members of the Navajo Nation Council.

SECTION FOUR. APPROVAL AND ADOPTION OF EXPENDITURE PLAN ADMINISTRATION

The Navajo Nation Council hereby approves administration of the N8031/N4 Road Project Expenditure Plan as follows:

- 1. The Navajo Nation Controller shall determine whether the source of the annual allocations from the total allocation of \$19,500,000 will be Síhasin Fund Principal or Income or a combination of both.
- 2. The funding for the N8031/N4 Road Project Expenditure Plan will be distributed to the Navajo Division of Transportation within ten (10) days after the effective date of this legislation. The Navajo Division of Transportation shall be responsible for administering the Project, in accordance with the N8031/N4 Road Project Expenditure Plan described in **Exhibit A**.
- 3. The funds allocated for the N8031/N4 Road Project Expenditure Plan shall be used solely to design, plan, and/or construct the N8031/N4 Road Project described in **Exhibit A**. Any and all cost-savings shall be returned to the Síhasin Fund once the project is completed.
- 4. The funds allocated for the N8031/N4 Road Project Expenditure Plan shall not lapse on an annual basis pursuant to 12 N.N.C. §820(N), however, any funds not spent or encumbered within thirty-six (36) months of the date funds are made available to the Navajo Division of Transportation shall revert to the Síhasin Fund principal, unless recommended otherwise by the Resources and Development Committee of the Navajo Nation Council and approved by the Naabik'íyáti' Committee.

5. The N8031/N4 Road Project shall be operated by the BIA/NRDOT, and maintenance and repairs for the Project shall be performed by the BIA/NRDOT.

SECTION FIVE. EFFECTIVE DATE

This legislation and the N8031/N4 Road Project Expenditure Plan, as set forth above, shall become effective pursuant to 12 N.N.C. § 2505.

SECTION SIX. DIRECTIVES

The Navajo Division of Transportation shall report the status of the N8031/N4 Road Project to the Resources and Development Committee, and to the Naabik'íyáti' Committee, on a quarterly basis.

N4/N8031 - Hardrock Pinon Project Summary & Recommendations

Project Description:

The project is located in Navajo County, Arizona, approximately 2 miles southwest of Pinon, AZ. It lies within the Hardrock and Pinon Chapters and within the BIA Chinle Agency Jurisdiction. The roadway improvements extend on N8031 from H4 to N4, 14.7miles (2.8 miles on Hopi Lands), and on N4 for 0.31 miles. There is one major crossing of Oraibi Wash located on Hopi Land at Station 4+400. The TTIP programmed amount is \$22,000,000.

The project consists of one major structure, several box culverts, grading, drainage, treated aggregate base, and fencing. Much of the existing dirt road will be realigned to avoid flooding issues, home sites, utilities and archaeological sites. The Bureau of Indian Affairs (BIA) prepared initial plans for this project. The route has been realigned since the BIA plans to avoid three archeological sites. The Navajo Division of Transportation (NDOT) is now preparing final plans.

Estimated Cost:

An Engineer's Opinion of Probable Construction Cost has been developed. The following is a breakdown of the current estimate.

Recommendations:

It is recommended the existing dirt road be realigned to avoid flooding issues, home sites, utilities and archaeological sites. The current road is not sufficiently safe and does not meet AASHTO criteria. The drainage culverts are routinely overtopped, the roadway surface is muddy and slick when wet, and impassable in heavy rains. When the wash is flowing, school children are unable to get to school and Chapter members on the west side of Oraibi Wash are unable to get to the Chapter, school, or other areas within the Hardrock Chapter. The detour is almost one hour. The improvements are needed for safety and operational efficiency. An additional \$18,500,000 is needed in order to construct everything that is in the scope of work. Within the current programmed amount on \$22,000,000, it is recommended to construct 9.0 mile on N8031 from H4 to station 15+060 including the Oriabi Wash Bridge. This would create a passable route during storm events because Oriabi Wash would be a bridge crossing. The surface would be a chip seal pavement which would last approximately 7 years. A future project should be programmed to pave the chip seal with an asphalt hot mix surface course within 7 years.




BE IT ENACTED:

Section One. Authority

- A. The Resources and Development Committee has oversight authority over roads and transportation to oversee planning and coordination of all roads and transportation activities of the Navajo Nation. 2 N.N.C. § 500 (C)(6).
- B. The Resources and Development Committee has oversight authority over the Navajo Division of Transportation. 2 N.N.C. \$ 501 (C)(1).

Section Two. Findings

- A. Pursuant to 25 C.F.R. Part 170, Subpart D of the Tribal Transportation Program, the Navajo Division of Transportation is charged with performing the critical functions in collaboration with the Bureau of Indian Affairs, local, state and federal agencies to develop a tribal transportation priority listing.
- B. The Navajo Division of Transportation prepared the FY2018 Navajo Nation Tribal Transportation Improvement Program (TTIP), **Exhibit A**, which includes projects for preliminary study which are cultural, environmental impact studies, rights-of-way, centerline surveys and design; construction engineering funds for construction administration; and, construction funds to construct roadway improvements.
- C. The Resources and Development Committee approved Tribal Transportation Improvement Program (TTIP) is to be submitted to the Federal Highway Administration.
- D. Approving the FY2018 Navajo Nation Tribal Transportation Improvement Program is in the Navajo Nation's best interest.

Section Three. Approval

The Navajo Nation hereby approves the FY2018 Navajo Nation Tribal Transportation Improvement Program as found at **Exhibit** A.



The Navajo Division of Transportation (NDOT) is working with the BIA Navajo Region Division of Transportation (NRDOT) and Hardrock and Pinon Chapters to construct 14.7 miles of road and bridge improvements along BIA Route N8031 from Hopi Route 4 to BIA Route N4 within the Hardrock and Pinon Chapters. Approximately 2.8 miles of N8031 crosses Hopi Tribal Lands with one major bridge crossing over Oraibi Wash. The current dirt road is not sufficiently safe, drainage culverts are routinely overtopped, the road surface is muddy and slick when wet, and impassable during heavy rains. When Oraibi Wash is flowing, school children are unable to get to school and Chapter members on either side of Oraibi Wash are unable to get the Chapter, community school or other areas within Hardrock and Pinon Chapters. The detour is almost one hour.

The Resources and Development Committee approved the N8031/N4 project on the Navajo Nation's Tribal Transportation Improvement Program and the project was awarded Tribal Transportation Program (TTP) federal funds for Preliminary Engineering, Construction, and Construction Engineering activities. The project was awarded \$22.3 million in construction funds.

NDOT will complete design plans, environmental clearance, 404/404 permitting, construction procurement and construction management for the project. These activities are fully funded using TTP federal funds. The NDOT is working with the BIA NRDOT to obtain right-of-way (ROW) for the project for both Navajo Nation and Hopi Tribal Lands. The BIA NRDOT is the ROW applicant and the BIA NRDOT will be responsible for operation and maintenance of the road and bridge improvements once construction is completed.

The NDOT prepared an Engineer's Opinion of Probable Construction Cost to construct 14.7 miles of N8031/N4 road and bridge improvements and cultural resources site remediation and the total cost is \$41,800,000 (see next page for cost breakdown). As mentioned above, the N8031/N4 project has received \$22.3 million in TTP federal funds for construction. An additional \$19,500,000 is needed in order to construct everything that is in the scope of work. At the request



Resolution of the Hardrock Chapter

Resolution # <u>#RC 68/20-06</u>

Requesting the Navajo Nation to Provide Sufficient Resources to provide the Necessary completion in the amount of \$19,500,000.00 for the Construction of NR 8031 and for Completion of NR 8031 Road with Asphalt Blacktop Using the Federal CARES Act Fund.

Whereas:

- The Resources and Development Committee, Navajo Nation Council
 approved and certified the Hardrock Chapter to represent and act on behalf
 of the region on issues affecting the region and threatening the health and
 welfare of the communities; and
- 2. The BIA and Navajo Department of Transportation, Services submitted a Preliminary Design Plan related to the Navajo Nation Council for consideration and the Hardrock Chapter reviewed the plan and responded with their comments and additional recommendations; and
- 3. In the Preliminary Design Plan, it shows \$22.3 million Programmed in the TTIP. This amount will cover only 9.3 miles on 8031. The remaining 6.4 miles of N8031 and N4 will need an additional \$19.5 million to complete construction. The region requested the Navajo Nation to seriously consider the completion of the entire 14.7 miles of N8031(2.8 miles on Hopi Lands) and 0.31 on N4 with asphalt blacktop; and
- 4. All paved roads within the region do not connect to another paved road, all pave road comes to a dead end. The current transportation system does not adequately meet the safety standard and it's not safe for school, public safety, emergency and the general public; and
- 5. In early April, 2020 the Navajo Nation received over \$640 million from the federal CARES Act to address and fight the deadly coronavirus diseases and providing safe transportation will eliminate much of the health issues now facing the Dzil Yijiin Region; and
- 6. It would be in the best safety interest to provided efficient resources from the federal CARES Act and other federal funds to provide construction and completion of NR 8031.

Now therefore be it resolved that:

The Hardrock Chapter hereby request the Navajo Nation to provide sufficient Funds to offset the shortfall of additional \$19,500,000.00 as needed in order to construct everything that is in the scope of work and finding the resources for the construction of NR 8031 and for the completion of NR 8031 with asphalt blacktop using the federal CARES Act fund.



- 1. Page 1, lines 10-16, insert the following:
 - AN ACTION RELATING TO RESOURCES AND DEVELOPMENT, BUDGET AND FINANCE, NAABIK'İYÁTI' COMMITTEES, AND NAVAJO NATION COUNCIL; ALLOCATING \$19,500,000 IN SÍHASIN FUNDS TO THE NAVAJO DIVISION OF TRANSPORTATION FOR THE N8031/N4 ROAD PROJECT; ALLOCATING \$112,080,000 IN SÍHASIN FUNDS TO THE NAVAJO DIVISION OF TRANSPORTATION FOR EARTH ROAD IMPROVEMENT PROJECTS; APPROVING AND ADOPTING THE N8031/N4 ROAD PROJECT AND THE EARTH ROAD IMPROVEMENT PROJECTS EXPENDITURE PLANS PURSUANT TO 12 N.N.C §§ 2501 2508

 - D. The Navajo Nation hereby approves and adopts funding for the Earth Road Improvement Projects Expenditure Plan in the amount of \$112,080,000 from the Navajo Nation Síhasin Fund, in accordance with 12 N.N.C. § 2505(A).
- 6. Page 4, lines 1-5, insert new wording in paragraph C as follows:
 - C. The Síhasin Funds allocated for the N8031/N4 Road Project and the Earth Road Improvement Projects may be further leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 et seq., as amended, using Síhasin Fund earnings for repayment and financing costs upon the recommendation of the Budget and Finance Committee and approval by a two-thirds (2/3) vote of all members of the Navajo Nation Council.

- 9. Page 4, lines 11-13, add the following:
 - 1. The Navajo Nation Controller shall determine whether the source of the annual allocations from the total allocation of \$19,500,000 for the N8031/N4 Road Project and \$112,080,000 for the Earth Road Improvement Projects will be Síhasin Fund Principal or Income or a combination of both.
- 10. Page 4, lines 14-18, add the following:
 - 2. The funding for the N8031/N4 Road Project and the Earth Road Improvement Projects Expenditure Plans will be distributed to the Navajo Division of Transportation within ten (10) days after the effective date of this legislation. The Navajo Division of Transportation shall be responsible for administering the Project, in accordance with the N8031/N4 Road Project Expenditure Plan described in Exhibit A, and in accordance with the Earth Road Improvement Projects Expenditure Plan described in Exhibit E.
- 11. Page 4, lines 19-22, add the following:
 - 3. The \$19,500,000 in funds allocated for the N8031/N4 Road Project Expenditure Plan shall be used solely to design, plan, and/or construct the N8031/N4 Road Project described in Exhibit A. The \$112,080,000 in funds allocated for the Earth Road Improvement Projects Expenditure Plan shall be used solely to design, plan, and/or construct the Earth Road Improvement Projects described in Exhibit E. Any and all cost-savings shall be returned to the Síhasin Fund once the project is completed.
- 12. Page 4, lines 23-29, add the following:
 - 4. The funds allocated for the N8031/N4 Road Project and the Earth Road Improvement Projects Expenditure Plans shall not lapse on an annual basis pursuant to 12 N.N.C. §820(N), however, any funds not spent or encumbered within thirty-six (36) sixty (60) months of the date funds are made available to the Navajo Division of Transportation shall revert to the Síhasin Fund principal, unless recommended otherwise by the Resources and Development Committee of the Navajo Nation Council and approved by the Naabik'íyáti' Committee.
- 13. Page 5, line 3, add a new paragraph 6, as follows:
 - 6. The NDOT shall oversee the Earth Road Improvement Projects, and NDOT shall perform or engage contractual services for all improvements, maintenance, and repairs for the Earth Road Improvement Projects.
- 14. Page 5, lines 5-6, add the following:

This legislation and the N8031/N4 Road Project and the Earth Road Improvement Projects Expenditure Plans, as set forth above, shall become effective pursuant to 12 N.N.C. § 2505.

Re: Legislation 0313-20.

This legislation is proposing to allocate \$19,500,000 from the Sihasin Fund to the Navajo Department of Transportation for NR 8031 and NR 4 project. The road project is two in one project.

I'm asking you to support placing this legislation on the coming winter council session agenda. I'm under the assumption it is not now on the agenda for your consideration.

Over the weekend the Chinle Agency Council unanimously supported a resolution requesting the Navajo Nation Council to approve legislation 0313-20.

See attachment of the unsigned agency resolution, I do not have a copy of signed resolution.

Very briefly, this road is 14.7 miles connecting the communities of Pinon and Hardrock it also traverses the Hopi reservation. The communities been working with the Bureau of Indian Affairs both Navajo Area and Phoenix Area, Navajo Department of Transportation and the Hopi tribe over 30 years. The road is not improved to safety standard and presents a very dangerous situation during inclement weather. During the none wet seasons it also present dangerous condition with wash board and blow sands. The unsafe situation is especially true for schools and emergency services. Ambulance refuses to travel on unimproved road. It also presents a very unsafe condition for all commuters.

For this road to become a reality two major issues got to be met:

First, is the resources. NDOT with its engineers (Dibble Engineering) to compete the total 14.7 miles with a bridge over Oraibi Wash would cost \$41,800,000. In 2018 the Navajo Nation received \$22.3 million in TTP from the federal government, this would only do 9 miles of the 14.7 miles. To wait for the additional \$19.5 million from the federal TTP will take years.

Second, is the approval from the Hopi tribe. The road at the west end traverses their reservation. It took over 20 years before the Hopi Tribal Council by resolution H-073-2013 approved a revocable permit to the Navajo Bureau of

Indian Affairs and Navajo Department of Transportation to enter and use certain lands of the Hopi tribe for the purposes of NR 8031 road improvement.

Should the Navajo Nation Council refuse to consider and approve \$19.5 million from the Sihasin fund to complete construction it will only add another road in the Dzil Yijiin region that comes to a dead end and not connect to another paved road. All paved roads in the region comes to a dead end, none meet another paved road. With the additional \$19.5 million it will complete the entire road not only for the two communities but for the central and western agencies for a more direct route. The entire road will be safe for all commuters, especially for schools and public safety.

The two communities are extremely pleased to have a revocable permit granted to the BIA and NDOT. It'll be 9 years this year since the permit, the communities worked very hard pleating with the Hopi tribe for their permission for the right of way. Remember, this is a revocable permit, it means it could be recalled and taken back. I know there are other right of ways for public projects needed by the Navajo Nation, by not exercising this permit it will interfere with other needs.

The Navajo Nation Council created the Sihasin Fund for development of economic development and regional infrastructures including transportation. It could also be use as leveraging fund as matching in this case to the federal government. We have hope and a dream to see this road become a reality before long.

I'm therefore asking you to support legislation 0313-20 by the Honorable Jimmy Yellowhair.
