The Navajo Nation Council established the Naabik'iyáti' Committee as a 24 Navajo Nation Standing Committee. All proposed legislation that requires 25 final action by the Navajo Nation Council, shall be assigned to the 26 Naabik'iyáti' Committee. 2 N.N.C. §§ 164 (A)(9), 700 (A). 27 C. The Navajo Nation Council is the governing body of the Navajo Nation and as 28 such has the authority to promulgate rules, regulations and procedures for the 29 conduct of its meetings and that of its committees. 2 N.N.C. §§ 102 (A),(E). 30

- C. The Navajo Nation hereby finds that it is appropriate for announcements to be made at the beginning of a Navajo Nation Council Session.

SECTION THREE. AMENDING RULE 6 OF THE NAVAJO NATION COUNCIL RULES OF ORDER SUCH THAT ANNOUNCEMENTS ARE MOVED TO ITEM 1. ON THE AGENDA

The Navajo Nation Council hereby amends Rule 6 of the Navajo Nation Council Rules of Order, as amended by Resolution CJY-39-13, as follows:


Rule 6. Order of Agenda Business; Guests; Legislation Priority

- A. The Order of Agenda Business for the Navajo Nation Council shall be as follows:
 - 1. Call meeting to Order; Roll Call; Invocation; Announcements
 - 2. Recognize Guests and Visiting Officials.
 - 3. Review and Adopt Agenda.
 - 4. Receive the State of the Nation Address from the President of the Navajo Nation.

2	6. Oral Reports:	
3	(a) Bureau of Indian Affairs (BIA)	
4	(b) Indian Health Service (IHS)	
5	(c) Financial Report by the Controller

25	SECTION 4. SAVINGS CLAUSE	
26	Should any provision of this Act be determined invalid by the Navajo Nation	
27	Supreme Court, or the District Courts of the Navajo Nation without appeal to the	
28	Navajo Supreme Court, those provisions of the Act not determined invalid shall	
29	remain the law of the Nation.
