BE IT ENACTED:

Section One. Authority

The Navajo Nation Council established the Budget and Finance Committee as a standing committee of the Navajo Nation Council. 2 N.N.C. § 300 (A).

Section Two. Findings

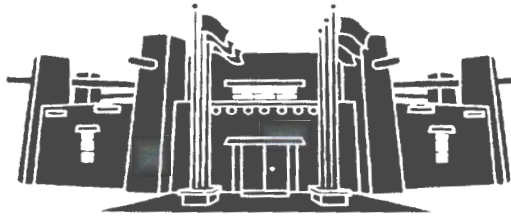
A. The Budget and Finance Committee shall consist of six members. 2 N.N.C. § 300 (B).

B. The Budget and Finance Committee's Chairperson and Vice-Chairperson shall be selected by a vote of the Budget and Finance Committee. 2 N.N.C. § 184 (A).

Section Three. Confirming Chairperson and Vice-Chairperson
