PURPOSE: This resolution will confirm the nomination of Ms. Lorencita Willie, a student at Diné College, to the Commission on Navajo Government Development. Ms. Willie will serve on the Commission as a student representative from the College (as required and permitted by Navajo Nation law).

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

BE IT ENACTED:

SECTION 1. AUTHORITIES

A. The Health, Education and Human Services Committee, pursuant to 2 N.N.C. § 400 *et seq.*, generally oversees matters relative to health, education, employment and social services within the Navajo Nation, among other duties and responsibilities.

B. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council 2 N.N.C. § 700(A). Pursuant to 2 N.N.C. § 164 (A)(9), a proposed resolution that requires final action by the Navajo Nation Council must be assigned to the Naabik'iyáti' Committee before it is considered by the Navajo Nation Council.

C. The Navajo Nation Council, pursuant to 2 N.N.C. §972(A), confirms appointments to the Commission on Navajo Government Development.

2 **SECTION 2. FINDINGS**

3 A. The Commission on Navajo Government Development consists of 12 Navajo
4 members. Regarding appointments to this commission, Navajo Nation law mandates -
5 "Commission members shall be chosen from among individuals who have demonstrated
6 scholarship, a strong sense of public interest, knowledge of Navajo history and cultural
7 heritage, spiritual leadership, leadership in the Navajo government and abilities likely to
8 contribute to the fulfillment of the duties of the Commission." 2 N.N.C. § 972(D).

9 B. Once nominated, members of the Commission on Navajo Government Development
10 are confirmed by and serve at the pleasure of the Navajo Nation Council pursuant to 2
11 N.N.C. § 972(A).

12 C. Concerning nomination and qualifications for the Commission on Navajo Government
13 Development, Navajo Nation law provides - "One member shall be nominated by the Student
14 Body Government of [Diné] College; the nominee shall be a student at [Diné] College and
15 serve so long as said nominee is a full-time student at [Diné] College, but no longer than two
16 years from the date of confirmation by the Navajo Nation Council." 2 N.N.C. § 972(A)(6).

17 D. On October 17, 2019, the student body of Diné College, by written resolution,
18 nominated Lorencita Willie as its representative on the Commission on Navajo Government
19 Development. Student body resolution attached hereto as Exhibit A. Further, the Dine
20 College Board of Regents supports this nomination. Exhibit C, resolution DC-NOV-24-19.

21 E. Ms. Lorencita Willie meets all the qualifications for the Diné College student
22 representative position on the Navajo Government Development Commission. See
23 documents attached as Exhibit B (including letter of interest, resume and verification of
24 student status). It is in the best interest of the Navajo Nation that Ms. Lorencita Willie be
25 confirmed as a member of the Navajo Government Development Commission.

27 **SECTION THREE. CONFIRMATION**

28 Pursuant to 2 N.N.C. § 972(A)(6), Diné College student representative requirements,
29 the Navajo Nation Council hereby confirms the nomination of Ms. Lorencita Willie to the

Commission of Navajo Government Development. The term shall be served consistent with Navajo Nation law.

5. Mrs. Willie possesses great leadership qualities and is a great asset serving on the Associated Students of Diné College (ASDC) student body government as the Senator for the School of Diné Studies & Education, and as an intern under the Native American Language Initiative Program Grant.

NOW THEREFORE BE IT RESOLVED THAT:

1. The Associated Students of Diné College (ASDC) hereby selects student, Lorencita Willie as the Diné College Student Representative to the Commission on Navajo Government Development (CNDG);

RESOLUTION OF THE BOARD OF REGENTS DINÉ COLLEGE

Recommends the Confirmation of Lorencita Willie as the Diné College Student Representative to the Navajo Nation Commission on Navajo Government Development.

WHEREAS:

1. The Diné College Board of Regents is empowered to exercise authority and control over Diné College and is responsible for the accomplishment of the Diné College purposes, 10 NNC § 2003 (2005 ed.); and
2. The Diné College is a non-profit post secondary educational institution chartered by the Navajo Nation Council in 1968 for the purposes of providing educational opportunities to the Navajo people and others in areas important to the economic and social development of the Navajo Nation and other purposes, 10 NNC § 2002; and
3. The plan of operation, for the Commission on Navajo Government Development requires a student representative from Diné College to sit on the commission as a full voting member; and
4. The Associated Student of Diné College (ASDC) selected student, Lorencita Willie as the Diné College student representative to the Commission on Navajo Government Development (CNGD); and
5. Ms. Willie is a student in good standings and recommended by the College President to be the student representative for CNGD for a term of 2 years, as defined by Navajo Nation Council, which is governed by the guiding principles: Professionalism, Respect, Integrity, Culture and Tradition, and Equality; and
6. The mission of the Commission on Navajo Government Development and the Office of Navajo Government Development is to accomplish the Peoples' project of instituting reforms necessary to ensure an accountable, trustworthy, responsible and transparent government.

NOW THEREFORE BE IT RESOLVED THAT:
