RESOLUTION OF THE NAABIK'ÍYÁTI' STANDING COMMITTEE OF THE 23rd NAVAJO NATION COUNCIL -- Fourth Year, 2018

AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT, NAABIK'ÍYÁTI' COMMITTEES; AUTHORIZING THE SPEAKER OF THE NAVAJO NATION OR HIS DESIGNEE TO INITIATE CONTACT WITH THE RESPECTIVE AGRICULTURAL DEPARTMENTS OF THE STATES OF COLORADO, UTAH, NEW MEXICO AND ARIZONA TO ESTABLISH NAVAJO NATION PARTICIPATION IN THE GROWTH AND PRODUCTION OF INDUSTRIAL HEMP PURSUANT TO THE RESPECTIVE STATE PROTOCOLS AND THE AGRICULTURAL ACT OF 2014 (FEDERAL FARM BILL)

WHEREAS:

- A. The Health, Education and Human Services Committee of the Navajo Nation Council has legislative authority and oversight over all matters related to health on the Navajo Nation. 2 N.N.C. § 401 (C).
- B. The Naabik'iyáti' Committee of the Navajo Nation Council has the legislative authority to assist the development of needed programs designed to serve the Navajo People. 2 N.N.C. § 701(A)(7).
- C. The Navajo Nation includes lands that lie within the States of Arizona, New Mexico, and Utah.
- D. The Navajo Nation owns fee lands that lie within the State of Colorado.
- E. The Agricultural Act of 2014 (Federal Farm Bill) authorized States to establish agricultural research projects involving the production of industrial hemp.
- F. The Governor of the State of Arizona signed into law, on May 14, 2018, enabling legislation which establishes a hemp agricultural pilot program and allows for the cultivation, processing and sale of industrial hemp and products made from hemp, pursuant to the Federal Farm Bill.
- G. The Supreme Court of New Mexico issued a ruling, in April of 2018, upholding legislation authorizing New Mexico's participation in agricultural pilot programs involving the

- cultivation, processing and sale of industrial hemp, pursuant to the Federal Farm Bill.
- H. The States of Colorado and Utah also allow for participation in agricultural pilot programs involving the cultivation, processing and sale of industrial hemp, pursuant to the Federal Farm Bill.
- I. The Resources and Development Committee finds it to be in the best interest of the Navajo Nation to recommend to the Naabik'íyáti' Committee that the Speaker of the Navajo Nation Council or his designee to contact each of the listed States to initiate participation by the Navajo Nation in the cultivation, processing and sale of industrial hemp, pursuant to the respective state protocols and the Federal Farm Bill.
- J. The Naabik'íyáti' Committee of the Navajo Nation Council finds it to be in the best interest of the Navajo Nation to authorize the Speaker of the Navajo Nation Council or his designee to contact each of the listed States to initiate participation by the Navajo Nation in the cultivation, processing and sale of industrial hemp, pursuant to the respective state protocols and the Federal Farm Bill.

NOW, THEREFORE, BE IT RESOLVED:

- A. The Resources and Development Committee recommends and the Naabik'iyáti' Committee of the Navajo Nation Council hereby authorizes the Speaker of the Navajo Nation Council or his designee to contact each of the listed States to initiate participation by the Navajo Nation in the cultivation, processing and sale of industrial hemp, pursuant to the respective state protocols and the Federal Farm Bill.
- B. The Speaker of the Navajo Nation Council or his designee shall, within sixty (60) days of passage of this legislation, provide a report to the Resources and Development Committee and the Naabik'íyáti' Committee of the Navajo Nation Council on the status of participation by the Navajo Nation in the cultivation, processing and sale of industrial hemp and products made from hemp.
