# RESOLUTION OF THE RESOURCES AND DEVELOPMENT COMMITTEE 24<sup>th</sup> Navajo Nation Council --- Third Year, 2021

#### AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT; CONFIRMING THE REAPPOINTMENT OF WYNETTE ARVISO TO SERVE ON THE NAVAJO TRIBAL UTILITY AUTHORITY MANAGEMENT BOARD OF DIRECTORS FOR A TERM OF THREE YEARS

#### BE IT ENACTED:

#### SECTION ONE. AUTHORITY

- A. The Resources and Development Committee was established as a standing committee of the Navajo Nation Council. 2 N.N.C. §§ 500(A).
- B. Pursuant to 2 N.N.C. § 500(C), the Resources and Development Committee shall exercise oversight authority over public utilities.
- C. Pursuant to 2 N.N.C.  $\S$  501(B)(9), Resources and Development Committee has the authority to grant final confirmation of appointments to enterprise boards.

#### SECTION TWO. FINDINGS

- A. Pursuant to 21 N.N.C. § 2, the Navajo Nation established the Navajo Tribal Utility Authority (NTUA) as an enterprise.
- B. The NTUA is authorized to acquire, construct, operate and maintain utility systems throughout the Navajo Nation. See  $21 \text{ N.N.C.} \S 1(B)$ .
- C. The general purpose of NTUA is to operate, maintain and promote existing utility systems furnishing electric, gas, utility services; generation, telecommunications and information services for the benefit the Navajo residents of Nation; including establishment, ownership, operation and maintenance of electric generating, telecommunications and information services on or off the Navajo Reservation; and to provide utility generation, telecommunications and information

- services on a non-profit basis and at a reasonable cost to residents of the Navajo Nation consistent with the economical operations of the Enterprise. See 21 N.N.C.  $\S$  5(A)(1)-(6).
- D. The NTUA Management Board shall have the delegated authority and responsibility for the management and operation of the Enterprise. See 21 N.N.C. § 7 (1).
- E. The management board shall consist of seven (7) persons, all of whom shall be appointed by the Government Services Committee of the Navajo Nation Council; whose authority to confirm appointments to enterprise boards has been delegated to the Resources and Development Committee. See 21 N.N.C. § 9 (A); See also 2 N.N.C. § 501 (B)(9).
- F. Members of the board shall be called directors, and shall have the following qualifications: (1) [f]our of the directors shall be members of the Navajo Nation who speak English with fluently and who have sufficient education and experience to qualify them for learning utility business practices and procedures and making sound judgments; (2) [f]our of the directors shall be persons having not less than 10 years' experience in business management of substantial character and at least two of such persons shall have had such experience in the management and operation of a utility business. See 21 N.N.C. § 9(B)(1)-(2).
- G. Vacancies in the management board may be filled for an unexpired term of the vacant office. See 21 N.N.C. § 9 (C)(2).
- H. Directors shall be eligible for reappointment. See 21 N.N.C. \$ 9(C)(1).
- I. RDCMY-50-17 appointed Wynette Arviso to the NTUA Management Board for a term of three years that expired at the annual board meeting in October 2019. The appointing resolution RDCMA-50-17 is attached as **Exhibit 1**.
- J. On September 19, 2019, Wynette Arviso was recommended to be reappointed by the NTUA Management Board resolution NTUA-33-19 which attached as **Exhibit 2**.
- K. Wynette Arviso meets the qualifications listed under 21 N.N.C. § 9(B)(1)-(2). Wynette Arviso's resume is attached as RDCMY-50-17 Exhibit C which is attached in **Exhibit 1**.

L. The reappointment of Wynette Arviso will be for a period of three years starting from October 2019 and will expire with the annual board meeting in October 2022. See 21 N.N.C. § 9(C)(2).

#### SECTION THREE. CONFIRMING APPOINTMENT

The Resources and Development Committee finds that Wynette Arviso meets the required qualifications to be reappointed as a director for the NTUA Management Board as set forth in 21 N.N.C. § 9 (B)(1)-(2), and hereby confirms the reappointment of Wynette Arviso for a term of three years, with the term expiring at the annual board meeting in October 2022.

RELATING TO RESOURCES AND DEVELOPMENT COMMITTEE; CONFIRMING THE REAPPOINTMENT OF WYNETTE ARVISO TO SERVE ON THE NAVAJO TRIBAL UTILITY AUTHORITY MANAGEMENT BOARD OF DIRECTORS FOR A TERM OF THREE YEARS

#### SECTION ONE. AUTHORITY

- A. Pursuant to 2 N.N.C.  $\S$  500 (C), the Resources and Development Committee (Committee) shall exercise oversight authority over public utilities.
- B. Pursuant to 2 N.N.C.  $\S$  501 (B)(9), the enumerated power of the Committee is to grant final confirmation of appointments to enterprise boards.

#### SECTION TWO. FINDINGS

- A. Pursuant to 21 N.N.C. § 2, the Navajo Nation established the Navajo Tribal Utility Authority (NTUA) as an enterprise.
- B. The NTUA is authorized to acquire, construct, operate and maintain utility systems throughout the Navajo Nation. See 21 N.N.C. § 1 (B).
- C. The general purpose of NTUA is to operate, maintain and promote existing utility systems furnishing electric, gas, water, sewer utility services; generation, and telecommunications and information services for the benefit of residents of the Navajo Nation; including the establishment, ownership, operation and maintenance of electric generating, telecommunications and information services on or off the Navajo Reservation; and to provide utility generation, telecommunications and information services on a non-profit basis and at a reasonable cost to residents of the Navajo Nation consistent with the economical operations of the Enterprise. See 21 N.N.C. § 5 (A)(1)-(6).

- D. The NTUA Management Board shall have the delegated authority and responsibility for the management and operation of the Enterprise. See 21 N.N.C.  $\S$  7 (1).
- E. The management board shall consist of seven persons, all of whom shall be appointed by the Government Services Committee of the Navajo Nation Council; whose authority to confirm appointments to enterprise boards has been delegated to the Resources and Development Committee. See 21 N.N.C.  $\S$  9 (A); See also 2 N.N.C.  $\S$  501 (B) (9).
- F. Members of the board shall be called directors, and shall have the following qualifications: (1) [f]our of the directors shall be members of the Navajo Nation who speak English with fluently and who have sufficient education and experience to qualify them for learning utility business practices and procedures and making sound judgments; (2) [f]our of the directors shall be persons having not less than 10 years' experience in business management of substantial character and at least two of such persons shall have had such experience in the management and operation of a utility business. See 21 N.N.C. § 9 (B) (1)-(2).
- G. Directors shall be eligible for reappointment. See 21 N.N.C.  $\S$  9 (C)(1).
- H. Vacancies in the management board may be filled for an unexpired term of the vacant office. See 21 N.N.C. § 9 (C)(2).
- I. On August 26, 2016 Ms. Wynette Arviso was recommended to be reappointed by the NTUA management board. See **Exhibit A** (NTUA-27-16).
- J. Ms. Wynette Arviso has expressed her continued interest in being reappointed as a Director to the NTUA management board. See **Exhibit B** (Letter of Interest).
- K. Ms. Wynette Arviso meets the qualifications listed under, 21 N.N.C.  $\S$  9 (B)(1)-(2). See **Exhibit C** (Résumé)
- L. The reappointment of Ms. Wynette Arviso will be for a period of three years starting from October 2016 and w2ill expire with the annual board meeting in October 2019. See 21 N.N.C.  $\S$  9 (C)(2).

#### SECTION THREE. CONFIRMING RE-APPOINTMENT

The Navajo Nation Resources and Development Committee finds that Ms. Wynette Arviso meets the required qualifications to be reappointed as a director for the NTUA management board as set forth in 21 N.N.C. § 9 (B)(1)-(2), and hereby reappoints Ms. Wynette Arviso for a term of three years, with the term expiring at the annual board meeting in October 2019.


