TITLE OF RESOLUTION: AN ACT RELATING TO THE LAW AND ORDER AND NAA'BIK'ÍYÁTI' COMMITTEES, AND THE NAVAJO NATION COUNCIL; AMENDING THE SEX OFFENDERS REGISTRATION AND NOTIFICATION ACT IN TITLE 17 OF THE NAVAJO NATION CODE

PURPOSE: The purpose of this legislation is to amend the Sex Offenders Registration and Notification Act ("SORNA") to allow Navajo Police Department civilian employees to handle sex offender registration and other related matters.


This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

OF THE NAVAJO NATION CODE

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Law and Order Committee was established as a standing committee of the Navajo Nation Council with the delegated responsibilities to “[t]o protect the rights and interests of the Navajo People by improving the quality and effectiveness of the justice system within the Navajo Nation” and to review and make recommendations to the Navajo Nation Council on proposed Navajo Nation Code amendments and enactments. 2 N.N.C. §§ 600(A), 600(C)(2) and 601(B)(14).
- B. The Naa'bik'íyáti' Committee was established as a standing committee of the Navajo Nation Council with the delegated responsibility to hear and act on proposed legislation that requires final action by the Navajo Nation Council shall be assigned to the Naa'bik'íyáti' Committee. 2 N.N.C. §§ 164(A)(9) and 700(A) (2).

- 1 C. The Navajo Nation Council is the governing body of the Navajo Nation and must
2 review and approve enactments or amendments of positive law, i.e., changes to the
3 Navajo Nation Code. 2 N.N.C. § 102(A) and § 164(A).

5 **SECTION TWO: FINDINGS**

- 6 A. These amendments, to the Navajo Nation's criminal statutes were developed during the
7 24th Navajo Nation Council through Work Groups led by the Law and Order
8 Committee and the Chief Prosecutor. The amendments developed by former President
9 Russell Begay's Executive Branch Work Group were incorporated, fully or in part, into
10 the Title 17 code amendments.
- 11 B. The Title 17 amendments went before the 24th Navajo Nation Council, however, the
12 Council ran out of time to vote on the amendments.
- 13 C. The Title 17 code amendments included changes to Navajo Nation's Sex Offender
14 Registration and Notification Act ("SORNA"). These changes are to assist the Navajo
15 Nation Police Department in timely registering those offenders who have been charged
16 with a sexual offense requiring registration as a sex offender.
- 17 D. Timely registration is vital to keeping individuals, communities, employees, and
18 employers within the Navajo Nation informed of sex offenders in their area and work
19 place.
- 20 E. Currently, SORNA requires Navajo Police Officer ("Officer") to register sex offenders.
21 However, due to the need for Officers to be active in the field and to quickly respond
22 to emergency situations when on duty, the Navajo Police Stations do not always have
23 Officer's on-site to conduct registration.
- 24 F. The Navajo Police Stations have civilian employees staffing the office to provide
25 administrative support. The civilian staff are available and able to register sex offenders
26 when Officers are out in the field.
- 27 G. The Navajo Nation Department of Justice reviewed the proposed amendments during
28 the 24th Navajo Nation Council and deemed them to be legally sufficient.
- 29 H. The 25th Navajo Nation Council determines that the amendments to Title 17 of the
30 Navajo Nation Code Sex Offender Registration and Notification Act are necessary and

1 vital to ensure adequate deterrence and punishment for sexual offenses that threaten the
2 Navajo Populace, including Navajo families and Navajo communities.

4 **SECTION THREE AMENDMENT**

5 The Navajo Nation Council hereby amends Title 17 of the Navajo Nation Code as
6 follows:

14 **§ 2100. Title**

15 This Act shall be known as the Navajo Nation Sex Offender Registration and Notification
16 Act of 2012 ("the Act").

17 *****

18 **§ 2102. Definitions**

19 The Definitions below apply to this Act only.

- 20 A. "Act" means ~~the~~ The Navajo Nation Sex ~~Offender~~ Registration and Notification Act
21 of 2012.
- 22 B. "Alford plea," means a A plea whereby a defendant does not admit the act but admits
23 that the prosecution could likely prove the charge, and a Court will pronounce the
24 defendant guilty upon such a plea.
- 25 C. "Business days," ~~r~~Refers to working days excluding Saturdays, Sundays and
26 holidays.
- 27 D. "Convicted," for purposes of this Act, means:
- 28 1. An adult who has been found guilty, or has pled guilty, or has entered a plea
29 of no contest or has entered an Alford plea to a sex offense as defined by this
30 Act and Title I; or

2. A juvenile offender who:

- a. Is prosecuted as an adult and found guilty, or has pled guilty, or has entered a plea of no contest or who has entered an Alford plea to a sex offense; or
- b. Was fourteen 14 years or older at the time of the offense and who has been adjudicated of a sex offense comparable to or more severe than sexual assault at 17 N.N.C. § 443 or an attempt or conspiracy to commit such an offense.

E. "Dru Sjodin National Sex Offender Public Website," ~~means a~~ A public website that is maintained by the Attorney General of the U.S. Department of Justice that includes information about convicted sex offenders.

F. "Failure to register," ~~means w~~ When a sex offender is required to initially register with the Navajo Police Department and ~~he or she~~ does not register within the required of time period.

G. "Goes to school," ~~means a~~ An an individual is enrolled in and attends a private or public secondary school, a vocational or professional school or an institution of higher education.

H. "Incarceration," ~~refers t~~ To being lawfully detained, pursuant to a conviction, in a tribal or local detention facility, a federal, state, military, foreign, private or contract facility or those under "house arrest" for a sex offense for which registration is required.

I. "Initial registration," ~~means w~~ When a sex offender registers for the first time with the Navajo Police Department within the required time lines.

J. "Jurisdiction" ~~means a~~ An Indian tribe, a state, the District of Columbia, the Commonwealth of Puerto Rico, Guam, American Samoa, the Northern Mariana Islands and the United States Virgin Islands.

K. "Maintains registration," ~~means a~~ A a convicted sex offender coming in person to register according to the timeline of the tier level of ~~his or her~~ their sex offense; for example, a convicted tier 1 sex offender registering in person every year ~~if the person is convicted of a Tier 1 sex offense.~~

L. "Minor," ~~means a~~ An individual who has not attained the age of eighteen (18) years.

- 1 M. "Navajo Indian Country," means ~~the~~The territory of the Navajo Nation as defined by 7
2 N.N.C. § 254.
- 3 N. "Navajo Nation Sex Offender Registry for the Public (~~"NNSORP"~~)," ~~means a~~A
4 website that contains information for the public about convicted sex offenders who
5 reside, work, or go to school within Navajo Indian Country. The NNSORP is available
6 to the public.
- 7 O. "Navajo Police Department Registry of Sex Offenders (~~"NPDR"~~)," ~~means a~~A website
8 registry of convicted sex offenders who reside, work, or go to school within Navajo
9 Indian Country and which is maintained by the Navajo Police Department. The NPDR
10 is restricted solely by use of the Navajo Police Department and to other law
11 enforcement agencies as required by law. The NPDR is not available to the public.
- 12 P. "Registers," ~~means~~the initial registration of a convicted sex offender who is convicted
13 by a Navajo ~~d~~District ~~e~~Court or who comes into Navajo Indian Country to reside, work
14 or go to school.
- 15 Q. "Resides," ~~means living in a~~ The place ~~which one is living and~~ considers "home" or
16 where one habitually lives or sleeps.
- 17 R. "Retroactivity or retroactive," ~~means s~~Sex offender registration requirements apply to
18 individuals who were convicted of sex offenses prior to 2006 provided they meet the
19 criteria set out in Section 2117.
- 20 S. "Sex Offender," ~~means a~~A person convicted of any sex offense that requires registration
21 as a convicted sex offender under this Act or under Title I as defined herein.
- 22 T. "Sex offense for which one is required to register," ~~means a~~A sex offense which, if
23 convicted of, requires the sex offender to register under this Act or under Title I as
24 defined herein.
- 25 U. "Title I," Title I of the Adam Walsh Child Protection and Safety Act of 2006, Public
26 Law 109- 248, 42 U.S.C. § 16901 et seq., is a federal statute that requires the registration
27 of all sex offenders who are convicted of a sex offense(s) for which Title I requires
28 registration and requires notification of the presence of sex offenders in ~~the a~~
29 community.
30

V. "Tier classification." Title I classifies sex offenses into three (3) tiers: Tier 1, Tier 2, Tier 3. The tier classifications are based on the nature of the sex offense, the length of incarceration, and whether an individual has been previously convicted of a sex offense that requires registration.

W. "Updates registration." means a A convicted sex offender comes in person within has three (3) business days to inform the Navajo Police Department in person that a change has occurred in one or more of ~~his or her~~ their required registration information.

X. "Works." means a An individual who is employed full-time, part-time, seasonally or temporarily for compensation by an employer; is self-employed; or is a volunteer, intern, extern or in some like capacity for which no compensation is paid.

§ 2103. Sex offenses that require registration under ~~this Act~~ Title 17 and under Title I of the Adam Walsh Child Protection and Safety Act of 2006

A. An individual is required to register as a convicted sex offender only if ~~he or she~~ they are is convicted of a sex offense(s) enumerated under ~~this Act~~ Title 17 or under Title I of the Adam Walsh Child Protection and Safety Act of 2006.

C. Every convicted sex offender who is required to register with the Navajo Police Department must comply with the registration requirements and will be subject to the notification provisions of this Act and of Title I if ~~he or she~~ they resides, works or goes to school within Navajo Indian Country.

§ 2106. Initial registration, maintaining and updating registration

A. Initial registration refers to the first time a convicted sex offender comes in person to register with the Navajo Police Department whether from conviction by a Navajo ~~D~~district ~~C~~court or by another jurisdiction.

B. Maintaining registration refers to a convicted sex offender coming in person to the Navajo Police Department in accordance with the time line required for the tier classification of ~~his or her~~ based on the charged sex offense.

1 C. ~~Updating registration refers to a~~ A convicted sex offender must update registration
2 ~~coming in person to inform~~ with the Navajo Police Department within three (3) business
3 days of any change in ~~his or her~~ their required registration information. The convicted
4 sex offender shall immediately notify the Navajo Police Department ~~if he or she will~~
5 of any travel outside of Navajo Indian Country for more than seven (7) calendar days
6 including international travel. If any international travel will be done by the sex
7 offender, he or she that person shall provide notice of destination to the Navajo Police
8 Department at least twenty-one (21) days prior to travel.

10 **§ 2108. Information required for registration**

11 A. A convicted sex offender who is required to register shall provide to the Navajo
12 Police Department the following information for ~~his or her~~ the sex offender's initial
13 registration:

- 14 1. Full primary name and any nicknames, aliases and pseudonyms regardless
15 of the context in which they may be used.
- 16 2. Actual date of birth and any other date of birth used by the ~~convicted~~ sex
17 offender.
- 18 3. A general description of the convicted sex offender's physical appearance
19 including any identifying marks such as but not limited to scars, moles,
20 birthmarks, or tattoos.
- 21 4. Navajo Nation census number, Certificate of Indian Blood and Navajo
22 Identification Card of which the Navajo Police Department will make a
23 photocopy.
- 24 5. Valid social security number and any other social security number the sex
25 offender used in the past whether valid or otherwise.
- 26 6. Landline telephone number(s), cellular telephone number(s), and any and all
27 Voice over IP telephone number(s).
- 28 7. Valid driver's license or other identification cards such as passports or
29 immigration documents of which the Navajo Police Department will make a
30 photocopy.

- 1 8. License plate number(s), registration number(s) and description of any
2 vehicle(s) including aircraft and watercraft owned and operated or occasionally
3 driven by the convicted sex offender and any permanent or frequent location
4 where any vehicle, aircraft or watercraft is kept.
- 5 9. Residence address at each place a sex offender resides or will reside, and if a
6 street address is not available, a description of the location of the residence(s).
- 7 10. Name and address or physical location of temporary lodging if the sex offender
8 does not reside in a permanent residence.
- 9 11. Name of employer, if any; place of employment including if self-employed;
10 place where ~~he or she~~ the sex offender volunteers, is an intern or extern or
11 works in any other capacity; and the telephone number(s) and address(es) of the
12 employer(s).
- 13 12. Name and address of the school where the sex offender is or will be a student.
- 14 13. Internet names including all email addresses, instant message addresses and
15 identifiers, and any and all designations used by the sex offender for the purpose
16 of routing or self- identification in internet communications or postings
17 including but not limited to social network identifications, Twitter accounts,
18 video posting site identifications such as YouTube.
- 19 14. Professional licenses that authorize the sex offender to engage in an occupation
20 or a profession or to carry out a trade or business.
- 21 ~~15. If any international travel will be done by the sex offender, he or she~~ they ~~shall~~
22 ~~provide notice of destination to the Navajo Police Department at least twenty-~~
23 ~~one (21) days prior to travel.~~

24 B. The Navajo Police Department shall obtain and process the following information
25 for all convicted sex offenders who are required to register as follows:

- 26 1. Photographs of the sex offenders.
- 27 2. Fingerprints that shall be submitted to the Integrated Automated Fingerprint
28 Identification System (IAFIS)
- 29 3. Palm prints that shall be submitted to the FBI Next Generation Identification
30 Program.

4. DNA sample from either the Combined DNA Index System (CODIS) or, if from the sex offender, a DNA sample that shall be submitted to the appropriate state DNA laboratory or to the FBI Laboratory for submission of such DNA sample into CODIS.
5. The statutory language that describes the criminal offense(s) for which the sex offender was convicted and is required to register.
6. Criminal history of the sex offender that includes dates of all arrests; dates of all convictions; ~~his or her~~ status of parole, probation or supervised release; ~~his or her~~ sex offender registration status; and any outstanding arrest warrants.

§ 2109. Initial registration of a convicted sex offender and notice to register

A. Every sex offender convicted of a sex offense by the Navajo ~~D~~istrict ~~C~~court shall initially register with the Navajo Police Department within the following time lines:

1. Within three (3) business days prior to ~~his or her~~ the offender's release from a Navajo corrections facility and shall be so informed by Navajo corrections officers; or
2. Within three (3) business days of having been sentenced by a Navajo ~~D~~istrict ~~C~~court and which sentence includes or does not include incarceration and shall be so informed as follows.
 - a. ~~i.~~ When an individual is charged with a sex offense that, if convicted of, would require sex offender registration, the individual will be so informed at arraignment by a Navajo district court judge.
 - b. ~~ii.~~ When an individual has been convicted of a sex offense that would require sex offender registration, the Navajo district court judge shall so inform the individual at the time of conviction and the sex offender registration requirement shall be included in the judgment and sentence.

B. Every sex offender convicted of a sex offense that requires registration by another jurisdiction and who has come into Navajo Indian Country to reside, work or go to school shall initially register with the Navajo Police Department within three (3) business days of coming into Navajo Indian Country.

- 1 C. Every convicted sex offender shall appear in person to register in with the Navajo
2 police district wherein ~~he or she~~ the sex offender resides, works or goes to school. ~~When~~
3 ~~a~~ A sex offender ~~comes to~~ can register and ~~the~~ with a Navajo police officer ~~who would~~
4 ~~conduct the registration is not available to do so, other~~ or designated civilian Navajo
5 Police Department personnel employee. ~~will obtain the sex offender's name, physical~~
6 ~~address, mailing address, and telephone number on a sign-in sheet.~~ Registration by one
7 police district will automatically make the sex offender's information available to all
8 Navajo police districts
- 9 D. Every convicted sex offender shall bring ~~with him or her~~ all the documentation required
10 for ~~his or her~~ initial registration as enumerated in 17 N.N.C. § 2108(A).
- 11 E. The Navajo Police Department shall obtain information on the sex offender that is
12 enumerated at 17 N.N.C. § 2108(B).
- 13 F. The Navajo police officer, or designated civilian employee, conducting the registration:
- 14 1. Shall verify that the documentation delivered by the ~~convicted~~ sex offender is
15 documentation about that individual.
 - 16 2. Shall explain the Sex Offender Registration and Notification Act ~~of 2012~~
17 Acknowledgment Form to the sex offender and shall obtain ~~his or her~~ the sex
18 offender's signature which verifies that the sex offender understands the
19 purpose, procedures and requirements of registration. The ~~Navajo police~~
20 ~~officer will provide the explanation and information will be provided in~~ Navajo
21 as necessary.
 - 22 3. ~~Will~~ Shall record all necessary information, take photographs, fingerprints, palm
23 prints, DNA samples and any other records as required by Title I of the Adam
24 Walsh Child Protection and Safety Act of 2006 and 17 N.N.C. § 2108.
 - 25 4. ~~Will~~ Shall explain the frequency and duration of registration to the sex offender
26 and that ~~he or she~~ appearance must ~~appear~~ be in person at each registration.
 - 27 5. ~~Will~~ Shall provide verbal and written notice to the sex offender that the Navajo
28 Police Department will conduct periodic verification of ~~his or her~~ the sex
29 offender's residence or temporary lodging.
- 30

1 6. Shall immediately transmit registration information through the SORNA
2 Exchange Portal to law enforcement agencies of other jurisdictions where a sex
3 offender may be required to register and to the National Clearing Information
4 Center ("NCIC")/ National Sex Offender Registry ("NSOR").

5 G. The Navajo Police Department:

6 *****

7 5. Shall designate personnel ~~for full-time duty two (2) Navajo police officers in~~
8 ~~each police district to implement the sex offender registration program, shall train~~
9 ~~the police officers~~ the designated personal in sex offender registration and shall
10 designate dedicated office space, equipment, and police vehicles for the use by the
11 sex offender registration program. ~~The full-time duty will be at least three~~
12 ~~consecutive days of the work week.~~

13
14 **§ 2110. Requirements to maintain an updated registration**

15 A. A convicted sex offender must maintain ~~his or her~~ registration in accordance with the
16 tier level of the sex offense for which ~~he or she~~ the sex offender has been convicted as
17 follows:

- 18 1. Tier 1 - every year for 15 years; and
19 2. Tier 2 - every 6 months for 25 years; and
20 3. Tier 3 - every 3 months for life; ~~and~~

21 B. The Navajo Police Department shall take a photograph of the convicted sex offender
22 annually from the date of initial registration unless a change in the sex offender's
23 physical appearance requires an updated photograph. A convicted sex offender must
24 appear in person to maintain registration at the Navajo police district office where ~~he~~
25 ~~or she~~ they are is-registered.

26 C. A convicted sex offender must update ~~his or her~~ registration within the three (3) business
27 days whenever any required registration information under 17 N.N.C. § 2108 changes
28 including significant changes in physical appearance. The convicted sex offender must
29 appear in person to update registration at the Navajo police district office where ~~he or~~
30 ~~she~~ the sex offender is registered.

1
2 **§ 2111. Reduction of Period to Register**

- 3 A. A sex offender who was convicted of a Tier I sex offense may have ~~his or her~~ their
4 registration period reduced from fifteen (15) years to ten (10) years if ~~he or she~~ has
5 ~~complied with~~ registration requirements have been complied with and has a clean
6 record has been maintained ~~a clean record~~ for ten (10) consecutive years beginning
7 from date of release from incarceration or from the date of sentencing if no imposed
8 incarceration.
- 9 B. A sex offender who was a juvenile adjudicated of a Tier 3 sex offense by another
10 ~~adjudication jurisdiction~~ may have ~~his or her~~ their registration period reduced from life
11 to twenty-five (25) years if ~~he or she~~ they have ~~has~~ complied with registration
12 requirements and has have maintained a clean record for twenty-five (25) consecutive
13 years beginning from date of release from incarceration.
- 14 C. For purposes of this Section, a sex offender has a clean record if ~~he or she~~ has they
15 have:
- 16 1. Not been convicted of any offense for which incarceration for more than 1
17 year may be imposed,
 - 18 2. Not been convicted of any sex offense,
 - 19 3. Successfully completed, and with no revocation, any period of supervised
20 release, probation, or parole, and
 - 21 4. Successfully completed a certified sex offender treatment program.
- 22

23 **§ 2112. Penalty for failure to register or for absconding**

24

- 25 B. Sentence. Any convicted Indian sex offender found guilty of failure to register or of
26 absconding shall be sentenced to incarceration for a term not to exceed 365 days, shall
27 register with the Navajo Police Department within three (3) business days prior to release
28 from incarceration, and thereafter shall maintain registration in accordance with the tier
29 level of the sex offense for which ~~he or she~~ the sex offender was convicted.
- 30

1 C. A non-Indian convicted sex offender who fails to register or who absconds will be
2 arrested and placed into federal custody for consideration for federal prosecution.

3 ****

4 **§ 2114. The Navajo Nation Sex Offender Registry for the Public (NNSORP)**

5 The Navajo Police Department shall operate and maintain a public website that shall
6 provide information about convicted sex offenders who reside, work or go to school
7 within Navajo Indian Country.

8 A. The information shall be maintained in a digitized format and by an electronic
9 database in a form capable of electronic transmission that will automatically
10 update changes in registration information.

11 B. NNSORP shall be capable of field search capabilities necessary for full
12 participation in the Dru Sjodin National Sex Offender Public Website including
13 the capability to conduct searches by name, country, city and/or town, and zip
14 code and/or geographic radius and that will enable the public to request e-mail
15 notices relating to sex offender information.

16 C. NNSORP shall include instructions on how a registered sex offender may seek
17 correction of information that ~~he or she~~ they contends ~~the information~~ is
18 erroneous.

19 D. The information contained in NNSORP shall not be used to injure, harass, or
20 commit a crime against any convicted sex offender named in NNSORP. Any
21 such Action may result in civil or criminal penalties.

22 E. NNSORP shall contain at least the following information on every convicted sex
23 offender:

- 24 1. Name including all aliases;
- 25 2. A current photograph;
- 26 3. A physical description;
- 27 4. License plate number and description of ~~his or her~~ the sex offender's vehicle.
- 28 5. Residential address, physical address, or physical location of temporary
29 lodging;
- 30 6. Address of the place where ~~he or she~~ the sex offender works;

- 1 7. Address of the place where ~~he or she~~ the sex offender goes to school;
2 8. Sex offense(s) for which ~~he or she~~ the sex offender is currently required to
3 register.
4 9. All sex offenses for which ~~he or she~~ the sex offender has been convicted; and
5 10. Information that ~~he or she~~ the sex offender did not initially register or has not
6 maintained or updated ~~his or her~~ their registration.

7 *****

8 **§ 2116. Community Notification**

9 Whenever a sex offender registers or maintains or updates ~~his or her~~ information, the Navajo
10 Police Department shall:

12 **§ 2117. Retroactivity**

13
14 A. A sex offender who was convicted of a sex offense by any jurisdiction prior to July
15 2006 shall be required to register if ~~he or she~~ they resides, works, or goes to school
16 within Navajo Indian Country, and is either:

18 B. A sex offender who meets the criteria set out in Subsection A may be credited time
19 toward ~~his or her~~ their required registration period based on the date of ~~his or her~~
20 sentence imposed without incarceration or the date of ~~his or her~~ release from
21 incarceration for the prior to July 2006 sex offense conviction.

22
23 **SECTION FOUR. CODIFICATION**

24 The provisions of this Act that amend or adopt new sections of the Navajo Nation Code
25 shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel
26 shall incorporate such amended provisions into the next codification or supplement of the
27 Navajo Nation Code.

28
29 **SECTION FIVE. SAVINGS CLAUSE**

30 Should any provision of this Act be determined invalid by the Navajo Nation Supreme

2 Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.



Dear Madam Speaker and Madam Chairwoman:

The Navajo Police Department strongly supports "An Act Relating to the Law and Order and Naa'bik'iyati' Committees, and the Navajo Nation Council; Amending the Sex Offenders Registration and Notification Act in Title 17 of the Navajo Nation Code." As the primary law enforcement program enforcing Title 17 on the Navajo Nation we are well place to recognize needed changes as practical circumstances arise in implementation and execution of sections of the criminal code.

As you are aware, the NPD has finite enforcement resources that spread our police officers thin in responding in emergent and critical events. The 2021 *Navajo Police Department Organizational Assessment* report outlines the challenges our program faces in providing direct service to the people of the Nation. As we continue to assess how we provide services, we have determined that civilian personnel can perform certain functions that are currently being performed by commissioned police personnel.

The Sex Offender Registration and Notification Act of 2012 (Act) currently requires a police officer to conduct the registration of a sex offender and they must explain the Act to a sex offender. The amendment that has been offered will allow a civilian employee of the police department or a police officer the ability to register and interact with a sex offender. This flexibility will allow operation discretion in the assignment of NPD employees who can better serve the plan of operation requirements of our program while also ensure the intent of the Act is carried out.

NPD has been working with the Navajo Department of Personnel Management since September 2020 to create a civilian employee classification titled SORNA Registrant. This classification will


initially deploy three registrants to supplement the current efforts of the SORNA program and may be expanded as required. The registrant shall register, maintain and update the information of convicted sex offenders. This information shall be populated into internal and external applications and registries. The registrant shall work with regional sex offender programs in classifying convicted sex offenders and shall coordinate verification assignments. The registrant shall work with enforcement and prosecution elements to arrest and prosecute a convicted sex offender who fails to register or absconds. This position shall also conduct community presentations and awareness campaigns about the Nation's sex offender registration and notification program. The final classification of this civilian position for public advertisement for hire is dependent on removing the mandatory police officer requirement and allowing civilian employees to engage in these processes.

We will not be the only program in Indian Country that is shifting from requiring commissioned police officers to administer the components of this program to civilian administration. The Office of Justice Program references two programs in their Substantial Implementation Review reports that have moved to civilian registry. They are Gila River Police Department that has a Sex Offender Registry Specialist and the Shoshone-Paiute Tribes which has a Sex Offender Registration Technician. Additionally, the 2020 *Guide to SORNA Implementation in Indian Country* states civilians carry out non-law enforcement functions of SORNA programs.

This amendment would ensure that only police officers will be able to arrest and engage the field verification components of the SORNA program. However, the registrant will be able to prepare the probable cause statements and reports if a convicted sex offender has not complied leading to a warrant for arrest. Additionally, the registrant will be able to coordinate law enforcement resources and those of the US Marshals in field verification efforts on the Nation.

The NPD continues to evolve the process of service that it provides to the people. Our support of this amendment is one component in that evolution of continual reassessment. Should there be any questions, please do not hesitate in contacting me.




