# RESOLUTION OF THE NAABIK'ÍYÁTI' STANDING COMMITTEE OF THE 24th NAVAJO NATION COUNCIL -- First Year, 2019

#### AN ACTION

RELATING TO NAABIK'ÍYÁTI' COMMITTEE; APPOINTING A DELEGATE MEMBER FROM THE NAABIK'ÍYÁTI' COMMITTEE TO THE DINÉ DEVELOPMENT CORPORATION AS A SHAREHOLDER REPRESENTATIVE

#### BE IT ENACTED:

### SECTION ONE. AUTHORITY

A. The Naabik'íyáti' Committee is established as a standing committee of the Navajo Nation Council. 2 N.N.C. §700(A).

### SECTION TWO. FINDINGS

- A. Standing committees are required to select a member to serve as a Shareholder Representatives or Member Representatives for certain Navajo Nation enterprises.
- B. The By-Laws of the Diné Development Corporation provide, "[a]s the sole shareholder, the Navajo Nation's shares in the Corporation will be exercised by five (5) 'shareholder representatives' comprised of one member from each of the five (5) standing committees of the Navajo Nation Council or their successor committees . . . "
- C. The Naabik'íyáti' Committee is permitted to designate one member representative to the Diné Development Corporation.

# SECTION THREE. NAABIK'ÍYÁTI' COMMITTEE SHAREHOLDER REPRESENTATIVE DESIGNEE

A. The following member from the Naabik'iyáti' Committee is designated to serve as its shareholder representative to the Diné Development Corporation: Honorable Delegate Jamie Henio.
